CIF Southern Section schedule has two seasons, fall and spring. First football games would be Jan. 8.

The CIF State office released a modified 2020-21 calendar for high school sports seasons in the state on Monday morning, as the coronavirus pandemic continues.

Soon after, the CIF Southern Section office released more detailed dates for high school sports, which would be divided into fall sports and spring sports.

The fall sports season would begin in December, according to the schedule, if state requirements for the coronavirus were met at that time. Most sports would conduct CIF championship games in March.

Traditional fall sports including football, girls' volleyball, boys' water polo, boys' and girls' crosscountry and field hockey remain in that season. Boys' volleyball, girls' water polo, gymnastics and traditional competitive cheerleading will also be fall sports in 2020-21.

Football would be allowed a full 10-week regular season under the schedule. Practice would begin on Dec. 14, with Week One games scheduled for Jan. 8, 2021. Teams would go straight from CIF Southern Section Championship games on April 9 and 10 to the CIF State Championships the following weekend, taking away the CIF Southern California Football Regional games.

Spring sports include baseball, softball, competitive sports cheerleading and boys' and girls' seasons for basketball, soccer, lacrosse, golf, swimming and diving, track and field and wrestling. The spring sports season would start with games in March for most sports and run through late May to June.

CIF Southern Section Commissioner Rob Wigod said in a Zoom news conference that the length of each regular season would last about 72 days. Each sport will have the same amount of Southern Section champions, divisions and guaranteed entrees into the playoffs as it had in previous years.

"In terms of the distribution of sports in these two seasons, there are instances where there are more sports in these two seasons than you would normally see spread across three seasons of sport," Wigod said. "But there is no way that you can go from a time frame of August through June, to December through June,

Orange County beach cities react to CIF plan

Athletic directors and coaches will be working overtime to make the 2020-21 CIF Southern Section sports calendar work.

Of course, that's better than the alternative of having no games to schedule during the coronavirus pandemic.

After the CIF State office released an announcement of a modified calendar Monday morning, the section released anticipated season dates. The fall sports season — which contains football, boys' and girls' volleyball, boys' and girls' water polo, boys' and girls' cross-country, field hockey, gymnastics and traditional competitive cheer — would start in December. be even more busy, with baseball and softball along with boys' and girls' basketball, tennis, soccer, track and field, swimming and diving, lacrosse, golf and wrestling. Also on the spring sports calendar are badminton and competitive sport cheerleading.

Sunset Conference athletic directors held an online meeting Tuesday afternoon. Soon after, Edison High School athletic director Rich Boyce said he had a big whiteboard out, trying to figure out volleyball schedules.

He said the conference would

H.B. closes City Hall for the second time since mid-March

Huntington Beach will close its City Hall to the public for the second time since mid-March in response to a recent spike in the number of Orange County COVID-19 cases, though county officials reported a slight dip in cases Monday.

Officials said Friday the city would be modifying operations as a proactive health and safety measure, effective Monday. While city business will continue to provide service, public access to City Hall, the Huntington Beach Police Department and "most other facilities" would be discontinued.

"All departmental operations will remain fully staffed, and the city will improve and expand the use of digital and telephone services to meet the community's needs remotely," staff said in a release.

Meanwhile, the Orange County Health Care Agency reported Tuesday 990 new coronavirus cases and 20 deaths from COVID-19, for a countywide cumulative total of 30,976 cases and 513 deaths. A reported 6,684 tests were issued Tuesday with an overall positivity rate of 12.4% drifting downward from a high of 14.9% as recently as July 13, but still above the 8% state threshold.

The third element on the California Department of Public Health radar is hospital capacity, which Orange County has long comfortably met. As of Tuesday, 39.4% of ICU beds were available and 64% of ventilators were available. The state thresholds for those are 20% and 25%, respectively.

By raw numbers, Tuesday's cases maintained Orange County's standing as second-highest in California for total infections and

Huntington council tables Gothard Street emergency homeless shelter proposal

The Huntington Beach City Council voted 5-2 Monday night to table a proposal for a 40-plus bed temporary homeless shelter at the Public Works Yard on Gothard Street, following a sometimes heated discussion.

Councilman Mike Posey made a motion to table Councilman Erik Peterson's proposal for two weeks, pending continuing development of the temporary homeless shelter at 17631 Cameron Lane.

Council members Barbara Delgleize, Kim Carr, Patrick Brenden and Mayor Pro Tem Jill Hardy supported Posey's motion, while Peterson and Mayor Lyn Semeta were the dissenting votes.

"In two weeks, we'll see what the update is from Cameron Lane," Posey said. "If there's a reason to talk about a backup site, then we talk about a backup site. Right now, there's no reason, but there might be."

About 50 residents showed up in favor of Peterson's proposal, many expressing frustration about the Cameron Lane site, which City Manager Oliver Chi said is slated to open in late October or early November. They wore black and white shirts that read "Take Back HB."

Many of the supporters were members of the Facebook group Huntington Beach Homeless Awareness, which has more than 2,000 members. Resident Jerry McKinish is a leader of the group.

"Huntington Beach has been trying to get a homeless shelter

No fines yet, but Costa Mesa warns that being unmasked could cost \$100

Costa Mesa is engaging in a campaign to remind people those who go out in public without masks could be cited and fined, though skeptical citizens are challenging the city's authority and, in at least one case, calling its bluff.

Officials spread the word on Saturday on the city's Facebook and Twitter pages anyone caught out in public without a facial covering would be subject to a \$100 fine.

"Don't face a fine. Wear a mask," read one tweet posted Saturday. "Wearing a facial covering in public is the Law. No Face Mask = \$100 Fine."

Requiring facial coverings in public was one of several orders issued during a local coronavirus emergency declared March 12 by City Manager Lori Ann Farrell Harrison, acting as the city's director of emergency services.

State and local government codes grant governors and city managers, respectively, the authority to issue orders during a declared emergency intended to

code pertaining to disaster relief state it is a misdemeanor offense to "do any act forbidden by any lawful rule or regulation issued pursuant to this title, if such act is of such a nature as to give or be likely to give assistance to the enemy or to imperil the lives or property of inhabitants of this city, or to prevent, hinder or delay the defense or protection thereof."

But while mandatory face masks have technically been required for more than three months, it wasn't

until this weekend's campaign that fines for offenders took center stage. City spokesman Tony Dodero on Monday likened the order to city rules prohibiting illegal fireworks.

"We can fine people up to \$1,000 for that but we typically don't if they're a first-time offender," he said. "A lot of times, we don't fine them, we say, 'Fireworks are illegal here, knock it off.' "

Dodero attributed the awareness effort to a surge in the number of cases and hospitalizations in recent weeks that put Orange County, and 32 other California counties, on a state monitoring list.

"We went from being one of those cities that was allowed to open and continue opening, beyond Phase 2 and into Phase 3 and now we're on the watch list," he said.

"It was just a reminder to people, because of the spike in cases, that wearing a mask is the way out of this.'

So far, the idea of barefaced citizens racking up fines is eliciting a mixed response among residents.

Some praised the move, while others took to Facebook with open challenges to city officials and the Costa Mesa Police Department, the agency authorized to enforce the order.

Tom Carroll, 35, went to a local bagel shop and posted a photograph of himself without a mask on a Costa Mesa public forum page.

"Currently sitting at Shirley's Bagels on 17th street with no mask with 2 other people ... \$300 in fines up for grabs for the city if they want to send the cops out to fine us," he wrote.

The Costa Mesa resident said state guidelines regarding mask wearing appear to put forth recommendations, rather than imposing rules, and exempt those who cannot wear masks due to respiratory problems

and issues with claustrophobia.

Until a business or individual can explain how they plan to accommodate those exemptions under the city's regulation, Carroll says he will continue to

challenge the local orders. "I was trying to incite someone to report me to someone from the city to give me a ticket. I want to have a discussion with the authority who's going to write me a ticket and talk about those exemptions,' he said of his experience.

"I got a couple of dirty looks from people, but no one said anything.'

Bryan Glass would not speak in an interview but said while department staff have been trained on mask regulations and how to respond to such calls, no citations or fines have been issued.

He said he's just excited for the potential for games, pointing to the fact that many colleges have canceled fall sports.

"I'm excited that we get to still play, that my senior boys and girls are going to have an opportunity to play hopefully," Sinclair said. "We still need to get back into the pool. I'd say that's the next hurdle, and I think we're waiting for more direction from the district on that."

Ocean View football coach Luis Nuñez said his team is looking for a Week 7 game. The Seahawks were scheduled to have Week 7 as a bye week before Pac 4 League play began, but that changed when the schedule changed. Ocean View was forced to drop a Week 0 game against Irvine, since there will be no Week 0 games this season.

"I'm trying to find a similar opponent," Nuñez said with a laugh. "I know like San Clemente and Mission Viejo are all looking for a Week 7 [game], but obviously, that makes no sense for a school like us."

Boyce said the calendar makes sense. He understands the CIF's reasoning behind it, even if it will lead to many more busy days to come for him.

"It's challenging, but I'm a math guy," he said. "I like numbers.'

change that," she said. "We wanted a place that was safer and could be controlled, and the City Yard kept coming up."

However, several speakers during public comment expressed concern at the site of the proposed emergency shelter on Gothard Street, which would be close to Ocean View High School and Central Park. Ocean View School District Supt. Carol Hansen sent a letter to the City Council opposing the item.

"Although shelters of this type usually do not allow walk-ins, the shelters do allow residents to leave to go to work and shop," Hansen wrote.

"That will put shelter residents on the street to access transit and stores in the area of the shelter that may conflict with children accessing parks."

The city voted to purchase the Cameron Lane site in February and authorized it for use as a temporary homeless shelter in April. It is paid for and operated by the county, though it would be transferred to the city in the future.

In discussing the item on the Gothard Street proposal, Posey and Delgleize offered rebukes of Peterson. Posey noted that Peterson was the lone dissenting vote when the city declared a homelessness emergency on April 18, 2019, and approved purchasing a structure at 15311 Pipeline Lane. That location eventually was not approved as a shelter site.

At one point, Semeta asked her colleagues to stop tearing each other down. Delgleize was emotional when addressing Peterson, calling his proposal and its supporters "deceptive."

"They lashed out at council members on social media, after they've been told and they've been explained to what we're doing and why it's taking longer," Delgleize said.

"I felt you were being a little disingenuous coming out and saying, 'We could have an emergency shelter up in two weeks, we could have 20 beds.'

"No way. You can't do it that quickly ... I think we should put all our focus on

the city's website.

staying a hair above Riverside County's 30,890 known infections.

Orange County has the third-highest population in California, with 3.2 million people. Riverside is California's fourth-most populous county with 2.5 million. Los Angeles County, population 10.1 million, leads California in raw coronavirus numbers, with 161,673 cases as of Monday.

The change in Orange County's three-day average of total hospitalized patients was -2.4%, not only below the 10% state threshold that would indicate stability but into the range showing short-term improvement.

But pulled back to the past week, hospitalizations have been back-and-forth, ranging from a peak of 722 on July 14 to 666 on Sunday.

A total of 700 people were being treated in hospitals, and 234 in ICU units, the agency confirmed.

As of Tuesday, 39.4% of ICU beds were available

available. The state thresholds for those are 20% and 25%, respectively. Huntington Beach spokeswoman Catherine

Jun said Monday City Hall initially closed on March 18 but was reopened to limited in-person services on June 29 with additional safety precautions in place, including regular disinfection, mask wearing, distancing and temperature checks.

"Unfortunately, with the spike in cases, we've had to pull back on these efforts and close our facilities to limit interactions that can spread COVID-19," Jun said.

"As one of the counties on the state's monitoring list, we felt it was critical to do our part by reimplementing closures to prevent gatherings that could spread COVID-19 and endanger the lives of visitors and employees."

While City Hall is closed once more, some services will continue to operate in a limited, socially distanced capacity, the release indicated. Central Library will offer book pickup and drop-off, while some recreational programs and the city's Junior Lifeguard program will be maintained.

Beaches will not be affected by Monday's closure, and the public can continue to purchase beach parking passes at 103 Pacific Coast Highway.

The Huntington Beach City Council and Planning Commission will continue to meet with protocols in place, and city commissions and committees will resume meetings in a largely digital medium, the release indicated.

"As [coronavirus] cases rapidly increase, the city encourages all residents and visitors to diligently practice social distancing and use face coverings to prevent infections," it continued.

In a similar announcement made July 10 the city of Newport Beach announced it would reclose its City Hall as of July 13. Officials at Costa Mesa had been working to reopen the city's civic center in June but never did, while Laguna Beach city services are currently open, according to
