Jewelry store owner fends off robbery

A store owner opened fire at multiple armed people who allegedly forced their way into a Huntington Beach business in an apparent robbery attempt over the weekend and then fled in two vehicles, including one that later crashed in Los Alamitos.

The attempted heist occurred at about 4 p.m. Saturday near Algonquin Street and Davenport Drive, Huntington Beach police wrote in a tweet. Shots rang out "as the store owner defended himself," police said.

The owner of the business was not hurt, but a customer was struck by shattered glass and suffered minor lacerations, police said. Isabella's Fine Jewelry was identified as the shop that was targeted, a representative for the store said in an Instagram post on Sunday.

"We would like to thank our wonderful customers for all your outpouring support and well wishes," a store representative said. "We also would like to give our thanks to the Huntington Beach Police Department for all their hard work. We will be back in business as soon as we can.'

The suspects fled the business in two vehicles that were seen heading north on the 405 Freeway, police said. One was later spotted and pursued by law enforcement before crashing near Katella Avenue and Wallingsford Road in Los Alamitos, Huntington Beach police spokeswoman Jessica Cuchilla said. Several people ran from the area, including a minor who was arrested and taken to juvenile hall on suspicion of robbery.

Heat wave sets records in O.C.

The extreme heat wave that started Aug. 30 and sent crowds to the beaches to cool off over the long Labor Day weekend will stretch through at least Friday, according to weather officials.

Temperatures soared over the weekend, with new records set in inland Orange County cities like Anaheim and Santa Ana, where the mercury climbed to 107 and 108 degrees respectively on Sunday.

Meanwhile in coastal Orange County, Newport Beach recorded a high of 97 on Sunday - close, but not quite high enough to upend its previous record of 102 degrees set in 2017.

Amid this, Southern California Edison reported a power outage in Laguna Beach at 1:08 p.m. on Monday that affected 4,216 customers. Power was restored to all users at 6:56 p.m. the same day.

Spokeswoman Gabriela Ornelas said Edison was glad to have been able to restore service within the same day. She noted the utility had received reports of other outages related to the heat over the weekend, but the cause of the Laguna Beach outage was still under investigation as of Tuesday afternoon

National Weather Service meteorologist Stefanie Sullivan on Tuesday said the massive upper level high pressure system hovering over the region for the past several days "doesn't seem to want to weaken or move. We've been stuck under this pattern that's bringing this heat.

"We've had some monsoon moisture moving in from the east [so there is humidity as well],"

Laguna Open beach volleyball tournament returns for 67th year

The Laguna Open beach volleyball tournament is celebrating its 67th year when play begins next weekend, making it the longest-running open beach volleyball tournament in the world.

Like anything that has been around for close to seven decades, the tournament has seen its share of ups and downs.

Tournament director Kirk Morgan has witnessed it all.

"It started in a very humble fashion and blew up in the 1980s and early '90s to be a tournament with a \$100,000 purse, sponsored by the big alcohol companies," he said. "But

then, the city outlawed advertising on sand, especially alcohol advertising on sand, and all the money went away. The tournament almost died. It went from being a \$100,000 purse down to a \$400 purse, and went from having the biggest names in the sport to basically being a poorly attended little regional tournament."

Morgan, who took over as tournament director in 2010, now can see it as something in between those two extremes. But he is excited, because big names are indeed expected in Laguna when the tournament starts Friday at Main Beach.

Edison stays perfect with win

Edison High football coach Jeff Grady said there wasn't much talk about last year's narrow loss to Orange Lutheran leading into this year's contest.

The Chargers came up just short then, after the Lancers hit a go-ahead field goal in the final minute.

"Obviously you watch the game and you see what happens," he said. "The kids all know what happened, but we can't do anything about last year."

This year's matchup came into the fourth quarter tied, and again seemed to be headed down to the wire.

But Edison flipped the script.

Two fourth-quarter interceptions on defense, by Carter Hogue and Dylan Walters, led to touchdowns on offense. The hosts rolled late for an impressive victory.

Edison beat Orange Lutheran 34-13 on Friday at Cap Sheue Field, improving to 3-0 this season.

"Our guys stepped up and really put pressure on their quarterback all night," Grady said. "We got a lot of pressure with our front four, and obviously some key turnovers. ... Of course I'm happy we're winning, but what's more important is how we're playing, the spirit we're playing with, the energy. You just try to grow a little bit more, week in and week out."

Edison has its first 3-0 start since the 2016 season after beating last year's CIF Southern Section Division 2 champion Orange Lutheran (2-1).

quarterback Senior Parker Awad finished 17 of 25 for 203 yards. He had a pair of long touchdown passes to Ashton Hurlev and Mason York, respectively.

Meanwhile, Hogue had career-best numbers at running back, with 16 carries for 138 yards and two touchdowns.

Nicholas Preston added a pair of field goals for the Chargers, helping them forge a 6-6 tie at halftime. Orange Lutheran's Noah Rodriguez had scored a short rushing touchdown in the second quarter, but Edison's Jackson Irwin blocked the extra point.

Irwin had two quarterback sacks, putting an exclamation point on the win by recording one on the game's final play.

"That was definitely the biggest relief, for sure," said Irwin, who also forced a fumble. "It's the best feeling ever beating a Trinity League school. We really just stepped up today. I didn't want to lose to them two years in a row."

Dom Lopez added an interception for Edison, which was tied 13-13 going into the fourth quarter.

That was when things started to shift in the Chargers' favor. First, Awad hit York on a 58-yard bomb that allowed Edison to retake the lead with 7:19 remaining. On the ensuing Lutheran pos-Orange session, Hogue made a diving interception over the middle, giving Edison possession at the Lancers 38yard line.

He said Edison running

coordinator Mike Walters, who sees Hogue on both sides of the ball, asked him if he wanted a breather.

"I was like, 'No, coach, not right now. I'm fired Hogue said with a up," smile after the game. "You've got to try to stay on the field as much as you can."

Hogue then finished off a short, four-play drive with a two-yard touchdown run, giving Edison a 27-13 lead.

Orange Lutheran drove into the Edison red zone, but Dylan Walters jumped a route to the right. He returned it 60 yards all the way to the Lancers 25-yard line.

Five plays later, Hogue scored on a seven-yard touchdown run.

"He's doing a great job, and he's playing almost every snap, both sides of the football," Grady said. "Troy [Fletcher] did the same thing last year."

Logan Gregory, Noah Thompson and Jake Giles added quarterback sacks for Edison.

The Chargers will try to keep their momentum going next week, when they host Palos Verdes (1-2) on Thursday night.

"The way we played today, it showed a lot," Hogue said. "O-Lu is no joke. They're a Trinity League team and they play against Mater Dei, JSerra, [St. John] Bosco, Servite. They're legit, so this team. I feel really confident that we'll go very deep into the playoffs and have a chance of winning CIE'

And the men's and women's tournaments will award \$24,000 in prize money — up 30% from last year — to those participants.

"We're pretty proud,' Morgan said. "We have a monster main draw. It looks like the much larger Manhattan Beach Open that was two weeks ago."

Four teams in each gender will qualify Friday for the 16-team main draw, which begins Saturday morning in a doubleelimination format. Beach volleyball legends Randy Stoklos and Laguna Beach native Dain Blanton will be announcing the action.

The top two teams in each gender will receive wild-card bids into the AVP Tour Huntington Beach Open event in November.

Among the men's teams scheduled to compete in Laguna are Trevor Crabb and Tri Bourne, who won the Manhattan Beach Open last month. Another top team in the draw features Trevor's younger brother, Taylor Crabb, and Taylor Sander.

Taylor Crabb was selected as a Tokyo Olympian in beach volleyball last summer, but was replaced by Bourne due to a positive COVID-19 test. Bourne and partner Jake Gibb went on to advance to the Olympics round of 16 before being eliminated.

Avery Drost and Chase Frishman is another Southern California team that looks to win at Laguna. Drost and Frishman already have a pair of second-place finishes together on the AVP Tour this summer, at the Atlantic City and Virginia Beach stops.

The Laguna Open is a city tournament, but run in partnership with the AVP and California Beach Volleyball Assn.

On the women's side, Morgan said top players scheduled to compete include Sarah Pavan, who won the 2019 World Championships with her partner Melissa Humana-Paredes. Geena Urango and Savvy Simo, former standouts at USC and UCLA respectively, will also be players to watch, as will Hermosa Beach native Carly Wopat.

The local "Battle of the Beaches" competition will also return for a third year. The competition pits the four iconic volleyball beaches of Laguna against each other in a four-person battle, and Victoria Beach will defend its title against Three Arch Bay, Emerald Bay and Main Beach.

Overall, Morgan said tournament staff works hard to keep the feel of the Laguna Open as an oldschool beach volleyball tournament, which the players appreciate.

"It's much more intimate than any of the other tournaments," he said. "People can almost sit with their feet right on the court, and that's a big thing from the old days. They would have people crowded around the courts, literally almost all the way up to the boundary lines. Nowadays, they're pushed way back and they're seated way up high in grandstands and everything.

"Our beach is so small that we're kind of forced to keep it intimate, but we like it that way, and the players love it because there's this instantaneous feel of feedback."
