# Assault victim leaves hospital for CdM home

Todd Miller says he doesn't recall much if anything about what happened to him at Crystal Cove State Park. **BY LILLY NGUYEN** 

Todd Miller doesn't really know how it happened.

Miller, a 69-year-old retired periodontist from Corona del Mar, was on a training hike Monday morning when he was assaulted by a stranger, according to Newport Beach police.

An avid hiker, Miller said he typically prefers to hike in the hills up and around Crystal Cove State Park, but had opted for a different path that morning because of the rains expected to sweep through Orange County later in the day.

"So, I decided to walk from my home to San Joaquin Road, up to the upper part of Crystal Cove State Park near Newport Coast," he said in an interview with the Daily Pilot on Thursday. "Then, I hopped on a trail that took me all the way down to [Pacific Coast Highway]. There's another trail that goes along the bluffs of Crystal Cove and I was taking that home. I was maybe 10 or 11 miles into my walk, but I can't remember if I got back onto PCH or if I fell right on the very end of the trail before it."

What he does remember clearly is waking up in Hoag Hospital, where he remained for about two days. Miller was re-

In the moments before two police chaplains would be recognized for more than three decades of service, Fountain Valley Mayor Glenn Grandis asked one of them if they would deliver the invocation before the City Council meeting on Tuesday night.

Tom Borgquist stepped in and did the honors, expressing gratitude for the growth of the community and for the protection provided by the police department.

The prayer to open the meeting directly preceded a presentation of proclamations to Borgquist of the Church of Jesus Christ of Latter-day Saints and Father Wayne Wilson of Saint Barnabas Orthodox Church, both of whom have retired after 31 years as police chaplains.

"Thank you for stepping up and doing the invocation," Grandis told Borgquist before reading the

## Woman suspected of ramming stolen car into police vehicles in Costa Mesa arrested

A 29-year-old woman was arrested Wednesday after allegedly ramming a stolen car into two law enforcement vehicles in Costa Mesa during an episode that also led to a separate collision involving a police sergeant, officials reported.

Destiny Hope Sherer, of Huntington Beach, was detained and booked on suspicion of assault with a deadly weapon and vehicle theft, after being located in the same Target shopping complex on Harbor Boulevard where she'd abandoned the vehicle, Costa Mesa Police Department reported.

Department spokeswoman Roxi Fyad said Thursday the station received a call at 12:45 p.m. indicating a suspect driving a stolen Audi wagon had crashed the vehicle into police vehicles and fled the scene. The driver was said to be located on the 3200 block of Harbor Boulevard.

A Costa Mesa Traffic Safety Bureau sergeant on motorcycle was the first to arrive at the scene but was involved in a crash with another vehicle near the intersection of Harbor Boulevard and Nutmeg Place, Fyad said. He received minor injuries in that incident, which is being investigated separately by the California Highway Patrol.

Other responding officers located the abandoned Audi at Costa Mesa Shopping Square, where the Target is located, and set up a perimeter in an attempt to find the driver. They eventually narrowed their search to a store, where Sherer was located and arrested without incident.

An online inmate locator maintained by the Orange County Sheriff's Department indicated Sherer was in custody Thursday and scheduled to appear in court Friday.

Orange County Superior Court records show Sherer was previously charged in July 2023 on one felony count of the unlawful taking of a vehicle, along with misdemeanor charges related to possessing a controlled substance for sale and possession of drug paraphernalia. Records also show other misdemeanor incidents involving drug possession and providing false evidence to police later in 2023.

a major cause for concern, though he noted he'd been told to keep a look out to make sure no clear fluid ran from his nose or ears, which he was told could be a sign of a cerebrospinal fluid leak.

Miller's been piecing together what happened through posts on Nextdoor, the hiking app that he uses to track his progress, as well as what he's heard from police.

His tracking app said he appeared to have reached Pacific Coast Highway, where he was found by

Newport Beach police at 12:09 p.m., near Camino Shores Road. Authorities said the assailant appeared to have struck Miller from behind, though Miller thinks he may have gotten struck in his face at least once after he fell.

Video evidence of the incident was collected, but the Newport Beach Police Department said it will not release it.

It was not immediately clear what provoked the incident, according to Newport Beach Police Sgt. Steve Oberon.

The suspect arrested in the incident has been identified as Steven Soliz, 31. Court records indicate

he has pleaded not guilty to all charges, which include resisting police officers, battery against an unspecified person, assault on a custodial officer, assault on a peace officer, resisting an executive officer, resisting a peace office and battery. He remains in custody and is next expected to appear in court on Feb. 29.

The Newport Beach Police Department declined to publicly name Miller as the victim in the case.

Miller said that he's seen Soliz's picture, but does not recognize him and believes this to be a truly random incident. He said he's since reached out to some of the

people who have commented on the Nextdoor app, as they were the first to come and help him.

"I'm going to hopefully meet with them in a week or two after I've recovered a bit to thank them personally and to find out exactly what they saw," he said. "It doesn't sound like they witnessed the assault directly, but I think they were there about a minute or so after it happened because they saw the guy running.

"I just feel like I was in a fight and like I've been beat up."
