Canoes take to the harbor

The three-part Va'a California Series, which had its inaugural race in February, is held by the Newport Aquatic Center.

Though no sunshine peeked through the clouds, and the fog rolled in, paddlers from all over the world climbed into their canoes early Saturday morning and hit the waters of Newport Harbor for the second in a threepart race series.

The series, which had its inaugural race in February, is held by the Newport Aquatic Center in Newport Beach. The Va'a California Series challenges outrigger paddlers of V1 canoes, which are rudderless and lack conventional foot pedals, to navigate waters with their paddles alone. The sport comes from Hawaii and other parts of Polynesia but made its way to California in 1959.

"It's a small world, but once you get into it;

County supes respond to winter storms

Declaration of a state of emergency opens the possibility for county to tap into state funds for storm cleanup efforts.

The ground continues to shift near the site of a landslide that consumed the backyard of a home in Dover Shores, prompting the Orange County Board of Supervisors to declare a state of emergency Tuesday with more rain forecast in the region through Wednesday.

On March 1, Gov. Gavin Newsom had announced a state of emergency in 13 counties battered by deadly winter weather. That made relief funds available to impacted communities. However, Orange County was not initially included among those eligible for aid.

The supervisors' declaration opens the possibility for the county to tap into those funds for storm-response efforts.

Winter storms have caused \$1.6 million in damage to Seal Beach Pier and destroyed a lifeguard tower in Laguna Beach worth around \$96,000, representatives for Orange County Supervisor Katrina Foley wrote in a statement. The backyard of a Dover Shores home fell into upper Newport Bay days after rain had soaked the bluff in Newport Beach.

"My hope is that there is no further sliding on the shore, but if these three homes fall, a cascading effect may happen to the 50 other homes on the bluff and we must be prepared in case that happens," Foley said in a state-

So far, the landslide appears to have been a "localized issue," Newport Beach spokesman John Pope said Tuesday. However, geologists continue to monitor the situation, and the ground di-

Sex offender charged in attacks during break-in pleads not guilty

A registered sex offender recently arrested on suspicion of attacking two women during a Newport Beach burglary pleaded not guilty Monday to a range of felony charges stemming from the March 4 incident.

Navdeep Singh Jhaj, 32, of Orange, was charged Thursday with two counts of assault with the intent to commit a sexual offense in a first-degree burglary, one count of sexual penetration of an unconscious victim and failing to notify law enforcement within five days of a change of address,

according to court documents. He was taken into custody by Newport Beach police on Thursday, according to City News Service, and an online prison inmate locator maintained by the sheriff's department indicated he was next scheduled to appear court in Newport Beach on March 21.

Jhaj has been listed on the Megan's Law database of registered sex offenders since 2018, where his risk of reoffense is placed as "above average." Court records show he pleaded guilty in 2017 to one count of felony

sexual battery, following an incident on Oct. 4, 2015, and was sentenced to one year in jail and

five years probation. CNS reported that, as part of a plea deal, additional counts of sexual penetration by a foreign object and force and sexual penetration by foreign object under the belief the perpetrator is another person, along with a misdemeanor charge of touching an intimate part of another person, were dismissed.

O.C. personnel must scrub TikTok from devices under new ban

Citing heightened concerns about online security and data collection, the Orange County Board of Supervisors declared Tuesday county employees will no longer be able to download, view or use the social media platform TikTok on governmentissued devices.

Panelists unanimously approved the ban, proposed jointly by Vice Chair Andrew Do and Sheriff Don Barnes as a means of mitigating security risks associated with the online app.

A similar prohibition was applied at the federal level last month, following guidance provided by a "No TikTok on Government Devices Act," passed by Congress in December.

"The particular platform Tik-Tok has vulnerabilities that exist within it, and those vulnerabilities can be exploited by the parent company in ways that put users and our national security

at risk," Barnes said in an interview Tuesday.

Barnes explained how the app's owner, ByteDance Ltd. collects users' personal data, building profiles based on an individual's viewing history, habits and even geographic locations and may tailor or manipulate the content that person sees - a potentially troubling trend, he said, given the company's rela-

it really opens up," Kelly Schwartz, race director and outrigger coach over at the Newport Aquatic Center, said, with a laugh. "Where has this been all my life? We've got hundreds of paddlers in SoCal. Here in Newport Harbor alone, we've got three or four outrigger clubs.'

That includes the center's own club, which also races internationally.

Schwartz said outrigger canoes require a different kind of training than other aquatic craft such as those used in stand-up paddling or kayaking.

Saturday's race brought more than 50 individual racers. Four of the participants Saturday came from Tahiti, one from Hawaii, three or four from the East Coast, one from Texas and a handful of others from the Pacific Northwest,

Schwartz said. Included was Redondo paddler Danny Ching, who has gained a reputation for both standup paddling and outrigger paddling, and Schwartz considers to be probably the No. 1 paddler in California.

Ching came in first place on Saturday, just one second ahead of Tahitian paddler Hititua Taerea, with a time of 1 hour, 36 minutes and 54.92 seconds. The two were followed by Newport Beach locals Will Reichenstein and Brent Campbell.

The race was initially meant to extend between the Newport Aquatic Center on Whitecliffs Drive to Newport Pier — a roughly 14-mile stretch of water but weather conditions

forced Schwartz and the center to change course.

"We had to pivot pretty hard because no one could go outside because the fog was too thick," Schwartz said. "As a race director and the race committee, we couldn't safely put people out there. We had to shift the course to all inside of Newport Harbor."

The race Saturday instead was roughly 13 miles and took paddlers from the center to the harbor mouth, through the harmain channel, around Lido Isle twice, and back.

The third race in the series is scheduled for April 29. The outcome of that event will determine who comes out as champion of the Va'a California Series, which is determined through points that are accumulated based off of

race rankings. First place in Saturday's race won 25 points, while second earned 18 points and third was given 15. It continues down to 10th place, which is awarded a

single point. This was true of the first race too, though it had an added sprint section that awarded some additional

points. Schwartz said Monday she was in the midst of updating participant standings but noted that Ching would not be able to make the third race, which opens up the possibility for Reichenstein and Campbell to take his place if either comes in first in the next race.

Still, that doesn't mean that the third competition won't see potential upsets from other paddlers who may have traveled from afar to participate.

The race Saturday was a qualifying event for the International Va'a Federaworld distance tion's championships that will be held in Samoa in August.

"We're the first place to have a V1, rudderless-only race on the mainland [United States]. Hawaii has races that they do, but we're the first ones to have the series here," Schwartz

rectly beneath the destroyed home and those directly adjacent to it is still shifting.

Crews have drilled eight 20-foot deep wells to pump out groundwater, Pope said. They hope that will somewhat stabilize the soil by "desaturating the hill from the inside, Pope said.

In the meantime, city officials have been "meeting regularly with the homeowners to discuss options," Pope said.

The latest bout of precipitation to fall on Orange County was expected to peak overnight Tuesday and taper off by this evening. With between 2.5 and 3.5 inches of rain expected during that period, meteorologists advised people to be prepared for flooded streets, wet roads and other hazards.

Newport Beach location among those closed as Signature Bank shut down

The Newport Beach location of Signature Bank was closed over the weekend, following the New York-based bank's overall closure by the New York State Department of Financial Services on Sun-

The commercial bank had about 40 branches, including the one in Newport Beach, and about \$110.4 billion in assets and \$88.6 billion in deposits as of December 2022, according to the Federal Deposit Insurance Corp.

All deposits and assets of Signature Bank were transferred to Signature Bridge Bank, N.A., which will functionally operate as a full-service bank under the FDIC as it markets the institution to potential bid-

Service is expected to remain uninterrupted and customers should be able to continue to access their funds and make loan payments as needed, the federal officials stated.

The transfers were completed under a "systemic risk exemption," which allows for regulators to backstop deposits too large to qualify for federal insurance.

No phone number was listed for the Newport Beach operations of Signature Bank on Bayview Circle on the company's website and other attempts to call lines associated with that location were disconnected as of Tuesday after-

website this week was an announcement of the opening of a bridge bank and new chief executive officer Greg Carmichael, noting that no deposits were at risk due federal intervention, saying, "We want you to know that you are a valued client, we appreciate your business, and look forward to continue serving you.'

According to a joint statement issued Sunday by the Federal Reserve, FDIC and Secretary of the Treasury Janet Yellen, officials said, "We are taking decisive actions to protect the U.S. economy by strengthening public confidence in our banking system. This step will ensure that the U.S. banking system continues to perform its vital roles of protecting deposits and providing access to credit to households and businesses in a manner that promotes strong and sustainable economic growth."

In that statement, federal officials acknowledged the closure of Signature Bank by the state department, adding that it would be completing resolution on Silicon Valley Bank, another commercial bank based

in Santa Clara, on the recommendation of the FDIC and Federal Reserve boards. SVB's collapse is considered the biggest bank failure since 2008.

All depositors will be made whole, according to the department, and no losses will be borne of the taxpayers for either bank.

The U.S. banking system remains resilient and on a solid foundation, in large part due to reforms that were made after the financial crisis that ensured better safeguards for the banking industry," the joint statement said. "Those reforms combined with today's actions demonstrate our commitment to take the necessary steps to ensure that depositors' savings remain safe."

President Joe Biden offered remarks on the matter Monday, remarking that the closures of both banks did not promise the arrival, or rather return, of the recession, and blamed the bank collapses on actions taken by former President Donald Trump's administration to loosen banking rules.

"You have a swing that you keep your left foot pretty flat, you have a big shoulder turn," Beyer told Couples. "That's asking one's back to do lots of things that it wasn't designed to do, to repetitively go out there and just bang golf balls for 40-something vears. ... I'm very comfortable in saying you probably would have had twice the number of wins that you had on the two tours if it wasn't for your back. You

missed a lot of tournaments, you had to withdraw from tournaments because of back issues. You missed this tournament, I remember, a couple of times because of back issues, but you've not succumbed to the menace of back surgery.

"... It took time away from the course, it took time away from practice, it took time away from your vocation, but you were resolute in your desire not to have surgery on your back, which quite frankly, I commend. ... I always say that the indication for the second back surgery is the first back surgery.'

A back injury played the culprit in Couples missing the last Hoag Classic, but the fan favorite feels ready to go to take on a redesigned Newport Beach course that was lengthened by 203 yards and added several sand bunkers and trees.

"As we knock on wood today, it's been a year," Couples said. "I've been doing really well. I did win at the end of last year, and I feel like I'm playing well enough."

tionship with the Chinese

government. "We have recognized the inherent risk of the way the TikTok social media platform operates and how [its] content can be misused by the parent company or the Chinese Communist Party against the best intentions of the American people," Barnes said.

Tuesday's decision amends the county's current information technology and social media use policies to apply the prohibition to company cellphones, laptops and desktop computers used by more than 18,000 Orange County employees, except as necessary for law enforcement purposes. IT practices employed at

the sheriff's department allow for the blocking of new uploads, although it is unclear whether devices on which TikTok has already been installed will be automatically disabled following the policy shift.

Do, who was unable to vote on the proposed amendment Tuesday, due to illness, issued a joint statement with Barnes in which he described the move as an important step in securing county data and information from potential hacking by the Chinese government.

"We are taking proactive steps to ensure the County of Orange is following best security practices to protect our county and the residents we serve," stated Do, who represents District

The statement described how China's government, under the guise of national security, could legally force domestic companies like ByteDance to hand over private user data to authorities without a warrant. That information could then be used "to identify, arrest and persecute political opponents, religious groups, ethnic minorities and social activists."

Supervisor Katrina Foley, whose 5th District includes Costa Mesa, Newport Beach and Laguna Beach, said Tuesday officials have become increasingly aware of the risks platforms like TikTok present for government agencies.

"There's a growing concern by our national security adviser about the threat that data is being collected about individuals living in America and is possibly being used by the Chinese government," she said. "[And here], every department uses social media to share information with the public. In this day and age, it's better to err on the side of caution."

Barnes said while the ban approved Tuesday impacts only devices owned and operated by the county, he hopes to spread a wider awareness among residents of the need to be careful about their private data and social media use.

"I also encourage the public, particularly parents, to consider the potential for compromised data and negative influence on users and take action to secure your personal devices," he said.

Marina sees run to state finals' end with loss to Bret Harte

SACRAMENTO - Marina High girls' basketball coach Daniel Roussel bore witness to the type of program growth that comes from issuing a challenge and it being accepted.

Marked improvement gave the Vikings a season, and an ending, to write home about, even if it was a bittersweet one.

The Vikings fell to Angels Camp Bret Harte 62-39 in the CIF State Division V final Saturday at the Golden 1 Center, capping an exciting and unexpected run for the self-proclaimed "underdog" squad from Huntington Beach.

"We challenged the girls in the offseason to work really hard," Roussel said. "They accepted the challenge, and we spent a lot of time in the weight room, a lot of time in the gym. We definitely improved.

Marina had 10 seniors on the roster, eight of which had spent four years in the program. Over the past three seasons, the Vikings had gone 17-59 with one playoff appearance, a 43point first-round loss in the Southern Section Division 3A playoffs against eventual champion Long Beach Wilson in 2020.

'We brought them in as freshmen from tryouts," Roussel said. "These are a lot of girls that really didn't have a lot of basketball experience coming into high school. Our coaching staff, over the last four years now, has worked extremely hard with these girls to build skills, to build confidence.

"They're great people. These are all great students in the classroom. I think our grade-point average is somewhere around 4.0. As a team, we represent Marina well, in the classroom, in the community and on the court."

Freshman guard Rylee Bradley scored a game-high 23 points for Marina (21-16), with 16 of those points coming after halftime.

"I just adjusted to the situation, and I feel like I played better in the second half," said Bradley, who admitted to fighting some nerves in the state finals environment.

The Vikings faced a severe rebounding disadvantage, with the Bullfrogs winning that battle 47-30. Ariah Fox, the leading scorer for Bret Harte (26-7), also led her team in that category. She finished with 22 points, 15 rebounds, five steals,

four assists and two blocked shots.

exclaimed "No," Fox when asked if she had allowed herself to think about a state title at any point this season. "That was not a thought in my mind. Not to be like 'Debbie Downer,' but I was not really thinking during [Mother Lode that we [play] League would be at this point."

Makenna Tutthill scored 10 points to go with six rebounds and three blocks for Bret Harte. Chase Silva had nine points and seven rebounds. Kadyn Rolleri, another key playmaker for the Bullfrogs, supplied six points, six rebounds, four assists and four steals.

"I hope the town don't burn down," said Bret Harte coach Jeff Eltringham, who returned to his alma mater and won a state title in his first season in charge. "... This is pretty special for our town. We don't do stuff like this very often.'

Marina started slow, falling behind 12-1 before Bradley made a floater on the run for the Vikings' first field goal almost five minutes into the game. Tiana To's steal and layup, aided by the perimeter defense of Maria Tejeda, cut the deficit to two possessions at 23-17 with 3:35 on the clock in the second quarter.

Bret Harte went on a 9-3 run to end the half, jumping out to a 32-20 lead at the break.

Bradley rattled in another tough runner to answer a

buzzer-beating bank shot by Fox with six minutes left. That made it 48-34 in favor of Bret Harte. At one point, Bradley had scored 19 of the last 21 points for Marina, but not before the Bullfrogs had extended their lead to 54-34 with 4:46 remaining.

To finished with 10 points, five rebounds and two assists. Tejeda scored four points, and Sydnie Smith had two steals.

"It's definitely another experience for us, another opportunity to bond as a team," To said. "I think that we prepared for this game, but obviously, it didn't come out the way we would have hoped to end our season. I'm very proud of us."

Roussel said the Vikings set a few goals for this season. Marina accomplished one in beating Huntington Beach for the first time since 2006. The Vikings beat the Oilers twice, which helped them meet their last goal of making the section playoffs. Marina had won 10 of 11 games entering the state championship game.

"It wasn't necessarily to win [the Wave] League, although we thought that was a possibility," Roussel said. "It was to make the playoffs, and we told them all season that if we could get to the playoffs in Division 5 that we had a chance to make a run and win some games, and that proved to be true.'



Pacifica Christian denied by San Joaquin Memorial in CIF State Division II title game

SACRAMENTO — The Pacifica Christian Orange County High boys' basketball team had a season to remember, by any metric.

The Tritons won their first outright league title. They were ranked No. 1 in Orange County for the first time. And the season culminated in their first CIF State championship game appearance.

But it was more about the hugs and high-fives along the way. Coach Jeff Berokoff, who has led the program since its first varsity season began in 2016, wasn't talking about strictly talent when he called this the greatest group he's ever been around.

That remained true, even after Pacifica Christian lost 58-47 to Fresno San Joaquin Memorial in the CIF State Division II title game Saturday at Golden 1 Center in

"These guys are more than just basketball players," Berokoff said. "They're just good, good young men, and they're going to make everything around them better with more positivity, regardless of wins or losses. I'm better because of them. I just hope they're better because of me."

Pacifica Christian (27-10) had that underdog mindset, and few people actually seemed to believe besides the Triton faithful. After senior standout Parker Strauss was injured during the team's run to the CIF Southern Section Division 2A semifinals, Pacifica Christian was seeded just No. 9 in the Southern California Regional Division II playoffs.

In five state playoff games, the Tritons had just one home game. And so they became road warriors. Their motto — "just us" — became a reality.

"I'm going to remember my teammate next to me," senior Tanner "Sarge" Deal said. "We were always the underdogs, and we've always fought back. I think we're the toughest team in California, and I'm just going to miss them. I just want one more practice, one more game, one more eating out together. I'm going to

really miss them."

Deal, Strauss and sophomore guard EJ Spillman each scored 11 points to lead the Tritons in the state championship game against San Joaquin Memorial (26-9).

San Joaquin Memorial, which won its first state title in program history, was led by its two senior standouts, 6-foot-7 forward Mike

Davis Jr. (17 points and 14 rebounds) and guard Armari Carraway (13 points).

After a first half that had seven lead changes, Pacifica Christian took a 25-23 halftime lead. San Joaquin Memorial coach Brad Roznovsky, whose team lost to CIF State Open Division finalist Santa Maria St. Joseph's in the Central Section Division 1 quarterfinals before making its state run, joked afterward that his team set basketball back 50 years in Saturday's first half.

"I think the thing that really carried us in this game, and throughout our state run, is that we really do a good job defensively," Roznovsky said. "We stress it in practice. I think we do a pretty good job of mixing up our zone and our man, and that really kept us in the game. We were bad offensively in the first half, but we were down two [at halftime] because we really guarded.'

Pacifica Christian couldn't buy a bucket for a stretch of the second half. Senior Salim Semaan's reverse layup early in the third quarter gave the Tritons a 29-25 lead. From there, they would go more than nine minutes before their next field goal, a floater in the lane by Spillman with 4:37 left in the

San Joaquin Memorial had gone on a 24-5 run to take a doubledigit lead. "I think we missed nine 'chip-

pies' in the third and fourth quarter, but the guys were fighting on the glass," Berokoff said. "You've just got to make a few of those."

The Tritons cut their deficit to nine points a couple of times late. but couldn't get closer. After battling with a bigger team for four quarters, they took the loss hard.

Spillman, who along with Davis Jr. was honored with the CIF's "Pursuit of Victory with Honor" sportsmanship award following the game, paused for a moment in the tunnel headed to the team's post-game interviews. He was consoled by Pacifica Christian Orange County head of school David O'Neil, who wrapped his arm around Spillman's shoulder.

When the team got to the interview room, the Northwestern University-bound Strauss was asked how it felt to play at the home of the NBA's Sacramento Kings in his final high school game.

Through a tear-soaked face, he answered confidently.

"We loved it," Strauss said. "It was one more team trip.'
