## Hospital gives teen a chance to give back

Charles Bertocchini is a breath of fresh air each Wednesday afternoon at the City of Hope's Huntington Beach location.

The 17-year-old Coto de Caza resident does tasks like restocking the snacks in the infusion room, cleaning the chairs and changing the pillowcases. But it's the conversations he holds with patients at the cancer treatment center that mean the most to him.

'That's the best part," Bertocchini said. "Usually, it's about my experience, but sometimes it would be things in the news. Anything to get their mind off of what's happening.'

Bertocchini is a member of the City of Hope's volunteer program. An incoming senior at Santa Margarita Catholic High School, he plans to continue volunteering once school begins again, eventually shifting to the City of Hope's Lennar Foundation Cancer Center in Irvine for even more handson experience.

It's his way of giving back to the organization that has given his family, well, hope in recent years. There's a good reason he's doing this, and it's the same one that has inspired him to want to pursue a career in medicine.

### Laguna ordinance aims to set standards regarding animals

Laguna Beach has passed an ordinance making several changes to its municipal code regarding animals.

Among the changes enacted via a second reading at Tuesday night's City Council meeting was a new measurable standard for enforcement against dog barking.

Thirty minutes of incessant dog barking, or 60 minutes of intermittent barking, within a 24-hour period would now constitute a violation of the municipal code.

Jim Beres, a professional services administrator with the Laguna Beach Police Department, said the municipal code previously lacked a threshold for quantifying barking as a code violation. Beres oversees the city's animal control officers and animal shelter.

"It's been based historically on the number of complaints we've gotten, and kind of the totality of the circumstances, and what the animal services officer felt was reasonable," Beres said when the ordinance was introduced at a council meeting on

July 25. "It's led to a situation where some dog owners have felt that they've been treated differently than others.'

The dog barking standards being implemented by Laguna Beach are consistent with those put to use by the county of Orange, as well as 13 cities across the county. The same threshold is in place for Fountain Valley,

Huntington Beach and Irvine, among other county municipal-

Laguna Beach police received 222 complaints for bothersome dog barking in 2021. That same year, the department wrote 81 warnings and nine citations in response to complaints. Animal

### Newport faces another dredging lawsuit

The complaint, filed by Friends of Newport Harbor, names city and the U.S. Army Corps of Engineers as plaintiffs.

The Friends of Newport Harbor has filed another lawsuit against Newport Beach and the U.S. Army Corps of Engineers over the planned confined aquatic disposal site in Newport Harbor.

The lawsuit, filed on Aug. 2 in Orange County Superior Court, has been assigned to Judge Peter Wilson. The complaint aims to enjoin city funding to construct and operate the confined aquatic disposal unit in lower Newport Harbor, where sediment unsafe for open ocean release would be stored.

Discussions on building the CAD date back to 2019 when mercury-tainted sediment was discovered in the turning basin and Lido Peninsula. Dredging needs to occur regularly in Newport Harbor to ensure safe navigation, with the U.S. Army Corps of Engineers responsible for the federal channels within the harbor.

Environmental groups, including the Friends of Newport Harbor, have long contended that the creation of the CAD is unsafe and have filed litigation against both the federal agency and the city in an effort to stay the project. The Friends of Newport Harbor alone has filed three separate lawsuits over the matter prior. Two of those suits remain active, while a third, filed over the Freedom of Information Act, has been

### Scout wins scholarship with heritage project

Katelyn Saiki grew up hearing stories about Cambodia from her grandparents.

The lessons she learned have paid off: Saiki recently found out she won a \$10,000 scholarship after attaining the Girl Scout's highest achievement, the Gold Award, thanks not only to her book on Cambodian folklore but the establishment of her nonprofit, Cambodian Revival of Arts, Folklore, and Traditions.

The Khmer Rouge was the communist regime that led to the genocide of the Cambodian peoples under the direction of the Communist Party of Kampuchea general secretary Pol Pot. The genocide led to the death of nearly a quarter of the country's population in the late 1970s. It is estimated nearly 2 million people lost their lives in the atrocity.

"My grandfather ... is the sole survivor of his family of the [Khmer Rouge] genocide, and from him, I learned that nearly a quarter of the population died and as a result that a lot of art and history was lost to the communist regime," Saiki said.



Many professionals, including doctors, lawyers, teachers, engineers and scientists, were killed along with their extended families. Saiki's grandparents and her mother were among the thousands of refugees that fled the country in the 1980s.

"A lot of [Cambodia's] identity was being destroyed, and that's what inspired me for my Gold

Award [work] because I wanted to center my project around something that is deeply connected to me."

According to a report published by the United Nations Educational, Scientific and Cultural Organization (UNESCO) office in Phnom Penh and Cambodia's Ministry of Culture and Fine Arts in 2002 on the rehabilitation

# F.V. man gets life sentence in maritime killing in O.C.

A 42-year-old Fountain Valley man was sentenced Monday to life in federal prison for killing a friend who owed him between \$30,000 and \$40,000 — on a lobster fishing boat off the shores of Dana Point Har-

Hoang "Wayne" Xuan Le was convicted Dec. 10, 2021, of first-degree murder, conspiracy to commit murder and using a firearm to com-

mit a crime of violence. He pleaded guilty in February 2022 to eight drug charges, including dealing cocaine and methamphetamine.

Co-defendant Sheila Marie Ritze, 43, of San Juan Capistrano, was convicted in April of last year for her part in the killing of 44-year-old Tri "James" Dao on Oct. 14, 2019. She was sentenced in April of this year to 21 years and 10 months

in federal prison. The victim's mother, Anh Tran, said in a victim impact statement to U.S. District Judge David O. Carter that she would "never be able to over get this nightmare and every day is a tearful reminder that I will never see my son again, and his daughters will grow up not knowing their fa-

To Le, she noted that the defendant was a friend of

One of the suits was filed in federal court in April of this year, accusing violations of the National Environmental Policy Act and the Administrative Procedure Act, and another was filed in November in Orange County Superior Court.

As of June this year, the dredging for the CAD and its construction have been halted in agreement with OC Coastkeeper as the Corps "considers revisiting its National Environmental Policy Act (NEPA) analyses and Endangered Species Act (ESA) analyses, including whether consultation under the ESA is appropriate," according to court documents. City spokesman John

Pope confirmed Tuesday that both the dredging which has been partially completed — and the CAD remain on hold.

Dredged material from the partial dredge earlier this year was placed at Port of Long Beach's Middle Harbor Fill Site.

The new lawsuit alleges that in February of this year the city approved a second memorandum of understanding that it would "fund a bigger CAD than the CAD it had approved in 2021 as well as additional dredging," though documents from that meeting indicate that no additional funding would be approved by the city as the \$10 milalready promised

toward the project would cover additional dredging. The memorandum also gave City Manager Grace

Leung the discretion to execute any other agreements with regard to the dredging or CAD project. The U.S. Army Corps of Engineers said the addi-

tional memorandum was necessary for the materials dredged that are technically below federal channel limits within the footprint of the proposed disposal site.

By authorizing the use of its public funds by the Corps for additional dredging is "different, bigger, and more environmentally adverse than the CAD initially presented to the public and approved in 2021," attorneys for Friends of Newport

"You often spent time together with my son's two young daughters. They called you uncle and thought of you as family,' Tran said. "How could you so mercilessly and violently murder him like this? It was incredibly heartbreaking and agonizing to sit in court every single day for months and see and hear all the gruesome details of this case. You lured my son by taking him on what he thought was a fishing trip, then you shot him and brutalized him with metal hooks, and left him to drown a slow, painful death in the darkness of the cold ocean.'

Tran added that Le never felt any pangs of conscience and "you continued to enjoy your life, brag about being a hitman and tried to intimidate his family by tracking them. You have not only killed him, but you have destroyed his family and ruined all our lives.'

Tran said Le is "an evil and cruel demon who belongs in hell so that you can repent and pay for your sins. You deserve a life in prison so that you cannot inflict harm and commit against anyone crimes

Prosecutors said in court papers that Le "has left a grieving mother, grieving widow, grieving brothers, a grieving sister and two fatherless small children ... The nature and circumstance of the offense are horrific: shooting and beating up a defenseless man, then leaving him brutally beaten and shot, in the middle of the ocean, 3 miles from shore, in the dead of night."

Le invited Dao to go fishing with Ritze on her boat for lobsters late at night in the waters off Dana Point Harbor, Assistant U.S. Atty. Gregory Scally said during Le's trial. It wasn't the usual time for fishing, and they ventured a little more than 3 miles offshore, another unusual move because the usual fishing spot near the jetty was a lot further inland, he added.

Dao was not dead when he was dumped overboard because the autopsy showed the cause of death was drowning. Beating, shooting and then leaving the victim so far from shore shows they intended to kill Dao, Scally argued. "This is no accident."

A little more than a week before the killing, the three went with other friends on a road trip to Las Vegas to see a Billy Idol concert, where Le spoke with Ritze about using her boat to "off" the victim, Scally the victim, Scally said.

Le's buddy Shawn Whalin also testified that the defendant told him he planned to "take out" the victim. Le also asked Whalin to help him kill Dao, but Whalin refused.

Le also told Whalin he intended to collect on the victim's life insurance policy to settle the debt and showed his pal a .38-caliber gun.

After the killing, Le told Whalin "I took care of it," referring to the victim's death. Another friend heard Le talk about killing Dao, but the friend did not come forward to authorities because he thought Le was just bragging.

Scally also referred to text message discussions he had with Nguyen and others about collecting on Dao's debt.

Le testified he acted in self-defense, but Scally said that claim contradicted the testimony of so many other witnesses in the trial. Dao's gunshot wound to the back puts the lie to the claim, Scally argued.

"You might begin and end your analysis of selfdefense with fact,"Scally said. "If James Dao shot himself, he's quite the contortionist."

Le testified he slugged Dao with a stick a couple of times, and the gun went off, but Scally counted up to nine wounds on the victim's head in the autopsy photo.

Le also testified that he thought the victim could swim back to shore, but Scally said that distance was further than even an Ironman competition.

health officer, in the statement.


"As people spend more time gathering with friends, there will be more opportunities for viruses to spread. If we all take precautions, we can keep each other safe," Chinsio-Kwong said.

Penh to try to survive in a countryside they barely understood," the report continued. "Most of them didn't return, dying either of illness or starvation, or often murder as a direct result of their skills and links, as the Khmer Rouge saw it, to a decadent class and roy-

Saiki said part of the inspiration for her project came from a 2018 trip she took to Cambodia with her family, visiting the village that her grandparents and mother were from.

"I was immersing myself in the community, saw the schools and hospitals that my grandparents helped with to give back, but when I visited the schools, I saw they weren't really appreciating their own heritage. No art was really offered compared to other subjects amidst Cambodia's reconstruction," Saiki said. "So, when I returned to America, I wanted to help preserve this folklore. I'm from a family of artists and storytellers, and I was always taught to take pride in my Cambodian culture.'

For her book, "Khmerical: A Collection of Cambodian Folktales," which she wrote and illustrated. Saiki

recounted three Cambodian folktales that her grandfather dictated and verified with teachers in the country to ensure its accuracy. It was her hope, she said, that she would be able to spread more Cambodian culture though it, but she encountered roadblocks in terms of credibility with libraries.

That's where the nonprofit came in, she said. Once that was formed, it helped her create a platform for herself and lend credibility to the book. She said she was then able to partner with several libraries and elementary schools, including the Mark Twain Neighborhood Library and the Michelle Obama Neighborhood Library in Long Beach.

Long Beach is home to ne largest Cambodian population outside of Cambodia.

"I feel that Cambodian voices are very underrepresented in the media. When you think of Asian culture. Cambodians aren't the first to come to mind. We aren't really a part of the multicultural conversation, but I want to expose people to our culture," Saiki said. "People still need to know about Cambodia's history heritage, and most people know the dark and sad parts of our history, but I wanted to shed light on

the beautiful parts too. It's my way of saying that after the [Khmer Rouge] genocide that we're still here. We still know who we are, and we take pride in our identity."

She said she found out that she was a finalist in early June for the Gold Award, and that it was official that she was the winner by late June. Saiki is heading to USC this fall to study business administration and narrative studies, both fields of study that she feels working on her award project guided her toward.

'Girl Scouts of Orange County is incredibly proud of Katelyn. The mission of Girl Scouts is to build girls of courage, confidence, and character, who make the world a better place, and Katelyn exemplifies that. Her Gold Award project has impact and sustainability. It stretches 8,000 miles to Cambodia," Vikki Shepp, Girl Scouts of Orange County's chief executive officer, said in a statement. "It builds community, and shows Girl Scouts have the power to change the world."

Saiki is one of 110 who are part of the 2023 Gold Award Girl Scouts class in the county.

Harbor wrote. ... service officers have issued 23 warnings but have yet to write a citation related to the issue this year, Beres added.

With a specific amount of time attached to code violations, the burden of proof for a dog barking violation would fall on the complaining party. That was cause for concern for resident Penelope Milne, an animal behavior consultant who suggested that animal control could be a fair and impartial arbiter.

"If we're looking at intermittent barking for 60 minutes within 24 hours, that is a lot of logging for the neighbor to do, and we would be depending on an irritated neighbor to be fair and accurate," Milne said. "There aren't too many other things in the city where our evidence base is irritated next-door neighbor without any kind of cross check?

Beres reckoned at the initial hearing on the item that tightening up the definition of a code violation would lead to fewer infractions because it would hold complaints to an objective standard.

Michael Obrand, a South Laguna resident, in a written communication to the council said that two complaints to the city resulted in a reduction of barking from a neighboring home. He argued that the changes to the city's animal code would be more permissive for irresponsible dog own-

"I got to tell you, I was very pleased to hear that the city is going to provide additional mental health services, because if you pass this ordinance as it's written, we're going to need that," Obrand said at the second reading. "I really want you to think about the impact of what you were about to pass here. You're talking about 30 minutes of incessant barking over a 24hour period.

"I'm not anti-dog. I'm anti-inconsiderate owners. In fact, I don't think I've ever heard a dog bark without stopping for 30 minutes. Dogs bark and bark for a few seconds at a time. It may go on for hours on end, and that's what we've been dealing with."

The approved municipal code amendments prohibit tying an animal to a moving vehicle or bicycle, including e-bikes. It also outlined the process for declaring an animal to be a public nuisance, potentially dangerous or vicious. Such a designation would be determined through administrative hearing. The pet owner could appeal the decision.

In reaffirming its unanimous decision, the council also requested that city staff return with a report on implementation of the ordinance following the first six

### Los Amigos celebrates facility improvements

On the southern wall inside the Los Amigos High gymnasium, words meant to inspire and bond the campus community together are prominently displayed.

Not unlike other high schools, that includes the school's alma mater. Perhaps more fitting for the occasion on Monday would be the school motto: "siempre con dignidad," which translates to "always with dignity."

That phrase rang true for the Lobos to kick off the week, as the school celebrated the addition of a nine-lane, all-weather track and turf field on campus.

A ribbon-cutting ceremony possessed many of the elements of a pep rally. Cheerleaders welcomed attendees to the track and bleachers, accompanied by a drumline performance and an appearance from the Lobos' mascot.

Gabriela Mafi, the superintendent of the Garden Grove Unified School District, noted that such facilities upgrades were made possible with the help of Measure P, a \$311-million bond measure that voters passed in 2016.

The measure also led to the construction of new stadiums at Bolsa Grande and Garden Grove high schools.

At Los Amigos, facilities improvements include a new floor and bleachers in the gymnasium, resurfaced tennis courts, and LED lighting added to the baseball and softball fields in addition to the new track. There are also new pits for the long jump and triple jump.

"The athletic programs at Los Amigos generate school pride and enhance the high school experience for hundreds of students each year," Bob Harden, a trustee for the school district, said. "We know that having modern facili-

ties for our athletes makes a difference. The new track and field provides a remarkable setting for our athletes to compete and to win, and we know that you will give your all to both of those things."

Following the ceremony, the football program took to the field for practice. The transformation from a dirt track to the brandnew facility started at the end of the last football season.

The new field will also become the home for the school's soccer

programs, which saw measurable success in the form of a CIF Southern Section Division 5 championship for the girls in 2019, while the boys won back-to-back Garden Grove League titles.

The route to those recent accomplishments often went through the uneven grass fields in the back of the campus. Chris Sandro, the school's athletic director and the former head coach of the boys' soccer program, remains very excited about the upgrades, despite the departure

from that home-field advantage. "We did know how to play

downhill and with the wind over there at the old field, but we'll make this place our home," Sandro said. "You feel the wind ... it's always coming from the west. It's always windy this way. ... We'll get used to it."

Sandro added that the track and turf field had been installed a couple of weeks ago. He said kids were out on the field playing catch from day one.

The track and field programs

will also compete at the facility, and it will serve as a resource for conditioning workouts for others.

"We want all [Garden Grove Unified School District] students to have the best high school education, the best experience both in and outside the classroom," Harden said. "I wish we could have done this sooner. I'm glad that we're able to do it and make this available for you now."
