Banning Ranch purchase moves nearer

An \$8-million grant from the state brings the Trust for Public Land's acquisition of the land closer to reality. **BY LILLY NGUYEN**

The dream of turning a 384acre oil field at the mouth of the Santa Ana River into a public park and nature preserve grows closer to a reality by another \$8 million, thanks to a grant from the state's fish and wildlife department announced earlier this month.

The \$8-million grant for the purchase of Banning Ranch, given to the Trust for Public Land, is one of 28 projects — and one of three acquisition projects — selected to receive a grant this year. State officials say the total amount given across all projects was \$39 million.

The grant comes from the Proposition 1 Watershed Restoration Grant program, which finances projects that establish more reliable water supplies; restore species and habitats; and create more resilient, sustainably managed water systems.

The Orange County Board of Education gives ISSAC in Costa Mesa a July 7 deadline to correct indiscretions.

A Costa Mesa charter school has until July 7 to demonstrate how it will correct several operational indiscretions being investigated by county education officials as potential violations, even as the Orange County Board of Education hesitates to take punitive action.

The International School for Science and Culture (ISSAC) opened its doors to K-8 students in 2019, advertising a standardsbased curriculum focused on science, technology, reading and writing, engineering, arts and math, with multilingual offerings.

But in recent months, the Orange County Department of Education has issued multiple notices of concern to school heads, who they claim overreported their

Woman arrested on suspicion of arson in hotel room fire

A woman who is thought to have started a fire inside a Costa Mesa hotel room Sunday morning, after calling the police and threatening self-harm, was arrested on suspicion of arson and is undergoing a mental health evaluation, officials confirmed.

Costa Mesa Police Department received a call shortly after 6:15 a.m. Sunday from a hotel room on the 3100 block of Bristol Street, where a woman threatened to harm herself and start a fire, according to a release issued Sunday.

Officers arriving on scene heard a smoke alarm sounding

near the location, where the suspect had barricaded the front door, the release indicated.

After forcing entry, police located the woman and observed thick smoke and flames inside the hotel room.

The woman and other guests from nearby rooms were evacuated as responders with Costa Mesa Fire and Rescue extinguished the blaze.

CMFR spokesman Capt. Joe Noceti confirmed the incident took place on the fourth floor of the Crowne Plaza Hotel, located at 3131 Bristol St.

Second Olympics for former Edison swimmer Tom Shields

Tom Shields is heading back to the Olympic Games.

The former Edison High School and Cal swimmer qualified for his second straight Olympic team with a strong performance Saturday at the U.S. Trials in Omaha, Neb.

Shields finished second in the 100-meter butterfly final, touching in 51.19 seconds. He will race the event at the Tokyo Olympics this summer and also will swim on the 400 medley relay.

Shields finished second in the butterfly Saturday to world-record holder Caeleb Dressel, who won in 49.87. Shields' time approached his personal-best of

51.03, which he swam at the 2015 FINA World Championships.

Shields, 29, told reporters after the race that racing at the Olympic Trials is a difficult experience.

"Trials is hard, man," he said. "We train so much for mind, not result. But it's really hard here. It's not like Pac-12s or NCAAs. Trials meets are very traumatizing. And people talk about the mental health side of this, and I've started to talk about it a little more, and going through this last Trials, it's like man, maybe it's the Games experience, because there's that Olympic hangover, people fall on hard times. I know I did myself.

The Wetlands and Wildlife Care Center officials were there to release the two pelicans into the wild after each had recovered from injuries.

One of the birds had been found at Crystal Cove beach on April 26, with a low body temperature, broken and bloody feathers on its left wing and a slight wing droop. The pelican had a wound on its shoulder, believed to be an injury caused by a fishing hook. The other pelican was

found nearby on May 13 suffering from severe dehydration and hypothermia.

On Tuesday, they were ready to head back into the wild. Dozens of people gathered at the beach for the release. Laure McCubbin of Las Vegas, who happened to be visiting her parents' Crystal Cove home, brought her 9-year-old son Mark to the beach to watch. "I would say it was a

once-in-a-lifetime experience for us, especially since pelicans are my favorite birds," McCubbin said. "We wanted to come and see them.'

The center takes in basically any animal that will fit through the door, from birds to mammals to reptiles.

McGuire said about 75% of them are eventually released back into the wild.

"Our favorite days are release days," said Wetlands and Wildlife Care Center board member Kelly Kveton. "It's the day that you see after all of that hard work, they finally get to go back [into the wild]. It's wonderful."

The center's development director, Matthew Gula, said the facility handled 149 different species of animals last year and nearly 6,000 animals total.

Currently, two snakes are being cared for there, he said.

"We're seeing a lot of reptiles like that because of those electric bikes that are everywhere," Gula said. "People are moving so fast, they can't see what they pass."

Releasing two brown pelicans back into the wild is significant, especially given the current concern for the species. The Wetlands and Wildlife Care Center reported recently that it had received 22 pelicans since October with severe wing fractures that broke the skin. None of them survived.

McGuire did not want to speculate on whether one of the pelicans released Tuesday was intentionally harmed, though she said it's a possibility.

"We can't assume that these [two birds] were involved," McGuire said. "They could have been. A fishing line entanglement is a serious problem, for more things than just pelicans. [It affects] all marine life.

"It's abusive. It's atrocious, actually ... People are more aware, and we're still pushing out that we still need the public's help."

The organization is urging those who see suspicious acts against wildlife to call the CalTIP hotline at (888) 334-2258.

Kveton, a science teacher at Edison High School, said that awareness is definitely key. The brown pelican was removed from the federal endangered species list in 2009, but remains protected under the Migratory Bird Treaty Act.

'We live here and we see pelicans every day," Kveton said. "For us, they're totally normal. You forget that it's more than just our city and this population. They're birds that move. We need to remind people that they are declining and we've got to be careful."

"We are thrilled to support the acquisition of Banning Ranch, a unique opportunity years in the making," said Matt Wells, the chief of the Watershed Restoration Grants Branch for the California Department of Fish and Wildlife.

"Preserving 400 acres of true biodiversity in an urban setting, with significant acreage of tidal wetlands and coastal sage scrub, is a massive leap forward in ensuring not only critical habitat for fish and wildlife, but also much needed open space access for California's residents and visitors," Wells said.

The Trust for Public Land announced in May that it secured an exclusive agreement with the owners of Banning Ranch to purchase the land, a first in more than 50 years, after the nonprofit organization received a \$50-million donation from Newport Beach philanthropists Frank and Joann Randall in 2019.

But the fight to protect and preserve Banning Ranch from development dates back decades, according to the Banning Ranch Conservancy in Newport Beach.

In 2006, Newport Beach voters approved a ballot initiative amendment to the city's general plan to preserve Banning Ranch, consolidate the oil opera-

tions that long operated in the area and restore the wetlands.

As part of the agreement, conservationists will need to raise \$100 million by next April.

Upon purchase, the land would be conveyed to a public agency to develop and maintain it as a public park.

Several sensitive species can be found there, including peregrine falcons, California gnatcatchers and the San Diego fairy shrimp.

A spokeswoman for the Trust for Public Land said the organization has raised about \$68 million toward the \$100-million purchase price to date, with the majority of it coming from the Randalls' donation.

"We see this grant as a giant vote of confidence for the future of Banning Ranch and a recognition of its benefits to the regional community," said Guillermo Rodriguez, California state director at the Trust For Public Land in a statement.

"This grant adds \$8 million toward our goal, and we are deeply grateful to the department of fish and wildlife staff and director Chuck Bonham," Rodriguez said.

"That's a big step, but we still have a long ways to go to climb this mountain and a limited time to reach the top."

scene within minutes of being called at 6:30 a.m.

"There was no smoke showing from the exterior [of the hotel]," Noceti said Monday. "They climbed to the fourth floor through an interior stairwell and saw visible smoke in the hallway."

Upon entering the room, crew members noted heavy smoke and no visibility, the captain continued.

A smoldering fire, about 2 square feet in size, was burning on the floor of the room and was quickly put out with the aid of a fire extinguisher.

An outside company was called to ventilate the area, according to Noceti.

One person on scene was treated for minor smoke- or fire-related injuries but reports from the

anyone was transported to the hospital.

Fire damage was con-tained to a single room within the hotel.

The woman discovered inside the barricaded room was arrested on suspicion of arson, and a mental health evaluation was being conducted Monday, according to Sunday's release.

Costa Mesa police were not releasing the suspect's name or identity, pending the results of the evaluation.

Exactly how the fire was started was still being investigated Monday by Costa Mesa Fire and Rescue as a possible arson.

U.S. pulls away late to win championship

Corona del Mar High School alumna Maddie Musselman scored three goals as the U.S. women's water polo national team beat Hungary 14-8 on Saturday, in the FINA World League Super Final title match in Athens, Greece.

It is the seventh straight FINA World League Super Final Championship for Team USA, which went a perfect 6-0 in the tournament.

Hungary was within 9-8 early in the fourth quarter before Team USA scored five straight goals to close out the victory.

Team captain Maggie Steffens scored a matchhigh four goals in the final. Laguna Beach High graduate Makenzie Fischer scored twice, and Edison High alumna Alys Williams added one goal.

The Team USA roster also included Laguna Beach's Aria Fischer, CdM product Stephania Haralabidis and Newport Harbor graduate Kaleigh Gilchrist, as well as CdM girls' water polo coach Melissa Seidemann.

"Our opponent was great and we expected a tough battle," U.S. head coach Adam Krikorian said following the match. "It was a tough physical battle. [They are] well coached ... luckily we pulled away in the fourth but both teams were really tired. [Going forward] we can improve everything, we look forward to getting back to training and spending time dissecting the film and making some corrections before we get to Tokyo."

The matches in Athens were the last ones for Team USA prior to the Olympic Games, which begin on July 23 with a match against host Japan. The U.S. has won the last two Olympic gold medals.

Krikorian will be naming the Olympic team roster on Wednesday in Los Angeles. Musselman, the Fischer sisters and Gilchrist hope to make their second straight Olympic roster, while Williams and Haralabidis are vying for their first Olympic team spot. For Seidemann, it would be her third straight Olympics.

enrollment to the state and received disproportionate funding, held classes in a facility not zoned for K-12 education and charged fees for instruction.

ISSAC's potential noncompliance was discussed by members of the Board of Education, the authorizing agency for the charter, in two regular meetings on June 2 and 16.

Aracely Chastain, director of OCDE's Charter School Unit, recommended the board issue a notice of violation to document the points of concern and provide the school a chance to remedy issues within 30 days.

"You have authorized 18 charter schools, and very few come to the board," Chastain said at the June 2 meeting. "At this point, this is the third time we've done this with ISSAC in the two years that they've been opened."

OCDE officials allege the school reported to the California Department of Education an enrollment of 150 students for the 2020-21 school year, when a budget submitted to the county for the same fiscal year projected growth of 100 students. The state consequently overpaid the school, based on the inaccurate attendance figures.

In July 2020, when students were learning from home during the pandemic, ISSAC relocated from a building leased from Newport-Mesa Uni-

meetings, Srinivasan and a team of legal and financial consultants representing ISSAC attempted to explain the missteps.

They described how officials confused two sets of financial documents and submitted the wrong paperwork to the state. To rectify the situation, state officials have agreed to withhold future apportionments until the overpayment is recouped. Srinivasan also explained the school offered daytime childcare services for families who could not stay home with children doing distance learning during the pandemic and brought in special-needs students for instruction when guidelines allowed the accommodation. "The pandemic has created a lot of new challenges and ISSAC does everything it can, with changing circumstances and limitations, to support the students," she said at the June 2 meeting. School officials told board members the charter school's board of directors would meet Thursday and decide on returning fees collected for the childcare services. Chastain requested Srinivasan submit a plan in writing detailing steps to be taken. ISSAC has also since applied for a conditional use permit that would allow them to operate out of the Boys and Girls Club but had still not received approval as of June 16. Although a notice of violation was urged by Chastain, board members elected to give Srinivasan and her team more time to provide a written response explaining how the issues of noncompliance occurred and work with OCDE officials to rectify them in a timely manner. "I'd like to bring us back in two weeks to reconsider it, assess where we are and look at how much has progressed in that period," Williams said at the June 16 meeting.

County officials learned from the city the property was not zoned for K-12 education and ISSAC would need to obtain a conditional use permit to operate there under a sublease.

Chastain said staff repeatedly told school founder and executive director, Padmini Srinivasan, no instruction could take place at the facility until a permit was secured.

However, in March of this year, the county received a complaint from a parent claiming students of the charter school were attending a hybrid instructional program at the Boys and Girls Club, participating in classes online with the help of instructional aides, for a fee.

Chastain estimated ISSAC has collected around \$64,000 for such services since the 2019-20 school year.

"Some of these families claimed these fees as deductions on their taxes," she said.

Board members, who approved ISSAC's petition and charter in March 2019, expressed their disappointment in the situation.

"We've really gone out of our way to help your school," board President Ken Williams said during the June 2 meeting. "I am not sure if this was intentional, or whether it was a well-intended person who did not understand the rules.

"I don't want to take any punitive actions that would hurt the school, but we really do need reassurances we're going to be within the boundaries of the law," he continued.

During the two June

David Patterson, president of California Charter Authorizing Professionals, a Sacramento nonprofit supporting agencies that provide oversight of charson said. "You can issue a notice of concern on small issues, and you can have a number of those for issues that need to be clarified. But if you're going to do a notice of violation, it's one of a significant and potentially serious nature."

Such notices are publicly recorded and may affect a school's reputation or whether its charter is renewed, he added.

Even with the county board's holding off on issuing such a notice, time is running out for the International School for Science and Culture, where classes are set to begin Aug. 23.

And to compound matters, ISSAC has applied for a material revision to its charter to allow it to expand to serve students on two campuses — both at the Boys and Girls Club and the NMUSD-owned facility it previously occupied.

School leaders requested the review process be expedited, even though the school would need to have its conditional use permit for the Boys and Girls Club site in hand for its application to be complete.

Srinivasan said she was told approval could take from six to eight weeks and expressed confidence all outstanding documents could be provided in time.

"It's cutting it close, but we have a good shot at getting it done, particularly because they have a lot of the background information already and have had it for such a long time," she told board members.

Costa Mesa staff confirmed Monday ISSAC's application for a conditional use permit to operate at the facility was submitted June 7.

"But I don't think it's exclusive to the people that make the team. It's the Trials experience and this whole value system. It's hard to manage. I was thinking about that a lot this week. I tried my hardest today, just go have my swim, focus on what I need to focus on, but it's really hard. And this is my fourth time doing it."

Shields shared his challenges with mental health on social media in late 2019, including that he tried to hang himself in 2018.

But he has come back stronger and will try to win more gold medals in Tokyo.

Shields won gold at the 2016 Olympics in Brazil as a member of the 400 medley relay.

He swam the butterfly in
