Higher surf, stronger rip currents forecast for county beaches

Weather forecasters warned Friday that higher surf and stronger rip currents are coming to Orange County and other southfacing beaches, increasing the danger for hordes of visitors expected during the Fourth of July weekend.

The National Weather Service issued a Beach Hazards Statement effective Saturday morning through Tuesday evening. Surf of 3 to 5 feet is expected, with the highest on south-facing beaches.

"Strong and long shore currents will create dangerous swimming conditions," the NWS said. "Larger waves can wash people off rocks and jetties."

The waves could hit 6 to 10 feet at the Wedge in Newport Beach, said Lifeguard Battalion Chief Brian O'Rourke.

Those conditions are only safe for swimmers and body boarders with experience, he said.

But O'Rourke said he worries about the majority of beachgoers who think just because they are strong swimmers in a pool, they will be safe in the ocean.

"They don't know about rip currents. They struggle, fight and become exhausted," he said. "Panic is also a problem."

m." Anyone who goes into the ocean is urged to swim in front of a staffed lifeguard tower and check in with the lifeguard about current conditions, O'Rourke said. Almost all lifeguard towers are likely to be staffed.

The proper technique for escaping a rip current is to swim sideways or parallel to the shore rather than attempting to swim directly to shore, he explained.

Swimmers in distress should wave their arms and a lifeguard will respond, he said. He noted lifeguards enjoy talking to visi-

tors about water safety.

Not guilty pleas in alleged attack

Two Long Beach men are accused of kidnapping and sexually assaulting a woman in Huntington Beach.

Two Long Beach men who stand accused of kidnapping and sexually assaulting a woman in Huntington Beach pleaded not guilty to all charges at the Central Justice Center in Santa Ana on Wednesday.

Florentino Contreras Bacilio, 47, and Angel Lopez Evaristo, 30, stand accused of one felony count of kidnapping to commit rape, one felony count of sodomy and two felony counts of forcible sexual penetration by a foreign object, according to court records.

Prosecutors said the 27-year-old female victim was walking home from downtown Huntington Beach just before midnight on June 6.

It is alleged that Bacilio and Evaristo stopped their vehicle and kidnapped the woman.

The two are accused of gagging, choking and sexually assaulting the woman who then lost consciousness.

The men later threw the woman out of the vehicle on Pacific Coast Highway after she regained consciousness and continued fighting back, the prosecutors allege.

She then flagged down a passing motorist who called the Huntington Beach

Laguna Beach man pleads not guilty to murdering his mother in 2019

A Laguna Beach man pleaded not guilty to murdering his mother in 2019 at the house they shared during an arraignment hearing held Friday at the Central Justice Center in Santa Ana.

Matthew Bryson McDonald, 36, was arrested in August 2019 on suspicion of murder after his mother, Megan Estes Hampton, 61, was found dead in their home by a neighbor who had arrived there to accompany Hampton to a morning church service.

McDonald is accused of murder with a sentencing enhancement of personally using a knife. If convicted of all charges, McDonald, who does not have a previous criminal record, faces a maximum sentence of life in prison.

Hampton became the sole conservator of her son after her ex-husband, Tom McDonald, died in 2010 from cancer.

A judge determined in 2007 that Matthew McDonald was "unable to properly provide for his personal needs for physical health, food, clothing or shelter" and that "there is no form of medical treatment for which the conservatee has the capacity to give an informed consent," according to court documents.

Records from 2007 to 2018 indicate that McDonald at various times objected to his conservatorship, only to withdraw his objections. The last time he withdrew an objection was in 2014.

McDonald became a suspect in the case

after neighbors told investigators that they saw McDonald leave the home quickly in Hampton's car, backing into a mailbox before speeding off. That incident was unusual, they said, as he hadn't driven in months.

He was later stopped by Orange County sheriff's deputies in San Clemente and found with blood on his clothing less than an hour after Hampton's body was discovered, according to a law enforcement official that spoke to the Los Angeles Times in 2019.

McDonald remains in custody on a bail of \$1 million, according to jail records, and is next scheduled to appear in court for a pretrial hearing on Oct. 15 at the Central Justice Center

Newport Beach resident hits the century mark

PATRICIA ELLIS of Newport Beach will have her 100th birthday on Monday. Ellis, who grew up in Washington, is a former Hollywood star who went on to be a college professor.

Patricia Wright Ellis of Newport Beach will turn 100 years old on Monday.

She's been an actress and a college professor. She has survived three husbands.

So, what's her secret to a long life?

"Lots of sex," she said Friday with a laugh, adding later that she was just kid-

Ellis, who moved to Corona del Mar in 1962 and has lived in the Bluffs community since 1974, certainly maintains her good sense of humor.

She is planning to have small gatherings with both family and friends this weekend to celebrate her birthday.

She grew up in Washington and received her bachelor's degree from Washington State, moving to Hollywood in the 1940s to start an acting career.

She became well-known

as Roberta, the female lead in the 1952 Three Stooges movie, "Cuckoo on a Choo Choo." She also was an announcer with Jack Bailey on the hit daytime series, 'Queen for a Day.'

But Ellis said Friday that her time as an actress ultimately was "boring."
"Nothing to do," she said.

"They put you under contract and you just sit, and sit, and sit. I got tired of that."

Later in life, she received her master's degree from UCLA and went on to become a college professor at Cal State Los Angeles and Cal State Long Beach.

Newport Beach resident Carol Tomlinson has been a close friend of Ellis' over the

Ellis used to swim with Tomlinson's water aerobics group before Ellis suffered a stroke that has slowed her down in the last couple of

"I had a hard time keep-

ing up with her," said Tomlinson, who is now 76. "She was so on top of everything

... To be honest, she's been my role model for a long time. When I met her, she said she was [online dating on] match.com. At that point, she was probably in her late 80s. She would have guys come over to her house to go out.

"I said, 'You can't do that.' I was worried about her, but I became attached to her.

Ellis said making it to 100 years old was "amazing," adding that she didn't expect to live this long.

She has four step-children now in their 60s and 70s, said her nephew, Russell Wright, who is in town from Michigan for his aunt's birthday.

"She's been great," Wright said. "I kind of take care of her from afar."



Steel, Rouda show different approaches to infrastructure, pandemic stimulus plans

It is impressive that the Daily Pilot featured commentaries by both former U.S. Congress member Harley Rouda (on June 24) of the 48th congressional district and current congress member from that selfsame congressional district, Michelle Steel (on June 22). The difference is stark and substantial.

Mr. Rouda emphasizes outcomes and benefits that can result from a comprehensive investment in infrastructure — jobs, modernization of aging structures and the stimulation of the nation's economy.

Ms. Steel stresses the costs of these projects, noting that "the national debt will skyrocket to its highest since World War II."

What the honorable Ms. Steel does not acknowledge is that the period from the end of World War II to the 1970s was among the greatest eras of economic expansion in history, with the gross domestic product of the U.S. increasing from \$228 billion in 1945 to nearly \$1.7 trillion in

The national debt needs to be part of a larger calculation of benefits versus costs. An improved infrastructure, fuller employment and greater economic participation of residents of this country are all indicative of a higher quality of life that we all will enjoy from this substantial investment in the workaday world of these United

The victim was taken to a nearby trauma

center, where she was treated for numerous injuries sustained during the attack.

Police said last month in a release that the investigation began with minimal leads, but eventually led to Bacilio and Evaristo in Long Beach, and they were arrested on June 9.

Police also said there was no existing relationship between either of the suspects to the victim and there were no other outstanding suspects at the time.

Jail records indicate that both Bacilio and Evaristo remain in custody, with both currently held on a bail of \$1 million each.

"Being grabbed off the street, gagged and sexually assaulted is the stuff nightmares are made of," Orange County Dist. Atty. Todd Spitzer said in a statement issued on June 11. "That nightmare became

reality for this victim and thankfully, by the grace of God, she survived. No woman should have to live in fear that a walk home would result in the horror she was forced to endure." The accused men are ex-

pected to appear in court for a pretrial hearing on Sept. 8 at the West Justice Center in Westminster.

Dream Team Boys' Water Polo Player of the Year, went on to star for Cal. He was a four-time All-American who was the 2018 Cutino Award winner as the best college men's water polo player in the

He is one of five returners to the team along with five-time Olympian Jesse Smith, as well as Alex Bowen, Ben Hallock and Alex

Wolf is one of two goalkeepers on the roster, along with former Stanford standout Drew Holland.

After graduating from Huntington Beach High in 2016, he played at UCLA, where he was twice a first-team All-American helped the Bruins win the 2017 national title.

Cupido and Wolf, both overseas, were unavailable for comment Friday. They helped Team USA earn silver at the FINA World League Super Final tournament in Tbilisi, Georgia, this week, losing 9-8 to Montenegro in the championship match on Thursday.

The U.S. Olympic men's water polo team opens play in Tokyo against host Japan on July 24.

Resistance eases a year into COVID-19

It was a year ago this spring and summer that some of our

local leaders in Orange County, particularly in the beach cities and on the Board of Supervisors. brought attention to themselves as COVID-19 deniers and resisters to medical science and state emergency mandates

The L.A. Times has published two recent articles on the negative impact that this resistance had on our county. I will never forget the frustration and fear of those of us who tried to appeal to these leaders to protect their citizens by listening to national and state medical leaders and by following COVID-19 protocols. Thus this validation by a major

newspaper of the actions of some of our leaders helps confirm our perspective that they were indeed extreme in nature.

In one of the articles the author described the extent to which this negative local action gave way to the following, "Orange County came to be seen as a hotbed of resistance to medical science and emergency health mandates. Some local leaders resisted a state order to close beaches.

"Orange County's chief health officer quit after receiving death threats and little backing from a timorous Board of Supervisors.'

One of the community leaders from a local university contends that robust debate is healthy. (I think most likely it is if it doesn't affect our health or put the economy before saving lives.)

This spokesperson figures that the small group of resisters and deniers protesting at the beaches, particularly Huntington Beach, should not influence elected officials or be "taken as reflecting the broad sentiment of county residents.'

The conclusion that most voters consider themselves "closer to the middle than the far reaches of either party" brings

us some hope for the future.

Recently it seems that the county has calmed down from the robust resistance that was displayed by several local leaders a year ago.

I would like to think that the silent majority will not forget the vociferous resistance or mere inaction of some of those leaders who threatened our safety and that the memory of the painful experience of the pandemic will be reflected in our voting habits in the future.
