# Rains long gone, Fountain Valley opens its 20th park

Four months after Fountain Valley had planned to celebrate the opening of its 20th park, the city finally commemorated the achievement with a ribbon-cutting ceremony on Saturday.

Warm weather and a cloudless sky, the ideal conditions for a day outdoors, greeted those on hand to mark the opening of Moiola Park, which is located at 9790 Finch Ave. The ceremony, originally scheduled for March, had been delayed due to frequent rain earlier in the year.

The 1.12-acre park was built on the site of the former Fred Moiola Elementary, a school that served students from kindergarten through eighth grade but was shuttered in

## Former H.B. High principal heads to Edison

After spending the last eight years as the principal of Huntington Beach High School, Daniel Morris has joined Edison High School in the same role.

Huntington Beach Union High School District officials announced the move Tuesday, signaling a homecoming for Morris, who returns to the school where his administrative career with the district began in 2006. Morris was an assistant principal for four years at Edison.

The announcement comes after former Edison principal Jennifer Graves resigned her position last month. In making the decision, Graves said she would serve as an assistant principal at Huntington Beach Adult School.

"Coming full circle by returning to Edison is something I have always had in my thoughts," Morris said in a statement. "I look forward to working with the Charger students, staff and community to build upon what Principal Graves and her team worked so hard to create. Edison has a legacy of excellence and is a pillar in the community. I am anxious to get started and can't be more proud to be a Charger."

Morris arrived at Huntington Beach in 2015, following a twoyear stint as director of alternative education for the Irvine Unified School District. Prior to that, his time in the Huntington Beach Union High School District saw him serve as an assistant princi-

# **Nature** preserve upgrades on the horizon

Public is invited to Muth Interpretive Center on July 24 to learn about coming improvements to Santa Ana-Delhi Channel.

On a bright, warm morning Tuesday, runners, bikers and joggers made their way down a low, curving path that led them to the Upper Newport Bay Nature Preserve. Visitors followed the path across the Bayview Trail Bridge, from which ducks could be observed paddling and fish leaping in the water below.

This is the site of the Santa Ana-Delhi Channel Improvement Project, and Orange County Public Works hopes both area residents and visitors to the preserve can weigh in on the upcoming infrastructure work.

The channel was built in 1965. Roughly 11 miles long, it extends from Upper Newport Bay to Warner Avenue. Much of the work has been completed upstream, according to county officials. Project manager Melissa Pasa said plans for the project area - from the intersection of Mesa Drive and Irvine Avenue to the Bayview Trail Bridge - have been around for some

The environmental impact report was completed in the 1990s, but studies and stakeholder agreements delayed the project's official start date until next year, though officials will hold an open house for the public on Monday at the Muth Interpretive Center from 5 to 7 p.m. to answer questions and gather input.

Pasa said stakeholders include the California Coastal Commission, regional water control boards, the California Department of Fish and Wildlife, the U.S. Army Corps of Engineers, OC Parks and OC Public Works.

"We really needed to do our

### Fresh off a makeover, Bommer Canyon Cattle Camp reopens

A rustic venue situated among a grove of mature sycamores in Irvine's pristine Bommer Canyon Preserve — shuttered for two years to accommodate a \$4.2-million facilities renovation — is back online after a grand reopening

The site's iconic Cattle Camp, which has stood on the property since 1967, underwent a major rehabilitation that included construction of a stage, a bridal suite and catering kitchen, along with accessibility improvements, installation of a sewer line and new restrooms.

Irvine officials convened Saturday with local dignitaries, residents and James Irvine, whose forebears owned the land for more than a century before donating a portion to the city, in a ribbon-cutting ceremony.

The moment was the culmination of more than two years of construction and several years of planning with input from local residents and stakeholders, according to Stacy DeLong, a senior project manager for the city of Irvine.

"Before, there were very rudimentary trailer-style buildings that were in a state of disarray," DeLong said. "The idea was to totally update and renovate the facilities, make it fully ADA accessible and just enhance the use to the community."

Although used more recently as a venue that could be reserved for private parties, camp-outs and rustic weddings, the camp marks the spot where ranchers would historically bring large quantities of cattle to be branded, disinfected and inoculated against dis-

# Board of Supervisors approves plans for Project Homekey development in Costa Mesa

The Orange County Board of Supervisors Tuesday approved plans to apply for a state Project Homekey grant to acquire a motel in Costa Mesa to refurbish it and provide low-cost housing and shelter.

The county wants to acquire and rehabilitate the 120-room Travelodge at 1400 Bristol St. with a \$6,781,520 loan.

Supervisor Doug Chaffee said he "strongly supports" the Homekey program but added he was concerned about the debt servicing of the project.

"At some point the amount of debt owed will exceed the value of the project, probably by a multiple of times, and the reality is when it comes time to pay it some of it may have to be written off or may be a gift and not collectible," Chaffee said.

Supervisor Katrina Foley, who made the proposal, said she agreed with Chaffee on that issue.

"I am concerned about the cost as well," she said. "[But] we do have a revenue source because of a restaurant and a Tesla charging station on site."

Foley said she was hopeful that the contract will be structured so the county and its partners on the project, Costa Mesa and Newport Beach, "will have a share of that revenue that can pay toward the debt service."

Foley said she also wanted county officials to push for vouchers for veterans in the project. Officials said they have reached

out to the Veterans Administration to approve the vouchers.

Foley said she preferred razing the motel and building new housing in its place, but developers said that would take longer than the required year for the project to be done.

Officials said they believe it would cost more to demolish and rebuild the housing, but Foley said she believes it may be the other way around and it would allow for a better design.

Foley asked county officials to lobby for more time for Project Homekey developments.

### Orthopedic surgeon gets jail time in bribery case

An orthopedic surgeon was sentenced Friday to 33 months in federal prison for accepting more than \$315,000 in bribes and kickbacks for performing spinal surgeries at a now-defunct Long Beach hospital whose owner was imprisoned for committing workers' compensation insurance fraud.

David Payne, 65, of Irvine, was also fined \$20,000 and ordered to forfeit \$316,597, according to the U.S. Attorney's Office.

Payne was found guilty in March in downtown Los Angeles of one count each of conspiracy and use of an interstate facility in aid of bribery, and two counts of honest services wire fraud.

According to court documents and evidence presented at trial, Michael Drobot — the owner of Pacific Hospital — conspired with doctors, chiropractors and marketers to pay kickbacks and bribes in return for the referral of patients to the hospital for spinal surgeries and other medical services.

The services and surgeries were paid for primarily through the California workers' compensation system.


During its final five years, the scheme resulted in the submission of more than \$500 million in medical bills for spinal surgeries involving kickbacks.

Payne received bribes from Drobot of up to \$15,000 for each spinal surgery that he performed at Pacific Hospital. The top bribe payment was for lumbar spinal surgeries Payne performed on patients at the hospital with implants from one of Drobot's companies. Drobot and Payne covered up the bribes by disguising them as payments for marketing services and fees based on a sham contract, evidence showed. In April 2013, law enforcement

In April 2013, law enforcement searched Pacific Hospital, which was sold later that year, bringing the kickback scheme to an end.

To date, two dozen defendants, among them doctors and surgeons, have been convicted for participating in the scheme, federal prosecutors said.

studies and analysis upfront to be able to get to where we are today," Pasa said. "And we're ready to go out to the community and hear their concerns and what they'd like to see as part of the project, make sure that they're part of our mailing and distribution lists so they can be informed of the project throughout the entire process.'

Upper Newport Bay to reduce the sediment transported to it, and provide habitat restoration in the associated channel system. Improvements will also be made to recreational trails in the area.

"Essentially, what we'll be doing here is we'll be widening the channel about double its existing width, and we'll be replacing the Bayview Trail Bridge, which has experienced a lot of erosion," Pasa said. "It was actually rehabilitated in 2017 just to stabilize the foundations in preparation for this capital improvement project."

Pasa said the Santa Ana-Delhi channel is trapezoidal because of the amount of erosion it's experienced over the years. Most of the walls lining the channels were nearly vertical on Tuesday, which she said impacts Newport Bay as the transported sediment affects water quality. Adding habitat would slow water as it travels through the channel, she said.

The total cost of the project is expected to be around \$31.2 million, with

2012.

Sandra Crandall, a Fountain Valley School District board member, said the district began as one that offered K-8 education, but a movement in the late 1990s pushed the district to establish middle schools. Some residents wished to preserve the K-8 configuration, and Moiola was the last of those schools, she said.

"What happened over the years with declining population was the K-8 school could not sustain itself," said Crandall, who worked as a kindergarten teacher and a reading specialist in her time at the school. "We didn't have a full math department there because the numbers weren't there, of students. The bulk of the parents really wanted the middle school experiences, and they kind of voted with their feet, so they went to our K-5 schools, and then our

three established middle schools."

Since its closure, the 13-acre school site had passed into different hands a few times. LePort Montessori, a private education institution, leased the property. The land was later sold to Brookfield Residential, then to another developer, Lennar, which resulted in the development of the park along with 74 new single-family homes.

City officials said the developer will be responsible for maintenance of the park for the first 10 years of its existence, and then that responsibility will transfer to the city.

"This is Moiola Park," Fountain Valley City Manager Maggie Le said. "It is open to the general public, and we're very excited to be here to provide this service and allow the community to have access to this new park."

Le's remarks were followed by presentations from local officials in attendance, including state Sen. Janet Nguyen and repre-

sentatives from the offices of Rep. Michelle Steel and Assemblyman Tri Ta.

Today, vestiges of equipment and infrastructure remain on the property and in an adjacent 1-acre interpretive Nature Park restored in April with native plant species that would have appeared on the landscape centuries ago.

An iconic water tank at the camp has been renovated and now serves as a 22,000-gallon fire suppression system that can be used to protect the vicinity in the event of a wildfire.

DeLong said Tuesday the city and construction crews worked carefully to avoid disrupting any natu-

ral habitat throughout the construction process, a move that delayed the camp's reopening.

'There were a couple of red-shouldered ĥawks nesting very near our work space, so we had to stop for a couple of months while they were doing their activities," he added. "A lot of efforts were made to be respectful of that fact and respectful of the historical nature of the space."

On Monday, the city began accepting reservations for newly renovated space for the remainder of the reservation season, which ends in October. But access to the Cattle Camp and nearby Nature Park will open to the public during the area's Wilderness Access days on the third Saturday of each month.

"There are picnic tables out there and adjacent trails where you could go on a hike, come back then sit under beautiful trees or just hang out," DeLong said. "We definitely want residents and visitors to enjoy the area."

begin in fall 2024.

"We need to reduce erosion along this entire channel system to ensure that we can move the storm water safely from upstream to the bay. This bridge is also heavily used by pedestrian cyclists, so we want to make sure that the trails can stay open," Pasa said. "If there's too much erosion here, that bridge will have to close and would have to have emergency repairs.

"This project is getting ahead of that, and so was the rehabilitation we did in 2017. We're doing this capital project now to address the erosion so that it's planned, and that we can keep the trails open as much as possible ... this segment's the last piece of the puzzle. What [this project's] doing is upgrading our flood control

channel to current design standards and providing 100-year storm protections."

Pasa noted the team is also acknowledging the adaptive nature of the improvements with relationship to climate change and sea level rise.

The hope, she said, is to bring the contractor on board during the final design phase so it can provide its methodology before OC Public Works goes back out to the community to answer questions of what they can expect during construction work.

Monday's open house will also feature experts, volunteers who see and work with the preserve and some of the engineers involved in the project.
