Landslide in Newport Beach

3 homes on Galaxy Drive were yellow-tagged after the collapse of a bluff above Upper Newport Bay early Thursday.

Three houses on Newport Beach's Galaxy Drive were yellowtagged after a landslide was reported to city officials early Thursday morning.

The slide appeared to have happened at around 4 a.m. in Newport Beach, according to officials. City spokesman John Pope said property owners had just contacted the city on Wednesday with concerns about the stability of the bluff and stated their intent to submit forms to bolster their property prior to Thursday morning's slide.

Pope said much of the backyard at 1466 Galaxy Drive was lost, but the property and the two properties adjacent remained intact.

One of the notices posted to an adjacent property indicated the houses had been yellow-tagged because of what city inspectors called a "severe rear yard bluff failure." Because of the exposure of a gas line and authorities' efforts to observe the bluff for any further damage, the properties have been marked for no occupancy, though residents are allowed to retrieve their things.

"At 4 a.m. this morning, the outside wall noise alerted me," said Steven Peisner, who lives at 1472 Galaxy Drive. "I heard the clank of flower pots all coming down, which is why I came outside."

Peisner said the majority of his concrete and brick patio sank 10 feet down the hill sometime during the early morning and stopped before falling into the bay against trees that stood in its path. The backyard swimming pool at his property was also damaged — the pool equipment was ripped from its foundation and the pool was empty. While the damage to his house, if any,

Costa Mesa council tackles affordable housing ordinance

After much back and forth, officials pass a law imposing affordability requirements on rental projects over 50 units.

If you want to see the mechanisms by which ideas and good intentions become transmuted into law, look no further than the city of Costa Mesa.

That's where officials Tuesday engaged in a deep and, at times, personal discourse to establish an inclusionary housing ordinance that would speak to the urgency of a statewide affordability crisis without turning away the developers whose efforts will be needed to produce solutions.

After an hours-long discussion that included a motion, substitute motion and a substitute to the substitute — with multiple revisions and refinements of that final proposition — the Costa Mesa City Council approved language that represents an amalgam of hopes, fears and compromises in a 7-0 vote.

Tuesday's second reading of the draft regulation continued an equally lengthy Jan. 16 hearing that covered the size threshold at which a housing project would trigger the ordinance and what percentage of units should be offered for low- and very low-income tenants.

That earlier talk ended in a 4-2 vote — with the council hovering around, but not content with, a set-aside rate of 11% low or 7% very low-income units for projects with a density of 60 or more units per acre and lower percentages for smaller projects — and left much still to be discussed.

Officials met again in a Feb. 27 study session to figure out what the city might accept as an in-lieu fee from developers who deemed the inclusion of affordable units infeasible. Consultants provided data on other cities with similar

Water balloons and beach noise: Surf City tweaks municipal code

The annual Huntington Beach Independence Day celebration is known as the largest west of the Mississippi River.

With that celebration comes house parties that can sometimes become unruly.

The Huntington Beach City Council unanimously passed two ordinances Tuesday night, one giving police officers more leeway when it comes to giving citations at such events, as well as another establishing emergency service access zones at Huntington City Beach and changing beach noise ordinance standards.

Ordinance No. 4317 amends Chapter 8.42 of the Huntington Beach Municipal Code, relating to the use of police services at loud parties or other activities. The code amendment expands the authority of officers to issue civil citations to people who allow or permit this behavior in this case, to whoever holds the water billing account at the residence.

HBPD Lt. Thoby Archer said in a presentation there has been an increase in calls for service on and around the Fourth of July in recent years, with complaints of people being hit by water balloons and other objects.

was minimal, the state of the backyard led to a yellow tag.

Pope said the city is in contact with both the state and county because the homes abut the Upper Newport Bay Ecological Reserve, which falls under the state's jurisdiction.

He confirmed the city is collaborating with the property owners to expedite efforts to stabilize their homes.

This is not the first time a slide has happened in Newport Beach or even on Galaxy Drive. In March of last year, a different property at 1930 Galaxy Drive, not far from the addresses affected Thursday, was red-tagged after a huge portion of the home's backyard collapsed due to a slide caused by heavy rain. That home was demolished later that month.

Councilman Erik Weigand, who represents the district where the slides have occurred, said he was at the scene Thursday morning and observed the damage from one of the neighbors' backyards. It appeared the hillside had largely fallen into the Back Bay.

Weigand noted he and Assemblywoman Diane Dixon recently spoke about what the state could do to help the Galaxy Drive homes impacted last year but that conversation tapered off as they were "hitting a lot of roadblocks.

definitely con-"I'm cerned about everyone's homes," Weigand said. "We've had a tremendous amount of water in the last two years. It's extremely saturated. When I was standing there [in a neighbor's backyard], I could see the hillside crumbling down. I may not have seen a major slide, but there were still rocks. It's still active, and it will still be active for some time based on the existing properties

experiencing [this same situation] last year," said Weigand. "The incident from last year was in part because [the houses] were built on fill material."

Dover Shores and the surrounding acreages that skirt the bay were developed by the Irvine Co. in the 1960s for residential use and have long battled the elements, with fortifications such as caissons, watertight retaining structures, drilled into the hillsides.

One neighbor, who declined to give her name but lives across the street from the impacted homes, told a reporter Thursday she knew one of the yellow-tagged properties had been fortified with caissons, and she was surprised to learn the house was not considered safe for occupancy.

"When the land here was developed back in the day, the land was smaller on some of these parcels so fill was added to make them equal with other properties. On this particular property, I don't know if that is the cause or if it could be something else. We'll have to hear from geologists, but it's concerning," Weigand said. "As long as we continue to receive these storms, it's a double-edged

sword. We need water in this state, but — the reality is that there's a lot of saturation all around. It's not just this street or this hillside but Orange County, and all of Southern California.

"This is not a problem unique to just this area or homes on the cliffsides. We're keeping an eye on this and making sure that other properties are, hopefully, not in the same situation, but you know we won't know until things like this happen."

Orange County Supervisor Katrina Foley issued a statement Wednesday afternoon saying she had sent her staff out to provide the affected homeowners with information related to property tax relief and to offer resources that could assist them while they are displaced from their residences.

"We are monitoring the situation and in coordination with the city of Newport Beach, state Assem-blywoman Diane Dixon, the California Department of Fish and Wildlife, and Office of the Governor,' Foley stated.

CdM, Newport Harbor swim to Battle of the Bay victories

It was top female club swimmers from Corona del Mar High against a deep, water polo-heavy group of girls from Newport Harbor High.

Both groups impressed Tuesday at CdM in the annual Battle of the Bay rivalry meet.

CdM's girls, who won every race but one, earned a 96-74 victory in the Surf League meet. On the boys' side, Newport Harbor claimed a 90-80 triumph for its second straight Battle of the Bay win.

Corona del Mar's girls lost key club swimmers like Maggie Schalow and Milan Bever to graduation, but they are 4-0 in dual meets this year, including a 2-0 league mark.

"I think it's been going good," said CdM junior Alex Milisavljevic, who won the 200-yard freestyle in 1 minute, 57.64 seconds and also touched first in the 500 free (5:09.01). "We have a really great com-munity here. The water polo players and the club swimmers get along really well, which is a really nice kind of bonus. I feel good about the races; I think

are now 0-2 in league. Stayt claimed the backstroke in 1:01.01, and the Sailors' depth kept things relatively close.

Coach Kevin Potter believes that depth will also help his team at Surf League finals later this month.

Newport Harbor freshman water polo player Madison Mack was second in the 50 free and 100 free in a pair of personalbest times.

The boys' meet was close throughout, but Newport Harbor gained momentum when both its "A" team and "B" team overall. "We lost a couple of our faster swimmers," he said.

Last year there were nine separate calls on the holiday for service on Alabama Street alone, requiring multiple officers to respond.

"While most of the activity is consensual, there are multiple incidents where unsuspecting or unwilling parties are walking, driving or riding bicycles down the street and they are hit by objects," Archer said. "When this happens, it is difficult and almost impossible to identify the suspects because they're acting with impunity and will often retreat into a residence or a backyard and not come out."

At Tuesday night's meeting, Archer showed a few minutes of body camera footage to illustrate the issue and resources needed. He said that HBPD plans a comprehensive education campaign, including water billing notifications, social media posts and hand-delivered fliers to locations that have previously engaged in the behavior.

"I think this will address what seems like a massive call for service for something that seems somewhat trivial but can really ruin somebody's day,' Councilman Dan Kalmick said. "As one of the officers said, you can throw them at people you know, just don't throw them at people you don't know.'

Archer responded that he knows nobody wants to write someone a ticket for throwing a water balloon, especially on Independence Day, but it becomes a problem when people do it and then refreat to a house.

"This would just give us another tool in our toolbox," he said.

ORDINANCE ALLOWS PUBLIC SAFETY PERSONNEL BETTER ACCESS TO BEACH

Another ordinance passed Tuesday night, Ordinance No. 4319, adds the definition of an emergency

services access zone to the municipal code.

This area includes the beach service road and all public stairways, sidewalks and access ramps, along with a 14-foot wide pathway down the center of the pier. Areas in Pier Plaza located between the outermost edges of the pier, directly in front of operational lifeguard towers and lanes and zones delineated by signs and barriers are also affected.

These areas would be prohibited from laying, storing or hanging property, HBPD Lt. Brian Smith said during a presentation, and it would be a misdemeanor to obstruct emergency services access zones after being warned.

The ordinance also switches beach noise regulations to prohibit sound that is "plainly audible" 50 feet from the source of the noise, after being warned, with exemptions for permitted activities and public safety personnel performing their duties.

If someone had an amplified device in the center of Pier Plaza, it would be audible to nearly all of those within Pier Plaza, preserving peace to the surrounding community," Smith said. "Another example of areas impacted by noise would be the fire pits, which are approximately 50 feet apart. Users of one particular pit could have amplified music at a volume where their party could hear the music, without disturbing the peace of parties two pits away."

The ordinance requires canopies to have two sides completely open to public view, and prohibits tents in excess of 100 square feet.

Blocking, obstructing or preventing free access to public restrooms and washrooms is also prohibited under the ordinance, as well as sleeping, loitering, camping, storing property or habituating there.

CdM gets even with rival Newport Harbor

Corona del Mar did something only one currently in its boys' volleyball program has achieved.

It took that individual, playing with an indomitable will to win, to break through for the Sea Kings' first win over the crosstown rivals in three years.

Senior outside hitter Sterling Foley had 21 kills and 3¹/₂ total blocks, sending CdM over host Newport Harbor 25-19, 25-20, 28-26 to begin the back half of the Surf League slate.

"I'm not ending my senior year on a loss to Harbor," Foley said. "I had to step up, kind of be a captain. The whole team played amazing, sided out really good. We stopped their middles, which we've been working on since the last time we faced them, basically.

"I think we were emotionally stable, not a lot of ups and downs, but when we were down, we kind of came back, took a deep breath."

Third-ranked Corona del Mar (20-5, 3-1) earned its first win over Newport Harbor (22-4, 3-1) since April 20, 2021. Third-year Sea Kings coach Katey Thompson also earned her first coaching win over the Sailors.

Newport Harbor, tied atop the CIF Southern Section Division 1 and 2 combined poll with Los Angeles Loyola (15-1), had extended its winning streak over CdM to eight matches in the first half of league.

Foley's impact was immeasurable. He flew from the back row to finish points, extinguished laserlike strikes with a team-

best nine digs, and he was a rover as a blocker in the front row. The USC commit factored into six blocks, which was matched only by freshman middle blocker Daniel Booker's six block assists.

"He's not only one of the best athletes on our team, he's also the emotional leader," Thompson said of Foley. "Everyone follows him, and when he's going 100%, everybody else is going just as hard, so he really sets the standard for our boys. Coming out tonight, he made sure every time the boys knew what we were here for, how we were going to do it."

The Sea Kings played from in front all evening, but they were pressed in the third set. Newport Harbor outside hitter Riggs Guy (14 kills), headed to UC Santa Barbara, had eight kills and an ace in the extended game.

Booker had a kill that brought CdM to within two points of victory, and when he exited later in the rotation, he engaged the bench and the fans behind it, seemingly thriving in the environment.

"Normally, I'm not good at talking to people, but I guess when I'm playing volleyball, I just get better at it all of a sudden," said Booker, who teamed up with Everett Welton to provide the match-winning block. "I don't really know how to explain it."

Setter Ryan Gant, a Stanford commit, had 31 assists for CdM. UCLA-bound libero Brogan Glenn had eight digs. Middle blocker Reid McMullen added 2½ blocks.

Middle blocker Jack Berry produced nine kills and three blocks for Newport Harbor. Chandler Swanson had five kills, and Jack Von Der Ahe and Charlie Herrington each chipped in with four kills. Grayson Springborn dished out 30 assists.

"They really kind of applied pressure," Newport Harbor coach Andrew Mabry said of CdM. "In each of those three sets, I think they played from in front. You could see it. They played a very free-flowing, kind of clean game tonight, and we were a little disconnected at times."

The Surf League is

primed to have significant representation in the CIF Open Division playoffs. The section will place eight teams in the top division. The league is rounded out by No. 5 Huntington Beach

Charlie Herrington (22).

and No. 6 Edison. "I think it's the best league in the country," Mabry said. "I don't think that's debatable, and I think everybody has a chance to win every single night in this league. To go 3-0 in the first half, I thought, from us was really impressive. We never assumed that this was an easy second half of league. Every night is an all-out battle."

ing. "This has been a long time coming. I've heard 8,000 stories in the time I've lived in Costa Mesa and in the time I've been elected," said Councilwoman Andrea Marr. "If I don't try really hard to get this thing across the line I'm not going to be able to live with myself."

Marr initially proposed a set-aside rate of either 15% low-income or 10% very low-income on rental projects with a density of 60 or more units per acre, striking any affordability on home ownership proposals. That motion went nowhere.

Other council members decried the dearth of housing produced since residents passed Measure Y in 2016, requiring voter approval for certain largescale projects. Only 182 units have reportedly been built in the past six years, Mayor Pro Tem Jeffrey Harlan said Tuesday, as developers have pursued projects in more buildable cities.

Although voters agreed to effectively undo the mandates of Measure Y through the narrow passage of Measure K in 2022 — freeing up the city to rezone certain commercial and industrial corridors to allow for residential projects with higher densities — the actual rezoning part of the initiative has yet to take place.

Offering a substitute to Marr's motion, Harlan suggested the council consider allocating \$2.5 million to establish an affordable housing trust that would let

"This is no incentive-based program. It won't be until we have the rezoning take place."

City staff estimated it could take the city at least two years to complete the rezoning process, a timeline some felt was too long to wait to apply an affordability mandate.

Mayor John Stephens suggested such requirements could be part of an individual project's development agreement, and others tried to work out with staff whether an affordable housing ordinance might be phased in as the city completed portions of its rezoning effort.

Councilwoman Arlis Reynolds put forth a second substitute motion that — after several iterations and amendments retained Harlan's idea about setting up an affordable housing trust fund but established an immediate requirement that rental projects of 50 or more units earmark either 10% for lowincome or 5% for very-low income occupants.

As part of the motion officials will reconvene, possibly in a study session, to review different strategies and resources that would help city staff accelerate the rezoning process and streamline projects that met the affordability mandate. A discussion on setting in-lieu fees will also return at a later date.

"I'm so proud of this group here," Stephens said after the vote. "If every branch of government throughout the country did business like we just did, we'd live in a different world."

BOYS' GOLF Corona del Mar rallies to sweep Battle of the Bay

A stirring close made up for a sloppy start as Corona del Mar rallied at the finish to complete a Battle of the Bay sweep on the golf links, a triumph that meant everything all successes against Newport Harbor mean, even with nobody around to celebrate.

The Sea Kings, behind late-charging James Leehealey and ailing Charlie Olson, pulled out a 188-191 decision on the final hole Wednesday on Costa Mesa Country Club's Mesa Linda Course, and if it wasn't quite that dramatic, it still felt pretty good to the victors.

"Battle of the Bay is something special," said CdM boys' golf head coach Steve Conti, whose team trailed the first five holes, "but I think it's unique in golf, because there's no fan base out here. Every other sport — volleyball, water polo, basketball, football - it would be a sellout crowd, but you don't get that fan base here and the kids storming the ninth green after you make the win or something."

Said Olson, a Gonzagabound senior who aggravated a back injury on his second-hole tee shot but was one under par on the last seven holes: "It's hard to tell how big it is, with the lack of fans — because they're not allowed [on the course] in golf — but to us, it means a lot."

There was plenty of suspense, most of it hidden. All anyone knew was that it was close, the outcome wasn't certain until the last of four quartets completed its round, and only an analysis of the scorecards revealed just how tight things really were. The match was even, at 168-168, after eight holes —

neither side had led by more than 4 strokes all afternoon — and the parfour ninth hole belonged to Corona del Mar (8-2).

Leehealey, whose round started with a pair of bogeys, sunk a birdie putt ---with it he overcame a twoshot deficit to share medalist honors, at even-par 35, with Sailors senior Zack Moreau — and six of the other seven Sea Kings made par. Five of Newport Harbor's eight golfers bogeyed the hole, including Moreau, who was sensational down the stretch, and his top-group partner Tyler Richardson. Only the top five individual scores count toward a team's total.

"I knew we were down early and it was close," said Conti, whose team won Monday's match at Newport Beach Country Club, 185-198, behind Olson's two-under-par 34. "But knowing exactly how it played out made for a crazy finish."

Neither side was at its best.

guarantee you, this will be the worst performance of the year," said head Newport Harbor coach Scott Tarnow.

Noted Conti: "We got a little lucky that we maybe caught them on an off day, too - on a series of demanding greens, but there was some very fine play within that."

Leehealey, who like Olson played a prominent role on Corona del Mar's 2022 CIF Southern Section championship side, found his stride quickly following the bogeys on the par-four first and par-three second and birdied two holes down the stretch.

"It was a little bit of a rocky start, but if you just keep grinding, stay in it, it eventually comes around Leehealey sometimes," said. "I tried to make a pretty risky [shot from the tee on the third hole], slice

it around a tree, and it worked, and I sort of felt it in my heart [that] things are coming around. Coming up to the ninth hole after I hit my perfect drive, I just knew it was going to be a birdie."

Moreau, playing in the group ahead of Leehealey, also bogeyed two early holes, then birdied the fourth, fifth and seventh . The par-five fifth was highlight-reel material: а hooked tee shot into deep rough beyond the cart path, a chip into a bunker, then a 30-foot putt from the fringe. He sunk a sloping 20-footer on the fourth hole.

"On a day like this, when the greens are firm, the pins are tucked and hard, it's not too difficult, because it's [a short course], but it can play tough around the greens," Moreau said. "That's how this course gets you. It doesn't get you with distance, it gets you with the greens."

Olson, who was in Moreau's group and finished two strokes off the lead, also had a beautiful birdie putt, a 30-footer on the par-three sixth.

"Those are always fun when they fall, because they rarely do ...," Olson said. "There's a lot of slope out here. You've got to be very strategic with where you land the ball, where you place it, so you leave yourself an uphill putt."

Olson had "tweaked" his back last week, and it was "bugging" him after that tee shot on the second hole. Advil helped, but he was hooking his drives.

"I played through it," he said. "Battle of the Bay. I was never going to quit. Conti wasn't surprised.

"It's easy to play when things are going your way,

but how do you perform when things aren't going your way?" he said. "But he's a competitor and he found a way to grind out a 37 today, which is not a score he'd be super happy about. Last week here he was four strokes better, but that's a real good score [under the circumstances], and that's a guy you want on your team."

Steven Yang and Bill Zhan shot 38 for the Sea Kings. Newport Harbor (2-4) also had two players at 38: Richardson, who led for two holes after a birdie on the par-three second, and Aidan O'Shea, playing in the fourth group.
