ICE raids F.V. car wash, 7 workers taken into custody

Seven employees were taken into custody during an immigration raid on Monday morning at a car wash.

The mood among a few employees gathered inside the lobby of Magnolia Car Wash was a somber one on Wednesday morning, a meeting taking place just a couple days after seven members of the team were taken away in an

immigration raid.

The raid occurred at approximately 9:30 a.m. on Monday at the hand car wash, which is located at the southeast corner of Magnolia Street and Talbert Avenue in Fountain Valley.

Gabriel Romero, a manager at the car wash, recalled the scene as uniformed personnel showed up at the business and began to escort workers off the property.

"We have customers. It's not fair," Romero said. "People come, never say, 'This is my ID. I come for ICE,' or something. They come in regular vehicles. It's not like ICE patrols or anything else. ... When a guy comes through the door, I say, 'What can I do for you, sir?' He didn't respond to me anything."

Romero described the crew arrived as dressed "like soldiers." During a heated exchange, one of the employees was grabbed around the neck, he said.

"[The employee] was pissed," Romero said. "When [he] tried to say, 'Hey, leave them alone,' the

Measures A and B proponents claim victory

Huntington Beach voters have decided on the future of library operations.

Amanda Galath has frequently taken her children, ages 12 and 14, to the Huntington Beach Central Library.

The Huntington Beach resident followed the campaign for Measures A and B closely, but a turning point came when signs asking residents to "Protect Our Kids From Porn" with a "no" vote popped up on streets near local schools on the Monday after Easter.

"I was so caught off guard and really infuriated that I was forced to have a conversation with my school-aged kids that I wasn't ready to have," Galath said. "That's what lit the fire."

A passionate campaign concluded with special election day Tuesday. Measures A and B appear on track for victory in Huntington Beach, with advocates calling that a win for the city's public

library system.
As of Wednesday afternoon,

Measure A had 30,407 votes for (58.96%) and 21,169 votes against (41.04%) on the Orange County Registrar of Voters website. The measure would repeal a parent/guardian children's book review board of up to 21 members, appointed by the Huntington Beach City Council, which could relocate books deemed offensive to a restricted area while also stopping new children's books from entering the collection if they didn't meet "community standards."

The board's decisions would have been final.

A Measure A victory would leave policies for the selection and use of library materials in the hands of the city's director of community and library services.

Measure B had 31,409 "yes" votes (60.95%), and 20,120 "no" votes (39.05%). That measure would require both the council and a majority of Surf City voters to approve any outsourcing of library operations. The council had explored doing so last year before a bid was pulled.

The next update was scheduled for Wednesday at 5:30 p.m on the registrar's website, after print

Vote counts in NMUSD race favor challenger

Voters in Newport-Mesa Unified School District's Trustee Area 5 — which represents three schools in Newport Beach — cast ballots to fill a school board seat vacant since December, favoring Andrea McElroy for the position, according to preliminary results Wednesday.

Ballot totals updated by the Orange County Registrar of Voters as of press time indicated McElroy was leading the two-candidate contest with 2,628 ballots, or 54.24% of the vote, over challenger Kirstin Walsh who had so far secured 2,217 ballots in her favor.

The contest pit Walsh, 54, a licensed occupational therapist and mother of two Newport Harbor High School students, against McElroy, 55, mother of a former NMUSD student and owner of an activewear brand for women.

Both candidates sought to fill a vacancy left by former Trustee Michelle Barto, who left the school board in December after she was elected to the Newport Beach City Council.

Newport-Mesa's Board of Trustees initially appointed Walsh in a 4-2 vote to fill out the remainder of Barto's term, after interviewing four candidates, including Mc-Elroy, during a Jan. 27 special meeting.

However, a special election was called in March, after a petition

H.B. draws from reserves for budget

The Huntington Beach City Council has passed a budget with a listed surplus of \$1.1 million for fiscal year 2025-26, though the city will be dipping into reserves and slashing some programs to do so.

The council unanimously voted to adopt the budget at its June 3 meeting. The fiscal year begins July 1.

Robert Torrez, the city's interim chief financial officer, presented the budget at the meeting. The nearly \$555-million budget includes more than \$298 million in general fund revenues.

Torrez said the budget balancing included the elimination of six positions, including a deputy city manager and senior deputy city attorney, which would save about \$2 million. Nearly \$3 million in ongoing operating expenses will also be cut, including the mobile mental health program Be Well. Laguna Beach also recently decided to scale back its Be Well

Costa Mesa police arrest H.B. man on suspicion of murder

Costa Mesa police have arrested a Huntington Beach man on suspicion of murder, after a woman was discovered last week with multiple gunshot wounds on a sidewalk outside a residential area, officials announced Monday.

With assistance from Costa Mesa Police Department's Special Investigations Unit, officers on Saturday morning located and detained 19-year-old Oscar Saldivar, after executing search warrants in Huntington Beach, according to a CMPD release issued

Monday.

Investigators believe Saldivar is responsible for the fatal shooting of Monserrat Colorado, 20, of Huntington Beach, the night of June 2 at the 1500 block of Costa Mesa's Lukup Lane. Police were called to the scene shortly before 11:15 p.m., where they found Colorado unresponsive.

After multiple attempts to revive Colorado, she was pronounced dead at a nearby hospital. Detectives believed the victim knew her attacker and, according to Monday's release, were led by evidence to the location where Saldivar was ar-

During the execution of the search warrants, officers recovered a firearm. It is unknown whether it is the same gun used to kill Colorado, officials said.

Saldivar on Monday was being held in county jail facing one count of felony murder and a felony sentencing enhancement for using a firearm to cause great bodily injury or death. He is scheduled to appear in court for an arraignment hearing on June 30, court records indicate.

garnered enough signatures to essentially repeal Walsh's appointment. The move is estimated to cost the district between \$444,695 and \$493,802, a sum a district spokeswoman confirmed Tuesday will be covered with general fund reserves.

McElroy and Walsh did not have much time to campaign after submitting papers to the county registrar during a three-day filing period in March.

From there, the two Newport Beach residents had less than three months to communicate their priorities and intentions to 19,076 registered voters residing in the trustee area, which incorporates Newport Elementary, Ensign Intermediate and Newport Harbor High.

Walsh received endorsements from the four NMUSD trustees who appointed her in January — Ashley Anderson, Carol Crane, Leah Ersoylu and Michelle Murphy — along with former Newport Beach Mayor Nancy Gardner.

McElroy was backed by the two trustees opposed to Walsh's appointment, Krista Weigand and Lisa Pearson, along with Barto herself, current Newport Beach Mayor Joe Stapleton, the Republican Party of Orange County and its chair, former Newport Beach Mayor Will O'Neill.

The race became heated last month, when a retired judge who'd reportedly donated to Walsh's campaign but was not active in it released to local media outlets details of several lawsuits filed against McElroy, some for nonpayment of rent and others related to past business enterprises she ran with her ex-husband under the surname Young.

McElroy alleged the leak was part of a "smear" campaign against her, a claim Walsh denied in an inter-

view with the Daily Pilot. Walsh, who on Wednesday was cheering on son Milo at a USRowing Youth National Championship in Florida, did not comment on the results, saying she and her family were waiting

for further election updates

that evening.

McElroy declined to answer questions about the race but thanked her husband, Thom, campaign team and district voters for their support.

"This process has been about giving Area 5 voters the chance to speak, and they have," she said in a message. "Kirstin ran a spirited campaign, and it will be my responsibility to represent our entire community. Time to get to work.'

Despite McElroy's lead, he preliminary results are not final. The Orange County Registrar of Voters estimated Wednesday there were still 3,260 ballots left to process between the school board race and two ballot measures in Huntington Beach, including 2,660 vote-by-mail ballots.



Another part of the budget balancing included withdrawing \$1.5 million from a Section 115 trust, as well as reducing \$4.5 million in general fund transfers to self insurance worker's compensation and general liability funds. Additionally, the budget calls for a transfer of \$2.4 million to the general fund from the Waterfront Loan repay-

Mayor Pro Tem Casey McKeon said he and his colleagues have worked hard every year since being elected in 2022 to turn a budget deficit into a surplus.

"This one was the hardest one — \$8.8 million and we did it," McKeon said. "To touch on the reserves, we used strategic and prudent use of reserve funds, which is what these reserve funds are designed for in situations like this."

But some residents were critical of the portrayal of a balanced budget, especially with more budget deficits

"We are in fiscal crisis, and the way you present things will not change those facts," Ken Inoue

More than half of general fund expenditures go to the police department (32.2%) and fire department (21.6%) combined.

Council members also

discussed hiring additional fire captains, with McKeon moving to add one more administrative fire captain and upgrade the ambulance model from 14 hours to 24 hours.

The department had asked for two additional captains, Councilman Chad Williams said. He then asked why the council couldn't approve the second captain position for special events, calling it a necessity rather than a lux-

ury.
"They wouldn't be asking
""They wouldn't be asking for it if they didn't need it," Williams said. "We have over 1,000 employees in the city, and I can't wrap my mind around the idea that these two fire captains would somehow end up at the very bottom of that bar-

But McKeon said he had talked with officials there.

'They understand that we need to get our revenues up and our expenses down,

and we'll readdress that second captain position later this year," he said. Williams' substitute mo-

tion for two administrative fire captains rather than one failed 5-2, with only Don Kennedy joining Williams in support. McKeon's amended motion for the one captain then passed 6-0-1, with Williams abstaining.

guy grabbed [his] neck, like a big guy."

Those who were executing the raid did not respond to questions from the management, nor did they produce a list containing the names of individuals they were looking for, he added.

Amid a small group of downtrodden employees in the lobby on Wednesday, Romero said the business shut down for the day following the raid and had not opened back up since.

A full team for the car wash consists of about nine or 10 workers during a shift, he said. There were plans for the car wash to resume operations, but the workforce was given time off in the aftermath of the jarring events.

"We have more guys, but the guys now, they say we got to wait two or three days because the guys not in panic, but you know, it's like a little disappointment, that why the rest of the people gone?" Romero said.

A video of the incident was posted to the social media platform TikTok, showing at least one individual led off the premises by the patrol squad. In the clip, the uniformed personnel keep their faces covered, and a customer also pulls his phone out to record the events.

As for whether the car wash has received updates about the whereabouts of its employees, Romero said the families have been in contact with them.

As of Wednesday morning, he had heard that one of the seven workers had released from custody.

"They don't ask any questions," Romero said. "They only grab, grab, grab the guys, take them to the van. They don't give you a chance to speak. They don't have a chance to say, 'Oh, let me see [if] I got my papers.' ... They only grab the guys and take them. No

questions. It's not fair.

"Supposed to be saying, 'Can I see your papers?' No papers, OK, you're not supposed to stay in this country, ... but why he come and take them? ... They don't give you a chance. They want legal guy."

As ICE conducts immigration sweeps in Southern California, the fallout has drawn national attention.

The bishops of the Diocese of Orange issued a statement on Tuesday calling on those involved and affected to "remain calm,

respectful and nonviolent." "Immigration laws have their place in society, as does enforcement of them, particularly to apprehend known criminals." statement read.

"But there is also a place for enforcement that does not invoke our worst instincts, that does not spread crippling fear and anxieties upon the hardworking, everyday faithful among us."

deadlines.

A statement from Protect Huntington Beach Wednesday morning thanked hundreds of volunteers who worked on the Vote Yes campaign.

'The voters in Huntington Beach made it clear that government overreach on the operations of the Huntington Beach Public Libraries was unacceptable," the statement reads, in part. "Our public libraries do matter and voters, across party lines, overwhelmingly said so with their vote. Let us use this opportunity to find ways to work together to hold our elected officials accountable. Thank you, Huntington Beach, for supporting democracy."

The measures were also supported by a group called Our Library Matters.

Proponents of the measures have largely sought no change in the way library operations have been traditionally handled, saying parents deserve the chance to make choices for their children instead of a politically appointed group.

Members of the current council have urged voters to vote "no" on both measures, particularly Chad Williams, a youth pastor who started a Political Ac-Committee against them. They have said the

parent board encourages community involvement and limits sexually explicit or pornographic material, while outsourcing could be considered as a moneysaver for a city that is strapped financially.

Williams posted a message of concession on social media Tuesday night, congratulating the "Yes on A and B" advocates.

"I can sincerely admire how hard you worked and stuck together as a united Williams wrote. front," "Your zeal, tenacity and whatever-it-takes mentality paid off, undeniably, and I can commend that.'

Laura Costelloe, a former

Huntington Beach Community & Library Services commission member, said she considers herself middle-of-the-road politically but advocated for "yes" votes on both measures.

"If a book is deemed inappropriate, we can move it, but why try to deconstruct something that for

100 years has been so beloved by our community?" she said. "I haven't been able to wrap my head around that."

Lindsay Klick, a Huntington Beach resident and Orange County children's librarian, said she felt that council members and other

overplayed their hand during the campaign.

They sort of made clear that this was a religious attack on the library, a politically motivated attack, and it all backfired," she said. "I'm just proud of Huntington Beach parents and busy people for paying atten-

Huntington Beach Councilwoman Gracey Van Der Mark has led the charge on restricting books deemed "obscene." She previously challenged the placement of the book "Gender Queer" in the children's section, though not without a fight from the former library director, she said Wednesday.

"I remain 100% committed to protecting our children from these materials," Van Der Mark said.

But Tru Olson, a Huntington Beach resident who identifies as transgender and voted "yes" on both measures, said they felt personally attacked during the campaign.

"It's just incredibly hurtful to see people in 2025 telling me that I harm children," said Olson, who has lived in Surf City for about four years and in the county for more than two decades.

'I think the city council overstepped their mandate, and I hope that's the message they get, that they need to dial that back."
