Orange County voters weigh recall of Gov. Gavin Newsom

The election is Sept. 14, but more than 1.8 million ballots went out Monday.

More than 1.8 million ballots were mailed out to Orange County voters Monday for the statewide recall election against California Gov. Gavin Newsom.

Election Day is Sept. 14, but voters can drop their ballots in any of dozens of drop boxes at any time. There will also be a number of vote centers that open as the election gets closer, where people can hand in their ballots in person.

Coastal cities vote centers opening on Sept. 4, among 64 throughout the county, include the Huntington Beach Central Library, Murdy Community Center. Costa Mesa Senior Center, Fountain Valley Recreation Center and Newport Beach Civic

Community Center, Golden West College, the Fountain Valley Recreation Center, Coastline College and the Laguna Beach Community Center will all be

open as of Sept. 11.

Orange County Registrar of Voters Neal Kelley said he expects a good turnout, though possibly not the kind of turnout

the county saw in 2003, when Gov. Gray Davis, a Democrat, was recalled and Republican actor Arnold Schwarzenegger was elected to replace him.

"In Orange County back then we had almost 62% turnout for a recall, and that's unheard of," he said. "That was very high. I think we may say in the high 30s or 40s in terms of turnout [this year], but it's hard to predict. We don't know what may happen between now and Election Day."

Polls show the recall election tightening up in recent weeks. Newsom was elected in a landslide in 2018 but has faced criticism from state Republicans about the way he handled the coronavirus pandemic, among other issues.

Voters are asked to answer two questions on the ballot: should Newsom be recalled, and which candidate should succeed Newsom if he is recalled? According to a poll from SurveyUSA re-

Health officials ask for public's help

With a recent surge in COVID-19 cases in O.C., residents are being cautioned to be careful in the weeks to come.

Following a recent rise in the number of COVID-19 infections, Orange County officials are doubling down on their efforts to educate the community on best practices in the fight against the

Dr. Clayton Chau, the director of the Orange County Health Care Agency, made another plea Tuesday to residents to get vaccinated if they have not done so and to do so with haste.

"My message for our fellow Americans is we are privileged," Chau said.

"We live in a society where we have access and we have excess of vaccines, and we have to throw away vaccines that are expired. People in other countries would love to have that, would die to have that, so for the sake of the well-being of our country ... please don't defy it. Get real information. Don't listen to misinformation about the vaccine."

Chau spent roughly an hour Tuesday providing a COVID-19 update for the county, answering questions first from Orange County Supervisor Katrina Foley and then from reporters.

He described the Delta variant as more virulent than earlier variants of the coronavirus that causes COVID-19.

"We noticed that folks who are contracted with the Delta variant, those who are unvaccinated, we notice they quickly get into the hospital, their condition is more severe, hence more risk for them to end up in the ICU than the previous variants.'

Sheriff's team probing South O.C. home break-ins catches suspects in the act in Newport's Back Bay

Two suspects believed to be connected to multiple residenburglaries throughout South Orange County were arrested Saturday, after a sheriff's investigation team probing home break-ins caught them allegedly burglarizing a home in Newport Beach's Back Bay.

Found in possession of more

than \$250,000 in jewelry and stolen items, the individuals attempted to flee the scene in an SUV, colliding with one sheriff's vehicle before taking off on foot into surrounding backyards, officials reported Tuesday.

Sgt. Ryan Anderson, a spokesman for the Orange County Sheriff's Department, said members of a directed enforcement team believe the suspects arrested Saturday may be linked to other burglaries that took place in Laguna Hills, San Juan Capistrano and Rancho Santa Margarita and are investigating whether accomplices

may still be at large.
The incident took place shortly before 9:15 a.m. at a home on the 1600 block of Antigua Way in Newport Beach, where the individuals were interrupted during the alleged commission of a home breakin, Anderson reported.

"The suspects tried to flee in a vehicle," he said. "There was a short pursuit, and the suspects' vehicle actually hit an Orange County Sheriff's vehicle while trying to evade."

After the collision, the sus-

OCC students get support from firm's gift of 50 refurbished laptops

After a year of learning the fundamentals of architecture remotely during the pandemic, a group of students at Orange Coast College was looking forward to getting back to in-person classes in the new school year, but there was just one problem.

Many of them didn't have regular and reliable access to computers or were forced to work from old units that couldn't support the programs they were accustomed to using on campus.

In a discipline that relies heavily on computer-assisted animation and design software, the setback was a serious one.

Hoping to give students a leg up as they returned to campus for the first time in a year and a half, OCC's Architecture Department reached out to the American Institute of Architects' Orange County chapter to see if a local firm might be willing to assist students by donating some muchneeded equipment.

Irvine-based sustainable design architecture firm LPA answered

Working with a grant from its charitable giving arm, the LPA Foundation, a team of 13 firm members secured the necessary computer hardware, parts, batteries and tools and then volunteered their time to refurbish the

Employees removed outdated batteries from decommissioned laptops and installed fresh ones, reset the computers to factory settings and installed the software OCC students would be using in their classes during the 2021-22

school year. The reconditioned laptops were

handed off Thursday during a visit to the Irvine firm.

Orange Coast Architecture Professor Rose Ann Kings said the donation came just in time for students set to start classes on Monday.

"Many currently have either no access to laptops or have laptops that are incapable of running any design programs — these laptops will make a tremendous difference for them," Kings said in an LPA news release Tuesday.

"We are so incredibly grateful for the opportunity to provide so many of them with the technology they need to succeed.

Ozzie Tapia, an associate at LPA, said in the release his firm was honored to help reduce some of the financial burden that would otherwise have been borne by

Laguna Niguel man arrested after leading police pursuit through Laguna Beach

A Laguna Niguel man was arrested Sunday after fleeing police in a pursuit that led Laguna Beach officers from Cress Street all the way to the intersection of Laguna Canyon Road and Canyon Acres Drive.

According to court records, Alexander Tracy, 29, faces several felony and misdemeanor charges including assault with a deadly weapon other than a firearm, unlawful taking of a vehicle, driving under the influence of alcohol causing injury, evading a peace officer, evading a peace officer while driving in opposite direction of lawfully moving traffic, hit-and-run with property damage and driving when the privilege is suspended or revoked.

Tracy pleaded not guilty to all charges Tuesday. Laguna Beach police said they responded to a

reckless driver near Coast Highway and 7th Avenue at 3:38 p.m. on Sunday.

The driver was alleged to be swerving and nearly colliding with other motorists. That driver was later located on Cress Street, where an investigative stop was initiated but failed as the driver didn't

Police then pursued the driver through Laguna Beach, including through portions of the city's downtown.

Eventually, the driver drove outbound on Laguna Canyon Road, but then turned onto Canyon Acres Drive. Stop sticks were deployed, but Tracy drove around them and eventually toward two offi-

The driver then entered the intersection of Laguna Canyon Road and Canyon Acres Drive where he broadsided another vehicle, pushing it into a third

vehicle. Tracy, ordered out of his vehicle by police, allegedly refused to comply and was Tased.

Lt. Jim Cota of the Laguna Beach Police Department said Tracy had been involved in an altercation at his family's residence in Laguna Niguel, after which he allegedly vandalized the property and stole the vehicle he was driving.

The Orange County Sheriff's Department will be seeking charges for vandalism and for theft of the vehicle.

Tracy was previously convicted of assault and battery in May and was sentenced a year of probation and 65 days in jail. Tracy will appear in court at the Harbor Justice Center on Aug. 31 for a probation violation disposition and reset and a pretrial settlement conference.

Huntington Beach man pleads guilty to 2017 fatal hit-and-run

A Huntington Beach man was sentenced Monday to 15 years in state prison after he pleaded guilty to gross vehicular manslaughter while intoxicated in Fountain Valley in 2017.

Justin Scott German initially pleaded not guilty in 2018 to a murder charge and denied a sentencing enhancement that alleged he fled the scene after committing the vehicular manslaughter of Binh Ngo.

In his plea Monday, however, German admitted to fleeing the scene of the crime.

Police alleged at the time

of German's arrest that he was driving a red Ford Mustang north **Brookhurst** Street around 12:50 a.m. on Sept. 13, 2017, when he struck a bicyclist and drove away. Fountain Valley police later found Ngo, 41, between two parked cars and pronounced him dead at the scene.

Broken Mustang parts were discovered in the roadway, leading investigators to put out a notice seeking help in identifying the suspect.

Authorities said that German's family noted significant damage to his car and asked a neighbor — a retired Huntington Beach police officer — for advice about how to contact police after seeing a report about the crash on the news. That neighbor later called authorities. German admitted in po-

lice interviews to having consumed two shots of alcohol and two beers at a bar in Huntington Beach and feeling intoxicated while driving home.

German will next appear in court for a firearms relinquishing hearing at the West Justice Center in Westminster on Aug. 30.



The county on Tuesday reported three deaths due to COVID-19, bringing the countywide death toll due to the pandemic to 5,161.

There were also 668 infections reported to take

the cumulative total of coronavirus cases in the county to 276,632. Hospitalizations climbed

to 549 in the county, with 126 of those patients being treated in intensive care

While county health officials believe the surge in cases may have stabilized, past data suggests that the peak in hospitalizations from the most recent wave has yet to come.

"The hope is that we don't mirror what happened in the winter, and hopefully the vaccinations will dampen the peak of the hospitalizations," Dr. Regina Chinsio-Kwong, deputy health officer for the Orange County Health Care Agency, said.

"That's the goal, but again, the hospitalizations will always delay about anywhere from two weeks to three weeks from the time that our case rates peak.'
