# **County reopens businesses** as it reenters the red tier

For restaurateur Darren Coyle, dining is about providing an experience — through the service of his staff and through the design and architecture of his Newport Beach restaurant, Fable & Spirit.

It's an experience he's glad to be able to provide again now that Orange County has advanced - along with Los Angeles, San Bernardino, Contra Costa, Sonoma, Placer, Mendocino, San Benito, Tuolumne, Siskiyou, Amador, Colusa, Mono, Riverside, Sacramento, Ventura and Santa Barbara counties - in the state's pandemic reopen-

ing guidelines to the red, "substantial" tier. That means restaurants like Coyle's are allowed to reopen indoor dining at 25% ca-

pacity or up to 100 people, whichever number is smaller. It also means indoor gyms and dance studios are allowed to reopen at

# Sewage spill shuts part of bay in Newport

The incident on Monday involving nearly 1,000 gallons of waste is being blamed on "operator error."

A section of Newport Beach waters is closed after nearly 1,000 gallons of sewage spilled Monday, the Orange County Health Care Agency said. An "operator error" caused the spill

during routine maintenance of a sewer main line, the agency said in a news release.

The closure, which is less than a mile long, affects a stretch of bay waters between Bayside Drive Beach and China Cove.

Newport Beach spokesman John Pope said the incident was caused by work crews with the Orange County Sanitation District.

Christine Lane, the director of environmental health at the Orange County Health Care Agency, said the backup occurred just after 1 p.m. at Bayside Drive and Carnation Avenue.

Officials think a piece of equipment was stuck during a routine line cleaning and caused backup and overflow.







# Man held in incident called hate crime

A Costa Mesa man was being held in an Orange County jail Monday on charges of assault with a deadly weapon after allegedly beating a transgender woman with a skateboard during an incident Thursday that prosecutors are calling a hate crime.

The county district attorney's office said in a release issued that Johnny Santos Friday

Moreno, 23, is facing felony charges of assault with a deadly weapon, dissuading a witness by force and violation of civil rights through violent injury, in addition to a felony hate crime enhancement.

Charges stem from an incident Thursday, during which Moreno allegedly hurled derogatory and homophobic epithets at a transgender woman, disparaging her sexuality as he repeatedly hit her with his skateboard,

prosecutors stated in the release.

A passing motorist witnessed the incident and called the Costa Mesa Police Department to report the attack, at which point Moreno allegedly used his skateboard to threaten the motorist for calling the police, according to the release.

Orange County Dist. Atty. Todd Spitzer said in a statement

### H.B. City Council to assess ways to aid outdoor services

The Huntington Beach City Council on Monday night voted unanimously in favor of directing staff to analyze and assess zoning codes and parking requirements, a move aimed at facilitating ongoing outdoor dining and retail operations after the coronavirus pandemic ends.

The agenda item introduced by Mayor Kim Carr noted that the temporary emergency use permits issued during the pandemic have been successful, adding that she has been approached by business owners who have asked if they can continue operating outdoors on private property after

# Huntington's Fletcher the dog a Cadbury Bunny Tryouts finalist

Fletcher, a 2-year-old golden retriever, is a constant source of joy for Huntington Beach resident Ellen Kuhnert and the people in her life.

Kuhnert, the chief nursing officer at Orange County Global Medical Center in Santa Ana, brings her dog to work on Fridays. They call it "Fletcher Friday."

People come into her office to visit with Fletcher. Recently, he's spent time being a cheerful presence for people who are getting their COVID-19 vaccinations.

"[COVID-19] has been psycho-

logically and emotionally and physically so draining," Kuhnert said. "Everybody's so exhausted, so we try to do things to keep each other's spirits up. Having him there is definitely one of those things."

Fletcher was a great comfort to Kuhnert a year ago, when her father, Robert, passed away just as the coronavirus pandemic was beginning.

Kuhnert isn't selfish with her pup, though. As a matter of fact, she hopes he will be on television screens across the country in just davs.

Fletcher is one of 10 national fi-

nalists in this year's Cadbury Bunny Tryouts. He's vying against two other dogs, a cat, an alpaca, a goat, a frog, a horse, a cow and one actual bunny.

Voting runs through Wednesday at 9 p.m. Pacific time at bunnytryouts.cadburyusa.com.

The family of the winning "bunny" will receive \$5,000 and have their pet featured in this year's Cadbury Easter commercial.

The people at Cadbury must have seen something in Fletcher, like most who are around him do.

"He's extremely friendly," Kuhnert said. "He's loving, very sweet but he's got a funny side to him, too. And he's really competitive."

Things have moved fast since Kuhnert, on the advice of a coworker, entered Fletcher into the contest in late February. She submitted a picture of Fletcher wearing bunny ears, relaxing in the backyard of the house she shares with her friend, Luis Tirado.

They found out he was a semifinalist on March 4, and had four days to pull together an audition video to send in.

They decided to put Fletcher behind the wheel of a purple Volkswagen Beetle owned by Tirado's father for the video. The premise was that with everyone using food delivery more during the pandemic, Fletcher could de-



liver Cadbury eggs.

Just two days later, Kuhnert found out that Fletcher was a national finalist among more than 12,000 entries. Now, they're in a campaign for the win. Kuhnert has signs in her yard and at work, as well as at a dog park in her community, encouraging people to vote for Fletcher.

out soon if he wins. "Obviously, we're partial to

him," Kuhnert said. "He's so special to us. We waited a long time to get him, did a lot of research. We put a lot of time in with him with training and everything, because that's the life we want him to have. To think just from a photo, everybody else found that kind of joy that he's brought to our lives? It was emotional, for sure.'

Fletcher, who has an Instagram following at @golden\_boy\_fletcher, clearly works hard and plays hard. Kuhnert has a collection of more than 365 bow ties for him - one for every day of the year — and he wears them depending on mood, situation or holiday.

Since he was young, Fletcher has been taking training classes at Zoom Room in Huntington Beach. He also goes dock diving at The Bone Adventure in Costa Mesa. Fletcher won a silver medal at a competition there in December 2019, with a dive of 19 feet.

Breana Dorame, the pool manager at The Bone Adventure, has known Fletcher since he was a puppy. Kuhnert and Tirado typically take Fletcher and the household's other dog, a border collie named Sydney, dock diving there on Sunday mornings.

Dorame said she was excited to hear that Kuhnert had entered Fletcher in the Cadbury Bunny contest, and even more thrilled that he is a finalist.

"I saw all of the pictures," she said. "He looked so handsome in all of them. It's just so adorable. I wouldn't put it past him to win that. He's just such a good boy, too.'

Kuhnert said winning the contest would be an honor. There is some precedent for one of Fletcher's species to claim the prize: Last year's Cadbury Bunny winner was a two-legged rescue dog from Ohio named Lieutenant Dan.

"It would be great to have everybody see the commercial and feel some love and joy from him," Kuhnert said. "Even if it makes 10 other people happy, it's so worth it."

Owners of local breweries Four Sons, Beachwood, Riip and Flashpoint also sent a letter to the City Council in support of the action.

#### NO CAP ON FOOD **DELIVERY FEES**

Council members voted 4-3 against establishing emergency limitations on third-party food delivery fees during the pandemic. Council members Natalie Moser, Dan Kalmick and Mayor Carr voted in favor, while Mayor Pro Tem Tito Ortiz, and council members Erik Peterson, Barbara Delgleize and Posey voted against the move.

The emergency ordinance, first proposed by Moser on Feb. 1, would have temporarily limited the delivery fees that could be charged by companies like Grubhub, DoorDash and Uber Eats to 15% of the cost of the food, with a 5% nondelivery cap on charges.

The ordinance, aimed at supporting local restaurants, would have needed five votes to pass.

But the majority of the council rejected the premise of it, even as a temporary move.

<sup>4</sup>I get a little bit nervous when the city is dictating how a business is supposed to operate, and that's what this really feels like to me," Delgleize said.

Peterson said he didn't believe the city should be restricting the food delivery services at all, while Posey agreed.

"Government shouldn't be involved in modifying contracts or setting prices, whether it's an emergency or a perceived monopoly,' Posey said.

Friday that differences in skin color, sexuality and religion should be causes for celebration of diversity, not targets for "haters" to mock, deride, harm and harass others.

"No one should have to live in the shadow of fear that they will be targeted and physically attacked because of the way they dress, speak, behave or who they love," Spitzer said in the release. "Those who engage in hate-motivated crimes will be prosecuted to the fullest extent of the law here in Orange County.' Moreno is currently being held at the Theo Lacy Facility in Orange on \$50,000 bail, according to prosecutors. He appeared

before a judge Friday, at which time he pleaded not guilty to the charges against him.

Information as to the condition of the victim or the extent of her injuries was not available Monday.

Court records show Moreno has been convicted of various misdemeanor offenses in recent years, including multiple charges of possession of a controlled substance and paraphernalia, trespassing and refusing to leave an area at an officer's request.

His next scheduled court appearance is March 26,

The city is also assisting the county health agency with additional sampling to ensure the bay is safe for reopening.

The area will remain closed for ocean contact sports until water quality tests show acceptable lev-

els. Ocean waters in Orange County were already under a rain advisory following the light showers that soaked the region Monday.

The rains cause runoff from storm drains, creeks and rivers to seep into the ocean, leading to a sometimes dangerous rise in the ocean's bacteria level.

Orange The County Health Care Agency advises swimmers and surfers to stay out of the water for three days after rainstorms.





ers, Road Runner Sports, off of Newport Boulevard in Costa Mesa, found sales improved during the pandemic as gyms shuttered and people tired of being stuck in their homes began to take up running, according to manager John

he could see the change almost immediately in customers Sunday once the transition was official.

"You could see people willing to come out," said Calderon on Monday. "You could feel they were excited to come out. That gives people encouragement to be able to go out and feel safer.'

He said, at least for himself, that he feels a little more at ease about opening with the knowledge that he and his employees are now eligible to receive the vaccine and that customers are more aware of the safety precautions necessary, such as wearing masks, as compared to when Orange County was last in the red tier.

Calderon said sales revenue for Taco Rosa is down between 45% to 50%, and he feels at least part of the reason is because customers couldn't come inside or were afraid to dine out. At the more casual Taco Mesa, which Calderon also operates, sales are down about 20%.

Calderon said he feels that if revenue is able to stay steady or increase that his businesses will stay afloat, but he knows there are plenty of other restaurants that haven't made it.

For Costa Mesa resident Ryan Jensen, Orange County's shift to the less restrictive red tier means he can finally enjoy a full workout at 24-Hour Fitness, where he's been a member for the past 20 years.

Jensen, 41, usually works out about four or five times each week but has found it harder to maintain his exercise regimen during the pandemic. When outdoor workouts became sanctioned by the state, he looked to locations in Santa Ana and Irvine, which had limited offerings. It hasn't been the same.

"It was better than nothing," he said. "But you were
