# 'Democracy in action' as petitions delivered in H.B.

Concerned Huntington Beach residents delivered more than 19,300 signatures against a controversial parent/guardian children's book review board to City Hall on Monday.

The volunteers gathered at a residence in Huntington Beach, taking 20 boxes of signed petitions to the trunks of two waiting cars. The petitions were headed to be reviewed by the city clerk.

Protect Huntington Beach co-founder Cathey Ryder said her organization has been asking residents to sign petitions for months. More than 19,000 signatures have been collected since April in an effort to repeal a Huntington Beach ordinance that establishes a parent/guardian review board for children's books at the library.

The conservative council majority in April finalized approval of Ordinance No. 4318, which formed the board that would have a final decision on which new children's books would be allowed in the public library.

"This is democracy in action," Ryder said after several people, including minority Huntington Beach City Council members Dan Kalmick, Natalie Moser and Rhonda Bolton and state Sen. Dave Min, helped with carrying the boxes to the cars. "This is what the United States is about. This is why we live

Monday was the six-month deadline to collect signatures on the petitions. The group needed to collect 13,247 verified signatures —

# Political mailers cause dustup in N.B.

Mayor Will O'Neill says fliers appear to show his endorsement, but Jeff Herdman says it's a mistaken interpretation.

Newport Beach Mayor Will O'Neill claimed his name and image were used to deceive voters into thinking that he supported former Councilman Jeff Herdman's campaign for City Council.

man's campaign for City Council.

In a letter distributed to local news outlets and published on Facebook Oct. 15, O'Neill referred to two fliers that were mailed to voters by Herdman's campaign. One includes a photo showing Herdman and O'Neill as well members of the City Council and Chamber of Commerce in front of the Balboa Island Museum. The picture was shot at an event recognizing the work of the museum's founder, Shirley Pepys, and accompanied by a caption reading "Preserving our city's special heritage."

heritage."

"If Mayor O'Neill chose to interpret that picture as an endorsement of me, that's unfortunate," Herdman told the Daily Pilot over the phone Tuesday. "That's his interpretation. I have certainly not sought his endorsement and would not seek his endorsement."

O'Neill is not seeking reelection. He accused Herdman of trying to "use the good will that I have in this community for his benefit" in his published letter. He went on to explicitly reiterate his endorsement of Herdman's

# Backed by court, O.C. fairground officials give horse boarders a deadline to leave

Equestrians who've refused to sign a new contract can either leave today or pay through Dec. 31, at which point they must leave the facility for good.

A judge Friday ruled Orange County fairgrounds operators may forcefully remove occupants refusing to sign new contracts and rent hikes therein — at the center's Equestrian Center as it undergoes rebranding into the more publicly facing Ranch

Community Center.

Now, officials with the OC Fair & Event Center are giving the holdout equestrians until today to pack up and leave, and pay all back due rent since June 15, or to

sign on for an extended stay through Dec. 31, at which time they must ride off into the sunset

for good.

The warning, signed by the Ranch Community Center, was issued Saturday to 10 renters on behalf of the center's board of directors, asking recipients to indicate their preferred removal sce-

"It is very unfortunate that it's come to this, after multiple attempts to seek compliance," OCFEC Chief Executive Michele Richards said Monday. "[But] we cannot allow public assets to be paid for by public money when they're being used by private businesses and private individuals."

Tensions between the equestrians and the Event Center, acting as California's 32nd Agricul-

## Ruling denies appeal in Surf City's housing mandates battle

U.S. 9th Circuit Court of Appeals panel issued its ruling Wednesday, stating charter cities are subordinate political bodies and not sovereign entities.

The U.S. 9th Circuit Court of Appeals ruled Wednesday against Huntington Beach in its ongoing fight against state housing mandates.

Huntington Beach's conservative City Council majority voted to sue the state in March 2023 over its state-mandated Regional Housing Needs Allocation requirement to zone for 13,368 new units in the current cycle, including a percentage of low-income housing. Huntington Beach City Atty. Michael Gates said at the time that state mandates could not have preemptive power over Surf City's authority as a charter city.

The state filed a motion to dismiss Huntington Beach's federal lawsuit and U.S. District Judge Fred Slaughter in November 2023

granted that motion, ruling that the city lacked standing based on 9th Circuit precedent, citing City of S. Lake Tahoe vs. California Tahoe Reg'l Plan. Agency.

At the time that ruling was made, Gates said he disagreed with the judge, noting that South Lake Tahoe is a general law city, not a charter city like Huntington Beach.

During his appeal before the 9th Circuit panel last week, Gates presented the same argument, but the judges were openly skeptical.

In Wednesday's two-page decision, Judges Richard Tallman, Ryan Nelson and Daniel Bress stated that "no matter how California categorizes charter cities, they remain subordinate political bodies, not sovereign entities."

tural District Assn., came to a head in late August, when two groups that board horses and run nonprofit programs at the Costa Mesa facility filed a lawsuit against the agency after months of trying to meet collectively with OCFEC officials.

Plaintiffs Lisa Sabo, coowner of equine therapy nonprofit Changing Strides, and OC Equestrian Vaulting founder Gibran Stout, allege fairgrounds operators imposed steep security deposits and phased rent hikes, amounting to a 52% increase by January 2025, but failed to define areas and activities covered by the agreement or assure training programs and lessons could continue.

Edits to the contract were rejected by the center's chief executive, Michele Richards, and checks for rent bearing the original amount, similarly rejected, are being held in an escrow account. Horse boarders say they filed the suit as a last resort, hoping to prompt a discussion.

"OCFEC has refused to negotiate this version of the rental agreement," their complaint states. "All tenants who have held over and not signed the new rental agreement have been illegally locked out of the arenas at the OC Equestrian Center."

Though equestrians sought a temporary restraining order to bar the center from taking action against them and other holdouts while the lawsuit was ongoing, presiding Orange County Superior Court Judge Sheila Recio denied the request. She determined the OC

Fair & Event Center would be within its legal right to restrict use at, and even forcefully dislodge tenants from, the 7.5-acre site. Recio considered the

likelihood equestrians' overall legal claims would prevail in court, a matter that came down to whether the agreement between the two parties was, effectively, a lease or licensing of the

property.

The former, she argued through the citation of precedent, gives lessees "exclusive possession of the premises against all the world, including the owner." A license, however, "merely confers a privilege to occupy under the owner."

Recio also weighed the harm equestrians would face, were an injunction not granted, versus the harm OCFEC would face if it were granted. She determined that, short of conveying hearsay about a rider injured by an improperly exercised equine, the plaintiffs did not provide enough evidence of harm.

Richards, who said her organization, as a state agency, is represented by a legal team from the state attorney general's office, explained the ruling gives OC Fair & Event Center the right to take possession of the equestrians' sessions, including the horses, if boarders do not leave by today or pay to stay until Dec. 31.

She emphasized animals would be kept and cared for on site and not relocated from the property.

"We are an agricultural association of the state of California, and we have animals in our care and ownership all over the property," Richards said. "We would never, ever put an animal in danger."

Costa Mesa resident Macki Hamblin, a dressage trainer and owner of Connected Equine, has boarded

horses at the Costa Mesa facility for the past two years. She did not sign onto a new contract, in hopes the two parties could sit down and reach an agreement over new terms and how equestrians and their wards could play a role at the Ranch.

"I will continue reaching out with that olive branch — I want to be a part of, and help create, that vision they have," Hamblin said. "But it does seem very onesided. You send correspondence in and don't hear anything back. It just seems unfortunate. Where does that disconnect come from? It hurts.'

Anna McLean, an attorney with the law firm Sheppard, Mullin, Richter & Hampton representing the equestrians, on Monday confirmed an appeal would be filed within the court's 60-day window.

"The court's order did not address a number of our clients' other arguments that's one of the things we'll be bringing up on appeal," she said. "We'll also be exploring other options for interim relief in response to actions the [OCFEC] Board has indicated it will take."

Hamblin said Wednesday she hadn't yet decided what to do about today's deadline.

"I do want to have a conversation and mend any bridges or misunderstandings," she said. "I'm still hopeful for a third option."

### Newport Harbor set for semifinals

The Newport Harbor High girls' flag football team probably did not expect to be down in the final two minutes of the first CIF Southern Section playoff game in program history.

Yet that was where the Sailors found themselves Saturday against visiting Camarillo. It took a fourthdown touchdown pass from senior quarterback Maia Helmar to freshman Skylie Cid for No. 2-seeded Newport Harbor to pull out a 19-14 win in its playoff opener.

Three days later, the Sailors returned to Davidson Field to host Goleta Dos Pueblos in a quarterfinal match.

A more complete effort ensued.

Helmar threw four touchdown passes and was one of four Newport Harbor players with an interception.

The result was a 33-14 win, moving the Sailors (24-2) into the semifinals on Saturday after recording their 23rd straight win.

A familiar Sunset League opponent waits there in Huntington Beach (21-7). The Oilers won 35-20 at Ventura on Tuesday in another quarterfinal match.

Huntington Beach will host the semifinal showdown on Saturday at 5 p.m. The Sailors already have

three wins over the Oilers this year, all by at least two touchdowns, though Newport Harbor coach Jason Guyser said he knows how tough it is to beat a good team four times in the same season.

Sunset League champion Newport Harbor is also tough to beat when it's operating like it did Tuesday on offense and defense.

After Helmar had two flag pulls to force a Dos Pueblos three-and-out on the opening drive, the Sailors drove down the field. Helmar pitched the ball to Cid on an option play, and she scored from 9 yards out, with the conversion pass to senior Audrey Burns also successful.

Dos Pueblos, the Chan-League runner-up, pulled even on its second drive after converting a pair of fourth downs. Senior quarterback Liliana Rodriguez found Sterling Streitfield on a short pass in the middle of the field, and the referee ruled she was in the end zone despite the flag pull and protest of Burns.

But Helmar found Burns on a 38-yard bomb down the right side to give the lead back to the Sailors, with the extra-point pass going to junior Cooper

On defense, Sailors sophomore Ashlyn Spicer came up with an interception to start the Chargers' next drive. The short field turned into points, as Helmar found Dick over the middle on a 1-yard score that gave the hosts a 20-7 halftime

The Sailors pulled away in the second half. Helmar's 5-yard touchdown pass to Cid was followed by Burns' second scoring grab of the day. That gave Newport Harbor a 33-7 lead, before Dos Pueblos closed out the scoring in the final two minutes.

They also ruled that the city and City Atty. Michael Gates did not have standing to sue in federal court, echoing the initial ruling last year by the district court judge.

'We are not persuaded by the city's efforts to differentiate South Lake Tahoe," the ruling reads. "The city argues that our standing bar does not apply because Huntington Beach is a charter city, which it claims is not a 'political subdivision.' Yet our precedent has applied South Lake Tahoe's standing rule to California's charter cities."

California Atty. Gen. Rob Bonta praised the decision in a statement Wednesday.

"While the city has been wasting the public's time and money pursuing this meritless lawsuit, its neighboring communities along with every Californian struggling to keep a roof over their heads or wondering where they're going to sleep tonight need Huntington Beach to step up and adopt a housing plan without further delay," Bonta said. "My office will continue pursuing all remedies in the state case against the city, where the court has already determined the city violated the housing element

The related state lawsuit against the city is also in appellate court, in San Di-

ego.
"Today, yet another court has slapped down Huntington Beach's cynical attempt to prevent the state from enforcing our housing laws," Gov. Gavin Newsom said in a statement. "Huntington Beach officials' continued efforts to advance

plainly unlawful NIMBY policies are failing their own citizens — by wasting time and taxpayer dollars that could be used to create much-needed housing. No more excuses — every city must follow state law and do its part to build more housing."

Gates said Wednesday that he wasn't surprised by the decision based on how the hearing went, though he obviously disagreed.

"There are almost innumerable number of California court decisions that hold that charter cities are not political subdivisions," he said. "It's really a misapprehension of the law and a misapplication of the law, so for that reason, we obviously have recourse."

He said the city could next petition for "en banc' (full panel) review or could try to take the case to the U.S. Supreme Court if that review is denied.

10% of registered Huntington Beach voters — in order to trigger a special election early next year and let the voters decide on the fate of the yet-to-be-formed children's book review board, which would feature up to 21 members appointed by the council.

The newly seated City Council, which will be determined in the Nov. 5 election, could also approve the petition outright or ask for a 30-day financial overview before placing it on the ballot, Kalmick said.

Ryder said Protect HB has been verifying that signers are registered to vote, are Huntington Beach residents and that their names match their voter registration, so the group is very optimistic that it has cleared the 10% threshold. After the signatures are finalized by the Orange County Registrar of Voters, a "Vote Yes" campaign for the special election will begin, Ryder said, though verification is not expected to happen until early December after the general election results are verified.

Protect HB teamed with the Bookloose initiative, also based in Huntington Beach, on the effort. Ryder said more than 360 volunteers have made phone calls, protested on Main Street or stood in front of a grocery store collecting sig-

"We have independents, we have Republicans, we have Democrats who have supported us," she said. "We don't believe this is a partisan issue. For me, it's about giving citizens a chance to vote on an important issue like this. Should we vote on every single thing the City Council does? No ... but a decision like this should not be decided by four people. It's too big.'

Kalmick helped draft the petition language.

"This would not have happened without a groundswell of residents who didn't see anything wrong with the library, and

injected in the library," he said. "If this makes its way to the ballot, you'll see a groundswell of folks coming out to protect the libraries."

**Huntington Beach Mayor** Gracey Van Der Mark, part of the conservative majority, pushed back on Monday. She noted that no books have been removed from the library, though some have been recatalogued.

Books are being relocated," she said. "Librarians move books all the time. I used to work in a library. I used to relocate books all the time. I wasn't considered a professional bookbanner. Yet, if a book is teaching children how to masturbate and we say, 'Let's just move that to the adult section,' they consider it a book ban?'

Some against the parent/ guardian review board have said that since it would be able to stop children's books from entering the library, that does amount to a ban.

Van Der Mark, however, argued that librarians shouldn't have the ultimate power to make decisions on content.

"Does her piece of paper, her degree, make it OK for her to reject the books?" she said. "But if us parents reject one, we're banners. That's actually pretty insulting, to say, 'Well, you don't have a library degree, so you're not worthy of reviewing a book.' That's insulting to moms and dads."

Assembly Bill 1825, authored by Assemblymember Al Muratsuchi (D-Torrance) and co-authored by Min (D-Irvine), was signed into state law by Gov. Gavin Newsom on Sept. 29. Also

called the "California Freedom to Read Act," it would seem to make Huntington Beach's parent/guardian review board a moot point.

The bill stops library boards from making policies to ban or limit circulation of books because of the views, ideas or opinions in them, or because they contain sexual content.

But Huntington Beach City Atty. Michael Gates has indicated that the city will fight the law, claiming it is unconstitutional.

"I've got three kids," Min said Monday. "When I take them to the library, or when I see them check out books from the library, I look at them. I'm a parent. There are books out there that some parents may not want to have their kids have access to, that I do. They shouldn't get to determine, because of their own beliefs, what the rest of us get access to. If they are that concerned that their kids have a narrow worldview and are not exposed to anything, then they should be more involved as parents."

Meanwhile, another petition related to the library continues collecting signatures of Huntington Beach voters. This one seeks to stop possible outsourcing of library operations in the future.

In June, private company Library Systems & Services pulled its bid to manage the city's library system, a day before the City Council was set to vote on that bid.

The deadline for signatures for the second petition is Nov. 25. Ryder said Monday that it already has about 13,000 to 14,000 signatures.

opponent, District 5 incumbent Noah Blom.

Another mailer attributed to Herdman's campaign and described as deceptive by the mayor includes the statement: "I agree with Mayor Will O'Niel [sic] that there should be an election so that residents can vote on the housing plan!"

Herdman and O'Neill previously sat on council together, from 2016 to 2020. In recent months, they have been on opposing sides of discussions regarding the city's housing element.

The City Council passed a raft of ordinances required to implement the housing element on July 23, bypassing a provision in the city's charter requiring Newport Beach residents to approve land use decisions that may significantly increase development. Herdman was among over a dozen members of the community at that meeting

 including other former council members and people who were part of the committee that helped develop the zoning plan who spoke out against it and called on the city to bring the issue to voters.

'That's the whole reason I'm running for City Council," Herdman said. "The council, on July 23, took our right to vote away on our housing element."

During that meeting, O'Neill went into detail about the years of public outreach and planning that went into developing the housing element, noting that many now against it had a hand in putting it together. He and other council members said the city needed to implement the plan to stay in compliance with California housing laws and prevent state officials from asserting authority over local zoning. He also attempted to counter specific claims made by speakers during public comment.

However, O'Neill was the only council member to abstain from voting on the housing element-related ordinances. In an interview with Stu News, he explained that he believed city charter section "423 requires a vote." That appears to validate Herdman's claim that they agree on at least one aspect of the issue, even if their opinions on the right course of action for Newport Beach conflict.
