# **Memorial honors bicyclist** killed in N.B. hit-and-run

#### **BY ERIC LICAS**

Randy Cintron launched his bicycle over berms and sent dirt flying as he slid around corners during a trip to the Big Bear area in August. His longtime friend, Cory McDougal, was following him in an ATV and recalled barely being able to keep up with him.

"He had to be the fiercest rider out of all of us in our group of friends," McDougal said.

The 43-year-old Costa Mesa resident rode every day and occasionally used apps to share live updates tracking his route. til GPS data showed him diverge from the path and begin traveling on a freeway a little after 8:30 a.m.

That's around the time the avid cyclist was struck by a vehicle Jamboree Road and near Bayview Way. The app he was using continued broadcasting his location to his followers as paramedics loaded him into an ambulance and rushed him by freeway to a hospital. He died later that day, McDougal said.

Those who knew Cintron as a man near the peak of his health could hardly contain their disbelief, McDougal said. But some took comfort in knowing he was See Bicyclist, page A2



# Body found at Surfside Beach ID'd

Moustafa Osama Gamil, 32, was found dead five days after another man's body was found near the Newport Beach Pier.

A man whose body was discovered Thursday on Surfside Beach has been identified by officials with the Orange County coroner's office as an individual with ties to Egypt, a sheriff's department spokesman confirmed Monday.

Sgt. Scott Steinle said the decedent was 32-year-old Moustafa Osama Gamil, whose current city of residence could not be determined. The coroner's office contacted the U.S. Consulate General to locate and notify his next of kin, who live in Egypt.

Gamil's body was found Thurs-day shortly before 6 p.m. on the shoreline of Surfside Beach adjacent to Surfside Colony by a resident out for an evening stroll, according to a news release issued Friday by the Seal Beach Police Department.

Police detectives were joined at

## **ISA WORLD SURFING GAMES** Women's events heat up at ISA World Surfing Games

The women's open heats started Monday at the International Surfing Assn. World Surfing Games on the south side of the Huntington Beach Pier.

It's a place where Sophie Mc-Cullough of Australia found success earlier this summer.

McCullough was a semifinalist at the U.S. Open of Surfing. She also had the highest heat total of the day Monday at the ISA World Surfing Games, a massive 16.43 in the second round.

Surfing is largely an individual sport; this is the first time McCullough has represented her country since the 2015 ISA World Juniors.

"When I got asked to come away with Team Australia it was a bit of a no-brainer for me," she said. "We've got a really good vibe going and I'm honored to be a part of it."

The women got through the

third round of the main event and the second round of repechage Tuesday. The repechage, similar to a "loser's bracket" in other sports, give surfers who lose in the main event a second chance to reach the final, albeit via a much longer road.

McCullough placed second in her third-round heat Tuesday, advancing to round four of the main draw. Repechage heats are planned all day on Wednesday, for both the men and women.

The event runs through the finals on Saturday morning, with the men's and women's team champions each earning an Olympics qualification spot for their country.

That spot is in addition to the maximum of two athletes per country, per gender, for the Paris Olympics in 2024.

Another woman who easily advanced Tuesday was Gabriela

# Environmentalists band together on National Cleanup Day

Coastal cleanup efforts began bright and early on Saturday morning, as environmentally focused groups and individuals worked to make a difference locally over the weekend.

National Cleanup Day, the third Saturday of September, saw groups such as Orange County Coastkeeper, O.C. Habitats, and even high school students who have developed a passion for protecting the planet, work under a common goal to clean up their communities.

Amanda and Joe Vlietstra, a couple from Upland, showed their dedication to the process of beach cleanup, sifting through the Huntington Beach sands on their hands and knees — to find "micro-trash" lying beneath the surface near the fire pits.

"This is what haunts me, is the micro-trash, the microplastic," Amanda Vliet-stra said. "This stuff gets back in the ocean. A fish isn't going to eat a disposable diaper. They're going to eat tiny shards of plastic. ... I get the corners of energy bar packages. It's

micro-trash. It's just something that you dig down a couple of inches, and there it is. I can just scan my hands and I'll find things."

Kayla Pierce, 17, arrived at Huntington Beach with several students at 8 a.m. with plans to participate in beach cleanup until noon. Kayla, who identified herself as president of the Surfrider Club at Sunny Hills High, said members of the school's Eco Club were participating in similar activities.

The sheer number of people contributing to the coastal cleanup effort seemed to act as a force coastal multiplier, Kayla added.

"We don't have a lot of trash, but I think collectively because there's so many people out here doing it, every little bit helps," Kayla said. "Even just walking around here, we were struggling to find trash, which is very rare because beaches are full of trash, but because there's so many people here right now - working and volunteering and helping out the community. It's nice to know that it is hard to find trash."

Kayla, a senior at Sunny said the Surfrider Hills,

Club at her school came into being during the coronavirus pandemic, and she commented that being a club officer makes her more self-aware of the impact her choices have.

Erika Moe of Irvine was participating in trash pickup in the Talbert Marsh wetlands. She figured out a way to volunteer when she happened upon a flier while on a walk in Newport Back Bay. She vouched for volunteering as a way for people to try something new and see if it sparks their interest.

"I'm just trying it out, seeing if I want to move into this space, maybe work in conservancy and try to just get over in this area," Moe said. "I also just like being outdoors in the morning. This is kind of my favorite time of day, so I thought kind of why not?

"The best way to get into that area, too, and see if I like it is probably volunteering, because you don't have to totally commit, but it also gives you a good feel for what the environment is like."

Moe said the volunteers were simply looking for items that did not belong in the marsh. Most of what

she had found during her pickup was plastics, she said, but there were also a phone case and a jacket left behind.

The California Coastal Commission and Caltrans also organized a "Trash-Free Jubilee" event, which called on Orange County volunteers to assist with

cleanup efforts along Huntington Beach near Brookhurst Street.

"The California Coastal Commission's Coastal Cleanup Day and Caltrans' 'Let's Change This to That' storm-water public education campaign are collaborating to create even more awareness to help reduce

litter and water pollution," Caltrans director Tony Tavares said in a statement. "We're asking people to join us this month to clean up the waterways and beaches that belong to us all."

the scene by lifeguards with the Seal Beach Marine Safety division, the coroner's office and the Orange County Authority. Fire SBPD spokesman Sgt. Nick Nicholas said Friday the body did not appear to have sustained any apparent signs of trauma.

Steinle said coroner's officials confirmed Monday there was no clear evidence indicate Gamil died to under suspicious circumstances.

"It appears to be an accidental drowning at this time," he said, adding that an autopsy was being conducted on the body and would conclude in the next day or two.

#### NAME RELEASED **ON NEWPORT BEACH** INCIDENT

The Surfside Beach incident occurred just five days after the body of another adult male was seen floating in the water near the Newport Beach Pier. Sheriff's officials identified the remains as belonging to S. Lee Short, 86, of Newport Beach. Details on that incident were not immediately available Monday. Steinle said the coroner's office was still investigating the possible cause of death and whether Short's age may have been a factor.

doing something he was passionate about when he died

"Although it doesn't erase the pain of losing someone who was so kind and so humble far sooner than we should have, there is some small comfort in knowing he was doing what he loved," Cintron's friend, Randy Canino, said.

Dozens of Cintron's friends and relatives gathered Sunday along Bayview Trail, one week after he died. A pair of bystanders who attempted to care for him before paramedics arrived on the day of the crash were also in attendance to pay their respects, Canino said.

Some wept and held each other as they placed flowers, candles and photos next to a small wooden cross. A bicycle that had been spray-painted white, known as a ghost bike, was also left at the makeshift memorial to mark the scene of the crash. The display will remain for about three weeks so that mourners can have an opportunity to honor Cintron's memory.

The driver of the vehicle involved in the crash was arrested the day of the crash and identified as a 36-year-old Anaheim woman. She has since been charged with murder and felony hit-and run.

"We want justice to be served because this was a good man," Canino said.

Cintron graduated from Cal Poly Pomona with an engineering degree, Mc-Dougal said. He worked on systems for use in submarines, aircraft and satellites.

# Edison snags big win over San Clemente

SAN CLEMENTE — The Edison High football defense was swarming all game long.

The Chargers recovered two fumbles and also stopped two San Clemente fourth-and-one attempts.

With the Tritons trying to drive and score the goahead touchdown on Friday night, Edison once again denied the hosts.

The result was a hardfought 21-16 nonleague victory for the Chargers, who stayed unbeaten at 5-0 headed into their bye week, and handed the Tritons (4-1) their first loss of the season.

This is Edison's first 5-0 start since the 2009 team, which had an undefeated regular season and advanced to the Pac-5 Division championship game.

"I just feel like, defensively, that was Edison football," Edison coach Jeff



was a team effort, it was 11 guys ... To me, that's always the sign of a good Edison team, when it's great team defense and team offense.'

Edison had to hang on after taking a 21-9 advantage late in the third quarter, when senior quarterback Parker Awad connected with receiver Ashton Hurley on a 60-yard touchdown pass over the middle. It was the second scoring play of the game

between Awad and Hurley, who now has seven touchdown grabs this season.

After Edison's passing game struggled in the first half, Awad had seven straight completions to start the second half.

"He was delivering left and right, shots all the way down the field," Hurley said. "That money ball to me all the way down the field was the most perfect pass I've ever seen. I saw the defense shift to cover

one, so I saw the guy roll up on me. I knew I had him beat if I could make a move around him. It was just me against him, and I felt like I could win that battle. I took it, and Parker delivered a great ball. Great protection as well.'

San Clemente pulled closer when Tritons junior quarterback Broderick Redden scored on his second one-yard keeper of the game, pulling his team within five points with 7:30 remaining in the game. San Clemente got a

standout night from senior running back Blake Allen, who had 25 carries for 168 yards. But the Chargers were able to limit his big plays for the most part, though he did get free for a 42-yard scamper on the final Tritons scoring drive and also had carries of 24 and 18 yards.

"Our plan this week was to stop that run," said Edison senior defensive end Jake Giles, who recorded 2 1/2 quarterback sacks. "We knew this was going to be a defensive battle. Everybody on our defense knew that we were about to play as physical as possible.

Édison had to punt the ball back to San Clemente late, then a muffed punt by Edison gave the ball back to the Tritons. But three plays later, Edison's Jackson Irwin poked the ball free behind as Redden from to scramble, and tried teammate Logan Gregory recovered at the Edison 32yard line with 1:49 left in the game.

Chargers went The three-and-out, though they did force San Clemente coach Jaime Ortiz to burn all three of his timeouts.

Needing a touchdown,

the Tritons got the ball back on their own 34-yard line with 1:24 left. They converted a fourth down near midfield on Redden's pass to Thomas Hartanov. Two plays later, Mason York's tackle of Redden ap peared to cause a fumble that Gregory recovered, but it was ruled an incomplete pass On fourth-and-15 at the

Edison 42-yard line, a pass to Mason Ord in the closing seconds came up short of the first-down marker, and the Chargers had secured the win.

Both teams scored a season-low point total in the defensive struggle.

"We found a way to get it done," Grady said. "Sometimes it feels like holy smokes, you know, we're just trying to give it away. But obviously, that's not the case. We just kept playing."

Carter Hogue had 94 yards rushing and a touchdown for Edison.

Defensively, the Chargers also got sacks from Irwin and Dylan Walters, while Irwin, Gregory and Malachi Pierce all had tackles for a loss.

Tucker Tripp stepped up to stuff an Allen fourthand-one run early in the fourth quarter, as the play ended up as a two-yard loss. Hurley recovered a Clemente red-zone San fumble in the second quarter on another key play.

Edison returns from its bye week on Sept. 30, with a Sunset League opener against Huntington Beach at Cap Sheue Field.

"We feel real good to go into Sunset League undefeated," Giles said. "We're ready to go undefeated again [in league] and put up a great game against Los Al.'

# WOODBRIDGE CLASSIC Locals clock in fast times at Woodbridge Classic

IRVINE — Distance runners from all over the nation have chased fast times under the lights at the Woodbridge Classic for Woodbridge decades.

The flat terrain and cool evening temperatures often leads to many competitors posting personal-best performances, but the manner in which Newport Harbor senior Kenny Wanlass managed to do so left him grateful beyond measure.

Wanlass ran 14 minutes, 21.9 seconds to shatter his personal record by 50 seconds, netting a top-25 fin-ish in the Doug Speck's boys' sweepstakes race of the 41st Woodbridge Classic on Friday night at the Great Park in Irvine.

Once he finished traversing the course, which was largely laid out over the venue's soccer fields, Wanlass was pulled into a bear hug by Chett Clark, a former teammate who graduated from Newport Harbor in 2021.

"It means a lot to me because those guys, like Chett, all those other guys who were on varsity when I was an underclassman, they kind of inspired me," Wanlass said. "They gave me that mentality of 'work

hard, expect nothing, and set yourself up for everything.

"I think I owe a ton to them for really inspiring me and instilling that value in me."

Wanlass, who last year won the Surf League title, ran in the sweepstakes race as an individual.

Benjamin Prado, another prime competitor within the Sunset Conference, had designs on breaking the Fountain Valley school record for a three-mile race. The Barons competed as a team in the boys' rated race, finishing 20th in a

field of 40 teams. A senior standout who laid claim to the Wave League title last season, Prado crossed the finish line in 14:45.8 (14th), but it left him three seconds shy of the school mark set by David Abraham (14:42 at the Dana Hills Invitational in 2013).

The Dana Hills Invitational, which incorporates downhill running as the competitors enter the stadium for the concluding 600 meters, will take place on Saturday, Sept. 24.

"It definitely makes it a

lot faster," Prado said of the downhill trek at Dana Hills. "I think I can probably go under 14:30 if I'm feeling good."

Alonso (15:21.1, Diego Ethan Kwong 65th), (15:57.4, 140th), Andrew Hsieh (16:00.5, 147th) and Luke Dias (16:20.6, 191st) also contributed to the team score for Fountain Valley.

Huntington Beach placed 19th out of 28 teams in the Bob Day's girls' sweepstakes race, led by a lifetime-best performance from Makenzie McRae, who knocked 31 seconds off her personal record in finishing 34th with a time of 16:51.5.

"I was definitely excited because I knew it was going to be a competitive field, so I was counting on this race to break my [personal record], just because the course is so flat and there are so many girls that I could run with that can push me," McRae said. "I was definitely excited to go into a competitive race like this."

Luna Centeno (18:21.6, 134th), Belle Baker (18:35.4, 145th), Devyn Durbin (18:36.2, 146th) and Emma Siok (19:01.8, 164th) completed the scoring quintet for the Oilers.
