Local cities focus on beaches as Fourth of July approaches

Newport Beach will close beaches from 10 p.m. Friday to 6 a.m. Sunday. Huntington Beach will also close its parking and pier in addition to its beaches.

Newport Beach is putting its beaches under hard closure on the Fourth of July after two lifeguards have tested positive for COVID-19

And with such a large neighbor shutting down, Huntington Beach will follow suit.

Newport Fire Chief Jeff Boyles said his lifeguard division has adequate staffing to absorb the lifeguards who are out of commission, but the remaining guards would be "stretched pretty thin." Newport's beaches will be shut down from 10 p.m. Friday to 6 a.m. Sunday.

Twenty-three of the lifeguards' colleagues are in quarantine. One of them is showing symptoms of COVID-19 and hasn't been tested yet.

"I cannot in good conscience add more onto our lifeguards," Mayor Will O'Neill said at an emergency City Council meeting Wednesday approving the closure. "We just can't responsibly ask our lifeguards to do more with less. We just can't."

The closure adds Newport to Los Angeles County, Ventura County and the cities of Laguna Beach and Seal Beach in locking

The Laguna Beach City Council votes unanimously to close the beach on July 4, but to also give the city manager the discretion to close on July 3 and 5.

Laguna Beach is closing its beaches for the Fourth of July.

The Laguna Beach City Council voted unanimously to close its beaches on Saturday, but it also gave direction to City Manager John Pietig to have the discretion to close city beaches on Friday and Sunday if it is determined necessary to protect public health. The city also canceled this year's annual fireworks show in May in response to concerns about COVID-19.

"I think that there are two extremes," Mayor Pro Tem Steve Dicterow said in early discussions on the subject of potential beach closures, adding that he saw people respecting social distancing on Main Beach on Tuesday, but that he also saw what the beach looked like during last year's Fourth of July.

"This is not the restaurants and bars. This is just the beach. And particularly on the Fourth of July, when there were fireworks, Heisler Park, Main Beach — it looked like sardines in a can," Dicterow said. "There was no space between people. Those are the two extremes. My concern is that even without fireworks, there

O.C. businesses adjust, again, after Newsom calls for 3-week closure of indoor dining, bars

Hoping to curb coronavirus infections heading into the Fourth of July weekend, Gov. Gavin Newsom on Wednesday called for the closure of indoor restaurant dining rooms and all bars for at least three weeks in key parts of the state, including Orange County.

The governor said the closures would apply to 19 counties across California being monitored by the state for recent surges in coronavirus infections and hospitalizations.

In Orange County, health officials Wednesday reported 570 new infections and 542 hospitalizations.

"If we want to be independent from COVID-19, we have to be much more vigilant in terms of maintaining our physical distancing from others," Newsom said. "And we have to be much more vigilant as it relates to being in situations where we are transmitting [the virus]."

Wednesday's announcement also calls for the shuttering of any Orange County wineries and tasting rooms, museums and zoos as well as card rooms, movie theaters and other family entertainment centers — many of which had barely reopened earlier this month under the prior easing of restrictions.

News of the shutdowns comes as residents and visitors look ahead to a holiday whose rituals starkly contrast restrictions calling for physical distancing and prohibiting gatherings of multiple households.

FOURTH OF JULY PLANS FIZZLE

In Huntington Beach, a city known for its Independence Day festivities, the holiday weekend is an important one for local businesses as out-of-town visitors patronize restaurants, bars and

H.B. restaurant's no-mask position deeply divides Orange County diners

With Orange County coronavirus infections increasing, even as businesses and restaurants operate with varying levels of compliance to pandemic guidelines, local residents are becoming vigilant about where they will and won't spend their hard-earned cash.

So, when one Huntington Beach restaurant — Basilico's Pasta e Vino — took to social media to proclaim its anti-mask sentiment using the hashtag #nomasksallowed, the move sparked controversy among diners who vowed never to patronize the establishment again and those who supported the view-

point.

An image posted on May 31 to the restaurant's Facebook page portrays illustrated mask wearers with big red lines drawn through them, along with *#nomasks allowed* and *#securitymatters*. Another image, the Gadsden flag with its signature "Don't Tread on Me" superimposed over an American flag, was posted to the

page on Monday.

The posts have inspired hundreds of angry and supportive comments from a deeply divided populace along with a groundswell of media attention, according to Basilico's operations manager Jonathan Mil-

likan, who was compiling a me-

dia contacts list as he greeted

guests Tuesday.

Millikan said he had no comment about the postings or whether customers were being asked to remove their masks before entering Basilico's.

The manager did say restaurant owners were seeking help from "spokespeople," who would be contacting local news outlets sometime in the next few days.

"We've decided we're going to reach out to everyone. We may end up holding a conference that's kind of our plan," Millikan

Huntington Beach passes 2020-21 fiscal year budget

The Huntington Beach City Council voted to improve a city budget for the fiscal year 2020-21 during a special meeting Monday night on a 5-2 vote.

Mayor Pro Tem Jill Hardy and City Council members Mike Posey, Patrick Brenden, Barbara Delgleize and Kim Carr voted in favor. Mayor Lyn Semeta and Councilman Erik Peterson were in opposition after the council members disagreed on workforce reduction options to address \$6.2-million budget deficit for the new fiscal year.

\$359-million budget, submitted by Huntington Beach City Manager Oliver Chi, includes \$216.9 million in general fund revenue. Both figures are down by about 6% from the adopted budget for the 2019-20 fiscal year, as the novel coronavirus pandemic continues.

"For the next couple of years, I think we are going to see a depressed economic environment," Chi told City Council members during the special meeting.

presented the council several options for workforce reduction designed to reduce current city staff, which includes 294 eligible retirees, by about 5%.

All of the council members disagreed with using a CalPERS early retirement option.

Hardy, Posey, Brenden, Delgleize and Carr voted for the budget option, which will use a self-designed voluntary separation plan providing \$1,500 for every year of service, plus six months worth of insurance coverage.

Chi identified it as the most cost-effective plan, though it may not achieve enough program particibudget.

"I do see the benefits of having some of our employees that are ready to retire, giving them the incentive to go ahead and do that," Hardy said. "There's a lot of advantages to doing it that way rather than laying off, both in time and in the way the cost savings that are recognized. I do see this as a good investment."

Semeta and Peterson said they were against using incentives to meet the staff reduction goals.

"I still can't support any type of benefit to enhance employees to leave, enhance their chances to leave," Peterson said. "It just doesn't seem right."

Semeta said she favored going the layoff route, rather than using the voluntary separation plan.

"We have to make the hard decisions as leadshe said. "It's not easy to have layoffs or furloughs, but that's what the other cities [in the county] are doing.

As part of the budget approval, the City Council also voted to put off funding two additional police officers and one police lieutenant until Novem-

BLACK LIVES MATTER SPEAKERS HEARD

Dozens of public comments during the meeting were in support of the Black Lives Matter movement.

"At the last City Council meeting, they spent about four hours talking about reopening Huntington Beach," said resident Brittany Baddon, who is Black.

Baddon, 32, spoke before council for the second straight meeting.

"They spent maybe 15 or 20 minutes speaking on the topic at hand,

pation to balance the which blew my mind, because 90% of the people that were there were to speak out for the movement," she said.

"The thing is, Huntington Beach has such a long history of racial tension, racial history, white supremacy. It's really not addressed, not talked about. It's kind of just swept under the rug. But me and my family, we're from Huntington Beach, and we've all experienced this over and over since we were little kids. No one wants to talk about it, so I thought it was important that we keep showing up to these City Council meetings to show how real it is and how painful

Chants of "Black Lives Matter" could be heard outside the council chambers for several minutes following the public comments.

At the June 15 council meeting, Carr and Delgleize submitted a resolution condemning "the unconscionable actions of the Minneapolis Police Department that led to the death of George Floyd" and supporting "people of color [and] all people who protest injustice." against passed by a 6-1 vote, with Peterson dissenting.

Carr's proposal reaffirming the city's 1996 "Declaration of Policy About Human Dignity," which promotes equal rights for all, passed unanimously.

Orange County Human Relations hosted an "HB Student Day of Dialogue" on June 23 to discuss the recent protests, community policing and fostering unity. Guests included Carr, Hardy and Huntington Beach Police Chief Robert Handy.

El Dorado Hills couple Todd and Lisa Smith, who'd come into town and were enjoying a beer at Perqs Nite Club and Sports Bar Wednesday afternoon, had planned to celebrate the holiday but moved their trip up when they heard closures might be on the horizon.

"I have never seen the Fourth in Huntington Beach, and the plan was originally to come down here for that, the mania," said Todd Smith, crediting his wife for the date switch. "[Still], it worked out because we can be here. We've experienced some good restaurants, our favorite

Murat Koc, the owner of Coach's Mediterranean Grill in Huntington Beach, said his restaurant has operated on Main Street for 32 years and employs about 20 people whose families depend on them being able to stay open.

Restaurants simply cannot survive continuing closures and restrictions, he said. "Fourth of July is the biggest day of the year for everybody on Main Street that's a big revenue loss," Koc said.

"What governor, Newsom, is doing is playing with everyone's bread and butter. Not having business, it will destroy everybody."

RESTAURANTS RIDE A REOPENING ROLLER COASTER For Michael Byrne - co-

owner of the Laguna Beach bar the Saloon and owner of Roux Creole Cuisine -Wednesday's announcement is one more in a series of curveballs that have required equal parts patience, adaptability and

Both of Byrne's businesses closed in mid-March as stay-at-home orders were put in place.

Roux eventually reopened for takeout and delivery, then welcomed back

dine-in requests in early June, as Orange County restrictions began to ease.

When a cook at Roux tested positive for the coronavirus about two weeks ago, just as Byrne was getting ready to reopen the Saloon on June 21, he made the difficult decision to reclose Roux while employees got tested. That's when he learned a chef had also tested positive.

"There isn't anybody who's going to get away with not getting it — every restaurant is going to have somebody," the restaurant owner reflected Wednesday.

"It doesn't have anything to do with what you're doing. It's going to happen.

Newsom's recent order goes into effect at midnight Wednesday. At that time, Byrne's Saloon will have been open just 10 days before having to close once

Steve Rosansky, chief executive of the Newport Beach Chamber of Commerce, said stories of loss and devastation are becoming more common as business owners experience closures all over again.

Those with outdoor spaces have been given a

hall pass for the time being, but not every restaurant has that luxury, he said.

"This new order is going to be a crushing blow to many of the restaurants in town," Rosansky said. "There will be a few who can maybe adjust as best they can. But a lot of places don't have the space."

HOPE FOR OUTDOOR EATERIES

Shortly before Newsom's daily coronavirus briefing noon Wednesday, Orange County Health Care Agency interim healthcare officer Dr. Clayton Chau issued a countywide order strongly recommending the closure of bars, breweries and pubs that do not serve food but seemed to make provisions for those that did.

The order advised bars offering dine-in meals through a dining room or contracted vendor to follow the same state guidelines as restaurants but made no mention of any new prohibitions against indoor dining.

Orange County spokeswoman Molly Nichelson clarified "the state's order supersedes the county's or-

In a comment Wednesday, Orange County Board Supervisors Michelle Steel said she and her colleagues are dedicated to protecting the health and safety of county residents.

"We will continue to follow all state orders and health guidance from federal and state health officials," Steel said. "I encourage all Orange County residents to follow these guidelines.'

Paula Hornbuckle-Arnold, who leads the Laguna Beach Chamber of Commerce said her city and the city of Costa Mesa recently passed ordinances allowing local food businesses to set up tables on sidewalks and parking lots to help restaurants survive.

Many permits have been granted in the past month, she said.

"People are applying, and they are taking advantage of it," she said. "Will it be enough? That's the question I don't know the answer to."

Proprietor Ghoukassian, who owns Bayside Restaurant in Newport Beach and Bistango in Irvine, is making full use of the establishment's outdoor areas to help keep business

He experimented with drive-up music concerts at Bayside in May that thrived before city officials told him he had to stop. Now, he'll shift his focus to outdoor dining and hope for the best.

"We're doing whatever we can and making the best of it," Ghoukassian said. "Thankfully, we have very loyal and supportive customers."

they've had with the owners, who Millikan acknowledged sometimes use his social media accounts when corresponding with the public.

Some of the posted conversations have since been removed, while in others, owners explain how they initially posted a "no sign outside the restaurant weeks earlier "during the few weeks of civil unrest and protests in Orange County."

"If you enter the restaurant for dine in and want to

wear a mask, you must remove it when sitting down," one June 27 comment ex-

plained. "If you are standing around inside and waiting for a table ... and you are wearing a mask, you will be asked to wait outside. Got it? And next time you have something to say, why don't you come by and tell us to

our face, in person?' On Tuesday, Yelp said the business "is being monitored by Yelp's Support team for content related to media reports."

A trendline of Basilico's online reviews showed a steep decrease in performance from May to June.

Huntington Beach spokeswoman Catherine Jun said Tuesday her office was unable to comment on whether the issue had been brought to the city's atten-

tion but would not say why.

Jun did say the Huntington Beach Police Department, which is responsible for conducting "educational outreach to noncompliant businesses," had been made aware of the situation.

Members of the public openly shared their views on Basilico's recent behavior and spoke broadly on mask wearing during a pandemic.

Fountain Valley resident

Denise Kelsey said Tuesday she refuses to patronize establishments where masks aren't required.

"I'm sheepish about going anywhere in public," she said. "If I go through a drive-through and see people not wearing masks, I've even refused my food.'

The 55-year-old said she wears a mask in public out of courtesy to others and figures facial coverings are one of the few things residents can do "if we want to make this go away quickly."

On the other side of the argument is Orange County resident Peggy Hall, a nonmask wearer who started

the website "The Healthy American," in early May to educate people about what she calls their right to remain unmasked.

Hall says Californians are confused about a mask "mandate" she says doesn't legally exist.

"A governor cannot make a law. He can only give direction to the agencies under him," she said of Gov. Gavin Newsom. "There is no law that requires people to wear a mask or not wear a mask that's called freedom."

Hall, who asked her city of residence be withheld due to vitriolic comments already received

down beaches for the weekend in the face of the coronavirus pandemic. County-controlled beaches will also close on Saturday. The state has already closed its beach parking lots.

Newport had earlier planned to go ahead with full access for the traditionally peak weekend, expecting an influx beyond even the typical Fourth of July crush as displaced L.A. beachgoers look for the next-closest sand and surf.

The city expected to have about 60 staffers on duty, with the flexibility to call in reinforcements if the turnout demanded it.

In addition, weekend swells are expected at 5 to 7 feet and temperatures are forecast in the mid- to high 70s on the water and into the high 80s inland.

The sidelined guards are among Newport's 95 seasonal lifeguards, bringing down about a quarter of this major component of the city's marine safety division. The division also counts 15 year-round senior lifeguards and more than 50 reservists.

If more of the quarantined lifeguards get sick over the next few days, even more on the force could be isolated and create "pretty severe drawdown levels," Boyles said. That's because many seasonal guards are close away from work, playing sports or rooming together, he said. Some are siblings.

A few residents urged the council to leave the beach open, arguing to allow that liberty on Independence Day. They had an ally in Councilman Kevin Muldoon, a well-established proponent of reopening the cuffed economy who voted against a

closure.

"In Newport Beach, a closure would be hard to enforce, and for good reason," he said. "People are not meant to be controlled by the government."

He was the only oppos-

ing vote.

That wasn't the case in late April, when the council voted against closing the beaches days before the bustling weekend that alarmed Gov. Gavin Newsom enough to shut down all Orange County beaches for several days. Local cities bristled, with Newport backing up Huntington Beach's resulting, but unsuccessful, lawsuit against the state.

However, this is a local decision based on local circumstances, O'Neill said.

Resident Portia Weiss supported the closure, saying it was about life.

"Liberty and pursuit of happiness are not even part of the equation if there isn't life," she said.

Newport also closed its boardwalk, piers and most of the parking for the holiday, leaving some spaces to support the waterfront businesses.

Like Newport, Huntington will also close its parking and pier in addition to its beaches — City, Sunset and Harbor.

"The potential, if we're the only beach open, to be inundated certainly exists," City Manager Oliver Chi said at a quickly called council meeting held a few hours after Newport's. "We don't want that situation."

Councilwoman Barbara Delgleize said she has received numerous constituent emails wanting the beaches closed for the weekend, a shift in tone from about a month ago.

She referenced a time

when curtains separated smoking and nonsmoking sections on airplanes, "and they closed the curtain like that was really going to keep it away."

"I kind of think we do that in Orange County," she said. "L.A. is right next door. How is the wind blowing, for goodness sakes?"

Councilman Mike Posey moved to only close on Saturday to avoid uneven impacts on neighbors only taking that single day, but left Chi the authority to close on Friday or Sunday.

Earlier on Tuesday, the county closed bars and the state closed indoor restaurant dining in Orange County and 18 other counties on the state watch list after posting concerning metrics of accelerated COVID-19 spread.

The oceanfront, especially on Newport's Balboa Peninsula, is packed with bars, pubs and eateries. Many customers would be able to order takeout but would potentially be pushed to the adjacent sand to wait or eat, crowding the beach even more.

"In the sailing, boating world you become really aware of the tides, and they seem to always be running with you or against you. it's really important to understand which way the tides are going," said Newport Mayor Pro Tem Brad Avery. "The tide's definitely running against us on this."

just may be a huge density of people on the beaches."

Discussion Tuesday focused on whether or not to close the beaches; if hours should be limited; limiting activity to active use only; or if beaches should close only if state and local authorities mandate the closure of beaches.

Marine Safety Chief Kevin Snow said that the department has been seeing voluntary compliance with current guidelines since the beaches reopened but said that there is a possibility for the beaches to crowd because of the holiday.

Police Chief Laura Farinella said that the majority of complaints have been coming from indoor seating in restaurants.

"We've had some big weekends. We've had a heat wave. We've had some ability to monitor the situation and we feel, that as of now, the public is complying," Snow said, but added that even if the city closes its beaches that the county may not close its beaches. City staff said in a presentation that beaches in south Laguna Beach, if the city closes its beaches, could be inundated with visitors.

Speakers on Tuesday encouraged the closures of the beaches, with some speakers urging that the city instead close indoor

dining and bars.

Another speaker said that the city should close all or nothing to disperse the crowd.

As of Wednesday afternoon, county authorities have not closed beaches.

Orange County reported 570 new cases and five new deaths Wednesday, bringing the total number of cases to 14,413 and deaths related to COVID-19 to 345, respectively.

The number of cases involving skilled nursing facility residents is 1,189 while inmates are at 401.

An additional 7,746 tests were reported, bringing the total to 241,027. Testing positivity Wednesday was at 10.4% and the change in the three-day average of hospitalized patients is 9%.

Hospitals reported 192 cases are in intensive care units out of a total 542 current hospital patients.

"The decision to close city beaches on July 4 was not taken lightly by the City Council," Mayor Bob Whalen said in a statement issued Wednesday.

"Ultimately, the safety of our community and the public is our number one priority. On balance, we decided that taking a one-day timeout at the beach to reduce the crowds in the city made sense in the face of the increasing number of confirmed cases in the county and region."

"It is clear that we all need to do more to stop the spread of the virus and I urge everyone to comply with the governor's order to wear masks and maintain physical distance," Whalen added.


