

## A walk to seed interest in learning 'earth skills'

An outdoor series offered by nonprofit Environmental Nature Center proceeds Saturday through Modjeska Canyon.

Many Orange County denizens know the region's geography, its rugged coastlines, hills and canyons, like the backs of their hands, but it's unclear how many could survive its wilderness if left to their own devices.

Earth Skills — a continuing series of monthly classes being offered by the Newport Beach non-profit Environmental Nature Center through June — aims to teach locals the art of surviving in nature, primarily by understanding it on a much deeper level.

From animal tracking and understanding birdsong to orienteering and creating fire by friction,

## Eric McCoy named Surf City fire chief

Previously deputy chief of operations for the fire department, the Huntington Beach native replaces Scott Haberle, who retired at the end of 2024.

Eric McCoy started working for the city of Huntington Beach in 1997

As a teenager at Edison High School, he was hired as an ocean lifeguard and ambulance operator.

Public safety has remained McCoy's realm for decades. Now, he's the fire chief in his hometown.

McCoy has been selected as the Huntington Beach fire chief, the city announced Thursday via a news release.

"It's such an honor and a blessing to be able to take this spot," McCoy said in an interview with the Daily Pilot. "I'm really excited to lead the men and women of the fire department and continue to serve the community that I grew up in. It's a dream, for sure."

He said he believes he's the city's first internal fire chief in the last 25 years.

McCoy, 44, worked briefly for the Fountain Valley Fire Department before returning to Huntington Beach in 2006 as a firefighter and paramedic. During the coronavirus pandemic, he

said he got moved from his fire suppression duties and he has held roles including public information officer, Marine Safety Division chief and, most recently, deputy chief of opera-

McCoy takes over as fire chief for Scott Haberle, who retired at the end of last year. He played a

## Convicted rollerblader charged with battery

Details of Jan. 2 attack, with charges of sexual battery and false imprisonment, weren't immediately available.

A 25-year-old man convicted of sexually assaulting a woman and two teenage girls in Huntington Beach was behind bars today on suspicion of sexual battery in Santa Ana.

Michael Anthony Meer was charged Monday with sexual battery and false imprisonment, both felonies, for an alleged attack on Jan. 2, according to court records. Details of the attack were not immediately available from police or prosegutors.

Meer pleaded guilty June 22, 2020, to sexual penetration by a foreign object, assault with a deadly weapon and mayhem, all felonies, as well as misdemeanor counts of touching an intimate part of another person and child annoyance. He was sentenced to six years in prison

with credit for 1,092 days behind bars.

Meer was convicted of attacking a 39-year-old woman in Huntington Beach Feb. 28, 2018, and the other victims on March 9, 2018.

The 39-year-old woman was walking to a fitness center about 6:25 p.m. when Meer roller-bladed behind her and slapped her on the buttocks, prosecutors said in court papers.

Meer then slapped a phone out of her hand before skating away, prosecutors said. Then, as she reached the parking lot, he rolled up behind her again, grabbed her left hip with one hand and molested her groin with the other hand, prosecutors said

cutors said.

The victim said she saw him smell his fingers as he roller-bladed away, prosecutors said.

On March 9, 2018, Meer jabbed a knife into the tailbone of a 16-year-old girl at Edison High School, prosecutors said. The girl said she was walking toward the campus parking lot

### Newport Harbor's Keaton Robar kept rising into record book

Keaton Robar wasn't exactly an unknown commodity early in her cross-country career.

She was faring well in gradelevel races as a freshman and moving up the ranks in the Surf League as a sophomore, but it wasn't until several months later that it seemingly clicked.

Robar dropped a low time of 2 minutes 9.13 seconds in the 800 meters of the Arcadia Invitational on April 7, 2023, and that was the moment that she supposes she realized "I'm kind of good at this."

"That was something I thought was beyond me, at that point," Robar said of making the invitational race that year. "Crosscountry, I wasn't at that level yet, and I was improving a lot, just as I was in the 800, but I was still yet to get to that level. I made state for the 800 before I made state for cross-country, and they kind of followed each other."

Robar came back the next year and let that confidence permeate through her performance. As a junior, she was the runner-up in the girls' sweepstakes of the Orange County championships. That season concluded with a fourth-place finish in the Division II race of the CIF State cross-country championships.

Things were definitely pointing

Things were definitely pointing up for Robar, and although she admitted to being aware of the window of opportunity closing as a senior, they stayed that way this fall.

Robar, a Michigan commit for cross-country and track and field, now stands alone in the Newport Harbor record book for 3-mile races. She clocked in at 16:28.5 in the girls' sweepstakes race of the Woodbridge Classic at the Great Park in Irvine, besting the standard of 16:33.0 established by Paige Tennison in the same meet when it was held at Estancia High in 2012.



"Woodbridge wasn't my best race," said Robar, who is the Daily Pilot Girls' Cross-Country Athlete of the Year. "I didn't feel the best, so honestly, crossing the finish line, it was more relieving to me that I broke the school record because that was a goal I had since junior year, and that was something that I definitely wanted to do before my time ended here.

"Senior year being my last season is something I've never experienced before, having to leave high school cross-country in the past now and move on, it was something totally foreign to

## Fountain Valley moves into tie for first in Sunset League

The Sunset League boys' soccer race is effectively down to the steepest of rivals, with a showdown a day away, after Fountain Valley took care of its opportunities in a comfortable victory over the team

looming closest behind. Drew Payne, Cash Heit and Ethan Ro scored and assisted goals and the Barons made big plays at the back when required in a 4-2 triumph Wednesday evening at Huntington Beach.

Next up: archrival Edison (6-4, 5-0 in the Sunset League), the consensus title favorite, Friday night on the Chargers' huge field.

"It's five wins, but five wins isn't going to get us in the playoffs [with six league games to play]," Fountain Valley coach Jason Smith said. "We've just got to keep going. It's a tough week. We knew we were going to be tested. I think we passed the first test, and now we got our second test.'

The Chargers, Wednesday, haven't been severely tested, scoring 18 goals and conceding twice in their first five Sunset outings. Fountain Valley (6-2, 5-0) has been on a roll, putting away 16 goals in its past four games.

"Those are the top two teams, right now, as advertised ...," said Huntington Beach coach Matt Moseley, who dropped a 2-0 home decision to Edison three weeks ago. "I almost want to skip my game [against Corona del Mar] and go

watch it."

Huntington Beach (7-5-3, 3-2) wasn't so tidy with its chances, conceded four minutes after immediately answering Fountain Valley's first goal, then fell behind 4-1 before scoring from a corner kick in stoppage. They struggled to contain Payne and Ro and gained few rewards during spells — with Kainoa Delarole, on the left flank and then up front, the chief protagonist — of possession and penetration.

"They man-marked us, and it was very effective," Moseley said. "They counterattacked extremely well. They're extremely fast, especially at the wings. They got in behind us several times, and [Payne] is very dangerous, as well. Hat's off to them. They're dangerous up top, and they did what they needed to do defensively to keep us

from scoring goals, and then countered out of it.

"That being said, did we have two blatant opportunities to score in the first minute of the game? Yes. Did we have another opportunity to score within five minutes of that? Yes. Did we finish our opportunities? No. The outlook would be entirely different if we are able to bag one of those, but then we give up the early goal ... and we immediately respond. That changes things. But then they respond within five minutes, and then it's just defeating."

Heit gave the Barons a 19th-minute lead, a glancing header on the sprint from Ro's corner kick, and it was even a minute later, when Clayton Gutierrez put away Juan Bonilla's goalmouth feed from the right post.

Payne, with his sixth

goal over five games, restored Fountain Valley's advantage on a quick burst in the 24th minute. It was too easy: "Cash won the ball, and he just split a perfect ball through two guys," Payne said. "I just took a touch around [a defender], and then second touch was in."

Huntington Beach might have equalized twice, in the 31st minute and then five minutes into the second half, but for center back John Ennen's goal-line clearance of a Bonilla shot and goalkeeper Jacob Stevens' acrobatic parry of Greyson Simington's header onto the left post.

The Barons were the better side the rest of the way and built a three-goal lead on Umar Majid's sharp 56th-minute shot inside the right post and Bernardo De Souza's 73rdminute goal-line triumph against two defenders to finish Payne's looping header from a long Nixon Hunt throw-in.

"At times we looked Smith said. "At great,' times they looked great. And at times, both of us were vulnerable. We definitely made the most of our chances, and I think we had the edge on the attack and the pressure, and that equated to four goals, right?"

How good is Fountain Valley?

"Find out Friday night," said Smith, whose team will be home in the Feb. 4 rematch to close the regular season. "I think we're good. We always can improve. We weren't perfect tonight. There's things we need to work on and things we need to be better at, but we had flashes of brilliance tonight. And I think if we can sustain that, then, we got a chance to do bigger and better things."

Edison, a longtime Sunset powerhouse, has won 11 of the past 13 meetings, outscoring the Barons, 12-1, in four wins the past three seasons. Its home field, significantly larger than most, plays into its strengths.

"We know it's gonna be a tough game, right?" Smith said. "We just need to be able to keep our shape, keep our composure, and keep doing what we've been doing to be successful. ... We've got to win the ball. We've got to keep the ball. We've got to possess. Can't let them get too into open space, because there's so much space [that it's difficult] to disrupt their rhythm. You can't give them time to play, so we've got to close the gaps. We can't make it easy for

Payne is excited about the challenge.

"I've been playing varsity for four years," he said. "I haven't beat them yet, but I think this is a year there's a different [feeling]. We can't be arrogant, but we've got to be confident. We can't take it lightly. We know it's gonna be a hard game, and we know we can win the game."

key role in starting the new program in which the city embarked on selling advertising space on the side of lifeguard towers.

"It's going to be a way for us to offset the cost of replacing the towers," McCoy said. "The revenue that we get from the lifeguard tower ads is going to help to pay for the annual preventative maintenance that we do, as well as a replacement schedule for those lifeguard towers. It's something that we're really excited about."

McCoy said goals include developing future leaders in the organization, building upon the fire department's legacy of quality service and innovating the current response model to best meet the evolving needs of our community.

Huntington Beach is currently assisting firefighting in Los Angeles County, as the city has an engine at both the Palisades and Eaton fires, McCoy said. The two fires combined had destroyed more than 9,000 structures as of Thursday afternoon, officials said.

McCoy has a bachelor's degree from Cal State Long Beach and a master's in organizational leadership from Columbia Southern University. He is currently enrolled in the Executive Fire Officer program at the National Fire Academy, and anticipates graduating in April.

He lives in Huntington Beach with his wife and three children.

the guided lessons get participants outdoors, learning through handson, sensory-rich experiences how to live in concert with the land, plants and animals around them, says ENC Vice President Lori Whalen.

"It gets you more connected to your surroundings and thinking about stuff that is completely outside of your normal day-to-day [routine]," Whalen said of the series, which began last weekend. "You're not thinking about your stressful job, you're thinking about the present and you're focused.'

While many of the courses take place at the Environmental Nature Center's own acreage, at 1601 E. 16th Street, an upcoming session this Saturday morning takes place at 12-acre Tucker Wildlife Sanctuary in Silverado's Modjeska Canyon, acquired by the organization in 2021.

That's where Southern California herbalist William Broen will lead visitors on a 90-minute plant walk, during which they will learn to identify native plant species and understand their various properties and uses in herbal remedies, including teas, tinctures and salves.

A lifelong plant lover formally trained in the

Pacific School of Herbal Medicine in Oakland, Broen's talks focus on how plants' abilities to adapt to and survive in their natural environments plays a big role in their use by humans

over thousands of years. "Plants have to defend themselves from whatever they're dealing with in the wild, and we get to benefit from the protection they have," the herbalist said Wednesday.

Some species have antioxidants to protect the plant's cells from damage, and the substance has the same protective capacity when ingested by humans.

White sage has antimicrobial properties that can aid in cleaning, while yerba santa, a favorite of Broen's, can help ease respiratory problems when used in a tea or be applied in a poultice for wounds or sore muscles.

"If we were living here 200 years ago, we'd all know about it, because it was used by first peoples all the time," he said of yerba santa. "It's got resins that protect the plant and tannins that can dry mucus. You can find it at some health food stores, but it's also everywhere in the

Broen, 60, always loved plants, but it wasn't until he went on an herb walk in San Francisco in 1993 that his interest in herbs and their medicinal uses was piqued.

I was totally hooked — I

thought this is the most fascinating thing ever," recalled the Los Angeles resident who now leads about 20 or more herb walks each year. "Whenever I go hiking, wherever it is, it's like new worlds open up. You could spend lifetimes learning about this."

Those who attend Saturday's walk will learn to use their senses, including smell, to detect plants' protective or poisonous qualities and learn more about the species in Modjeska Canyon.

"We're basically animals and for years we've been connected to the natural world," Broen said, opining a bit on ENC's Earth Skills series. "So this is all really good stuff to learn just for our connection to nature."


