USA Water Polo premieres Olympic doc in Newport

SA Water Polo set out to produce a documentary on the Olympic women's water polo team, as it prepared to win its fourth straight gold medal in Paris last summer.

Then, an unexpected thing happened.

Team USA didn't win gold. Or silver.

Or silver. Or bronze.

The fourth-place finish, and some of the challenges along the way, are covered in the documentary "Women of the Water: An Olympic Journey." It premiered at the Lido Theater in Newport Beach on Monday

night.
Three members of the team attended the premiere, including

Corona del Mar High alumna Maddie Musselman, Rachel Fattal and goalkeeper Ashleigh Johnson, as well as head coach Adam Krikorian.

"You have to earn success," said Musselman, 26, the Olympic MVP of the Tokyo Games who was attempting to win her third straight gold medal in Paris. " I think this is a really good premiere because we lost. I think getting fourth, and seeing the work that goes into it, is really important. It's like, you can do all this work and still not be successful. I think that's a hard pill to swallow for us, but I think it's so good for the younger generation.

An exploration of grief, 'A Monster Calls' opens on stage

The monster in the new Huntington Beach Academy for the Performing Arts production of "A Monster Calls" continually bothers young Conor O'Malley.

"Stories are important, if they convey the truth," the monster tries to reason with Conor at one point.

The truth is, the story showcased in the play is one of loss and grief. Conor has to cope with the fact that his mom is getting more and more sick, dealing with cancer and chemotherapy.

"The whole show is about time, and time just goes," director Jenny McClintock said. "You think you have enough, but it just goes and goes. When you want to stop time, you

C.M. theater needs a new home

Newport-Mesa Unified is reconfiguring Rea Elementary, which has hosted Costa Mesa Playhouse since 1984.

Costa Mesa Playhouse was planning the upcoming 2025-26 season at its theater on the grounds of Rea Elementary School to coincide with the non-profit community theater's 60th anniversary, when officials received some troubling news.

Newport-Mesa Unified School District — the property owner of the school where the Playhouse has leased a 73-seat theater for a nominal fee since 1984 — recently communicated its plan to terminate the lease after a 90-day notification period.

Although the warning had been issued in March, the news didn't land until the theater's board members checked a post office box on April 17 and found the termination letter inside.

The missive indicated the company had until June 29 to vacate the venue, meaning officials would have to find a new location

H.B. man found guilty in brutal slaying

The jury took roughly two hours to find the defendant guilty for the killing of his girlfriend in September 2020.

A jury convicted a Huntington Beach man who was abusing his girlfriend in the weeks leading up to her fatal stabbing in 2020 of first-degree murder on Tuesday.

After a week of testimony, it took the jury roughly two hours to unanimously find 39-year-old Craig Charron guilty of killing Laura Sardinha on Sept. 2, 2020. Her mother, Marie Sardinha, broke into tears as the verdict was announced at the Orange County Superior Courthouse in Santa Ana, before embracing other friends and relatives who were present throughout the trial.

The defendant was scheduled to appear for sentencing July 25. He and his attorney, Michael Guisti, had requested a continuance to allow Charron to sort out unrelated business with the

Cause of Fairview Park brush fire unknown, but signs of human activity seen nearby

Costa Mesa fire investigators are examining the cause of a 1-acre brush fire that broke out Friday in a portion of Fairview Park, where sensitive wildlife is known to reside and where evidence of human activity was also spotted.

Department spokesman Battalion Chief Chris Coates said the blaze was first seen and called in shortly after 9:30 p.m. by Huntington Beach police helicopter HB1, as officers flew over the scene just west of Placentia Avenue.

"They happened to be flying in the area and observed it," Coates said Monday.

Crews arrived at the park and saw flames reaching toward the sky but could not immediately access the fire's origin point, as the area was covered in thick brush that was unreachable by vehicle, the fire spokesman said.

Firefighters used chainsaws to hack their way through the vegetation to gain access, and then ran approximately 2,000 feet of hose to the spot to tackle the fire.

Personnel from four engine companies and one battalion chief remained at

the park for 4.5 hours to make sure the site was completely overhauled and no burning embers remained, according to Coates.

No people were seen in the vicinity, but the fire spokesman said there were signs of human activity in the surrounding area.

No structures were damaged. No injuries were reported.

"The fire occurred in an area where there is evidence of homeless encampments," Coates said,

clarifying that it will be up to investigators to determine whether that may have contributed to the brush fire.

Such fires are not uncommon in Fairview Park, which falls under the care and maintenance of the city of Costa Mesa, and the adjacent Talbert Park, whose acreage is maintained by the county.

On June 23, 2024, crews battled an 8.4-acre brush fire at the park's southern end near Victoria Street that, fueled by high tem-

peratures and dry conditions, caused the temporary evacuation of residents on Swan Drive to the north

Two teenagers reportedly received minor injuries during the blaze and were assessed at the scene, while another individual found in an encampment at the park was taken into police custody on suspicion of trespassing.

It is unknown whether that person may have been linked to the start of last year's fire, the cause of was never publicly reported. Although the Pilot requested public records on the investigation in September, that request was denied because the case was still under review.

Costa Mesa spokesman Tony Dodero confirmed Tuesday the city typically performs brush clearance at Fairview Park each year before the July 4 holiday, but waits until September to maintain portions of the park's east side, due to bird nesting season.

Last year, city crews began mowing certain "fuel modification zones" in the park beginning in late June, according to Dodero.

just cannot."

"A Monster Calls," based on the 2011 novel by Patrick Ness, debuts Thursday night for four shows this weekend at the historic Huntington Beach Union High School District auditorium. It will likely be deeply personal for some patrons.

Huntington Beach High School sophomore Antonio Lopez, who was double-cast as Conor along with Izzy Vosper, feels the connection with the character he is portraying.

Lopez said he lost his own mother, Heather, to breast cancer last August, before he even knew anything about this production

"It's been nice coming to terms, in a way, with the things that have happened in my life with this show," he said. "But it's also been pretty difficult ... Throughout the play, his mom gets gradually more sick, and he has to deal with the fact that he's losing her. He wants his pain to go away, but she's the one who's giving him his pain. It's this emotional journey of him trying to let go, but also trying so hard to desperately hold onto the things

that make him happy."

The two-hour play, pre-

sented by the Huntington Beach Academy for the Performing Arts is set in contemporary times. That's not an accident for Mc-Clintock, in her fourth year as HBAPA faculty. Her first year, the students performed Shakespeare, then a Greek production, then a modern play and now this

temporary.
The cycle will repeat again starting next year, she said.

year's show, which is con-

"I want to expose them to all of theater, so that they have that experience going into college," she said. "This is contemporary, and it's very contemporary. The way it's staged is contemporary, it's very abstract. The actors never leave the stage. I might be a pupil at your school in one scene, and now I'm actually acting out your anger in kind of an abstract, physical way. It's unique, and they've embraced it."

Chairs sit on each side of the stage, ready to be put in formation depending on what the scene calls for. McClintock, who lost her own father to cancer when she was an adult, called the stage barren and empty. That symbolizes the grief the character Conor is going through as the condition of his mother, played by Robin McClure and Bianca Stratta, contin-

ues to worsen.

The theme extends to the costume color choices of muted beige and also red, which can symbolize nightmares. Conor is visited each night by a large yew tree that transforms into a monster.

"For the makeup, we tied in a lot of the beige," said Huntington Beach High senior Alessandra Pham, a hair and makeup designer. "We usually don't use such heavy eye shadow on the men, but we used a lot of gold and browns. Even the boys have all of this gold glitter, so it kind of just flows throughout the cast."

Costume designer
Rhonda Choat, aided by
her daughter and HBAPA
alumna Tara, said six professional-grade bald caps
were purchased to put on
the mother after she
undergoes chemotherapy,
as well as eight cheaper
bald caps. The more expensive caps, reserved for
the show itself rather than
rehearsals, take 45 minutes
to an hour to put on properly.

Cameron Mullin, a Huntington Beach High junior who was doublecast as the monster along with Benjamin Marshall, said she sees the monster as representative of not only Conor's grief, but also Conor himself.

"I like to think of it as Conor in the future trying

to tell past Conor that it's OK to be ashamed with how you feel," Mullin said. "It's OK to have these feelings, you just need to be able to tell the truth. As soon as you tell the truth, you'll be able to face whatever comes, you'll be able to move on."

move on." Audrey Cone, a HBHS junior who did the sound design, said the show may be a bit scary but it's important to see, especially for teenagers.

"Not a lot of teens get to see us dealing with grief and just being so open about it." she said.

In another personal touch, McClintock cast her

own twin children as "young Conor."

Part of the show proceeds are going to Fran's Place Center for Cancer Counseling, based in Brea. For tickets to "A Monster

team, you're not just going to win all of these gold medals that they won in the past. It's actually going to take a lot of work."

One person working to promote the sport is Flavor Flav, TV personality and founding member of the rap group Public Enemy known for wearing a big clock necklace. Last summer, he signed a five-year sponsorship deal as the official hype man for the U.S. women's and men's national water polo teams, also contributing an undisclosed amount to the 2024 Olympic women's team.

"I really, really feel that all of these Olympic teams need some sponsorship," Flavor Flav told the crowd in the theater before the movie began. "Everybody works hard to achieve goals. I want to thank the girls for allowing me to sponsor them. I went over to Paris and had an amazing experience."

ing experience."
"Women of the Water" is a six-part series with episodes that are roughly 10 minutes long, though all episodes were shown consecutively Monday night. It was shot beginning in early 2024, as Team USA had already secured its Olympic

spot.
The series explores loss in Musselman's life, as her husband, former Mater Dei High and UCLA men's water polo player Patrick Woepse, whom she'd married in 2023, was diagnosed with a rare form of aggressive stage 4 lung cancer. Woepse made it to Paris to watch Musselman play, but died last October at the age

of 31. Team captain Maggie Steffens also had her sisterin-law Lulu Conner, die unexpectedly after arriving in Paris to watch the team play.

Suzi Mellano served as executive producer and director of the series, which also takes viewers inside practices and intimate moments, including Flavor Flav himself jumping in the pool during a practice. Greg Mescall produced the project with collaboration from

associate producer Sherie Smith

USA Water Polo is aiming to distribute the series broadly, Mescall said, adding that it is the second series that the organization has made. "Path to Paris," documenting the journey of the Olympic men's team, debuted last year.

"We'd love to do more of this," said Mescall, chief of content and growth for USA Water Polo. "Hope-

fully, there's an audience for it ... What's cool about it is that you don't know what you're going to get, and you document this whole journey. Sure, it didn't end with a gold medal, but I think it gives you some insight into how tough it is to make a team, and how close this group is, given all the challenges they went through."


The audience included plenty of young girls' water polo players and their parents, with Back Bay and Patriot water polo clubs among those with many in attendance.

to host productions and store its theater seats, equipment and stage other property in the interim.

"It was a shock," Mark Tillman, director of communications and Playhouse board member, recalled Wednesday. had so many exciting plans built up to celebrate our 60th anniversary had a lot going on."

Members and supporters quickly pivoted to advocating for the theater's survival, appearing at an April 22 meeting of Newport-Mesa Unified's Board of Trustees to plead for a lifeline.

"We fully understand the needs of the students must come first, with respect to the building's usage, and we are eternally grateful for the support the school district has provided over the last 40 years," Playhouse President Mike Brown told trustees. "That said, we implore you to work with us in good faith moving forward, considering any and all avenues to help relieve the burden your decision has placed on our organization. We have no place else to go.'

Playhouse Artistic Director Peter Kreder told school board members the group still had two more productions in the 2024/ 25 season and had invested thousands in next year's 60th anniversary season, including purchasing the rights to multiple productions.

Were operations at Rea to cease, the nonprofit could be forced to find a new venue, paying steep market rates well beyond what the group's coffers, consisting of modest box office receipts and community donations, could

transition, which will allow us time to fundraise and gain support from the community and patrons, so the heartbeat of our theater can continue another 60 years," he said.

In a separate interview Tuesday, Kreder said despite a "fantastic relationship" with NMUSD, the issue of the building's usage has come up before.

"We've had instances of nearly losing the space at one point we were told it was going to turn into a computer lab — and now that's finally come to fruition," he said.

Newport-Mesa Unified Annette spokeswoman Franco explained the decision to terminate its longstanding agreement with the Costa Mesa Playhouse was due to a grade level reconfiguration happening at Rea and Pomona elementary schools.

Starting in the fall, Rea will serve students from both schools in grades 2 through 6, while Pomona will be dedicated to youngsters attending preschool through first grade.

"The space is needed to continue to support highquality academic and enrichment programs, both during and after the school day," Franco wrote in an April 23 email.

"While we value our community partnerships, our lease agreement allows for termination with 90 days' notice. This allows

us to respond to evolving student needs and effectively plan for the upcoming academic year."

Although the district's actions fall within the terms of the latest twoyear lease agreement, which was set to expire in June 2026, Kreder said NMUSD trustees Leah Ersoylu and Michelle Murphy met with theater leaders last Sunday, following the meeting, to learn more about the situation.

And it seems a glimmer of hope may be on the horizon. A contingent of Playhouse board members met with district officials Tuesday evening and discussed the possibility of extending the move-out date to allow the current season to conclude.

Franco confirmed Wednesday Newport-Mesa staff are also considering possible alternative locations on school grounds that might accommodate Costa Mesa Playhouse productions.

Tillman said Wednesday he was cautiously optimistic.

"We're still hopeful there are things to be worked out with the school district," he said. "In the event we cannot find a space, we will be launching a fundraising campaign and crossing our fin-



Marina doubles team settles for runner-up finish at Ojai tourney

OJAI — Trevor Nguyen and David Tran came extremely close to earning another significant tournament victory on Saturday afternoon.

It can't get much closer than a third-set tiebreaker. The Marina High boys'

tennis tandem was a few points away from winning the Ojai Tennis Tournament title, dazzling the crowd at Libbey Park with their play

In the end, Beckman senior Caden Lee showed he could go back to back.

Lee won his second straight CIF doubles division title at the prestigious tournament, teaming with freshman Edwin Yuan for a 4-6, 6-4, 7-6 (7-5) victory over Nguyen and Tran.

"It feels great," Lee said. "The first two years, I played singles, and I only got to the second round

once and the first round the second time. Going all the way with two different partners, it just feels really good."

Nguyen, a senior, and Tran, a junior, were last year's CIF Southern Section Individuals doubles champions for Marina and topseeded this year at Ojai. They made it into the championship match without dropping a set.

"It would have been nice to win it my senior year, but they played well," Nguyen said. "In the third set, it was just anyone's game, whoever executed better on the returns. That was probably the biggest factor.'

Despite the loss, Nguyen and Tran became the first boys' tennis players from a Huntington Beach Union High School District school to ever make a title match at the Ojai tournament. Last year, they fell in the semifinals.

They looked good early Saturday in the title match, racing to a 4-0 lead in the first set against the No. 2seeded Beckman duo, which closed within 5-4. Nguyen was successfully able to serve for the set, recording a service winner at deuce before an outright

Lee, an Air Force commit who won Ojai doubles with his younger brother Tyler last year, came back strong in the second set with Yuan. They took a 4-1 lead, though this time Marina battled back to 4-4. Tran's serve was broken at 4-5, however, as the match went to a decisive third set.

"Both teams played really well at times, and were off at times," Marina coach Chuck Kingman said. "Just a lot of swings of momentum. A couple of points either way, but they played

Veteran's Affair's office, which Senior Deputy Dist. Atty. Janine Madera objected to.

"Next of kin and loved ones have waited long enough," she said.

Charron said Sardinha, snuck up behind him and tried to cut his throat with a knife, resulting in a struggle. But prosecutors say the defendant ambushed the victim, then injured himself and manipulated evidence in an effort to gaslight investigators.

Guisti, acknowledged his client had been violent and manipulative with Sardinha in the weeks leading up to her killing. He hit her hard enough to perforate one of her ear drums

according to a medical exam performed Aug. 16, The defendant is heard threatening to end their relationship as the victim repeatedly tells him she is in

pain in a cellphone video recorded that morning. Charron begs Later Sardinha not to report the incident to authorities in texts sent while she was at the hospital. "Would you be willing to

talk to me without calling me names or hitting me?" she wrote in a reply. "... I'm so scared you won't stop." But the abuse didn't end,

according to footage recorded in the hours leading up to Sardinha's killing. She is heard asking Charron to leave her alone over 50 times as he harasses her at 4 a.m. Charron is seen continuing to berate her in videos shot on their patio later that morning.

Charron is also heard saying "don't hurt me" when Sardinha picks up her laptop and walks away

from him to go inside. Madera claimed that was an attempt to manipulate potential viewers into believing the defendant was afraid of being harmed by her. The prosecutor also noted Sardinha was 10 inches shorter and over 100 pounds lighter than the defendant.

After exchange that Sardinha went to their building's leasing office to have Charron evicted and the locks to their apartment replaced. When he texted to ask if he could come over to gather his belongings, she referred him to property management.

By that afternoon the victim was at home celebrating her freedom from Charron in a conference call with her mother and best friend. That conversation was interrupted at around 1:15 p.m. when Sardinha's relatives heard her exclaim "Oh my [expletive] God, he's here," followed by her screams and the sound of her phone falling to the ground. It's unclear how Charron got back into the residence.

"She fought like hell to her last dying breath," Madera told jurors. "... Laura was the most powerful witness you heard in this tri-

Blood streaked the walls and floors of their apartment in photos presented during trial. Sardinha was slumped facedown against the jamb of their bathroom door with two fatal stab wounds to the chest as well as numerous cuts to her

head and hands. In police body-worn camera footage, Charron was seen lying on the ground in the hallway just around the corner with wounds to his throat and chest. The defendant's injuries featured several shallow slashes next to a two

deeper cuts, one on his neck and another at his heart. His attorney, Michael L. Guisti, claimed those

were made by the victim. However, Dr. Nicole Ellis of the Orange County Coroner's Office testified that the surface lacerations were consistent with what are known as hesitation wounds, suggesting those as well as his most serious injuries were self-inflicted.

Madera suggested Charron attempted to flee the scene of the crime but, after seeing flashing sirens and hearing a police helicopter overhead, he instead went back inside, cut himself and planted a knife near Sardinĥa's body. She pointed to droplets of what appeared to be blood at the bottom of the stairs leading to their apartment that are only seen in the body worn camera footage after officers arrived, as well as a pool of Charron's blood near the entrance of their home that was separate from where he and the victim were found, as evidence of her theory.

Guisti challenged Madera's theory, noting Charron nearly bled out as a result of his injuries. Guisti said it was unreasonable to believe his client could have precisely orchestrated events "just in time to lose his vital signs and die on the floor" before first responders resuscitated him.

"They need you to believe my client is a faker," Guisti said.

while they were on the phone with her immediately prior to the attack.

Other witnesses brought to the stand included three women who all filed restraining orders against the defendant after dating him between 2013 and 2017. One of them testified being strangled and struck with a wine bottle in the predawn hours after her birthday in Oct., 2015. At some point during that confrontation, the defendant recorded himself saying the words "Rachel stop hitting me," Madera said.

Guisti pointed out that one of thsoe women admitted hitting his client. Charron testified during trial, and said what past lovers had characterized as violent episodes were rough sex or otherwise misunderstandings.

Madera noted that he claimed to have no recollection of critical events and refused to review transcripts provided to refresh his memory when questioned during cross examination about inconsistencies he presented in his interviews with police. Guisti said Charron was in a hospital, intubated, taking medication for pain and recovering from injuries, all

of which would have impacted his memory.

Marie Sardinha recalled confusion and asking her daughter "who's here?" followed by horror as violence unfolded on the other end of the line. The victim's mother called police then immediately drove from her home in Long Beach to her daughter's apartment in Huntington Beach. But by the time she arrived, Laura Sardinha had already been killed.

At some point during the attack two calls were sent from the victim's phone. One resulted in a voicemail in which she is heard "narrating a portion of her own murder."

About a week later the recording appeared in Shaina Smith's inbox. Smith is Laura Sardinha's best friend of 21 years.

Loved ones said Laura Sardinha loved to cook, but had trouble using a knife following a motorcycle crash in 2019. Smith described her as a typically outgoing and happy person. But she stopped hearing from her friend as much and noticed a change in her demeanor shortly after she started dating the defendant about two months before she was killed.

H.B.'s Drotter plays the 'hero' with late homer

A day after its bats carried it to a critical win at Los Alamitos, the Huntington Beach softball team hosted Marina in a battle for Sunset League title aspirations.

The Oilers' victory over the Griffins had forged a three-way tie in the loss column at the top of the league, a trio that also included the Vikings each having two losses to their league ledger.

Huntington Beach continued to take control of its own destiny, a two-out, three-run home run by Morgan Drotter in the sixth inning turning Tuesday's game on its head in a 3-2 win over the visiting Vikings.

"There's something special with this group here," Huntington Beach coach Jeff Forsberg said. "They all believe in each other. They all like each other. There's no drama. There's no cliques. We've gone through a lot."

"These years past, we've had expectations. We have no expectations. There's a new hero every game."

It was an improbable late-inning rally. Any momentum from Monday's triumph, a 9-4 final at Los Alamitos in which the Oilers had 16 hits, appeared to be stymied by Marina right-hander Mia Valbuena.

Huntington Beach (17-7, 5-2 in the Sunset League) left the bases loaded in the

second inning, Valbuena escaping the jam with a strikeout of Willow Kellen. The Oilers had just two hits through five innings. Then their power hitters — third baseman Tea Gutierrez and first baseman Bree Carlson — bounced ground balls through the infield with one out.

Valbuena struck out the next batter, and when Drotter stepped up to the plate, the Vikings ace quickly got two strikes on the Oilers' shortstop. Drotter then got an inner-half offering and lifted it to left field, and on a cool, 60-degree evening without wind, the ball landed on the solar panels in the parking lot beyond the fence.

The Oilers ran out of the dugout to celebrate with their teammates as they crossed home plate.

"I told them in the huddle, when I got my second strike and I swung and missed, in my head, I was like, 'Shoot. I don't even know if I can do this,' but I know that they have my back, and that means the whole world to me," said Drotter, who has committed to Cornell University.

Valbuena was dominant outside of that moment, but the damage was done. The Michigan commit allowed six hits and a walk, striking out seven across six innings.

"She's definitely the best pitcher we face in league, for sure, like speed-wise, too" Drotter said of Valbuena. "I have a lot of relie drive off the bat of Liz team plays like that, good so

buena. "I have a lot of respect for Mia and Marina, in general. We knew this game meant a lot, and I think just coming out and being together was the most important thing. The outcome showed that."

Marina (12-12, 6-3) had the leadoff batter reach base in the fifth, sixth and seventh innings, opting to bunt each time. In the fifth, Eva Mazzotti singled to right field with the runner in scoring position, but the runner was held at third base.

Gutierrez charged a weak ground ball at third for the second out, and left fielder Sienna Shortle plucked a Byer out of the air to save at least one run.

After a single by Ava Kim, it was Maryland-bound catcher Gabby DiBenedetto's turn to advance the runner with a sacrifice bunt in the top of the sixth. Avi Valbuena had a two-out, run-scoring single; Halle Piramo followed with a double to score another

"That's all we can do is ask for the kids to do their best and battle and compete, and I think they did," said Shelly Luth, who co-coaches Marina along with Dan Hay. "We came up a little short, but when this

team plays like that, good things can happen."

Marina was up 2-0, needing to get just six more outs with its ace twirling a gem in the circle.

"When a pitcher is dominating a team like Mia was dominating this team, their job in the later innings is just get the ball in play," Hay said. "Those balls that went in the 3-4 hole and up the middle, they could have been 6 feet to the right or left, we would have made the play. They would have been routine grounders. They just happened to have eyeballs on them."

In a most important of weeks in the Sunset League

softball standings, Huntington Beach has earned two signature wins that have given it the inside track to the title. The Oilers have a doubleheader remaining against Newport Harbor (10-14, 2-6) on Thursday. Then they host Corona del Mar (8-15, 0-10) on Monday, closing the regular season at Edison (11-13, 6-5) on Tuesday.

Marina takes on Los Alamitos (14-11, 8-2) at home on Thursday, before finishing with back-to-back games against Newport Harbor next week.
