(b) (3) (A), (b) (6), (b) (7)(C) will be held accountable at battalion-level non-judicial punishment and subsequently processed for administrative separation in accordance with Section 6210.9 of reference (c). (b) (3) (A), (b) (6) (b) (7)(C) conduct is incompatible with military service and Marine Corps values.

Preliminary Statement

1. This letter reports completion of the command investigation conducted in accordance with reference (a) into allegations of white nationalism in the case of (b) (3) (A), (b) (6), (b) (7)(C) USMC.

Subj: COMMAND INVESTIGATION INTO ALLEGATIONS OF WHITE NATIONALISM IN THE

2. The catalyst to initiate the investigation was an online disagreement on Twitter on 27 February 2020 which resulted in a Twitter user contacting the San Diego Tribune on 27 February 2020. A reporter from the San Diego Tribune contacted III Marine Expeditionary Force (MEF) Communication Strategy and Operations (COMMSTRAT) on 28 February 2020. After III MEF COMMSTRAT notified Battalion Landing Team (BLT) 1/5, the battalion notified HQMC via an OPREP-3 on 28 February 2020. On 29 February 2020, the Battalion Commander for BLT 1/5 initiated a command investigation. The Equal Opportunity Advisor for III MEF was contacted on 17 March 2020 by the Investigating Officer.
3. In accordance with reference (b) this investigation was conducted to determine whether or not (b) (3) (A), engaged in dissident and protest activity (including supremacist activity).
4. All reasonably available evidence was collected via in person interviews, email correspondence, and research on publicly viewable social media and news websites.
5. This investigation was extended due to the unit being deployed aboard the 31st Marine Expeditionary Unit (MEU) at sea.
6. On 17 March 2020, (b) (3) (A), (b) (6), the Regional Defense Counsel-West, detailed (b) (3) (A), (b) (6), to represent (b) (3) (A),. Via his appointed counsel, (b) (3) (A), declined to participate in this investigation.
7. The original items of evidence are maintained on an encrypted external hard drive kept on the person of the Investigating Officer, (b) (3) (A), (b) (6), (b) (7)(C)

Findings of Fact

1. (b) (3) (A), (b) (6), (b) is a (b) (3) (A), (b) (6), (b) (7)(C) with Combined Anti-Armor Team 1 in Weapons Company. He enlisted in the Marine Corps on 1 January 2018 and joined 1st Battalion, 5th Marines on 6 July 2018. His end of active service date is 7 January 2022. His home of record is (b) (3) (A), (b) [Encl (2)]
2. (b) (3) (A), has (3) unofficial counseling records in his Weapons Company Record Jacket. The first is for questionable material on his social media pages and questionable participation in an online organization called the United States Nationalist Initiative (USNI). The second is the follow-up to ensure compliance with the tasking in the previous counseling. The third is for insubordination towards an NCO after being asked to stop talking about politics and political beliefs in a training setting. [Encl (3), (4), (5)]
3. (b) (3) (A), has (1) page 11 on file in his OMPF for insubordination towards a Non-Commissioned Officer (NCO) dtd 12 September 2019. (b) (3) (A), received this counseling from his Company Commander, (b) (3) (A), (b) (3) [Encl (6)]

4. According to the Facebook page, the United States Nationalist Party (USNP) was founded in 2014. [Encl (7)]
5. According to its Facebook page, "All Americans are welcome to join the Nationalist Initiative, regardless of religion, sexual identity, race, political affiliation, religion, or any differences that haven't been named." [Encl (7)]
6. According to the (USNI website, (b) (3) (A), is the self-declared "chairman". While the San Diego Tribune article on 15 March 2020 notes that (b) (3) (A), (b) (6) as the Co-Chairman of the USNI, the investigating officer was unable to find a connection between the two during his investigation. The stated mission of the USNI is to "act as a platform of unity for those who share a common love for their country, promote and defend the principles on which our nation was founded, to defend our culture and identity, to restore national pride, to improve the individual American citizen and to volunteer in our communities." According to the USNI Facebook page, the organization has around 1,400 followers. It is unknown how many Facebook followers are dues paying members of the USNI. [Encl (8)]
7. On 11 February 2016, prior to (b) (3) (A), enlisting the Marine Corps, a video was released online in which (b) (3) (A), allegedly describes how he would conduct a mass shooting at (b) (3) (A), (b) (6), (b) (7). While the investigating officer was unable to acquire an original copy of the video, there are portions included in the nightly newscast of click2houston. In these portions, an unknown third party films (b) (3) (A), as he explains a tactical plan to conduct offensive actions against the high school. [Encl (9)]
8. On 12 February 2016, (b) (3) (A), was arrested on allegations of Terroristic Threats by the Montgomery County Precinct 5 Constable's Office. [Encl (10)]
9. On 18 February 2016, (b) (3) (A), was arraigned before a judge for the 410th District Court in the state of Texas. [Encl (10)]
10. On 28 April 2016, charges against (b) (3) (A), were dropped after a Grand Jury found insufficient evidence to indict (b) (3) (A), on the charges of Terroristic Threats and a motion to dismiss was filed. This is labeled on the paperwork as "No bill by Grand Jury." [Encl (10)]
11. On 25 October 2017, during his enlistment process at the Military Entrance Processing Station in Milwaukee, Wisconsin (b) (3) (A), marked yes to questions 6g and 6h of the Medical History Provider Interview: "Have you ever been arrested?" and "Have you ever been suspended from school?" On the comments page the examiner (whose name is illegible on the form) annotates, "Accused of making threat 2016, Taken into Custody, Released 3 months later, No Conviction, Reviewed by Marines Already." There is no waiver on file for the arrest on 11 February 2016 because the charges were dropped. [Encl (6)]
12. On 2 September 2018, The USNI posted graphic art of what looks like an African-American girl smiling and holding up the American flag with the caption, "Pride, never be afraid to show it." This graphic bears the insignia of the US Nationalist Party. This graphic depicts the individual in a positive way. [Encl (11)]
13. On 7 November 2018, the name of the U.S. Nationalist Party was changed to the U.S. Nationalist Initiative by an unknown party and for an unknown reason. [Encl (12), (13)]
14. On 23 November 2018, The U.S. Nationalist Initiative posted a graphic re-using an image previously posted by an organization called "Patriot Front" bearing the slogan "Not Stolen, Conquered." The graphic depicts a map of the United States divided into (6) sections with a year in the middle of each section. The years signify the time when each section of land was acquired by the United States.[Encl (14)]
15. The Southern Poverty Law Center identifies the Patriot Front as a white supremacist organization. [Encl (15)]
16. The Anti-Defamation League identifies the Patriot Front as a white supremacist organization. [Encl (16)]
17. According to the Southern Poverty Law Center and the Anti-Defamation League, the Patriot Front was created in Texas in August 2017. The Patriot Front's predominant message is that "their ancestors conquered America and

bequeathed it solely to them. They distribute their message predominantly online but also conduct public gatherings and demonstrations. [Encl (15), (16)]

18. On 3 February 2019, a social media user "(b) (3) (A), (b) (6)" posted a photograph, allegedly from (b) (3) (A), (b) (6) personal social media, with the caption "be gone degenerate." The photograph is of (b) (3) (A), (b) (6) standing perpendicular to the camera but facing the camera wearing camouflage utilities with a distortion effect overtop of the entire photograph. This distortion effect is used in other photographs that are currently on (b) (3) (A), (b) (6) Instagram page. "(b) (3) (A), (b) (6)"'s post identifies (b) (3) (A), (b) (6) as an alleged white supremacist and lists the Facebook and website links of the USNI. The real life identity of "(b) (3) (A), (b) (6)" is unknown and the original source website has been taken down or is no longer publicly accessible. [Encl (17)]

19. On 3 February 2019, social media user "(b) (3) (A), (b) (6)" alleges that, "the USNP is rebranding as the United States Nationalist Initiative" and "they've [the USNI] deleted hundreds of incredibly racist and anti-semitic calls to literal murder from their comments." [Encl (17)]

20. On 24 July 2019, (b) (3) (A), (b) (6) posted photographs to his personal Instagram and the USNI Facebook page depicting the USNI uniform insignias. The first insignia is round and has the symbol of the USNI in the middle. The second insignia builds off the first with oak leaves around the outside and an eagle sitting on top. [Encl (18)]

21. On 24 July 2019, Facebook user (b) (3) (A), (b) (6) asked how to get one of the USNI uniform insignias. (b) (3) (A), (b) (6) explains that the smaller insignia is the basic membership pin and the larger is the Patriot Corps pin and that they are earned through loyalty to the organization. (b) (3) (A), (b) (6) does not explain how loyalty to the USNI is demonstrated. (b) (3) (A), (b) (6) explains in a different comment that "the USNI is a Super Pac and a volunteer organization." [Encl (19)]

22. According to the Federal Election Commission a Super Political Action Committee (Super PAC) is an independent expenditure only political committee that many receive unlimited contributions from individuals, corporations, labor unions, and other political action committees for the purpose of financing independent expenditures and other independent political activity. The committee will not use those funds to make contributions directly to federal candidates. Super PACs must be registered with the Federal Election Commission (FEC). It is unknown at this time if the USNI is registered with the FEC. [Encl (20)]

23. According to (b) (3) (A), (b) (6), (b) (3) (A), (b) (6) Company Commander, and (b) (3) (A), (b) (6) Platoon Commander, in August 2019 (b) (3) (A), (b) (6) and (b) (3) (A), (b) (6) brought to the company staff's attention that (b) (3) (A), (b) (6) was a member of the USNI and had been suspended from high school due to a video allegedly threatening (b) (3) (A), (b) (6), (b) (7)(C) [Encl (21)]

24. (b) (3) (A), (b) (6) reached out to (b) (3) (A), (b) (6) a reservist Staff Judge Advocate for his legal advice on the situation. (b) (3) (A), (b) (6) advised (b) (3) (A), (b) (6) that "others could perceived the group as an extremist organization." (b) (3) (A), (b) (6) further advised (b) (3) (A), (b) (6) to direct (b) (3) (A), (b) (6) to remove himself from the group." [Encl (21)]

25. (b) (3) (A), (b) (6) updated (b) (3) (A), (b) (6) the Battalion Commander of 1st Battalion, 5th Marines, on (b) (3) (A), (b) (6) membership in the USNI and the advice from (b) (3) (A), (b) (6) directed (b) (3) (A), (b) (6) to proceed with the advice from (b) (3) (A), (b) (6) [Encl (21)]

26. On 1 September 2019, (b) (3) (A), (b) (6) was counseled by his Platoon Sergeant, (b) (3) (A), (b) (6), for having "multiple social media platforms that serve as a political medium." Additionally, he was counseled for social media pages that "display opinions and comments that have been received as racist, sexist, and not keeping with good order and discipline." (b) (3) (A), (b) (6) was tasked in counseling with "removing any questionable material from across your social media platforms." [Encl (4)]

27. On 1 September 2019, (b) (3) (A), (b) (6) responded to the above counseling by stating, "The U.S. Nationalist Initiative is an organization comprised of patriotic men and women of all backgrounds. All American citizens are welcome to join the Nationalist Initiative regardless of religion, sexual identity, race, political affiliation, religion, or any differences that haven't been named. The U.S. Nationalist initiative does not partake in supremacist acts and in no way shape or form does it endorse such ideas." [Encl (4)]

28. (b) (3) (A), s response to counseling on 1 September 2019 is a word for word copy of the "About section" on the USNI Facebook "About page". [Encl (4), (7)]

29. On 9 September 2019, (b) (3) (A), was given a follow-up counseling by (b) (3) (A), where (b) (3) (A), remarked, "SNM has removed posts that contain material that could be detrimental to good order and discipline." And "After reviewing what information is still broadcast, there are no concerns that any violation of the UCMJ is being committed." [Encl (5)]

30. (b) (3) was aware of both of these counseling and signed them. [Encl (4), (5)]

31. According to (b) (3) (A), in September of 2019, while Weapons Company was training at the Infantry Immersion Trainer on Camp Pendleton, (b) (3) (A), and (b) (3) informed (b) (3) (A), that (b) (3) (A), had shown disrespect to an NCO in his platoon by telling the NCO, who had requested that (b) (3) (A), cease speaking of politics, that if he didn't want to hear he could go somewhere else. (b) (3) (A), personally counseled (b) (3) (A), and issued him a negative reprimand in the form of a Page 11 report. [Encl (6), (21)]

32. (b) (3) (A), (b) notes that following the page 11 entry, he has not been notified about any behavior contrary to good order and discipline by (b) (3) (A), [Encl (21)]

33. On 5 September 2019, (b) (3) (A), (b) (6), (b) (3) (A), Vehicle Commander, issued (b) (3) (A), an informal written counseling for the same conduct as annotated by (b) (3) (A), [Encl (3)]

34. On 1 December 2019, (b) (3) (A), posted a photograph to the USNI Facebook Page captioned, "'Racist' is a term that was heavily used by Marxists during the time of the Bolsheviks. It was and is utilized when leftists are attempting to discredit or demonize someone they don't agree with. It's a term used to socially assassinate anyone who holds a differing viewpoint in an effort to strip someone of any credibility they might possess. It's no different than all the other made up terms like xenophobe, islamaphobe, and anti-Semite. That's the tactics of the left. To divide, categorize, and label everyone they don't agree with. Effectively fighting the left begins with one simple decision: Sacrifice what you believe in... Or get called a racist. I know what my choice is gonna be." [Encl (22)]

35. On 27 February 2020, (b) (3) (A), entered into an exchange of messages on the social media platform Twitter with users "(b) (3) (A), (b) (6)", "(b) (3) (A), (b) (6)", and "(b) (3) (A), (b) (6)" wherein (b) (3) (A), was accused of being a white supremacist and posts from his personal Instagram page were posted. (b) (3) (A), (b) (6), posts, "When you find yourself on the friends list of a member of Atomwaffen that was arrested by the FBI for nazi shit and you're an open Nationalist in the USMC" and "I'm not even posting your trans and queer phobic screenshots, just these that align with everything every fascist org is out there pushing." Due to several of the messages being deleted prior to when the Investigating Officer discovered the conversation, it is unclear who started the exchange. The real life identities "(b) (3) (A), (b) (6)", and "(b) (3) (A), (b) (6)" are unknown. [Encl (23), (24), (25), (27), (28)]

36. On 27 February 2020, the Twitter user "(b) (3) (A), (b) (6)" posted a photograph allegedly from (b) (3) (A), s personal Instagram page depicting a man and woman in front of the Eiffel Tower with Adolf Hitler superimposed and bearing the caption, "It gave me chills." (b) (3) (A), allegedly posted this picture on 21 October 2018. [Encl (25)]

37. The photograph allegedly from (b) (3) (A), s personal Instagram page was originally created by photographer (b) (3) for a History Channel advertising campaign. It is one of several photographs with historical scenes superimposed over modern day people in an album called "Know Where You Stand." [Encl (26)]

38. On 27 February 2020, the Twitter user "(b) (3) (A), (b) (6)" publicly messaged another Twitter user "(b) (3) (A), (b) (6)" saying, "Hey (b) (3) (A), (b) (6), wanna get another serviceman dishonorably discharged?" [Encl (27)]

39. On 27 February 2020, the Twitter user "(b) (3) (A), (b) (6)" replied saying, "Let's do it". (b) (3) (A), (b) (6) is the real name of "(b) (3) (A), (b) (6)". She runs a website called First Vigil where she tracks cases and investigations involving hate groups. As of 20 April 2020, (b) (3) (A), is not being tracked by First Vigil. [Encl (27)]

40. On 27 February 2020, On Twitter, (b) (3) (A), responded to “(b) (3) (A), (b) (6)” by saying, “Defamation of character won’t get any of you far. I’ve violated no articles of the UCMJ.” [Encl (27)]

41. On 28 February 2020, Andrew Dyer a reporter for the San Diego Tribune sent an email to the III MEF Media email account. In his email he identifies that he is aware of the Twitter exchange that happened on 27 February 2020, the USNI Facebook Page, and the Patriot Front photographs. He solicits a comment from the Marine Corps about whether or not an investigation has been opened. [Encl (29)]

42. On 28 February 2020, (b) (3) (A), (b) (6), the BLT Executive Officer, sent an OPREP-3 to the Marine Corps Operations Center detailing the contact from Andrew Dyer and the details Andrew Dyer shared. [Encl (30)]

43. On 29 February 2020, a command investigation into allegations of white nationalism in the case of (b) (3) (A), (b) (3) (A), (b) (6), (b) (7) USMC was initiated by (b) (3) (A), (b) (6) to determine whether or not (b) (3) (A), (b) (6) violated MCO 5354.1E. [Encl (1)]

44. On 15 March 2020, the San Diego Tribune posted an article on its website which focused on (b) (3) (A), and the investigation into the allegations of white nationalism. The article notes the relationship between (b) (3) (A), and the USNI. The article relays the views of (b) (3) (A), (b) (6) a senior research fellow at the Anti-Defamation League’s Center on Extremism. (b) (3) (A), (b) (6) notes that “no white supremacist group I’m aware of has done memes featuring people of color in a positive way.” [Encl (31)]

45. (b) (3) (A), (b) (6) an anti-fascist researcher who created First Vigil, a website that tracks neo-Nazi criminality, is quoted in the San Diego Tribune article. She says, “He does espouse out and out white nationalist beliefs....Patriot Front is an explicitly white nationalist organization and he is quite clearly using their propaganda.” [Encl (31)]

46. On 15 March 2020, the San Diego Tribune posted a photograph of (b) (3) (A), “liking” a post that said, “We must secure the existence of our people.” [Encl (31), (32)]

47. On 15 March 2020, the San Diego Tribune drew a comparison between the quote “We must secure the existence of our people.” and the slogan the “14 words” [Encl (31)]

48. According to the Anti-Defamation League, the “14 words” slogan is, “a reference to the most popular white supremacist slogan in the world: ‘we must secure the existence of our people and a future for white children.’” [Encl (33)]

49. On 15 March 2020, The San Diego Tribune posted a photograph from (b) (3) (A),’s personal Instagram Page captioned, “Real pic of me dreaming about my future blue eyed blonde haired mistress.” In the photograph (b) (3) (A), (b) (6) is wearing what appears to be USMC desert camouflage utilities and a rifle. In a reply to a comment on this photograph, (b) (3) (A), (b) (6) says, “No discrimination intended. I’d just like to help contribute to the preservation of my lineage.” [Encl (31)]

50. On 17 March 2020, (b) (3) (A), (b) (6), (b) (7)(C) USMC, was detailed by (b) (3) (A), (b) (6), Regional Defense Counsel-West to represent (b) (3) (A), (b) (6) [Encl (34)]

51. On 7 April 2020, (b) (3) (A), (b) (6) declined to make a voluntary statement via his appointed counsel, (b) (3) (A), (b) (6), (b) (3) (A), (b) (6), (b) (7) USMC. [Encl (35)]

52. On 11 April 2020, (b) (3) (A), (b) (6) posted on his personal Facebook page. In the comments he says, “‘Change’ or ‘Cultural enrichment’ is only inevitable if the ethnical majority of a nation becomes so docile that they neglect to preserve the racial fabric of their own country. The United States was founded by men of European decent and this nation is majority European... Our identity as a nation is vital to its survival because a nation without said identity is practically no different than a mind without a conscience.” In a different comment in the same thread he says, “We are talking about the important of preserving an ethnic majority in our country which is vitally important. If people like you really cared about ‘diversity’ then you’d be more inclined to uphold the predominantly ethnic backgrounds of every country in the world. If we subvert the sanctity of the racial majority of every nation, then what makes France French, or Japan Japanese, or India Indian? To protest the idea of preserving the racial sovereignty of any nation is a

direct contradiction to your yearning for ‘diversity’ you can’t experience the uniqueness of a foreign nation if you’ve destroyed the racial substance of its people.” [Encl (36)]

53. According to reference (b), dissident and protest activity (including supremacist activity) is: “knowing and wrongful conduct that involves actively advocating supremacist, extremist, or criminal gang doctrine, ideology, or causes, including those that advance, encourage, or advocate illegal discrimination based on race, creed, color, sex (including gender identity), religion, ethnicity, national origin, or sexual orientation or those that advance, encourage, or advocate the use of force, violence, or criminal activity, or otherwise advance efforts to deprive individuals of their civil rights.” And “Knowing and wrongful conduct that involves actively participating in criminal gangs, or in other organizations that advocate supremacist, extremist, or criminal gang doctrine, ideology, or causes; including those that attempt to create illegal discrimination based on race, creed, color, sex (including gender identity), religion, ethnicity, national origin, or sexual orientation; advocate the use of force, violence, or criminal activity; or otherwise engage in efforts to unlawfully deprive individuals of their civil rights. Active participation in such gangs or organizations is prohibited. Active participation includes, but is not limited to, fundraising; demonstrating or rallying; recruiting, training, organizing, or leading members; distributing material (including posting on-line); knowingly wearing gang colors or clothing; having tattoos or body markings associated with such gangs or organizations; or otherwise engaging in activities in furtherance of the objective of such gangs or organizations that are detrimental to good order, discipline, or mission accomplishment or are incompatible with military service. The prohibition extends to acts committed through electronic communications and social media, as well as in-person and other means.”

#### Opinions

1. (b) (3) (A), s participation in the USNI can be categorized as active due to his being the chairman and his frequent posting to the Facebook page and official webpage. [ff (6), (11), (12) (13), (14), (21), (34)]
2. (b) (3) (A), s participation in the USNI can be categorized as active due to his creation of an official badge of the USNI. This badge appears to be used to identify members of the USNI in public [ff (20), (21)]
3. (b) (3) (A), s posts and comments constitute acts or active participation with the USNI organization through electronic communications. [ff (6), (11), (12) (13), (14), (21), (34)]
4. (b) (3) (A), has, both personally and on behalf of the USNI, posted and “liked” social media that refers to white supremacist organizations or white supremacist slogans. [ff (14), (18), (19), (44), (45), (46), (47), (49)]
5. (b) (3) (A), has both liked and used language that is similar to “we must secure the existence of our people and a future for white children” also known as the “14 words”; a phrase commonly used by white supremacists. [ff (46), (47), (49)]
6. (b) (3) (A), has directly advocated for the preservation of the white ethnic majority in the United States. While his advocacy in this Facebook post does not call for action of discrimination against minority groups, his statements about preserving the racial fabric of the country being vital for the country to succeed indicate he is in favor of the white ethnicity being preserved as the majority. [ff (52)]
7. The USNI, has posted social media that offers inclusion and positive messaging towards minority groups. It is not clear whether or not (b) (3) (A), himself has posted these positive message photographs to the USNI Facebook page, or if it was another member of the group. [ff (12)]
8. (b) (3) (A), has been linked to conduct both in favor of and contradictory to white supremacist ideology or causes. This balancing of conduct is most likely a tactic to obscure or deflect attention from the true motivations of (b) (3) (A), to advocate white supremacist ideology. [ff (12), (14), (18), (19), (44), (45), (46), (47), (49), (52)]
9. It is likely that there was more white supremacist social media photographs and posts that are no longer publicly accessible online due to the fact that (b) (3) (A), was tasked with removing questionable material from his social media and the temporary taking down of Facebook pages and websites on or about 1 April 2020. [ff (13), (18), (19), (26), (28), (29), (36), (37)]

10. (b) (3) (A), s affiliation with the USNI has been tied to his affiliation with the Marine Corps. He publicly identifies himself as a United States Marine and also publicly identifies himself as the chairman of the USNI. (b) (3) (A) probably views his service in the Marine Corp and his chairmanship of the USNI to be related; He probably believes that they are both serving the United States. If (b) (3) (A), or the USNI's interests are white supremacy, they are not compatible with the equal opportunity policies of the Marine Corps. [ff (6), (18), (19), (20), (21), (46), (47), (49), (52)]

11. Noting that Twitter users "(b) (3) (A), (b) (6), (b) (7)(C)" and "(b) (3) (A), (b) (6), (b) (7)(C)" discuss "getting another serviceman dishonorably discharged," it is possible but unlikely that the posts alleging (b) (3) (A), had committed misconduct were manufactured. [ff (18), (19), (35), (36), (37), (38), (39), (40)]

12. The investigating officer was unable to acquire financial information regarding the USNI and thus unable to determine to what end the membership dues or funds raised were utilized. Additionally, the investigating officer was unable to uncover posts that have been deleted or taken down. [ff (7), (18), (19), (22), (26), (29)]

13. From the evidence currently possessed, the allegations of knowing and wrongful conduct by actively advocating supremacist ideology or causes are supported by a preponderance of the evidence. While there are conflicting pieces of information and pieces of information that remain hidden from this investigation, (b) (3) (A), has knowingly advocated for the preservation of an ethnic majority in this country which constitutes actively advocating supremacist, extremist, or criminal gang doctrine, ideology, or causes and has violated MCO 5354.1E. [ff (6), (11), (12), (13), (14), (18), (19), (20), (21), (34), (44), (45), (46), (47), (49), (52)]

#### Recommendations

1. I respectfully recommend further investigation by appropriate law enforcement agencies to further uncover evidence or information not available without law enforcement tools and to better determine the extent to which (b) (3) (A) is affiliated with white supremacist organizations or people. [O (1), (6), (9), (12)]

2. I respectfully recommend that (b) (3) (A), receive Battalion-level Nonjudicial Punishment for violation of Article 92 and subsequent administrative separated from the Marine Corps. His online actions through the USNI of re-using postings from white supremacist organizations and personal Facebook posts of advocating white supremacist ideology constitute violations of MCO 5354.1E. He clearly associates himself with both the USMC and USNI on his public websites. Despite being appropriately warned and counseled by his chain of command about his online posts and political rhetoric in the work-place, (b) (3) (A), has not ceased his activities or behavior. (b) (3) (A), views and online posts, evidenced as recently as 11 April 2020, are incompatible with military service, and he should be accordingly separated. In accordance with reference (c) paragraph 6210, section 9, processing for administrative separation is mandatory following the first substantiated incident of misconduct resulting from the Marine's participation in extremist or supremacist activities. In accordance with reference (c) paragraph 6210, section 9, part (b) an incident is considered substantiated when there has been a nonjudicial punishment based on a preponderance of the evidence that the Marine has engaged in supremacist or extremist conduct. [O (6), (9), (10), (13)]

3. Legal assistance from the 31st Marine Expeditionary Unit Staff Judge Advocate, (b) (3) (A), (b) (6), (b) (7)(C) via (b) (3) (A), (b) (6), (b) (7)(C) and administrative assistance from the BLT 1/5 Adjutant at (b) (3) (A), (b) (6), (b) (7)(C) are available during the course of your investigation.

**MAGNOLIA, Texas** – A Magnolia ISD student has been arrested for comments he made in a video that details a plan to shoot students on the campus of (b) (3) (A), (b) (6), (b) (7)(C) the Montgomery County Precinct 5 Constable's Office said Friday.

Deputy Constables arrested (b) (3) (A), (b) (6), (b) (7) Thursday night, officials said. (b) (3) has been charged with Terroristic Threat, a felony, according to constables.

Video obtained by KPRC2 shows a person identified as (b) (3) detailing a plan for a school shooting.

"I would walk outside and I would go back to the top of the woods and grab my gun and go back to the bleachers," (b) (3) can be heard and seen saying in the video, which officials said was recorded by other students on campus. He goes on in the video saying, "Three football fields is the length of the way from the top of the bleachers where my shooting position would be and the front door of the high school. Then when the bombs exploded people would come running out and I would have a perfect shot."

Magnolia ISD confirmed to KPRC2 that (b) (3) is also enrolled as a student at (b) (3) (A), (b) (3) (A), (b) (3) (A). A Facebook profile picture of (b) (3) (A), (b) (6), (b) (7)(C) shows, and authorities confirmed, he was a part of the school's junior ROTC program.

Officials said they were investigating a motive, but spoke to (b) (3) who told them the ordeal was a misunderstanding.

(b) (3) also posted a comment that detailed what he said took place. The page was taken down as of Friday morning, but KPRC2 obtained a copy of the post from investigators.

In it, (b) (3) wrote that his alleged plan was part of a conversation with friends on campus about whether a shooting could take place.

"I proceeded to explain how a shooting could easily be done. I told the story in first person... while not knowing I was being recorded," (b) (3) posted. "People who know me know I would never do such a terrible thing."

Parents of students enrolled in (b) (3) (A), (b) (6), (b) (7)(C) said the school district informed them of the threat Thursday night, after it had been thwarted. Still, some had questions about precautions being taken.

"It's a harsh lesson," said (b) (3) (A), (b) (6) who lives near the (b) (3) family and has a son enrolled at (b) (3) (A), (b) (6). She kept her son home Friday, but she said she wished Magnolia ISD alerted parents sooner when officials learned of the threat Thursday.

"I heard about it. I'm still trying to find answers," said (b) (3) (A), (b) (6), whose daughter is in ninth grade.

"I haven't dropped off my daughter yet. I was just checking it out," (b) (3) (A), (b) (6) said.

Both Precinct 5 Constable's Office and Magnolia ISD said campus was safe, noting Deputy Constables along with Montgomery County Sheriff's Office's Crime Reduction Unit searched campus Thursday night, with help from bomb-sniffing K9s.

"The security of our community, students and campus is the utmost priority of our department," said (b) (3) (A), (b) (6), (b) (7)(C).

Officials said they added additional officers to patrol campus Friday, as a precautions. Parents welcomed the additional support.

"I think it is for a while just till things calm down," said parent (b) (3) (A), (b) (6), (b) (7)(C).

Channel 2 asked Magnolia ISD at what time did district officials know about the threat and when they alerted teachers and parents.

"Since this matter is still under investigation by local law enforcement, I am currently not at liberty to comment further regarding details of the investigation," Director of Communications at Magnolia ISD (b) (3) (A), (b) (6) said in a written statement.

**Magnolia ISD released the following statement:**

*"On Thursday afternoon, February 11, Magnolia ISD administrators were made aware of a video posted by a (b) (3) (A), (b) (6), (b) (7)(C) student. School administrators immediately contacted Precinct 5 of Montgomery County Constable's Office due to the serious nature and the threatening manner of the video. The Constable's Office has thoroughly investigated any potential security threat on campus and has deemed (b) (3) (A), (b) (6) as a secure and safe campus*

*for our students. The District is working closely with law enforcement as the investigation is still underway. The District wants to make sure our students, parents and staff feel safe on campus so at the request of Magnolia ISD, the constable's office will have an increased presence in and around campus tomorrow. The safety of our students and staff will always remain Magnolia ISD's number one priority. The campus will operate on a regular schedule on Friday."*

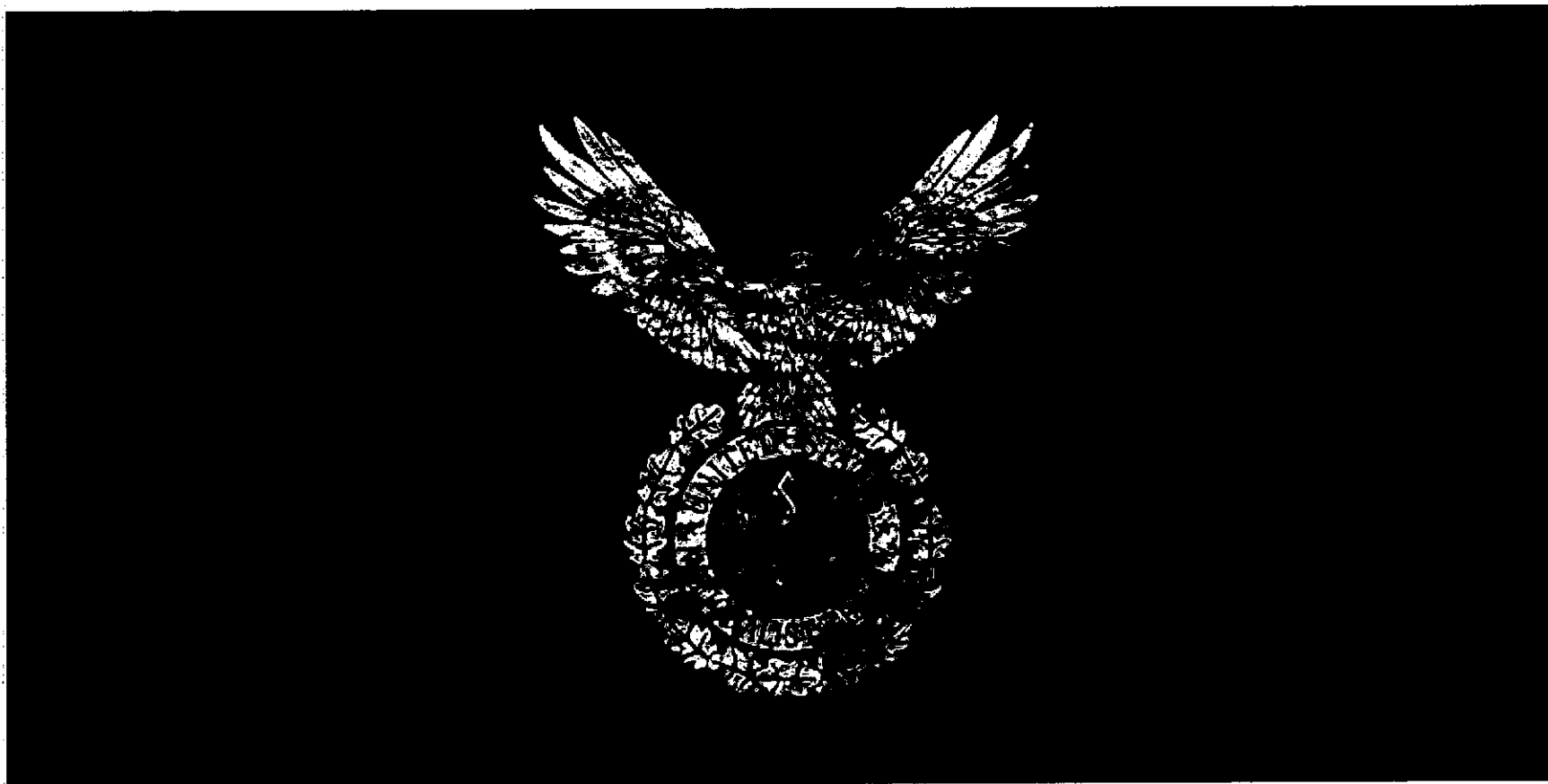

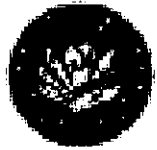

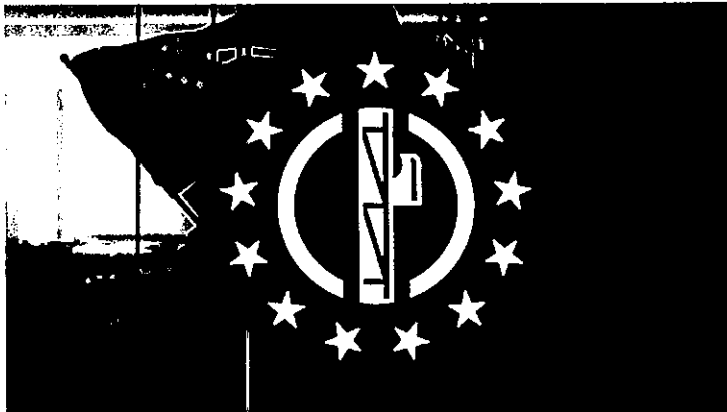

## Background

Patriot Front (PF) is a white nationalist hate group that formed in the aftermath of the deadly "Unite the Right" rally in Charlottesville, Virginia, of August 12, 2017. The organization broke off from Vanguard America (VA), a neo-Nazi group that participated in the chaotic demonstration. PF's founder, Thomas Rousseau, led VA members during "Unite the Right," including James Alex Fields, Jr., the young man accused of murdering anti-racist protester Heather Heyer after fatally driving his vehicle into a crowd of protesters.

Rousseau and his loyalists broke away from VA after a months-long feud with VA's leader Dillon Irizarry. Excerpts from leaked internal communications that were later posted to a number of online forums, including Kiwi Farms, reveal that tensions between Irizarry and Rousseau were coming to a head as early as June 2017.

*On June 20th, Thomas underhandedly and deceitfully exiled me from all of the Vanguard discord servers that HE controlled due to "security reasons". ... I logged off of discord and when I got back on an hour later I was banned from every single server, including the women's server. It was a literal coup with the guise that I left to handle family matters. So Thomas literally assumed control and is now cobbling and holding vanguard together with the fragile scaffolding of a lie and deception. He had been working out the plan for weeks, if not months, slowly taking the most miniscule steps under false pretenses such as "security" or "ease". ... He had already basically assumed control over Vanguard even before the large Austin event happened. He even went so far as you tell the coordinator of the event that HE was leading vanguard which is why he gave a 10 minute*

*speech about bullshit and when I went up there to give MY speech some people were confused. So this was all a very lengthy and elaborate plan for an 18 year old kid to treasonously assume control of a disgruntled internet group so he could accomplish....nothing. Thomas did all this of his own accord. Thomas is a traitor and should be regarded as such. — Dillon Irizarry, CEO/leader of Vanguard America*

PF's formal break from VA came amidst a movement-wide debate over the effectiveness of public demonstrations and the issue of optics in the wake of "Unite the Right," which resulted in widespread condemnation from the mainstream public. In the midst of this contentious feud, Rousseau formally broke with VA on August 30, 2017, just 18 days after the rally, in an announcement posted to the VA's southern region Discord server.

*Due to the unwillingness to meet any semblance of a compromise to resolve ongoing disputes with disagreeing parties, we are rebranding and reorganizing as a new entity. Vanguard America, as you know it, will now be the "Patriots Front." ... Our website is under construction, and will be back online via the same domain. Our focus will remain much the same, as will our overall [sic] goals, this restructuring will happen alongside the creation of an extended manifesto, and a top-down reform of the entity's ranking system. ... This change comes alongside many new visuals, and a new overall look. The new name was carefully chosen, as it serves several purposes. It can help inspire sympathy among those more inclined to fence-sitting, and can be easily justified to our ideology [sic] and worldview. The original American patriots were nothing short of revolutionaries. The word patriot itself comes from the same root as paternal and patriarch. It means loyalty to something intrinsically based in blood.*

Rousseau's conscious rebranding under the banner of PF was a direct consequence of "Unite the Right" organizers' inability to control the rally's presentation. Swastikas and other Nazi-era imagery was prominent among attendees who were also chanting slogans such as "Jews will not replace us." PF was one of a number of hate groups that sought to recast itself as mainstream, patriotic Americans by dressing up their propaganda and rhetoric in Americana.

PF's manifesto makes frequent reference to American historical figures, casting its politics as a revival of an allegedly authentic American identity based on "pan-European" colonizers. As Rousseau notes in his internal announcement of the organization's split with VA, PF's rebranding was aesthetic, not ideological. The group's politics remain staunchly white nationalist, albeit less explicitly.

PF's manifesto states, "Our people must learn to internalize their natural identities and come to connect that re-emerging identity with their homeland. Americans are descendants of Europeans, but at the same time they are not European. This nation is unique in its newly realized pan-European identity which has allowed it to succeed."

The manifesto continues with a call for the formation of a white ethnostate.

"The state has long since ceased to advocate for the interests of the descendants of its creators, and thus a State which will be, above all else, a reflection of the national interest must be implemented fully and absolutely."

PF's manifesto is also explicit in its exclusion of people of color from its conception of pan-European identity:

*An African, for example, may have lived, worked, and even been classed as a citizen in America for centuries, yet he is not American. He is, as he likely prefers to be labelled, an African in America. The same rule applies to others who are not of the founding stock of our people as well as to those who do not share the common unconscious that permeates throughout our greater civilization, and the European diaspora.*

PF frequently inveighs against “replacement populations,” meaning any non-white resident, immigrant or refugee, as a direct threat to its mission. Its manifesto accuses these often vulnerable communities as a threat to so-called pan-European culture. PF asserts, “The nation will see the thin veneer of civilization begin to wane as resources are diverted from them to the replacement population.”

Roughly a dozen members of PF turned this xenophobic platform into street activism at a San Antonio, Texas, Immigration and Customs Enforcement detention center on July 28, 2018. PF members marched up to an “Occupy ICE” protest encampment chanting “Strong nations, strong borders” before filming themselves vandalizing the protesters’ tents and signs. Rousseau, who is based in Texas, was among PF members filmed in the encounter.

PF’s activism typically consists of anonymously posting flyers, dropping banners off buildings or overpasses or performing miscellaneous acts of public service such as park cleanups. When PF orchestrates protests or public appearances, they are typically tightly choreographed and scripted to maximize propaganda value. Virtually all its activities are undertaken with propaganda value in mind.

Such was the case at a PF demonstration at the University of Texas at Austin on November 3, 2017, with roughly 30 members gathering around a statue of George Washington on campus with torches and flares while Rousseau delivered a speech stating, “America our nation stands before an existential threat. The lives of your children, and your children’s children, and your prosperity beyond that, dangle above a den of vipers. A corrupt, rootless, global, and tyrannical elite has usurped your democracy and turned it into a weapon, first to enslave and then to replace you.”

In a similarly theatrical performance, members of PF besieged a group of Houston anarchists at a book fair at the Multicultural Education through the Arts community center on September 24, 2017. A group attending a seminar on “refusing fascism” titled “Punching Nazis” barricaded themselves in the building while masked members of PF and local affiliates of the neo-Nazi website the Daily Stormer and the white nationalist radio network The Right Stuff lit flares and chanted outside the building.

Rousseau maintains strict control over PF. Members are barred from holding membership with any rival organization and must regularly engage in activism — such as posting flyers in their local communities — or risk expulsion. Members’ typically mundane local activism is then distributed across PF’s social media accounts alongside ostentatious quotes from PF’s manifesto.

The group’s top-down discipline and brand consistency have found success while many peer groups have struggled to maintain relevance. The fallout from “Unite the Right” left many other white nationalist groups completely alienated from mainstream politics. PF, through its garish patriotism, has also managed to rehabilitate the explicitly fascist agenda of VA with a foothold on major social media platforms for a nationwide membership.

## Origins

Patriot Front is a Texas-based alt right group led by 19-year-old Thomas Ryan Rousseau. The group split from Vanguard America (VA) in late August 2017, several months after VA participated in a white supremacist rally on the capitol steps in Austin, Texas. Both Rousseau, as the Texas leader, and Dillon Hopper (aka Dillon Irizarry), as the group's national leader, spoke during the event. Hopper later complained that Rousseau had led event organizers to believe that Rousseau, rather than Hopper, was VA's leader, and that Rousseau's lengthy speech during the rally further confused people about the group's true leader.

Two days after the Austin rally, Rousseau began his takeover of the group's servers and its "bloodandsoil.org" website. In an exchange that was posted on Twitter,

Hopper explained, "On June 20, Thomas underhandedly and deceitfully exiled me from all Vanguard discord servers that HE controlled due to 'security reasons.' I logged off...and when I got back an hour later I was banned from every single server, including the women's server. It was literally a coup with the guise that I left to handle family matters."

Just a few weeks later, with Hopper conspicuously absent, Rousseau led several dozen Vanguard America Texas members and associates at the August 12<sup>th</sup> "Unite the Right" rally in Charlottesville, Virginia. Though Rousseau led the Unite the Right contingent, it was Hopper who faced derision in the rally's aftermath as event images showed that James Alex Fields Jr., who is accused of plowing his car into a group of counter-protesters and killing Heather Heyer, participated in the event standing shoulder-to-shoulder with Vanguard America, and carrying a shield bearing the group's fascist symbol. VA has denied that Fields was ever a member of their group.

In late August, as Hopper isolated himself from the fallout from Unite the Right, Rousseau seized the moment. Rather than take over the troubled

America, he opted to rebrand VA's "bloodandsoil.org" as the Patriot Front website. The move allowed those associated with Patriot Front to distance themselves from both Vanguard America and any association with James Field. Ironically, the bulk of those who defected to Rousseau's Patriot Front were those who attended "Unite the Right" under the Vanguard America umbrella.

## **American Nationalism**

Leadership disputes aside, the split between Vanguard America and Patriot Front is symptomatic of the divergent opinions among white supremacists about optics and how to best promote their cause to the public. Rousseau's camp prefers to promote "American Nationalism" and advocate for a racist ideology that appeals to conservatives, using ostensibly unifying symbols like the American flag. In that same vein, Patriot Front uses an image of a fasces, the original symbol of fascism (a bundle of sticks featuring an axe) encircled by thirteen stars as "an American symbol of revolutionary spirit."

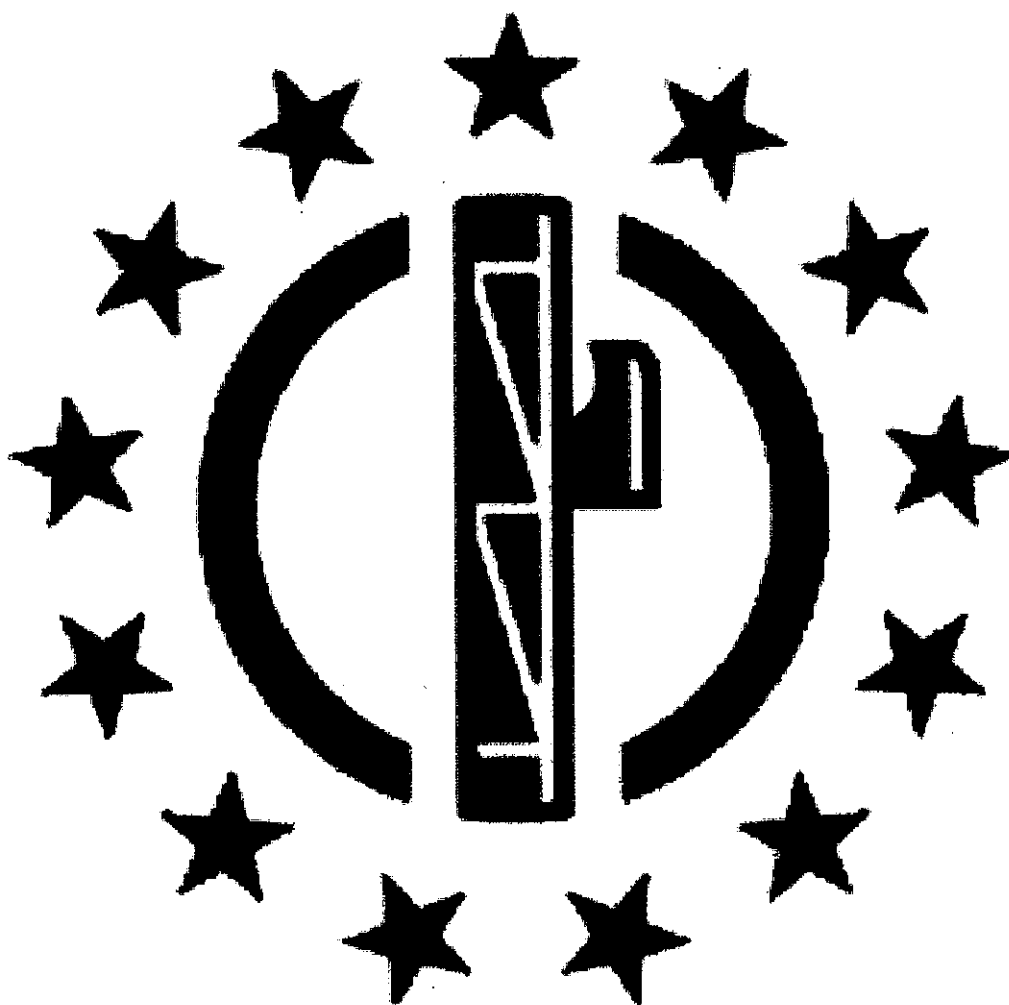
They also use the American flag during demonstrations, and often wear American flag-themed masks or bandanas.

After the split, one Patriot Front member posted on the alternative social media network Gab, "There is room for multiple iconography [SIC] as long as it's rooted in Americana. You can have a proper patriotic organizational flag alongside old glory. The issue is the folks among us demeaning the sacrifice of our ancestors and denouncing this nation as never being valid or moral." He also wrote, "We have been advocating for American Nationalism for a while. Unfortunately, our imagery with VA didn't facilitate it. When we in leadership split from VA we went full on American Fascism/Nationalism to great success."

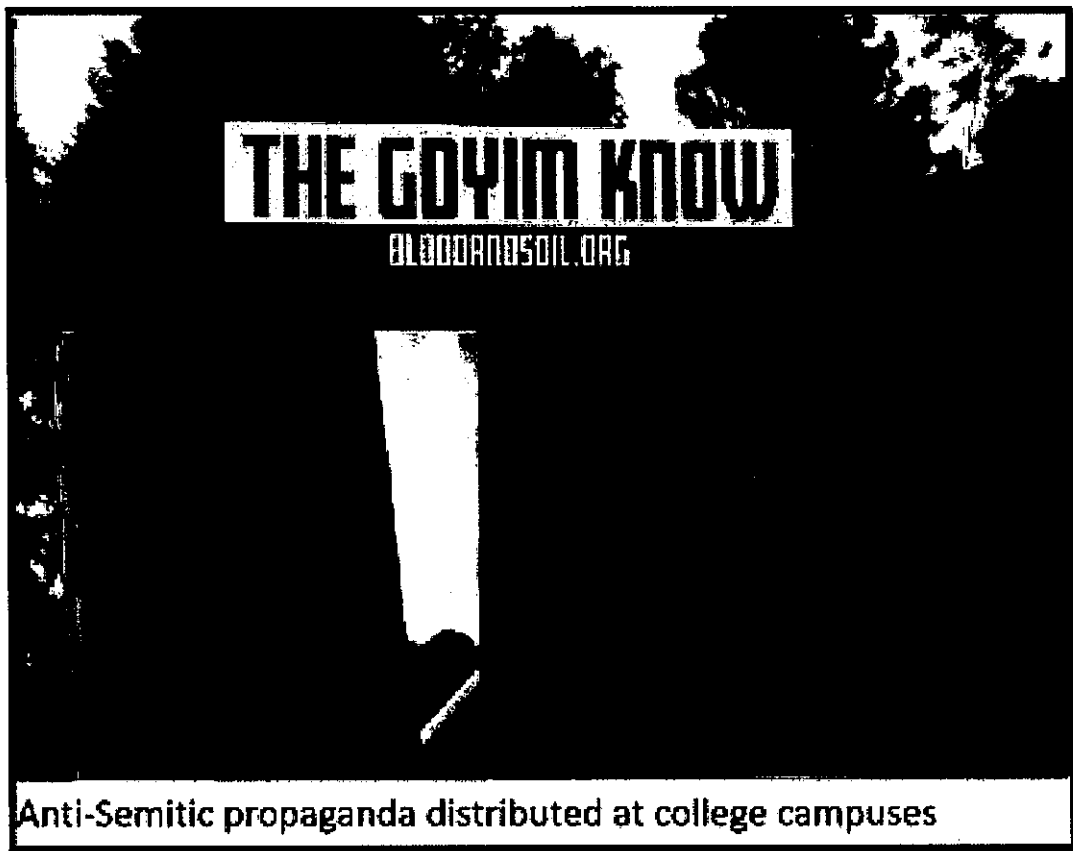

They may have split from Vanguard America, a group known for directly targeting Jewish institutions with hateful propaganda, but Patriot Front hasn't abandoned their anti-Semitism. The organization has distributed anti-Semitic fliers promoting Patriot Front on college campuses around the country.



In October 2017, someone placed a Patriot Front sticker on the glass door of a Jewish educational institution in Los Angeles. The sticker read "The Goyim Know," a reference to an anti-Semitic trope about Jews trying to keep non-Jews "in the dark" about their plans for world domination. A week later, the same institution was targeted by a second Patriot Front flier, this one bearing symbols of Islam and Judaism and the words "Reject the False Dichotomy. Both Must Go."

Another Patriot Front flier, which depicts two hands representing Jews and communists taking over America, has been disseminated widely.

Anti-Semitic online rhetoric is common among Patriot Front members and associates, and has included the use of "ZOG," a white supremacist acronym for "Zionist Occupied Government" which reflects the popular white supremacist belief that the U.S. government is controlled by Jews. Members have also used "1488," a combination of two popular white supremacist numeric symbols (14 is shorthand for the "14 words," a white supremacist slogan, and 88 stands for HH, or Heil Hitler.)

#### Additional Activity

Patriot Front is active online and uses social media to promote racism, anti-Semitism and intolerance, but they are also part of a broader effort by white supremacists to move from their longtime roles as online provocateurs to real-world activists. Real-world activism generates the group's desired localized outrage and media attention, as well as images and videos, which can be used to generate self-promoting and graphic online content.

Patriot Front's most frequent form of activism has been the distribution of racist and anti-Semitic propaganda on college campuses and in various communities in at least 12 different states. As of December 13, 2017, the Anti-Defamation League has counted 37 incidents in which Patriot Front flyers, banners or stickers were posted on campuses. Most of the incidents occurred in Texas, where the bulk of the group's membership resides, but Patriot Front propaganda has also been distributed in states as far-flung as California, Delaware, Florida, Maryland, Massachusetts, Michigan, New Jersey, North Carolina, Ohio, Utah and Washington.

Patriot Front members have participated in localized flash mob demonstrations in Texas alongside Daily Stormer's virulently anti-Semitic activist Robert Warren Ray (aka Azzmador), as well as other small alt-right groups such as the Whomsters and Houston Goylers. During these flash demonstrations, Patriot Front members generally wear khaki pants and a blue or white polo shirt; many also wear masks. The group, intensely focused on "optics," has used attention-grabbing smoke bombs, signal flares and torches during their demonstrations. Members routinely chant, "Blood and Soil," a slogan with origins in Nazi Germany that Patriot Front uses to conflate white European identity with American soil.

In addition to distributing propaganda, members also participate in private meet-ups, which routinely involve a physical fitness element like sparring or hiking. The group's internet propaganda stresses physical training and includes images of members boxing, coupled with phrases like "Become war" and "Train with your friends. Fight your enemies."

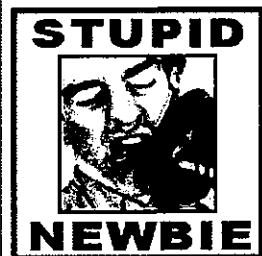

# Registering as a Super PAC

Super PACs are independent expenditure-only political committees that may receive unlimited contributions from individuals, corporations, labor unions and other political action committees for the purpose of financing independent expenditures and other independent political activity. The committee will not use those funds to make contributions, whether direct, in-kind or via coordinated communications, to federal candidates or committees.

## Registering as a Super PAC

Super PACs file a Statement of Organization (Form 1) to register with the FEC.

### HOW TO REPORT Registering a nonconnected committee

In addition to filing the Form 1, Super PACs also submit a letter stating:

*The committee intends to make independent expenditures, and consistent with the U.S. Court of Appeals for the District of Columbia Circuit decision in SpeechNow v. FEC, it therefore intends to raise funds in unlimited amounts. This committee will not use those funds to make contributions, whether direct, in-kind, or via coordinated communications, to federal candidates or committees.*

Paper filers submit this information as a letter with the committee's information.

Electronic filers can submit this letter as memo text added to a Form 1 submission using the FEC's Form 1 webform.

Mr Taras travelled the world shooting his pictures from the exact spot that major historical events were captured, then used photo editing software to blend these with their older counterparts.

### Camp Pendleton Marine under investigation for allegedly sharing white supremacist material online

### Marine infantryman chairs the “U.S. Nationalist Initiative,” a group he compares to those at deadly 2017 Charlottesville, Va. rally

CAMP PENDLETON —

The Marines are investigating an infantryman based at Camp Pendleton for potential violations of the Pentagon’s policy against extremism, according to a Marine Corps spokesman.

Lance Cpl. Thomas Cade Martin, 23, posted what some experts called “white supremacist” material across at least two social media accounts over the last two years.

The material includes a flyer with the white supremacist slogan “not stolen, conquered” over a map of the continental U.S. That flyer has been associated with the white nationalist “Patriot Front” organization. Identical flyers were anonymously distributed at San Diego State University in 2018.

His pages also include stylized patriotic graphics and photo illustrations of early 20th Century nationalistic propaganda which experts say are similar to those affiliated with the American Identity Movement, a white supremacist organization that changed its name from Identity Evropa

after its involvement in planning the 2017 Unite the Right rally in Charlottesville, Va., where a white supremacist drove his car into a crowd and killed an anti-racist activist.

Martin describes himself on his Twitter account as a "nationalist" and says he is the chairman of a group called the "U.S. Nationalist Initiative." Its Facebook page has more than 1,400 followers.

Experts who reviewed the page said it displayed indicators of white supremacist messaging, but one said Martin's is a "borderline" case because older posts on the page featured race-inclusive messaging.

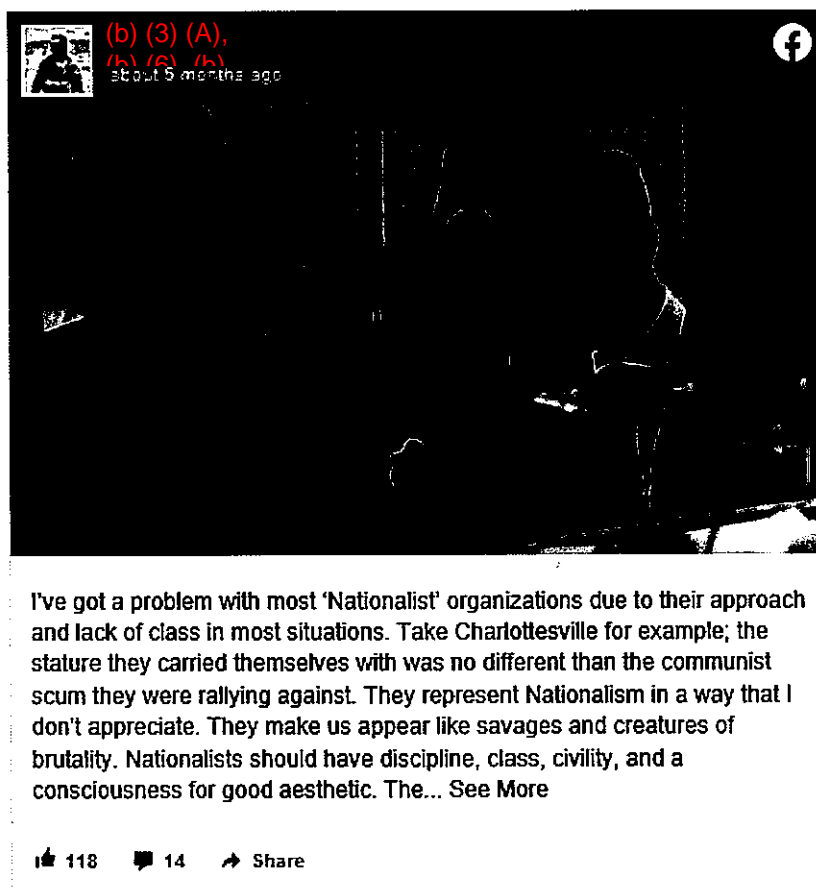
Reached via Facebook, Martin, who is deployed with the 31st Marine Expeditionary Unit on the Navy amphibious ship Green Bay, told the Union-Tribune that, due to his deployment, he's "barely able to communicate with the outside world by voice out here."

He declined to answer questions about his beliefs or his organization. He also stopped responding to requests for comment over Facebook Messenger.

In a post on his personal Facebook page dated Dec. 2, 2019, Martin called the organizations that marched in Charlottesville "nationalist," the same word he used to describe his beliefs.

Martin wrote that he has problems with the way the groups at the Charlottesville rally "carried themselves."

"Nationalists should have discipline, class, civility, and a consciousness for good aesthetic," Martin wrote in the post. "Instead of engaging in pointless temper tantrums; we should be strengthening our minds, bodies, and spirits."

Martin, who does not mention the protestor's death, added, "the stature they carried themselves with was no different than the communist scum they were rallying against. They represent Nationalism in a way I don't appreciate. They make us appear like savages and creatures of brutality."

Recently Martin has defended his writings on social media. In a tweet on Feb. 26, Martin told his Twitter audience that activists were defaming him.

"I've violated no articles of the UCMJ," he wrote, referencing the Uniform Code of Military Justice, which provides the legal framework of the military justice system.

According to Pentagon regulations, military members are not allowed to advocate "supremacist, extremist .... doctrine, ideology, or causes .... or otherwise advance efforts to deprive individuals of their civil rights."

Martin is assigned to the 1st Battalion, 5th Marines at Camp Pendleton — the same unit in which several Marines were arrested in July for allegedly transporting illegal immigrants and for drug offenses. Martin was not among those arrested.

He is deployed with the III Marine Expeditionary Force in Okinawa, Japan. A spokesman for the Marine Expeditionary Force confirmed the Corps is investigating Martin.

"III MEF takes all allegations of misconduct seriously, whether on duty, off duty, or online," said 1st Lt. Ryan Bruce in an email.

"Any form of racism or discrimination undermines the core values of the Marine Corps and is not tolerated. The command is thoroughly investigating this situation."

The spokesman did not say how Martin and his social media posts came to their attention.

The Union-Tribune reviewed Martin's Facebook account and the Facebook page and web site of the U.S. Nationalist Initiative with Mark Pitcavage, a senior research fellow at the Anti-Defamation League's Center on Extremism. Pitcavage in February testified before a House Armed Services subcommittee on white supremacy in the military.

Pitcavage said in an interview he has never seen a case like Martin's before because, while Martin's latest posts contain "clearly racist things," his older posts on the U.S. Nationalist Initiative page suggest a more race-inclusive brand of nationalism.

"No white supremacist group I'm aware of has done memes featuring people of color in a positive way," Pitcavage said during a phone interview Friday.

"It's unusual.... This may be a case of someone evolving from a civic nationalist to a white nationalist. Early in the alt-right (movement), not everyone was a white supremacist. After the alt-right got so much publicity as a white supremacist movement, these people began dropping out of (it)."

People in the "alt-light" prefer the term "civic nationalist," Pitcavage said.

"Some of (Martin's) earlier stuff looked like an alt-light, civic nationalist thing," he said. "But his later stuff — like the post about Charlottesville, talking about aesthetics, talking about fighting for your own people, are more white nationalism. This is a difficult, borderline case; there's certainly enough to make you suspicious."

Emily Gorcenski, an anti-fascist researcher who created First Vigil, a website that tracks neo-Nazi criminality, was among those on Twitter trying to draw attention to Martin's activity. To Gorcenski, Martin's ideology is obvious.

"He does espouse out-and-out white nationalist beliefs," she told the Union-Tribune in a direct message. "Patriot Front is an explicitly white nationalist organization and he is quite clearly using their propaganda ... he even describes himself as a nationalist."

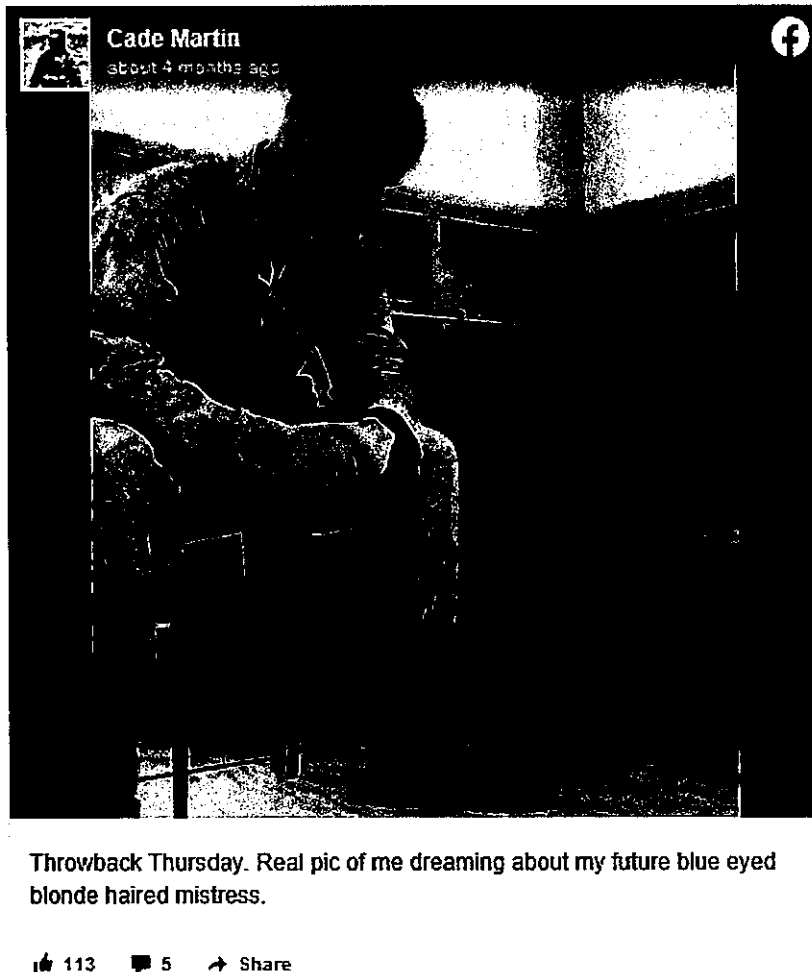
Gorcenski also pointed to Martin's photos of himself.

"'Conquered, not stolen' is a white nationalist belief, and despite the fancy window dressing and sharp suits, his messaging is indistinguishable from the messaging of orgs like Patriot Front, Identity Evropa (now known as the American Identity Movement) or the Rise Above Movement," she said.

Martin's own comments are suggestive of ideology as well, experts said.

In one post on his personal page, a photo of himself in uniform with a rifle, Martin says he's "dreaming about my future blue eyed blonde haired mistress."



In the comments on the post, he explains "I'd just like to help contribute to the preservation of my lineage."

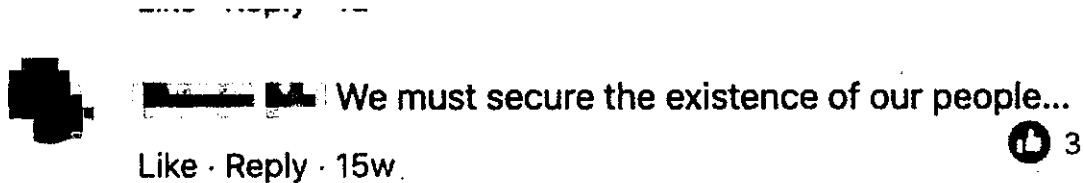

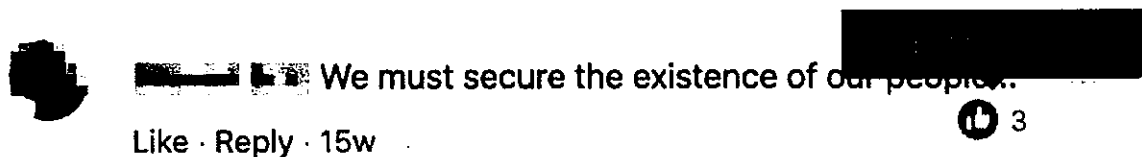

The Anti-Defamation League describes the 14 words as "the most popular white supremacist slogan in the world."

Peter Simi, a professor at Chapman University who has studied extremist groups for 20 years, said that although Martin appears to go to great lengths to avoid overt references to white supremacy online, his approval of the 14 words is a "giveaway" to the ideology underlining his activities.

"(White supremacist ideology) is pretty camouflaged for the most part but there are a couple of giveaways," Simi said while reviewing Martin's Facebook account and and page.

"The reference to the 14 words is one of them," he said.

The other, Simi said, is a post on Martin's personal account where he says the word "racist" is "made up."

"That kind of denial is consistent with white supremacist ideology," Simi said.

Martin says in the post the word "racist" is among several "made up" words used by the left. Another, he says, is "anti-Semite."

"Sacrifice what you believe in ... or get called racist," Martin wrote. "I know what my choice is gonna be."

Martin has had one run-in with authorities before.

In 2016, as a senior at Magnolia West High School in Magnolia, Texas, Martin was captured on video describing how he would commit a mass shooting at the school. He was criminally charged with making terroristic threats but the charge was dropped.

According to a story on Houston's KPRC news channel, Martin explained in a Facebook post he was just describing how a shooting could happen at the school, not saying he would do it.

Pitcavage said the Anti-Defamation League is not tracking the U.S. Nationalist Initiative, which Martin chairs, because it appears to be a small operation.

A review of the nationalist organization's website shows only one other person in leadership — Everett Corley, listed as the group's vice chairman.

Corley is a realtor who ran for Congress in Kentucky in 2016 and became embroiled in controversy around the removal of a Confederate monument at the University of Louisville. Corley called a professor a "damn dirty black bastard" in a Facebook post he later deleted, [according to the Louisville Courier-Journal](#).

Corley also has appeared on a white nationalist YouTube show called "The Ethno State" in 2014, the newspaper reported.

In a November 2018 Facebook post, Martin called Corley an "unsung hero ... an amazing friend and very wise man."

Corley did not respond to an email sent to his U.S. Nationalist Initiative address, to texts to a number associated with him nor to private messages sent via Facebook.

The Marines have taken a hard stance against members of white supremacist organizations within its ranks.

In 2018 it court-martialed a Marine who participated in the Charlottesville rally and had joined a neo-Nazi group, and in 2019 it discharged a Marine who included Nazi images in an Instagram account. In February, Marine Corps Commandant Gen. David Berger announced a ban on Confederate paraphernalia on the Corps' bases, [telling](#) Military.com "things that divide us are not good."

Pitcavage said during his Congressional testimony that the unchecked presence of extremists in the military leads to "serious negative consequences for the services ... and the country."

Among the most dangerous extremists, Pitcavage said, are those with white supremacist beliefs.

"While there are many extreme right-wing causes in the United States, white supremacists have posed the greatest challenges to the U.S. military," Pitcavage said.

Simi said knowing Martin is currently armed and deployed with the Marines is worrisome.

"It makes me nervous, knowing he endorses the 14 words and is walking around with a firearm overseas," Simi said.

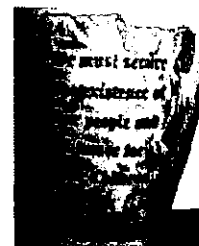
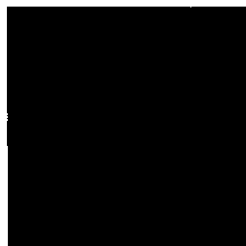
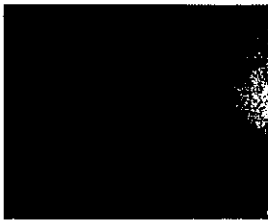

"14 Words" is a reference to the most popular white supremacist slogan in the world: "We must secure the existence of our people and a future for white children." The slogan was coined by David Lane, a member of the white supremacist terrorist group known as The Order (Lane died in prison in 2007). The term reflects the primary white supremacist worldview in the late 20th and early 21st centuries: that unless immediate action is taken, the white race is doomed to extinction by an alleged "rising tide of color" purportedly controlled and manipulated by Jews.

Because of its widespread popularity, white supremacists reference this slogan constantly, in its full form as well as in abbreviated versions such as "14 Words", "Fourteen Words," or simply the number "14."
