## Name of new UCI school honors \$50M donor

The Joe C. Wen School of Population and Public Health will be the first school of public health in Orange County.

The University of California Irvine will establish the first school of population and public health in Orange County, school officials announced Thursday after receiving approval from the UC Board of Regents.

It will bear the name of the Joe C. Wen School of Population and Public Health, recognizing a \$50-million donation made by Wen and his family to the university.

"When we created the Susan and Henry Samueli College of Health Sciences, UC Irvine committed to elevating all of our health science programs to full schools," said Howard Gillman, the chancellor of the university. "I am delighted that the regents have completed the final piece of that promise."

The Susan and Henry Samueli College of Health Sciences also encompasses the Sue and Bill Gross School of Nursing, the Susan Samueli Integrative Health Institute, the school of medicine, and the school of pharmacy and pharmaceutical sciences.

Plans to put the gift to use include the establishment of two endowments. The lion's share of the gift — \$42.5 million — will go toward priorities set forth for the new public health school, which becomes the fourth within the UC system. The remaining funds will help move forward cardiological

## OASIS garden plots feed the souls of those who tend them

t's hard not to notice the summer crops of produce that occupy over 5,000 square feet of outdoor space at the OASIS Senior Center on Marguerite Avenue in Corona del Mar.

"I have bell peppers, tomatoes, celery, romaine, red potatoes and zucchini growing in nine spaces that I created in here," said Scott Paulsen, president of the Friends of OASIS Garden Club, who shares his bounty with city staff and OASIS members. "I eat produce every day and still grow enough produce to give away."

Paulsen, a Newport Beach resident, is especially proud of his plump red tomatoes.
"I've picked about 20 so far, and we eat

them every night and they taste so good and fresh," he said. "And zucchini sneak up on you, one day they're 8 inches long, and the next thing you know they're over a foot. I make great zucchini pineapple bread usually with two big zucchini squash, which makes about 12 loaves."

"South Coast Plaza is so influential ... we thought it was a perfect fit for Yu Cake," said Bruce Guan. "It's a great opportunity to introduce our high-quality desserts to O.C. residents."





The Garden Club, which began 14 years ago, currently has 57 plots that are mostly 11-by-11 feet, with a handful about half that size set aside for gardeners who are just starting out. There is a wait list of 50 people

that carries a fee of \$5 to maintain interest in the garden. To have a garden costs \$30, and requires a \$40 security deposit. The club meets monthly except during the summer and features gardening lectures that are free and open to the public.

Newport Beach resident Linda Ŝimos said she has tendered her OASIS garden for five years, the same length of time she had been on the wait list.

"I live in a condo and I didn't have a yard at my house," explained Simos, who grows kale, tomatoes, herbs and roses. "Also, I've gotten to know a whole new group of people that I wouldn't have met without the [existence of the] garden.'

The are some common sense rules that govern the organic space.

Don't pick from somebody else's garden, ever, and you can't block sun from another garden or plant anything that might interrupt other gardens,

like nasturtium," Paulsen said. "Gardeners are required to keep [their gardens] up, weed-free and looking good and use the majority of the their plot. We don't want it wasted; too many people want it."

He said the garden club board will tell members who aren't taking good care of their plots to either fix them or lose them. "We give them 30 days' notice," he said. "We're not harsh, but we do have standards." According to Melissa

Gleason, OASIS director, on the morning of June 26,

one of the garden owners found a 4-foot-long rattlesnake, and animal control was called in.

Everyone was pretty calm, especially the animal control officer, who said [to the rattler], 'Hi Buddy, you're amazing.' We've had garden snakes periodically, but this is the first time I'm aware of a rattlesnake," Gleason said. "There's no way of keeping everything out of reach — we do the best we can being close by Buck Gully.'

The snake was given to Newport Beach Animal

Shelter, Gleason said.

Paulsen has also contended with wildlife visitors to his plot, although he didn't mention any reptiles.

"Varmints come in from the hillside — and rabbits, they love my green beans,' he said.

"It's a wonderful hobby one more place to stay active, and most people stay and don't want to give up their garden," he added. "Ît's a wonderful place and we love it."

The Chargers and Diablos will have to wait until Oct. 25 to face off, when Edison travels to Mission Viejo for its penultimate game of the regular season. Edison and Mission Viejo, along with Los Alamitos and San Clemente, were placed in the Alpha League.

"I think we know exactly what we're getting into," said Edison senior running back Julius Gillick, a recent commit to Montana. "Los Alamitos was easily one of our toughest games last year, [along with] San Clemente. Nobody in our

Edison went unbeaten in a pool that included Bakersfield Liberty, Centennial, Clovis North and Ventura St. Bonaventure. The Chargers notched another win against JSerra in the quarterfinals.

The Bravo League also consists of San Juan Hills, Tesoro, Villa Park and Yorba Linda.

"The way last year worked for us is it was never easy," CdM coach Kevin Hettig said. "Not one of the wins [was] easy. It wasn't easy at all, but we only find out about ourselves when we go through hard stuff. I think our kids, there's a belief going through that they'll be successful this year. It's not going to be easy this year. There's some tough games we play."

Corona del Mar went 3-2 on Saturday, notching wins over Harbor City Narbonne, Palos Verdes and Los Alamitos, before falling to Santa Margarita in the quarterfinals. Senior Max Nashed and junior Brady Annett shared the snaps. They are vying for the opportunity to replace Kaleb Annett, who is heading into his first season with the Boise State football program.

The Sea Kings bring back five of their top six receivers from a year ago, including junior wide receiver Dorsett Stecker, senior tight ends Zach Giuliano, Sebastien Boydell and Breck Clemmer, and senior running back Wyatt Lucas.

Other former Sunset competitors League showed up to the tournament. Huntington Beach sophomore quarterback Brady Edmunds and junior wide receiver Troy Foster

"We were up at 6 or 7 a.m. before school, working out, throwing together. I feel the chemistry we've built over these months is different than anyone else. This year, we obviously come in with a chip on our shoulder, and I think we're coming for it all this year, for sure."



as part of the Huntington Beach City Junior Lifeguard exchange program with New Zealand.

The program, established in 1979, typically runs every three years, though this is the first year it's happened since 2019, before the coronavirus pandemic. About 30 Junior Lifeguards from Piha and Tairua Surf Lifesaving Clubs, on the west and east coasts of New Zealand's North Island respectively, made the trip along with a few coaches.

"We got to be in the towers for a bit, shadowing the lifeguards," said Muir, who lifeguards at Tairua back home. "I did a rescue. It was my first rescue in America, so that was pretty cool. I think it boosts our confidence. We're all qualified lifeguards in New Zealand, and some of us haven't done rescues before. I think it's a good opportunity for us to boost our confidence, knowing we're capable of doing that so we can go back to New Zealand and be confident when we're patrolling.'

The Stevens family of Huntington Beach, which has both James and Peter in the exchange program, has been hosting two New Zealand junior guards this month. The larger group of teenagers has also done other fun activities together — an Angels baseball game and a visit to Disneyland last weekend, and a Catalina trip on Wednesday.

On Tuesday night, the New Zealand junior guards performed a special haka dance at the City Council meeting.

Kelli Stevens said it's been a valuable experience for her family. James, a Junior Guards captain and incoming junior at Huntington Beach High, and incoming freshman Peter are two of the Huntington Beach contingent who will head to New Zealand in December to complete the exchange.

"As a parent, I love to just sit and listen to them communicate," Kelli Stevens said. "They're talking about the similarities and differences between the food and the culture and the life-saving techniques ... It's fun for them to have a friend across the world. I know my boys can't wait to go and visit their families and see them again."

Huntington Beach Marine Safety Battalion Chief Doug Leach was part of a program, similar through the California Surf Lifesaving Assn., in 2006 and 2007. He returned each year for several years, working as a seasonal lifeguard in Surf City during summer before heading back to New Zealand for the summer down under, which stretches from December through February.

He understands the importance and legacy of the Junior Guards exchange program as well.

"I know how many of our staff members have been over there when they were younger, and how influential it was on them," Leach said. "Personal growth as a young person, the relationships they've built with their Kiwi counterparts, it's just such a cool and unique thing."

Jack Tyler, 16, is another of the New Zealand teenagers on the trip, which ends Friday. He said Piha Beach is much smaller than Huntington Beach. The lifeguards there set up flags for the safest areas for peo-

ple to swim, an impossibility on the vast Surf City sands.

On one surf session on his lunch break this week, Tyler said he ran into a surfer from Spain

surfer from Spain.
"It was just a super-cool environment, and everyone was super-friendly," Tyler said. "It's just been a fantastic experience."

The junior lifeguards went on a jetty run together Thursday morning — more than five miles round trip — which James Stevens said was a nice bonding moment.

The Huntington Beach Junior Lifeguards are about 40% of the way toward meeting their \$125,000 fundraising goal for the December trip, Junior Lifeguard program coordinator Samantha Dieterman said. A pancake breakfast is scheduled for July 27 at Lake Park, and a portion of the \$6 cost will go toward

the travel expenses.

"Overall, I'd say it's a really good experience and it just boosts the relationship between the countries and the life-saving clubs," James Stevens said of the program. "I've learned some stuff too, like the releases and the grabs and stuff. We don't really do that down here, at least not as far as I've progressed. It's just learning new things, and being able to do adapt better to different scenar-

ios. It's been awesome."

Come December, the Kiwis look forward to treating the Southern California kids to a slice of their life as

"It's going to be exciting, like an extra sibling in the house, I guess," Muir said. "It'll be good to return the favor."
