# O.C. officials, residents react to inauguration

#### **BY ANDREW TURNER**

The peaceful transition of power has long stood as a symbol of the democracy that Americans hold dear.

Joseph R. Biden became the 46th president of the United States on Wednesday, the inauguration ceremony taking place just two weeks after rioters stormed the U.S. Capitol in protest of the election results.

"Today, we celebrate the triumph, not of a candidate but of a cause, the cause of democracy," Biden said. "The will of the people has been heard, and the will of the people has been heeded. "We've learned again that democracy is precious, democracy is fragile. At this hour, my friends, democracy has prevailed." After being sworn in by Chief Justice John Roberts, the overriding message of Biden's 21minute inauguration speech was one of unity. "We can see each other not as adversaries but as neighbors," Biden said. "We can treat each other with dignity and respect. We can join forces, stop the shouting and lower the temperature, for without unity, there is no peace, only bitterness and fury."

The inauguration ceremony also featured Biden calling for a silent moment of prayer to remember the victims of the coronavirus pandemic during the past year.

Biden has set a goal to vaccinate 100 million Americans in his first 100 days in office, but he warned that coming through the pandemic will require the nation to work together.



## County reports 1,701 new cases

The Health Care Agency reveals another 31 people died from COVID-19 with 1,975 patients hospitalized.

The Orange County Health Care Agency reported 1,701 new cases of the coronavirus on Wednesday, which brings the county total to 216,509.

Data also show another 31 deaths from COVID-19, the disease caused by the virus. One of the patients was a resident of a skilled nursing facility and the rest were residents not living in a facility.

With 16,310 coronavirus tests reported on Wednesday, the total number of tests in the county is 2.5 million, not including positive antigen tests which cumulatively total 12,623.

Area hospitals say that there are 1,975 patients with COVID-19 currently hospitalized, with 527 in intensive care units. Adjusted numbers from the agency indicate that ICU capacity countywide remains at 0% with 34% of ventilators available.

Orange County remains in the purple, "widespread" tier, the most stringent. To meet the requirements of the red, "substan-

By a 5-2 vote, the Huntington Beach City Council paves the way for future development on the 29-acre site.

The spectacle of the inauguration was in no way diminished by the absence of a large crowd.

## Ex-councilman John Stephens named to fill Costa Mesa Planning Commission seat

#### **BY SARA CARDINE**

Former Costa Mesa City Councilman John Stephens — who left office in December following an unsuccessful reelection campaign in the city's 1st voting district — will return to public service after being appointed Tuesday to the Planning Commission.

Council members were tasked with filling four open seats on the seven-member commission, including Districts 1, 2 and 6 and one at-large position, from

#### among 27 candidates.

Districted-seat appointees are first nominated by their district equivalent on the City Council and then voted on by the entire panel and appointed only upon majority approval, while the mayor is responsible for nominating a candidate for the atlarge position, subject to the same approval process.

And that's just what Mayor Katrina Foley did Tuesday when she selected Stephens to serve in an at-large capacity for a twoyear-term. "I think at this time it's really important that we have somebody who has some experience with our housing element issues and our cannabis issues," Foley said.

Council members unanimously approved the appointment in a 7-0 vote. Stephens will replace outgoing at-large Commissioner Marc Perkins, whose seat expired Jan. 31. Perkins did not seek reappointment.

The council was also unani-

The Huntington Beach City Council voted 5-2 to approve zoning changes to the controversial Magnolia Tank Farm site in southeast Huntington Beach during a virtual meeting Tuesday night.

Mayor Pro Tem Tito Ortiz, Dan Kalmick, Natalie Moser, Barbara Delgleize and Mike Posey voted for the zoning changes, which were considered after more than an hour of comments during a public hearing. Mayor Kim Carr and Erik Peterson voted against them.

The move was the first step in paving the way for future development of the 29-acre site, which is located at 21845 Magnolia St. It would change zone use of the Tank Farm site from public/semipublic heavy industrial to four land uses: residential medium density, coastal conservation,

## Newport Harbor teens create CurBros curb painting business

Trent Edmondson used to work a job on the Balboa Island ferry.

But when the pandemic set in, the 17-year-old decided that he'd leave his job. His mother, Cindy Edmondson, didn't have the best immune system, he said, and he wanted to limit his exposure to strangers to protect his and his family's health.

After he quit, he said he'd been looking for things to do outside attending his classes at Newport Harbor High School, where he is a senior.

Then, he saw an advertisement for curb painting.

"I thought, 'That's a great idea. I think I can do it,' " Trent said, laughing. "That day, I talked to my friends. We started to work on it and ... just jumped right in and got a bunch of different materials. My own curb has like 10 layers of paint on it now because we wanted to get it just right."

That was the start of CurBros, a business venture made up of Trent and childhood friends Corey Campbell and Dylan Bernal, both 17 and seniors at Newport Harbor.

Organizing began in December, but the team didn't start painting in Newport Beach and Costa Mesa until last week. Corey and Dylan said the business was all Trent's idea, but Dylan added proudly that he came up with the name.

Corey said that he stopped helping his dad at the family's automotive shop to help limit the exposure of his family to the coronavirus. He used to do things like sweeping the shop and cleaning the restrooms, but now he's focused on the curb-painting business, which they said has received positive feedback.

"Initially when we posted it on Nextdoor, we didn't get very much attention in the first 24 hours," Corey said. "But after that, it started to blow up with a lot of positive stuff from the community."

CurBros have around 25 curb paintings scheduled through the next week, if the weather permits, and have started the process to apply for a business permit in Costa Mesa.

City officials from Newport said that the three-man team will need to apply for encroachment permits to paint curbs, but will be able to block a number of adKevin Chang | Staff Photographer

#### **CITY SUSPENDS STREET-SWEEPING TICKETS DURING STAY-AT-HOME PERIOD**

In other news Tuesday, City Council members agreed to temporarily suspend issuing tickets to vehicles that do not move to accommodate citywide street sweeping schedules, to help ease the economic burden of residents during the latest pandemic-inspired stayat-home order.

Officials agreed people now forced to work from home have less motive and opportunity to move their vehicles on a regular basis. And with many residents out of work or facing economic hardship, issuing tickets for a relatively minor violation seems overly punitive.

"I don't personally feel comfortable knowing we're getting money fining our residents, especially during a pandemic," Councilman Chavez Manuel said. "[This] is one small thing we can do to help out struggling families, particularly in low-income communities.

City Manager Lori Ann Farrell Harrison acted on Dec. 23 in her capacity as the city's emergency services director - a designation granted in March under the first coronavirus shutdown — to halt streetsweeping tickets during a Scott Smeltzer

regional stay-at-home order issued by the state in December.

A previous suspension was made in March and later lifted as restrictions eased and businesses came back online. Farrell Harrison reinstated the suspension on Dec. 23, and council members agreed Tuesday to ratify that decision.

The latest suspension is intended to last at least as long as Orange County remains under stay-at-home orders. With a single citation costing as much as \$45, previous budget estimates have indicated the city roughly earns \$1 million annually from streetsweeping citations.

Some members of the public argued against the loss of revenue, while others wondered at the environmental impacts of sweepers not clearing from gutters debris that will ultimately runoff into the Upper Newport Bay and, ultimately, into the Pacific Ocean.

But Councilwoman Arlis Reynolds said most of the purported \$1 million revenue came from Costa Mesa neighborhoods hardest hit by the pandemic.

"[This] is a temporary direction to reduce the impacts on residents who are really struggling," she said. "We've heard a lot of pain from residents who've been in areas that have been getting those tickets. So, frankly, it's the least we can do."

## Man suspected of DUI in fatal H.B. collision

A 35-year-old Sunset Beach man was arrested on suspicion of DUI in a multi-vehicle collision Tuesday on Pacific Coast Highway in Huntington Beach that killed two motorists and injured one, police reported.

Eric Kinser was allegedly driving a white 2007 Dodge Ram pickup truck northbound on the highway near the Bolsa Chica Conservancy off Warner Avenue just before 6:45 p.m., when he crossed over the center median into southbound lanes of traffic, according to a release issued Tuesday by the Huntington Beach Police Department.

His vehicle allegedly collided head-on with a silver 1999 Toyota Solara driven by a 19-year-old Newport Beach man and then struck a white 2012 Lexus RX350 occupied by a 71year-old Huntington Beach woman and her passenger, a 45-year-old woman, the release stated.

open space park and coastal visitor serving/commercial.

The zoning change will go before the California Coastal Commission for approval, since it includes a Local Coastal Program Amendment.

Shopoff Realty Investments, which purchased the site in 2016, plans to build real estate on the land, including 250 singlefamily attached and detached units and a boutique lodge. The development also would include 19,000 square feet of retail and dining space, as well as parking and a new public park, Marsh Park. The existing greenbelt area known as Squirrel Park would be turned into another public park called Magnolia Park.

"I think that this project is an opportunity for us to start shaping a vision for what we want the area to be, and what the residents want it to be too," Moser said. "I know there are mixed opinions regarding that, but one of the commenters earlier talked about it being a potential legacy project. I think that it has the potential to be that ... I think that the community benefits do truly outweigh the challenges. First things first for this, you have to check the public safety box. I believe that with the [California Department of Toxic Substances Control] letter and report that shows that they've met the threshold for residential building on the property, that would indicate that box has been checked.

"I've heard from some community members that it would be revenue over the residents, and I don't believe that at all."

The proposed devel-

opment has generated controversy, at least partially because it is next to the Ascon property that is a former landfill. Work on cleanup of the site was paused in June 2019 and has not resumed. However, the Huntington Beach Planning Commission, which featured Kalmick at the time, voted 5-2 in October 2019 to verify the project's environmental impact report was complete and approved a general plan zoning amendment for the site.

The City Council received 428 supplemental emails in regard to the Magnolia Tank Farm project.

In voting against the zoning change, Peterson said he didn't feel the zoning change was compatible to the surrounding area, noting that the heights for houses in the project could be different than houses in the surrounding community.

Carr voiced concerns about building homes adjacent to the AES power plant "that won't be going away anytime soon."

"On the face of it, this project is really quite beautiful, but what I don't like about it is the location of it," Carr said. "It's adjacent to AES, it's adjacent to Ascon, it has Poseidon potentially next to it and the wetlands."

## Huntington Harbour public boat channel to open

#### **BY MATT SZABO**

Harbour Huntington Yacht Club commodore Rudy Lopez said he hopes to take his boat out into the ocean on Thursday, weather permitting.

It isn't just another day for Lopez.

Thursday marks the first day that the new civilian boating channel through the Anaheim Bay will be open to the public, Naval Station Weapons Seal Beach has announced.

"I just want to go out there, putz around, get into the open water and come on back," Lopez said. "I think it's a historic thing for us as a club. You can take that travel path any time you want, but there's nothing like that very first dav."

Under the former con-

figuration, which has been in place since Huntington Harbour was developed in the 1960s, civilian boaters had to pass through the Navy base in order to enter and exit the Pacific Ocean through Huntington Harbour. Now, they have their own dedicated lane.

The old channel is becoming part of Naval Weapons Station Seal Beach and being blocked off, said Gregg Smith, public affairs officer for the weapons station.

"It improves safety and security, both for the boating community as well as for the Navy," Smith said.

The new channel is part of a \$154-million U.S. Navy project designed to reconfigure Anaheim Bay, as well as build a new ammunition pier for the Navy. The project is set to



be completed in 2024.

"We have an ammunition pier currently," Smith said. "It's actually an ammunition wharf, but it was originally constructed in 1944 and then rebuilt in 1953. It's not been substantially modified since that time, so yes, we are definitely looking forward to a replacement.

Smith said the public channel had to be completed before construction could continue.

Burt also loved basketball, the Lakers, the Rams (then and now) and the local rock band scene. Many of his longtime friends are musicians.

Writing song lyrics since high school, in his last year of life he and a good friend's band recorded one of Burt's songs. The music video is coming out soon.

During Burt's four-year journey with cancer, he charmed doctors, nurses and hospice team with his unique wit and kindness, as he has to so many who know him. The night before he died, lifelong friends arranged to sing carols to him via Zoom. The last carol was Silent Night. When "Sleep in heavenly peace" was sung, we didn't know how soon it would

Burt had many friends who, like our family, are heartbroken but glad he's no longer in discomfort. This year of COVID-19, and its enforced isolation, added to his medical challenges. Yet he handled it with grace, concern and caring for others, an active Facebook community, and his great sense of humor

Burt's early career was in the restaurant business, allowing him to enjoy a flexible schedule for surfing and music. Later he transitioned to apartment property management, following his sister and cousin Kris. He worked on the management side for prominent Orange County companies like Sares Regis, Western National and Arnel. He then found his niche selling advertising to the apartment industry, first print ads and later online advertising, with Apartment Magazine / Apartment Finder.

Burt was active in several professional organizations particularly the Apartment Association of California Southern Cities. He taught industry training classes and during his career received several awards including South Coast Apartment Association Manager of the Year; Arnel Manager of the Year; California Southern Cities Product Service Council Member of the Year and Industry Partner of the Year.

Burt loved life and enjoyed the support of his family, friends, co-workers, and industry colleagues — so many of whom he considered friends. Burt is survived by his mother Alice MacWilkinson (Derek), sister Susan Sirota (Robert Goto), step-brothers Nigel MacWilkinson (Barbara), Philip MacWilkinson, aunt Adele Kopecky, cousin Kris Berry (David), and numerous nieces, nephews and cousins.
