# A return to full-day classes

and adults alike Wednesday morning, as Newport-Mesa Unified School District welcomed thousands of elementary students to campus for the first full day of in-person instruction since March 2020.

Masked students at Adams Elementary School in Costa Mesa were greeted with cheery hellos and elbow bumps galore during the school's morning drop-off period. For some friends, the start of the school day was the first opportunity for them to reconnect across cohorts that had been separated and attending in-person classes in shifts since Sept. 29.

NMUSD trustees approved the return of elementary school

# OCC's Newport facilities named for waterfront

The Intercollegiate Rowing and Sailing Base and the Professional Mariner Training Center are now the OCC Waterfront Campus.

Orange Coast College's marine facilities in Newport Beach are now going by a new name, following approval by the Coast Community College District Board of Trustees earlier this month.

What was the Intercollegiate Rowing and Sailing Base and the Professional Mariner Training Center on West Coast Highway will now be collectively called the Orange Coast College Waterfront Campus.

Campus officials said expansion of the Costa Mesa college's footprint in Newport Beach has been met positively by locals and the boating community at large

"Our community boating, intercollegiate rowing and professional mariner programs will continue to grow and evolve with our new designation as OCC's Waterfront Campus, and our mission to provide nautical education of the highest quality will continue," said Sarah Hirsch, director of the Orange Coast College Waterfront Campus, in a statement issued by the college

statement issued by the college.

Discussions to name the locale began last fall when maritime staff met with Hirsch, Doug Bennett, the executive director of college advancement and foundation, and then-interim vice president of instruction Pamela Walker.

Beneath the umbrella name, the two facilities will retain their individual names — the Intercollegiate Rowing and Sailing Base and the Professional Mariner Training Center.

Renaming the Newport Beach location will allow the college to market the programs available on West Coast Highway in one place to streamline information for interested students and visitors,

# Attorney says prosecutors expect to move forward in doctor drug-sexual assault case

A prosecutor told an Orange County Superior Court judge Wednesday that she is prepared to go forward with some counts and dismiss others in the case against a Newport Beach hand surgeon and his girlfriend, who are accused of drugging and raping several women.

Yvette Martinez of the attorney general's office said a decision on

the future of the case against Dr. Grant Robicheaux, 40, and Cerissa Laura Riley, 34, was "imminent," but first she must brief Rob Bonta after he is expected to be sworn in as the new attorney general, if approved by state lawmakers. The new attorney general, she explained, must sign off on the recommendation from Martinez.

Robicheaux and Riley are charged with drugging and sexually assaulting multiple victims

they allegedly met at social gatherings. Robicheaux is charged in connection with seven alleged victims, while Riley is charged with five. They have both continued to maintain their

innocence.

The idea of waiting for the new attorney general troubled Orange County Superior Court Judge Steven Bromberg as he cited the lengthy history of politics involved in the case as it became a political football during Orange

County Dist. Atty. Todd Spitzer's campaign to unseat Tony Rackauckas. Spitzer's office was removed from the case last year after he tried to dump it and the attorney general's office took it

over.

Martinez initially asked for a final pretrial hearing for May 25 before setting a preliminary hearing, but Bromberg moved it up to May 14 instead. He said a

# Body found in Huntington, authorities investigate death

A body was discovered by a local resident in the oil fields southwest of Talbert Avenue and Edwards Street.

The resident reported discovering the body to Huntington Beach police at 5:37 p.m. on Monday, and investigators located the decomposing remains of what appeared to be an adult male. Property believed to belong to the decedent was also found

# Aircraft club's long glide at Fairview Park on the skids as hiatus extended

A complex debate over whether city parks should be used for recreation or preservation is causing some turbulence in the city of Costa Mesa.

lence in the city of Costa Mesa. Fairview Park — a 208-acre open space home to some 30 protected species that has been found to contain artifacts from at least two Native American tribes — is also a draw for residents who, for decades, have biked, picnicked and recreated on its ample plains.

Take the Harbor Soaring Society, a club for aviation enthusiasts and remote-control aircraft flyers. For more than 60 years, members have enjoyed the friendly skies at a model airplane flying field on Fairview's west side.

Flyers were displaced from the park in March 2020, when the city closed public facilities during the pandemic. And

though Fairview has since reopened, the flying field remains closed as the city updates the site's master plan and considers whether airplanes, gliders and drones are compatible with other park uses and priorities.

With its latest use agreement having expired in December, the Harbor Soaring Society has been looking to re-up the arrangement. Leaders recently put forth proposals suggesting tougher restrictions on operating hours and the types of craft allowed, creating a means of measuring noise and requiring flyers seeking city permits to undergo certification, among other plans.

Still, members of a Fairview Park Steering Committee in an April 14 meeting decided not to extend the club's entitlement. They instead favored possibly relocating the flying field to the park's east side, where the Orange County Model Engineers operate locomotives on a miniature railway under a separate use agreement.

# New dining options coming to Huntington State Beach

Alicia Whitney is ready for her next challenge, and visitors to Huntington State Beach will ultimately benefit from her culinary adventure.

Whitney, a Huntington Beach resident, is the founder and chief executive of Prjkt Restaurant Group, which is bringing three new concessionstyle eateries to the local state beach in the next year.

The Huntington Beach House, located at Beach Boulevard and Pacific Coast Highway, is scheduled to open this spring. Sahara's Sandbar, a pizza place named after Whitney's 10-year-old daughter Sahara, will open this fall at Magnolia Street and PCH.

California Fork and Spoon. located at Brookhurst Street and PCH, is slated to open in early 2022. Additionally, SandBox Beach Rentals, located at Newland Street and PCH, will offer services like surfboard and firewood vending machines when it opens to the public this May.

Whitney, 41, describes herself as "all things Huntington."

"I'm just excited and grateful," she said. "I hope that I can continue to make our community and State Parks proud with the effort we put into this big project." The existing conces-

sions buildings, which have been at the Huntington State Beach since 1984, are being rebranded as part of the Prjkt Restaurant Group effort. Whitney, who previously was behind four concessions areas at Bolsa Chica State including Beach, popular SeaLegs at the Beach, found out she won the bid for the new project last May after responding to a request for proposal in September 2019.

Prjkt (pronounced "Project") has a 10-year agreement in partnership with the California State Park System, State Park Orange County Supt. Kevin Pearsall said. Prjkt must spend at least \$650,000 on the improvements, and 10% of the concessions sales go back to the state park system.

Whitney said that the combined renovations will likely exceed that requirement and pass \$1 million.

"They're getting pretty significant facelifts, all of them," she said of the properties. "It's time to create new legacies and memories. Each time you build a restaurant, it's not just four walls. It's kind of like your home. Your home is four walls until you make it a home, and a restaurant is four walls until you make it a restaurant.

She said California Fork and Spoon will feature the California state carved into a Redwood tree out front, creating a photo opportunity. A California mural created by Newport Beach-based artist Timree Gold will reflect the history and energy of the coastal region.

The Huntington Beach House, the first to open of the three new outdoor concession areas, will feature fire pits, sandboxes and a 120-foot seated counter over the boardwalk.

Pearsall, who first worked with Whitney on the Bolsa Chica concessions, said the new concepts will represent a welcome change in Surf City. He said he liked that they

brought the option for healthier food choices.

"They were so underachieving and so underused, the concession element of these beaches, for such a long time," he said. "You could see how much mental design she put into her submissions, her bid proposals. They were so impressive, and they were exactly what we were looking for to make these two parks the destinations that they are. They have the ocean, they have the sand, they have the beauty and the weather. They didn't have a comfortable, lounge concession environment."

Whitney said she had to make sacrifices along the way. The restaurateur closed her SeaLegs Wine Bar and SeaSalt Woodfire Grill — both located in town but not at the beach – in 2019 so she could focus on her beach operations.

"I knew that if I wanted to grow on the beach, I had to re-strategize my business," she said. "On paper, it seemed like it was going to be so easy. But in reality, it was so hard to say goodbye to my two restaurants that were like my babies that got me going, especially SeaLegs Wine Bar. I literally was heartbroken, but I knew that I needed to do this to grow."

Whitney, who also has a SeaLegs location at Los Angeles International Airport, said her daughter Sahara was still in the womb when she began developing SeaLegs Wine Bar.

Now Sahara, whose name is tattooed on Alicia Whitney's arm, has been around for a decade. And her name is the inspiration for a restaurant to

"I looked at her one day and I got the name," Alicia Whitney said with a laugh. "You'd better believe she'll be working there when she can."

students to full-day instruction five days per week in a meeting last month, citing the continued countywide decline of coronavirus cases. Orange County Health Care officials on Wednesday reported 53 new infections and two COVID-19 fatalities.

During an April 8 special meeting, school board members decided secondary students would also be allowed to return to campuses on a fulltime basis four days each week, with one day remaining under a distance learning model beginning next week.

Trustees also approved continuing the district's 100% virtual Cloud campus in the 2021-22 school year for families not wishing to send their children to brick-and-mortar

classrooms in the fall.

It is still unclear, however, whether a "Cohort C" of secondary students who currently livestream classes at their home schools will be disbanded or continued in the year ahead. Officials have committed to surveying school families to learn their preferences, so as to aid the planning process.

"We have done our best in distance learning, but it has its limitations,' Supt. Russell Lee-Sung said at the April 8 meeting. "If we can get kids back to in-person [attendance], that is our first objective."

Cynthia D'Agosta, administrator of Fairview Park, said the move would reduce the impact of remote-control flyers on vernal pools and other wildlife-rich areas located on the west side, an area identified for future restoration.

"There's been action to change direction of management of the park over time," D'Agosta said, describing a shift away from recreational uses toward protection of open space. 'So, we're going to update the master plan to have more of a focus on restoration and biological management."

City staff will revise the plan to reflect the changing priorities, previously codified in Measure AA, an initiative passed by voters in 2016 that calls for any significant changes or additions at Fairview Park to be put to a citywide vote.

Pushing that process forward and considering the environmental impacts of relocating Harbor Soaring Society activities is a complicated process that could take from three to five years, D'Agosta estimated.

HSS President Mike Costello said Tuesday talk of relocation has members worried it's only a matter of time before the club is completely pushed out of Fairview, the only park in Costa Mesa that allows fly"The steering committee wants us out," he said. "They just keep stalling us and stalling us, and our membership declines as they put more restrictions on us. I'm going to guess by the end of the three-year evaluation process, they're

going to get rid of us." A longtime Costa Mesa resident, Costello enjoyed flying at Fairview in the 1970s and '80s and recently resumed his interest in 2016 after working two decades at Fountain Valley's now-shuttered Hobby Shack.

He said Harbor Soaring Society's 100-plus members run the gamut from retired aerospace engineers to kids interested in aviation and engineering. And while technology has progressed from simple gliders to electric-powered planes and even drones, most make sure to keep their park use respectful.

Still, there's no accounting for novice flyers, or kids who just got a drone for their birthday and want to take it out without first learning the rules or seeking proper permits.

We try to educate them, but enforcement is pretty hard," Costello acknowledged.

Ď'Agosta said complaints from residents and park users over the noise generated by the remote-controlled planes or reports of an occasional flyer venturing into a vernal pool to retrieve a downed craft have

been stacking up over the years.

"Fairview is not your typical neighborhood park," she added. "It is an open space nature area that has a lot of floral and faunal activity that is important for Orange County, so it's got a lot of biological eyes on it, all the way up to the federal level."

Local eyes are also watching. Members of the Fairview Park Alliance, a preservation advocacy group formed in 2015, drafted Measure AA to protect the open space from the impacts of recreational users and past city councils, which they say saw Fairview as a giant playground.

Member Kim Hendricks said there has been little oversight of the Harbor Soaring Society's use of the park and claimed a lack of enforcement of rules and policies has put wildlife at

remote-control planes shouldn't be there in the first place," Hendricks said Tuesday. "They defi-nitely negatively impact the birds and wildlife there. And for years the city had overlooked that."

But now, it seems, someone is paying attention.

The city's Parks, Arts and Community Services Commission will review the steering committee's decision in a May 27 meeting before making its recommendation to the City Council. D'Agosta said council members could review the matter as early as June.

preliminary hearing will be held soon after

"We have conducted a very thorough review of this case," Martinez told the judge. "We've done our due diligence ... We are very close to a decision." But Martinez said "in deference" to Bonta she needed a chance to brief him on it before making that final decision.

"In deference to the new attorney general? I don't understand that," Bromberg said.

Bromberg suggested it was improper for an elected official to make political decisions about the prosecution of a crime. "Can you give the court a preview of where you're going with the case?" Bromberg asked Martinez. "What do you think you might be doing?

Martinez said her office would likely not pursue having a new independent prosecutor assigned to the case.

"I don't make decisions for the attorney general, but I can make recommendations," Martinez said.

"I'm asking you to give the court a heads up, an idea," Bromberg said. We expect to move forward on some

counts, but not on all counts," Martinez said. The prosecutor said she also wanted to discuss the future of the case with the alleged victims as well.

"When a politician starts getting involved in a case we get nervous," Bromberg said of the judicial branch in general. "And you told me the attorney general, the elected official, is going to make a determination about this case.

Bonta, if confirmed, would take over for Xavier Becerra, who joined the Biden administration cabinet as the head of health and human services. "We know the history of this case and

that got ugly," Bromberg said of the cries of politics in the past between Spitzer and Rackauckas.

"My recommendation will be based on the evidence and not politics," Martinez said. "But I'm a trial attorney, and I'm not

Defense attorney Philip Cohen, who represents Robicheaux, reiterated previous complaints about Bromberg's sealing of a memo regarding Orange County district attorney investigator Jennifer Kearns, who worked on the case before being placed on administrative leave. Kearns this month sued the county, alleging she was retaliated against for pursuing the case while Spitzer attempted to have the charges dismissed.

Cohen has objected to Kearns citing attorney-client privilege with Matt Murphy, who is representing several alleged victims in the case, and claimed the memo would be helpful to his defense. Cohen also represents the defendants in a separate civil suit filed by an alleged victim, and Murphy has previously claimed Cohen was using the civil suit to harass the alleged victims in the criminal case.

Bromberg said he sealed the document out of concerns for Kearns' privacy but said he would revisit his decision if it became an exhibit in Kearns' lawsuit.
