Virus cases, deaths rising

The Orange County Health Care Agency says the numbers have nearly doubled since advanced reopenings were OKd.

Total known cases of the novel coronavirus and related deaths have nearly doubled in the month since the state gave Orange County the green light to enter advanced "Stage 2" reopening after shutdowns put in place early in the pandemic.

According to the Orange County Health Care Agency, total cases of the virus climbed from 6,095 to 11,960, and related COVID-19 deaths rose from 168 to 323 between May 23 and Friday. Those are increases of 96% and 92%, respectively.

Restaurant dining rooms and shopping malls and other "nonessential" retail businesses reopened on May 23. Bars, entertainment and gyms reopened June 12.

The Health Care Agency released an overhauled, far more detailed case count website Friday. Pages and datasets include several dashboards showing representations of cases and deaths by city and ZIP Code layered over maps, how the county stacks up against the transmission and infections, estimated recoveries, tests, hospitalizations, deaths, and infection and death demographics and counts at jails and nursing homes.

The county also offered new calculations, such as infections as a percentage of total county population — Orange County's is 0.4% of the population — plus cases and deaths among homeless people and how many children have been diagnosed by city. And the county revised historical data to attach reported deaths infections

'Coach Ballgame' not letting pandemic strike him out

"Coach Ballgame" plays the guitar, as well as the bongo

He sings songs about the late Major League Baseball star Roberto Clemente, as well as Andre Dawson. He does pushups and moves a basketball around his body, not at the same time, though you get the sense that he would try that if

In simpler times, James Lowe and the kids he's coaching would be doing these activities outdoors on the green grass.

Now, during the coronavirus pandemic, he does them from

either the backvard or a back room in his Lake Forest home, as hundreds of children from across the country - many of them local - watch live on Lowe's YouTube page, Instagram or Facebook Live.

There is a quirky positive energy to the online physical education class of Lowe, which goes live every weekday at 9 a.m. Lowe, who calls himself "Coach Ballgame," also does a baseball skills class at 3 p.m. on weekdays, not to mention his virtual sandlot games or trivia contests.

Kids sign in with baseball-re-

New indictment in death-at-sea case involving F.V. man

A new indictment has been issued in a case concerning the death of a man who was allegedly shot on a boat before being thrown overboard into the sea near Oceanside on Oct. 15.

Hoang Xuan Le, 39, of Fountain Valley, and Sheila Marie Ritze, 40, of San Juan Capistrano both face charges of first-degree murder and conspiracy to commit murder after a federal grand jury returned a 10-count superseding indictment on Wednes-

Ritze, a registered owner of the had previously been charged with being an accessory to murder after the fact. Le, who was known as "Wayne" or "Wangsta," faced one count of first-degree murder at sea and one count of possessing and discharging a firearm in furtherance of a violent crime in the initial three-count indictment. Both pleaded not guilty in January.

Le and Ritze are being held in federal custody. U.S. Magistrate Judge Karen Scott previously de-

nied bond to the defendants in their initial federal court appearances in Santa Ana on Dec. 19.

They are now scheduled to be arraigned on the new indictment on July 6 in U.S. District Court in Los Angeles, the U.S. attorney's

office said in a statement. Additional charges in the amended indictment include narcotics charges against Le connected to drug deals with an undercover operative. Authorities allege that Le twice distributed cocaine and distributed methamphetamine on two occasions

during the murder investigation. Le is also charged with possession of methamphetamine and two firearms when he was arrested, the release said. The firearms were a shotgun and an

AR-15-type "ghost gun."

Ritze has also been charged with lying to federal investigators following her arrest. The indictment alleges that she falsely stated that she had never met the victim prior to the boat trip.

The victim, a man around 40

Facing challenges from pandemic, H.B. to consider adoption of 2020-21 budget

Huntington Beach officials will consider adoption of the city budget on Monday for the 2020-21 fiscal year, which addresses current fiscal challenges arising from the COVID-19 pandemic and begins in July.

City Manager Oliver Chi presented a proposed 2020-21 budget during a study session at a June 1 City Council meeting, saying that the city's general fund budget revenues are projected at \$216.9 million for the 2020-21 fiscal year, \$20 million less than the 2019-20 projected revenues of \$236.9 million prior to COVID-19.

A revised presentation was subsequently presented to the council on June 15 and continued to Monday's meeting.

The current proposed budget sits at \$359 million with a general fund balance of \$216.9 million, according to a staff report pre-

pared for Monday's meeting. Up for discussion is whether or not to authorize the implementation of the CalPERS early retirement program for eligible candidates and/or implementation of a self-designed retirement plan to reduce current city staff by about 5%. Both proposals were also presented on June 1.

Huntington Beach has 294 city employees currently eligible to retire. Chi said earlier this month that if at least 15% of them participate in a CalPERS early retirement program, it would result in annualized savings of at least \$6.2 mil-

Another option to be discussed

is the potential for layoffs. The council is also expected to adopt a Gann Limit, which curtails the amount of revenue that can be appropriated in a given fis-

Monday's meeting begins at

6 p.m. and can be watched on channel HBTV-3 or online at huntingtonbeach.legistar.com. Residents are encouraged to

hb.org. All communications received by 2 p.m. Monday will be distributed to the council prior to consideration of agenda-related items. Once a caller has entered the meeting, the caller will be put in a holding queue to speak in order.

The council chamber will also be open for public comment, but social-distancing measures will be in place and, after making their comments, participants will be asked to leave the chambers, and the city will provide an area for viewing the council meeting on television to a limited number of participants.

Pedestrian dies of injuries after multi-car crash in Fountain Valley

A pedestrian died in a hospital after being struck during a crash involving multiple vehicles in Fountain Valley on Tuesday, officials said.

Fountain Valley police released a statement that said officers responded to the traffic collision on Warner Avenue, east of Brookhurst Street, at 11:04 p.m. A male victim was found unresponsive

at the scene in the westbound lanes.

The statement said the victim was taken to an area hospital, but died of his injuries. The Orange County coroner's office and Fountain Valley police were working to confirm the identity of the victim

The drivers of two vehicles involved in the crash
— a blue Acura RDX and
a gray BMW X3 — stayed
at the scene at the south-

west corner of Mile Square Regional Park and cooperated with investigators, officials said. A preliminary investigation has hinted that more vehicles may have been involved in the collision.

Fountain Valley police investigators were also trying to determine if alcohol or drugs played a role in the crash.





lated usernames, which Lowe can shout out at a moment's notice during the broadcast. It's all done over the internet now for Lowe, 37, who enlists the help of his wife, Tara, also known as "Mrs. Ballgame."

Lowe has been a baseball coach for 15 years but is now unable to run inperson camps, clinics or sandlots.

"For me, my day to day is human contact with multiple kids," said Lowe, who is originally from North Carolina and played college baseball at Brown University.

"Not being able to do that, we had to immediately figure out some way to keep this train moving.

I'm a pretty optimistic person by nature, so I kind of look at how to fix situations quickly. That's kind of how we walk each day of this quarantine, just making the best of each day."

Lowe's sayings countless. He encourages kids watching to say "attawhen something good happens, and he has dozens of salutes he will sprinkle into the broadcasts.

Lowe, who has partnered with Major League Baseball's "Play Ball" campaign and helped run baseball camps last year at the MLB All-Star Game and the College World Series, must keep local for now.

He takes solace in the fact that he's still impacting the lives of kids in a

positive way.

'Meet, squeeze and freeze' is a popular saying in our household," said Meredith Medeiros of Laguna Beach, using Coach Ballgame's phrase for how to properly catch a fly ball.

Medeiros, who is the auxiliary chair and secretary for Laguna Beach Little League, describes her family as a baseball family. Coach Ballgame is a big part of that.

She has three sons who tune in online each morning during the current "shelter in place" directive. Kingston is 9, while twins Knox and Cruz are each 5 years old.

"We don't exactly live on a street where we can be like, 'Go play in the street,' " Medeiros said.

"We live on a steep hill; that's not an option for us. Having that time where they're focused on something and I can unload the dishwasher and clean up from breakfast, that's a nice distraction too, where they're committed to doing that for an hour with him.

Casey Walker of Costa Mesa also coaches baseball, for Costa Mesa American Little League. Without in-person games, Walker said his three boys, Ben (11), Reid (9) and Ian

(7) are all participants in both morning and afternoon sessions with Coach Ballgame. Their sign-in names are "Benji," "MVP" and "Little A-Rod," respectively.

"He's teaching these kids to enjoy the game of baseball," Casey Walker said. "As you get older, it gets more competitive and intense. What he's trying to teach them is just to have fun.'

Any kids are welcome to join Lowe's online broadcasts, he said. He's trying to get by while raising two young daughters himself, while not making nearly as much money as he ordinarily would. He asks for donations at the end of his morning P.E. classes; the afternoon baseball classes cost \$10 each.

"With small businesses, this quarantine has really caused us to get creative and find different avenues," he said. "It's something I look forward to every morning, and I think some of the families do as well. It gives the parents an hour break from trying to be a home-school teacher. They get to drink their coffee in peace, and I can entertain the kids.

'We're just keeping the momentum going the best we can. It's not ideal, but I've definitely gotten some good feedback from parents that needed this kind of thing. It's bringing joy to their homes, so all in all, no complaints. We're doing all right."


Costa Mesa resident Jess Krueger said the online classes are entertaining for her boys Holt and Henry, who are ages 11 and 7.

"They tuck their shirts in, even though we're at home," Krueger said. "But that's a thing with Coach Ballgame. He always says, 'Ballplayers tuck their shirts in.'

meetings that he was willing to be hired as a "hit man.

Investigators suspect that Ritze was also on the boat during the killing, citing video footage from the harbor and cell phone records.

A conviction on the firstdegree murder charge against Le and Ritze would carry a mandatory sentence of life imprisonment without parole, the statement said.

The conspiracy charge and the charge of discharging a firearm in furtherance of and during and in relation to a crime of violence both could carry a maximum sentence of life in prison without parole.

The narcotics counts against Le could add decades to any sentencing he receives if convicted.
