## 'Porn' on election signs in H.B. 'inappropriate,' officials say

The signs urge a "no" vote on two library initiatives that are the focus of a June election.

When Megan Fowler dropped her 9-year-old daughter off at Harbour View Elementary School in Huntington Beach on Monday morning she couldn't miss seeing some political signs near the school entrance that she was not expecting.

"Protect Our Kids From Porn, No on A & B," the large signs read. They were visible from the playground of the Ocean View School District school.

Fowler was worried about her daughter, who is in the third grade, having questions about the word "porn." She said she felt the signs used her child as leverage in an adult debate.

"We haven't even had the sex talk yet," she said. "I was waiting

#### Steve Hilton launches California governor bid in Huntington Beach

Steve Hilton made it clear early in his comments Tuesday morning why he chose Huntington Beach to launch his California gubernatorial bid for 2026.

The 55-year-old Republican podcaster and former Fox News host, originally from England, said he admired the way current city leaders flipped the City Council from majority Democrat to all Republican in a matter of a few of years.

"Here's why we're here," he said during a rally at Pier Plaza. "The spirit of Huntington Beach is going to be the spirit that saves our beautiful state of California and makes this state truly golden

gain

again.
"Don't let anyone tell you that we can't change California," he added, referring to the current council as the "MAGA-nificent Seven." "This city shows us how we can."

Hilton, who had announced he was running on Monday, said Surf City felt like home to him. The commentator hopes to be making Sacramento home by 2027, throwing his hat into the ring of a crowded governor race alongside fellow Republican Chad Bianco, a Riverside County sheriff known for defying state mandates during the coronavirus pandemic.

# Trial begins for man accused of killing

Attorneys for defendant Craig Charron did not dispute that he stabbed and killed his girlfriend nearly five years ago.

Prosecutors making opening statements Monday in the trial of Craig Charron said he beat and manipulated Laura Sardinha before she kicked him out of their Huntington Beach apartment Sept. 2, 2020, but he came back and killed her while she was on a conference call with her mother and best friend.

Attorneys for the defendant did not dispute Charron stabbed his girlfriend to death nearly five years ago. But they say he acted in the heat of passion and in self de-

The couple began dating in June 2020, and had moved into an apartment on the 8400 block of Jenny Drive by July, during the height of the COVID-19 pandemic. Text exchanges between them suggest he had become physically abusive just weeks later.

"I'm locking myself in a box so you can't beat me anymore," Sardinha wrote in a message to Charron dated Aug.15 of that year. "Because I can't even drive. You blew out my ear drum."

Charron was heard threatening to "end this relationship" if the victim refused to massage his calves in videos recorded the following day, before she went to a hospital. Medical records that will be presented in court verify she

# H.B. may ask court to hear housing appeal

The U.S. Court of Appeals for the Ninth Circuit denied an en banc hearing against housing mandates Monday.

Huntington Beach might appeal its fight over state housing mandates all the way to the U.S. Supreme Court, after a federal appellate court declined another hearing the city's lawsuit on Monday

The U.S. Court of Appeals for the Ninth Circuit denied an en banc review of *City of Huntington Beach v. Newsom*, where all judges from the full circuit court would

Huntington Beach City Atty. Mike Vigliotta said in a statement Tuesday that he would ask the City Council to approve filing a petition to the Supreme Court, the last option for the case to continue. The all-MAGA City Council has taken a firm stance against the state getting involved in the charter city's business, particularly in the area of zoning for more housing

"A city's right to sue the state in federal court is an issue that presents a split among federal circuit courts across the nation," Vigliotta said. "These are the kinds of cases the Supreme Court will sometimes hear to resolve the split among federal circuit courts. We remain determined to challenge Sacramento's unconstitutional stronghold on cities. We will not

### 2 dead in separate Huntington Beach incidents ID'd

Coroner's officials released information on a man and a woman who died last week in two separate incidents investigated by Huntington Beach police — a crash involving a pedestrian and an apparent suicide — while a third death was reported at a local park Monday.

The first incident happened shortly after mid-

night April 16, near Beach Boulevard and Talbert Avenue, when a vehicle traveling northbound on Beach struck a pedestrian who was standing in a traffic lane just north of the intersection, a police spokeswoman reported last week.

The driver, a 73-year-old Santa Ana man, remained on scene and cooperated with police, who determined impairment did not appear to be a factor in the crash.

pedestrian was The identified by coroner's officials as 45-year-old Todd Anthony Wilkins, according to Sgt. Gerard McCann of the Orange County Sheriff's Department. Although Wilkins had initially been thought to have connections to the city of Stanton, McCann said Tuesday he did not have a fixed residence at the time of the incident.

Several hours after the collision, Huntington Beach police received a call about a woman's body discovered lying on the beach near Lifeguard Tower No. 8 in what appeared to have been a suicide, HBPD spokeswoman Jessica Cuchilla confirmed.

McCann confirmed Friday that coroner's officials had identified the de-

cedent as a 45-year-old Whittier resident. The cause of death was not yet determined.

A second suicide was discovered Monday after-Huntington Beach's Wieder Park, located on Lynn Lane, where someone heard a gunshot and called police shortly before 4 p.m., according to Cuchilla.

"An adult female was located with a self-inflicted gun was located at the scene," she said Tuesday.

The spokeswoman was unable to provide further details about where in the park the incident took place. McCann confirmed the woman had been identified by the coroner's office as a 56-year-old Huntington Beach resident.

## Jean Forbath opened eyes to those in need

Jean Forbath — who grew a humanitarian effort from a tiny church room into the nonprofit Share Our Selves, a netof volunteers. work healthcare and service providers that serves tens of thousands of people countywide — died early Monday at age 95.

The longtime Costa Mesa resident, who experienced health complications in her later years, was surrounded by family and loved ones, who noted the devout Catholic passed shortly after the death of Pope Francis in Vatican City.

"She'd spent all of Holy Week at home with all of her kids and grandkids," daughter Mary Cappellini said Wednesday. "And it was just an hour after the pope — it was quite the experience."

Forbath was recognized by numerous honors, including Costa Mesa's "Woman of the Year" award in 2017 and the O.C. Human Relation Commission's "Legacy Awards,"

honoring the county's civil families annually. rights heroes.

Yet, her personal pathway of charitable service had relatively modest ori-

Inspired by a 1969 adult education class at St. John Catholic Baptist Church, in which participants pondered the social doctrines of the church, Forbath thought about how she and others could help neighbors in need. What started out as

charitable donations of food, clothing and material goods swiftly turned into a coordinated effort as participants got to know the people they were helping — and in 1970 the nonprofit Share Our Selves (SOS) was born.

"Our organization brought to the foreground that there were needs in Costa Mesa that people were closing their eyes to,'

Forbath recalled in 2017. Forbath led a team of volunteers as they opened their first free medical and dental clinic in 1985 and started an "Adopt a Fam-Christmas program that now benefits 1,200

SOS today provides medical and dental care for nearly 16,000 individuals across Orange County in eight locations and provides food and financial assistance to countless others.

"We're really staying rooted in the legacy of what the original vision was, because the need is still there today," SOS Executive Director Christy Ward said Wednesday. "We're doing really expansive work, but a lot of what they did still goes on — we just added to it."

Forbath tirelessly advocated for access to affordable housing and medical care for the county's poor, regularly appearing before the Costa Mesa City Council and Orange County Board of Supervisors.

She worked as the unpaid executive director of Share Our Selves for 22 years and retired in 1991, though she remained on its board for 39 years.

In 1993, she co-founded the Costa Mesa nonprofit Save Our Youth (SOY). The group provides academic

readiness and leadership opportunities to first-generation college students from low-income families, annually bestowing a "Jean Forbath Scholarship" to standout youths who strive to change the world for the better.

'When you think of Jean Forbath, everyone thinks about Share Our Selves, but I think about the big contribution she made to youth," Joe Erickson, SOY

co-founder and a former member of the Costa Mesa Council, Wednesday. "I'm happy she lived a good, long life and I was part of it."

Forbath is predeceased by her husband Frank and son Joe and is survived by children Steve (and Betsy) Forbath, Kathy (and Bahram) Esfahani, Mary (and Cesar) Cappellini, Susie Forbath, Patty (and Steve) Uchytil and Brian

(and Georgina) Forbath, along with 15 grandchildren.

A service is planned for May 9 at 1 p.m. at Saints Simon and Jude Catholic Church, 20444 Magnolia St., Huntington Beach. Donations may be made to Share Our Selves or Save Our Youth's Jean Forbath Scholarship.

zone for 13,368 dwelling units in the current cycle. The city filed a federal lawsuit against the state of California in March 2023, arguing that the requirements violate the charter city's right to zone property.

The courts have largely not agreed. The state's motion to dismiss the lawsuit was granted by a U.S. district court judge in November 2023.

Michael Gates, who recently left his job as Huntington Beach city attorney, argued the case before the Ninth Circuit Court of Appeals in 2024, but a threejudge panel ruled that the city did not have standing to sue in federal court.

Additionally, that panel stated in its ruling that "no matter how California categorizes charter cities, they remain subordinate political bodies, not sovereign entities."


Now, the Ninth Circuit Court of Appeals has denied taking another look at the case with a larger group of judges.

"We are pleased that Huntington Beach's latest attempt to exempt itself from our state's housing laws has failed," California Atty. Gen. Rob Bonta said in a statement. "All along, Governor Newsom and I have asserted that the city's federal lawsuit is meritless and a waste of the public's money. Like every other city in California, Huntington Beach has a legal obligation to build its fair share of housing. We will be closely monitoring what the city decides to do next."

In a state lawsuit against Huntington Beach, a San Diego Superior Court judge ordered last July that the city must pass a compliant housing element within a year. That case is also on appeal.

until like 10 or 11. How can I explain 'porn' without having to go through all of that? I don't want my child to be like me, who grew up in a super-conservative, right-wing Christian home, where I had to learn about sex through other kids at school. I feel like that's my responsibility to inform my child. But she's 9 years old. She's a very innocent child to share this information with, but now the council, Chad Williams, has blatantly put these signs in her face.'

Williams was one of three conservatives elected last November to form an all-MAGA Huntington Beach City Council. A political action committee he started recently, "Protect the Children With Councilman Chad Williams, Vote No on A and B," is behind the signs.

The signs, many of which were hung near the city's elementary schools, were put up late Sunday night in advance of a special election in Huntington Beach scheduled for June 10.

At issue are two library measures. Measure Å would repeal a parent/ guardian children's book review board, while Measure B would require voter approval before any future attempts to outsource services at the public li-

Some local parents took to social media to voice anger at Williams on Monday for the use of the word "porn," shorthand for "pornography," on the signs.

"It's not even a conversation, it's like an ambush," said Desireé DeLattre, a Huntington Beach resident who immediately noticed signs at the corner of Adams Avenue and Bushard

Street on Monday while taking her children to Orange Coast College Children's Center in Costa "Conversation is Mesa. healthy, but this is just nothing that was on a parent's bingo card this morning. The most important part of a parent's job is to keep their children safe, and I think that with this short-sighted stunt, Chad Williams put our kids' safety at risk.'

Williams, a former U.S. Navy SEAL who's a youth pastor and public speaker, defended the signs and use of the word "porn" in a Monday interview.

"There is content in the library that is far worse than just the word," he said. "The people that have pushed this sexual content. this obscene content in our public library have pushed this conversation into the public forum. There's no debating that there is obscene content being made available to minors in the library. I can give a number of examples of what is depicted, but you probably wouldn't be able to publish it, and that should tell you all you really need to

Williams' colleague on

the City Council, Butch Twining, said he helped put up some of the signs Sunday night.

"To a certain extent, I understand where [parents] may be coming from on the 'porn' thing," Twining said Monday. "But you know, 'porn' is a word that's been thrown around in the public arena for years and years. Now, all of a sudden, 'Oh my God, it's like the 'F' word.' The PAC that printed these things out probably weighed whether the word 'porn' was more upsetting than the actual porn books in the library, and they probably determined that the word 'porn' isn't actually as upsetting as having actual porn in the library.

#### **WHERE'S THE PORN?**

After a post that Twining made on social media recently, Ocean View School District Trustee Gina Clayton-Tarvin and Friends of the Huntington Beach Public Library member Carol Daus pushed back on that assertion of porn in the public library. They openly challenged Twining to meet them at the Central Library and show them where the porn is.

So far, he has passed on that request.

"I don't need to go on an Easter egg hunt in the library to go look among half-a-million books to find one," Twining said. "I know they're there, because I know I've got some here in my office.'

Clayton-Tarvin now has taken it a step further. She said she talked to Orange County District Atty. Todd Spitzer on Monday morning, requesting an investigation on the claims of porn in the library.

"They're the governing board of the city," she said of the members of the City Council. "If the books in the library are pornography, as they say, then they are purveyors of pornography. It's as simple as that. It doesn't matter what their opinions are. Is it pornography? This is what the D.A. is going to look into, are these pornographic materials? And if it comes back that it's not pornographic materials, then I guess we have our answers, don't we?'

Williams said his concern was not about books "Everyone Poops," which was initially moved into a restricted area on the fourth floor of the Central Library but eventually returned to the children's section. A recent Daily Pilot review of books that are currently in that restricted area found eight titles, the majority of them dealing with puberty.

"Library employees intentionally spotlit books like 'Everyone Poops,'" Williams said. "These are not the books we're talking about. It's the books that talk about shoving household items up where people poop."

He also mentioned a book titled "Identical," which is cataloged as an adult book, though Williams said it is still

available to minors. It deals with themes including rape and incest.

"I'm shedding light on the darkness that's happening," he said. "It's been said, 'All that's required for evil to triumph is for good men to stand back and do nothing.' There are those that would like to put their heads in the sand and look the other way, pretend it's not there and not deal with it. Then there are those that are willing to take that stand and address it. I'm asking all of the responsible adults in the room, as it were, to take a stand and expose these works of darkness with the truth,

with light." As for the "No on A and B" signs, reports surfaced that some of them were taken down Monday by angry community members, though the Huntington Beach Police Department reminded residents that removal and vandalism of election signs is a crime.

HBPD spokeswoman Jessica Cuchilla said Tuesday there were four reports of vandalism on the signs, and two individuals had been cited and released.

One man, Jason Teter, said in a video posted to social media that he was responsible for cutting the word "porn" out of 12 of the signs, returning that part of the signs to City Hall.

Teter said he wrote an email to Williams, who he voted for last November, stating that the election signs may be legal but he didn't believe it was right to put the word "porn" in clear sight of children.

"Pornography is indeed a destructive force that exploits individuals and damages family," Teter read aloud from the email he sent Williams. "But using the term so prominently in public spaces feels counterproductive to

the very cause that you are trying to campaign. Frankly, it reads more like a tactic to provoke than a message grounded in conservative values, and that's something I believe we should rise above."

A letter sent to Ocean View School District families on Monday by Board of Trustees President Patricia Singer and Supt. Julianne Hoefer called the signs "inappropriate."

"While the inappropriate signs are not affiliated with the district, we did want to reassure our families that our school libraries do not contain any inappropriate material," the letter read, in part. "Our commitment to maintaining a safe, age-appropriate and educational environment for all students remains steadfast. We also recognize that some of our teachers have received questions from students regarding these inappropriate signs. In such instances, our educators are doing their best to thoughtfully redirect these conversations to parents and guardians, as these topics are most appropriate for family discussion."

Fowler said she had friends on both sides of the political aisle that were upset, and she understood why. While she did not want to have that conversation with her daughter yet, she also knows the explicit websites that pop up when someone conducts an online search of the word "porn."

"That's what some of these kids are going to do," she said. "That leads into a whole another conversation ... so they're exposing our children, deliberately, into what porn kind of unlocks. It's like this key. Once it's opened, it's a downward spiral from there."

### CdM caps undefeated league season with win over rival

Corona del Mar took care of the last two things on its list before the truly important games arrive, a mere formality for the boys' lacrosse powerhouse, perhaps, but significant nonetheless.

Garrett Ip and Owen Majit led the fifth-ranked Sea Kings to a 16-5 home triumph Friday afternoon over archrival Newport Harbor to make it 14 of 15 Battle of the Bay conquests and complete their fifth successive Sunset League

Now, after a final tuneup Wednesday at No. 7 Foothill, it's on to the big stuff.

'We always have our eyes set on that CIF championship, and I think that's always the goal here at CdM," said Ip, a senior attacker and midfielder who was a freshman reserve when the Sea Kings won their third Southern Section title in 2022. "Winning league's very important, but we have our eyes on the prize.'

The rivalry?

"It's fun," Charlie Hamilton, a co-captain alongside Ip and Jake Card. "It's still a rivalry. Every other sport is always intense, but it's good to get off your shoulder. It's just fun. And winning league is a goal we have, and it's nice to get it done.'

The Battle of the Bay is "a special thing," said Corona del Mar head coach G.W. Mix — "it's meaningful to the kids" — but more so something of an annual rite for the lacrosse team, which has wholly dominated the series, with 19 victories in 20 meetings since the Southern Section certified the sport in 2007, eight of the last 10 by double digits. The result was not unexpected.

"We talk to the kids about that, particularly this

time of year," Mix said. "It's far more important that we get better than we focus on the Battle of the Bay and sinking the Sailors and all of that other hullabaloo that goes along with it."

The Sea Kings (14-5, 4-0 in the Sunset League) have won three CIF Southern Section titles — in 2012 and 2016 before the Southern Section began administrating the postseason and again three years ago. They've since reached the semifinals and quarterfinals and will face stiff competition, primarily from several Catholic powprimarily erhouses. Brackets will be revealed next Friday.

Ip and Majit are returning All-CIÉ standouts headed for elite liberal arts colleges in New England to play for top NCAA Division III schools — Ip to Williams, Majit to Bowdoin - who have played together since third grade. Mix says "they're incredibly skilled with the stick, incredibly quick and fast, and that's a deadly combination for an offensive player [who] understands the game really, really

"They work all the time," said Mix, whose nearly five decades in the game includes stints as head coach of two NCAA programs, as president and general manager of the late Major League Lacrosse club L.A. Riptide, and as founder and executive of Surf Dawgs Lacrosse, a Newport Beach-based youth program that has fueled CdM's success and contributed to Newport Harbor's roster. "They're those kids that when I drive by on a Saturday afternoon and I look through the fence, they're out here shooting. Every weekend in all fall and all summer. The best players we've had here are the kids that continuously work on their own to get better.

"It's no different in any other sport. You hear that about all the great ones, right? They know what they want to do, and they put their minds and bodies to it, and they get after it. That's what makes those two really special, is that they practice their craft all the time, dodging and shooting and throwing the ball around. The good news is they drag some of the others out there with them, which tends to make us a little better."

That work ethic, Ip said, is what he admires most about his brother, Logan, who led CdM's 2022 charge and is now a junior midfielder and captain for Harvard's top-10 team.

"He definitely played a big factor [in my development]," he said. "We used to shoot in the backyard all the time. ... He's a really hard worker, and he's a smart player. He taught me to study both the aspects of playing the game and the mental side of the

Mix calls Logan "phenomenal, and as good a player as he was, he was every bit as good a leader and every bit as good a human being." Garrett is

"very similar"

Garrett says he is "better than my brother."

"Good for him," Mix said. "In a lot of ways, he may be, because he's done some things that Logan didn't have to do. Logan had a really good group around him, a lot of good teammates that are all playing Division I lacrosse now. Garrett hasn't had quite the supporting cast, but he's had a bunch of wonderful kids around him, no doubt."

Ip started Friday's romp a minute and a half in, assisted the first of two Alex Aldoroty goals to double the advantage, then added a fourth just before the end of the first quarter. The Sea Kings had six before Newport Harbor struck, and Mix began emptying his bench after halftime.

Ip and Gavin MacBeth off the bench finished with a hat-trick and two assists, Majit tallied a goal and four assists, and Domingos Alves and Auggy Luong added two goals. Griffin Habermehl and Hamilton led a dominant defense, and Tucker Rosenberger and Card were key in buildup and in counter-

Braden Brock led Newport Harbor (6-10, 0-2) with two goals and an assist.

was CdM's fifth straight Battle of the Bay triumph, by far the tightest of the five. The Sailors' only win in the series was a 5-4 decision in 2019, to win the Sunset League title, and they've not been to the playoffs since. Winning their remaining games at home Monday against 10th-ranked Los Alamitos (14-3, 2-1) and Wednesday against Huntington Beach (7-8, 0-3) — would give them the Sunset League's other automatic playoff berth.

An at-large berth, otherwise, appears unlikely, acknowledged third-year head coach Blake Lenk, a former Newport Harbor standout. He's playing a longer game. It's a juniorheavy team, and next year looks promising.

"We have a lot of areas to develop," Lenk said. "The biggest thing is overall mindset. We look to focus on not tallying wins and losses, but rather tallying wins and lessons, because there's always something to learn every time we get out there on the field.

"They've got a lot to learn, but they bring the effort, attitude, energy. Those are the things we can control. As long as we can keep in control of the things that we can control, we can expect positive results out of them."

Winning a CIF title "would be a dream," said Hamilton, who as a freshman was brought up from junior varsity for the playoff run in 2022. "We've just got to keep our head down and block out the noise and keep rolling. As long as we worry about ourselves and take care of the small things, I think we'll be

The other contenders are mostly Catholic schools. led by defending champion Santa Margarita (13-2), Trinity League champion Mater Dei (11-3) and Los Angeles Loyola (17-3), California's top-ranked side.

Loyola is "a different level," said Mix, whose team was drilled, 16-4, two weeks prior by the Cubs. They're significant title favorites. The only teams to beat them come from states with deeper lacrosse

"They've got speed and athleticism and depth," said Mix, who had Cubs coach Jimmy Borell on his roster during his Riptide tenure. "I was giving him a hard time after the game, talking about the embarrassment of riches that he has there. But he's got a great culture and a great group of kids. They work hard, play hard, but they're talented. Just big, strong, athletic kids."

Ip isn't intimidated.

'They're a pretty talented team," he said. "But I think I'll take my group of guys up against any group any day of the week.

had a perforated ear drum, Senior Deputy Dist. Atty. Janine Madera said.

In footage captured the morning Charron killed Sardinha he is heard repeatedly asking for her permission to have a friend over, noting that the visitor and defendant had been inti-

mately involved. "You're trying to f—- with me and be mean," Sardinha replied. "...I can't wait to tell her how you beat the sout of me.

By that point, she was done with Charron, according to testimony from her mother and best friend. They were among about a dozen of Sardinha's loved ones who showed up at the trial Monday and heard detailed accounts about her final moments alive. Some embraced each other while sobbing in the hallway outside of the courtroom between proceedings.

The victim went to her apartment's leasing office, had Charron evicted at about 11:30 a.m. Relatives said she felt relieved to be rid of him.

"She was happy, and I was happy for her," the victim's friend of 21 years, Shaina Smith, recalled of the last conversation she had with Sardinha. "And then things changed very suddenly.

Charron showed up at the apartment in the middle of that call. Cries of "Please don't hurt me," and "No" are heard before Sardinha's phone falls to the ground, according to transcripts and recordings played Monday.

The victim's mother, Marie Sardinha, who was still on the line at the time, said her daughter "just kept screaming."
She and Smith hung up

call police. Laura Sardinha called back and wound up leaving a voice message for Smith, in which she is heard "narrating a portion of her own murder," Madera said.

First responders found Charron's girlfriend curled up in a ball on their bathroom floor, Madera said. She had suffered two stab wounds to the chest as well as numerous slashes to her hands and face.

Charron, who is 10 years older than the victim and 10 inches taller, sustained cuts to his left hand as well as lacerations to his chest and throat. He had to be rushed to a hospital for what defense attorney Michael L. Guisti described as "nearly mortal" injuries. he claimed the defendant acted on impulse, and then on instinct as the altercation unfolded

in order to defend himself. "His actions were instinc-

tual, not criminal," Guisti

said. "...It was a mutual struggle with both people
