H.B. fire saves 7 (ducklings') lives — just in time for Easter

embers of the Huntington Beach Fire Department engaged in a daring rescue effort Thursday that took them to harrowing depths but ended with seven lives being saved — and their mama couldn't be happier.

Spokesman Eric Blaska said the incident took place Thursday at around noon on Gothard Street near Promenade Parkway.

"One of our engines was out driving and they saw someone waving them down," he said.

A resident indicated a mother duck and some of her ducklings were hovering in an area near a storm drain and some of the babies seemed to be stuck inside the structure.

Firefighters lifted the lid, only to discover the drain extended about 30 feet below street level. Backup would be needed.

They called the department's urban search and rescue team, whose members specialize in rescues involving trenches, steep terrain and confined spaces, according to Blaska.

"They suited up in all their gear and went 30 feet down to rescue all the ducklings," he said of the operation, which lasted about an hour as the mother duck and her other offspring watched from a distance. "Mom was over in the grass kind of far away. I think she was afraid of the fire engines."

When all was said and done, seven ducklings were extracted from the storm drain and handed over to Orange County Animal Care, which provides animal control services for the city of Huntington Beach.

life Care Center in Hunt-

ington Beach, where they received medical evaluations and were still being held Friday. Blaska said the Fire De-

partment has conducted a number of animal rescues in its long history, listing cats, parrots and rabbits among some of the more recently aided species.

"Any animals that need to be rescued, we'll always send people there," he added. "We are here to help."

H.B. leaders talk about how to be an upstander, not a bystander

Presentations on combating racism are featured at Thursday night's town hall meeting

Hate crimes and hate incidents have skyrocketed in the last couple of years in Orange County, and Huntington Beach has not been an exception.

Huntington Beach interim Police Chief Julian Harvey said during a virtual town hall Thursday night that there have been two reported hate crimes in the city so far in 2021. One involved threats

made against a Black family and the other was an assault of a Latino fisherman at the Huntington Beach Pier.

Against this backdrop, as well as a "White Lives Matter" rally possibly planned for the pier on April 11, the town hall meeting seemed very timely. The topic was being an upstander instead of a bystander, training attendees how to react if they witnessed a public act of hatred or bigotry.

Panelists included Huntington Beach Mayor Kim Carr, City Councilwoman Natalie Moser, Human Relations Task

Laguna council to consider repealing foul language code

The Laguna Beach City Council will welcome members of the public to speak at the Council Chambers at its next meeting on Tuesday.

In the first meeting with in-person public participation since meetings went virtual due to the coronavirus pandemic, the council will consider repealing a portion of the municipal code that criminalizes using foul language during council meetings.

A staff report cited the

section of the code added in 1953.

It said that a council member or other person speaking at a meeting could be deemed guilty of a misdemeanor if they engage in profane, vulgar or boisterous speech.

According to staff, the city attorney believes that excerpt from the municipal code is unenforceable due to statutory developments and court decisions that have followed the original adoption of the policy.

Davis Magnet School kids raise funds for fire-ravaged program

At Davis Magnet School in Costa Mesa, kindness grams cost \$1 but are worth so much more.

Whether kids purchase and bestow the tiny notes and gifts to classmates or are themselves the recipients, the annual springtime ritual always seems to generate an abundance of warm fuzzies.

And with funds raised each year benefiting a local organization in the community, it's a true winwin.

But this year a group of students in the Peer Assistance Leadership (PAL) program wanted to make a special effort to help a program hit hard by December's Bond fire, which scorched nearly 7,000 acres in and around the county's Silverado Canyon.

Inside the Outdoors, operated by the Orange County Department of Education since 1974, is a hands-on environmental stewardship program that lets kids have an up-close experience with animals and nature through field trips and class visits.

Last year's wildfire destroyed the program's animal facility and all the creatures living there, along with an office building and an onsite caretaker's residence.

For the past week, Davis students have been working extra hard to sell and assemble kindness grams in advance of next week's campuswide Kindness Week, during which the notes of positivity will be delivered.

Helping Inside the Outdoors provided an extra motivation for sixth-grader Dior Harvey.

"They bring in animals and teach us about their surroundings. Last year, they brought these huge turtles and spiders — it was cool," the 11-year-old said Friday. "It was a huge shock to everybody when we heard about the brush fire."

Sixth-grader Marley Smith, 12, said raising funds for a group that helps schools is perfectly aligned with the principles behind Kindness Week, a time for everybody to celebrate being together.

"I think it's very important to do it, because it shows kindness throughout the whole school," she said of the springtime activities, which include allowing kids to dress in line with special themes while still adhering to social distancing and mask mandates.

"It's like everyone coming together as a community," she add-

Lisa Holman, who teaches sixth grade at Davis and serves as a PAL adviser, said kids have been selling kindness grams all week and coming in before school to help assemble kits. This year, recipi-

Force chair Vashia Rhone and Don Han, Orange County Human Relations director of operations.

Han's presentation showed that reported hate incidents in Orange County increased from 14 in 2014 to 165 in 2018. Hate crimes steadily grew each year, from 40 in 2014 to 78 in

Hate incidents against Asian Americans and Pacific Islanders in the county have shown an even more

dramatic increase, from four in 2019 to 40 last year, though he emphasized that those numbers are underreported.

"When people get called racial slurs or things like that, typically they just normalize it," Han said. "They don't pick up the phone and call the police ... But we're beginning to see the trend of more harassment being associated with the pandemic.

"Often times, people just don't know what to do, including myself. I've been here 40 years, I came here as a refugee, and I can tell

you a couple of times a year experience incidents of name-calling or comments to me. Sometimes I don't even report it to my own agency, because I normalize it and I forget."

Han introduced five D's of bystander intervention, created by a nonprofit called Hollaback!, that onlookers should utilize if it is safe to do so. They include direct, distract, delegate, document and delay.

Tactics for speaking up against racism that can be used directly toward the perpetrator include interrupting them, questioning them, educating them or echoing someone who speaks up against them.

Han encouraged people who are victimized to immediately report it to the police or sheriff's department. They can also call the O.C. Human Relations hotline at (714) 480-6580, and remain anonymous if they choose.

Huntington Beach also has a diversity, equity and inclusivity webpage.

Moser, formerly chairwoman of the Human Relations Task Force, said that even one hate crime is too many.

"I think that we can only change our community for positive if we start just actively practicing these things — knowing hate, understanding it and changing it," Moser said. "We have that within our grasp, and I know that we have a wonderful community who's committed to welcoming one another."

many students, like Harvey, were touched to learn about the tragedies Inside the Outdoors endured during the Bond fire and wanted to help.

"Once I explained what the program was, my kids were like, 'Oh my gosh!' " Galen recalled. "It had a big impact on them because they know what that program has done for our school.'

For Stephanie Smith, operations manager for Inside the Outdoors, the Davis fundraiser is especially touching.

"We are speechless and so grateful," she said. "We know we make a difference in kids' school days because we bring them something different from what they're used to. But for them to remember us long term reminds us that we really are making a difference in a

bigger way."

Dec. 3, 2020 — the day the Bond fire, fueled by powerful Santa Ana winds, ripped through Orange County's canyon country before spreading to near-side hillsides — is forever etched in Smith's memory as the day she lost the caretaker's residence where she lived with her husband and 14-year-old twin daughters.

Carrying little more than a cat, a dog, two backpacks and some laundry, the family narrowly escaped danger but suffered the loss of other family pets, all the program's animals and the place they had called home for the past 20 years.

"That night was really,

really, really scary," she recalled Friday. "We're really

fortunate that we got out."

A GoFundMe page has been set up to help the program rebuild, while educa-tors lead virtual lessons during the pandemic.

So far, about 27% of a \$152,000 goal has been raised. Next week, Davis students will hold a Zoom meeting with Principal Christy Flores and Smith to announce how much they will be adding to the cause.

No matter the amount, Smith said the students' enormous act of kindness will never be forgotten.

"They really do want to do good things and share kindness," she added. "They're going to be great grown-ups some day."
