Helping women's infertility struggles

Newport Beach's Dr. Sanaz Ghazal aims to put the experiences of her patients first.

With National Infertility Awareness Week, April 18 through 24, approaching, one local doctor says her practice is doing its part by extending a helping hand and actively encouraging women facing fertility challenges to seek assistance.

Sanaz Ghazal, MD, FACOG, is the medical director and founder of RISE Fertility in Newport Beach, one of more than a dozen fertility clinics in the city. The double-certified fertility specialist (reproductive endocrinology and infertility as well as obstetrics and gynecology) attributes becoming a mother to helping make her a better doctor.

"Because of the connection, I understand on a deep level what patients are going through," Ghazal said in an interview this week. "I was in training before becoming a mother myself and prior to building my own family I went through my own experience to become a mother."

RISE Fertility officially opened this week to provide in vitro fertilization, egg freezing and fertility preservation, embryo transfer, intrauterine insemination, LGBTQ care, third-party options and genetic testing.

Ghazal, who was born in San Diego and grew up in Temecula, said she always knew she wanted to pursue a future in medicine and that it was women's health that most resonated with her.

She has an East Coast education, doing her undergraduate work at Harvard University before studying to become a doctor at

Taking action to 'stop the hate'

The six letters were written by airplane about 11,000 feet above Huntington Beach on Friday afternoon.

Kien Nguyen looked overhead and smiled. "No Hate," the letters spelled out against the bright blue sky.

That's a goal for the Fountain Valley resident, 76, who is a grandmother of six. Nguyen said she paid for the airplane writing out of her own pocket to send that message.

"I'm not working now, I'm retired, but I still have a little bit of my savings," she said. "I

can do it."

Now she can be proud that the local Asian-American community is going beyond just words to try to stop the anti-Asian hate speech and violence.

The air writing came at the conclusion of a news conference at Whale Spa Salon Furniture in Huntington Beach. Local volunteer group "Nailing It for America," which was cofounded by Kien Nguyen's son Tam, announced that it is joining with Grammy-winning Thuy Nga Productions to present a global benefit concert online.

The concert, designed to combat hatred against Asians, will be broadcast in coordination with VietFace TV from 5 to 8 p.m. on Asian hate rhetoric and violence, as well as provide services for vulnerable community members via a fund through Orange County United Way.

The concert is called "We Must Look Up: Rising Above Hate With Love," the same name as a recent op-ed piece that Kien Nguyen wrote in Vietnamese. Donors can contribute at *UnitedWayOC.org/stopasianhate* in English, or *UnitedWayOC.org/vn* in Vietnamese.

Ted Nguyen (no relation to Kien), another co-founder of "Nailing It for America," said the organization has hosted 10 events like candlelight vigils and rallies in just the last three weeks. awareness is important, but beyond the hashtag #StopAsianHate, we wanted to do something about it. We wanted to channel people's anger and frustration and fear into positive energy, so that we can get money to arm front-line workers, to protect our most vulnerable community members against hate. We want them to have all of the necessary resources that they need in order to protect their families, protect themselves and protect all of us."

Alison Edwards, chief executive of nonprofit Orange County Human Relations, said at the news conference that hate incidents

Marina collects fourth straight win

ANAHEIM — When the national anthem wasn't playing over the loudspeakers at Glover Stadium on Thursday night, some Marina High School football fans took it into their own hands.

They started singing "The Star-Spangled Banner" a cappella, finishing just in time before Marina's Dylan Keidel kicked off to start the Vikings' Big 4 League game against Katella.

Some traditions are old. When it comes to league titles, Marina wouldn't mind starting a new tradition after winning its first league title in 33 years in 2019.

The Vikings will play for their second straight Big 4 League crown after finishing off a 21-6 win over Katella.

Marina (4-1, 2-0 in league) can clinch the outright title with a win at Segerstrom in its final game of the season on April 16.

Vikings coach Jeff Turley remembers the last time the teams played there, or at least tried to. The teams' league game in 2018 was delayed a day due to lightning, with Segerstrom winning the next day.

"It's going to be another tough one," Turley said. "We've got to go to their house. Hopefully, this time there won't be any lightning."

The Marina offense provided the flash against Katella (2-2, 0-2). Senior quarterback Jack Miller threw touchdown passes to three different receivers — Dane Brenton, Gavin Del Toro and Wyatt McClour.

The first touchdown pass, to Brenton, came on the Vikings' first drive and was the longest play of the game for either team. Brenton was left wide open on the right side, and 67 yards later he was gone for a score.

Marina doubled its advantage late in the first half when Miller found Del Toro open on a 10yard slant in the end zone, and took a 14-0 lead into halftime.

Katella got on the scoreboard when quarterback Donnovan Arrington ran up the middle on a seven-yard keeper on the first play of the fourth quarter. But the Vikings immediately went on a 69-yard drive, capped when Miller hit McClour, the tight end, on a 10-yard score on fourthand-goal with 6:50 remaining in the game.

That drive also featured a 46yard bomb from Del Toro to Brenton.

"[Making] a one-possession game to two is a huge deal for us," said Miller, who passed for 170 yards and was also inter-

A construction project to replace the box culvert on Coast Highway at Main Beach will bring full overnight street closures to Laguna Beach next week.

Traffic has been reduced to one lane in each direction because of the project, which is expected to be completed in late May.

California Department of Transportation (Caltrans) officials said Wednesday that overnight street closures are anticipated for Tuesday, Friday, April 16, and Saturday, April 17, with each closure lasting from 8 p.m. to 8 a.m.

The Coast Highway closures will be implemented between Broadway Street and Ocean Avenue.

Traffic that approaches those streets will be redirected up to Beach Street, a map of the planned detour provided by Caltrans shows.



targeting the local Asian American Pacific Islander community increased by 10 times in 2020 compared to 2019. The recent incidents compelled the Huntington Beach City Council to pass an item denouncing hate speech, and another denouncing white supremacy, at Monday's meeting.

A possible "White Lives Matter" rally is scheduled for the Huntington Beach Pier at 1 p.m. Sunday, two hours after a counter-rally co-organized by Black Lives Matter Huntington Beach founder Tory Johnson.

Edwards said the hate speech against Asian Americans shows no signs of stopping. She brought up that karate champion Sakura Kokumai, who is preparing to represent the United States at the 2021

"RISE" for her clinic because she sees it as an empowering word that embodies the journey.

Her work, she said, is "deeply about how much my patients struggle to go on. They feel isolated and lonely, which can bring you to your knees."

Ghazal explained that while technology is available, what sets her practice apart from other clinics and makes it unique is its high quality of the latest in fertility care that puts patient experience first.

For example, barriers are removed to improve access to the doctor and medical team. Also, her clinic offers its own financing to help make the process more accessible.

Ghazal says her philosophy is to listen to a patient's individual needs and goals in order to build a strategy to get them where they need to go.

She went on to explain that markets are changing, and people no longer follow blindly what doctors advise. They are savvy and smart with all of the information available to do their own research and look for a true partner to help achieve their goals.

"Our goal is to elevate the patient experience, beginning with space, create warm, inviting comfortable setting rather than a cold,

Ghazal resides in Irvine with her athletic family, consisting of her husband and three children, ages 7, 4, and 1. Tennis and golf are among the family's favorite outdoor activities.

National Infertility Awareness Week was established in 1989 by Resolve: National Infertility the Assn., an organization that began in 1974 with a group of people who shared the disease of infertility and were seeking support.

Today the association provides resources toward the care and education of individuals struggling with infertility.

As the Resolve website points out, infertility does not discriminate. No matter the economic status,

awareness week is to educate, to inspire grassroots advocacy and to encourage those with infertility to be open with friends and family about the issue.

Resolve makes its mission clear on its homepage: "We are here until barriers to starting your family are not."

Ghazal shares the association's goals to make inneed them.

"I'm big on education," Ghazal said. "I want my patients to understand [the treatment options], which will build trust. I love when patients are active participants in their own care."




