LCAD to resume in-person classes

The Laguna school announced this week it is planning to bring back on-campus learning for the fall 2021 semester.

Laguna College of Art and Design plans to bring back in-person classes for the fall 2021 semester, the school announced this week.

"The entire teaching and staff community are eager to return to campus and welcome our students," Hélène Garrison, chief operating officer and provost at LCAD, said in a statement issued Wednesday. "If there is any gift to be found from this pandemic, it is the even deeper commitment and appreciation of LCAD's mission to support our students.

"Every conversation and decision has focused on how we can work with our students one-on-one to meet their needs, and we look forward to the day when we can do so face-to-face, in person."

Garrison added the school would not be mandating that students and staff get vaccinated to return to campus.

In the fall 2020 and spring 2021 terms during the coronavirus pandemic, the college has offered limited use of campus facilities. Students had to have appointments for studio space and the LCAD Fabrication Lab.

Health and safety protocols implemented by the college have included requirements for physical distancing and masks, as well as regular sanitation of touch points. The college still plans to have a virtual commencement ceremony on May 21. Jonathan Burke, who recently retired as president of the college, is expected to be the keynote speaker.

Orange County progressed to the red tier regarding its coronavirus transmis-

much she loves the sport and wants to be an ambassador.

Abruscato has been involved with pickleball since about 2013. In that time, she's seen the sport's popularity grow exponentially.

It's accessible for all ages, and fairly cheap to play. There always seems to be action at the four pickleball courts that the city installed at Worthy Park, located at 17th and Main Street, in 2017.

"The sport started in Huntington Beach



with four players, and 24 players were playing in 2007," Abruscato said. "Now we've seen over 2,000-plus players come through our courts just in the last five or six years."

During the coronavirus pandemic, Abruscato has used the extra time to her advantage. She installed a board of directors for the nonprofit Surf City Pickleball Society last June.

The group's website, *surfcitypickleball society.com*, also was recently launched.

That should help the society cater to a younger audience, as will the school pro-

Surf City Nights return to Huntington Beach

Surf City Nights are back.

The venerable Tuesday night street fair returned this week to downtown Huntington Beach, with about 50 vendors set up along three blocks of Main Street between 5 and 9 p.m.

Restrictions are easing across Orange County, which moved into the red tier for reopening on Sunday and has case numbers that suggest the orange tier could be soon to follow. Surf City Nights had been shut down since March 2020 due to the coronavirus.

Sean Dick, who owns Red-Beard's Hot Sauce with his wife, Carolyn, set up shop on the second block, at the corner of Main Street and Olive Avenue in front of the Wet Dog Tavern.

"I thought the energy was outstanding," Dick said of the first week back. "It was fantastic. It really felt like the street fair used to be, that was the best part about it. They brought us back when they first started the farmers market, and that was about three months ago. Now that they opened it up for the

street fair, everybody came out. "The foot traffic was just steady all night long. I think people were just dying to get out of the house and go have something to do again."

Jaime Strong, the marketing manager for the downtown Business Improvement District, said there were fewer vendors at Surf City Nights than before COVID-19, since restaurants downtown have built patios outside to encourage outdoor dining.

"We're utilizing the space that we have on Main Street to coexist with the outdoor dining patios," she said. "We're putting vendor booths between them where we can. It's a positive that we're working together, and it actually creates a really unique flow."

Man sentenced for attempted murder of N.B. attorney

A former doctor has been sentenced to eight years to life in state prison with the possibility of parole after a jury found him guilty of attempting to kill a Newport Beach attorney.

Richard Lee Austin, 69, received the sentence on Friday at the Central Justice Center in Santa Ana. Austin was convicted in September last year of attempted murder. He was convicted in a previous trial in 2018 of the stalking and attempted kidnapping of attorney Limor Lehavi.

Austin was previously tried for attempted murder, but two juries were unable to agree on if Austin intended to murder Lehavi when he confronted her with a gun at her office.

The origins of the case date back years, beginning with an altercation that Austin had with another driver following a car accident. The driver claimed damages.

Austin then sued his car insurance company, arguing that his policy should have covered the costs. Lehavi defended the insurance company and won.

Austin then filed a lawsuit against Lehavi personally, which she won.

Prosecutors said that Austin became "obsessed" with Lehavi.

In 2017, Austin appeared at Lehavi's office in Newport Beach after she switched firms and called to the office under a pseudonym several times.

Lehavi said last year that he claimed he was from Chicago and had been referred to her, but her receptionist saw his caller ID and alerted Lehavi.

Worried about her and her family's safety, Lehavi said she was accompanied by her coworkers to her car. There, she saw Austin in a rental car. He took off when he saw Lehavi with her coworkers, who then called the police to report the incident.

Austin was arrested in May that year. He is next scheduled to appear in court on April 5 for a hearing on the relinquishment of firearms.

With his son Jeff by his side, David had many successes on the family's Ranger 33 Puff, Islander 30 Flying Colors, and custom Britt Chance Design ³⁄₄ Ton Eclipse. Together with his crew, David won the Hugh Angleman series five consecutive years, the Humphrey Bogart series, and many other regattas. Over the years, David enjoyed his friendships and the comradery of yachting at Newport Harbor Yacht Club. David continued his passion for bacting by building two power boots. boating by building two power boats, Coaster and Crosser, later acquiring Solaia in 2007. David married Sandra Howarth in 2004. Together they shared many happy years traveling the world on Crosser and Solaia, visiting more than fifty-five countries on four continents and logging more that 130,000 miles at sea, the equivalent of five times around the earth.

timidating, threatening and defrauding. If convicted of both counts, he faces a maximum sentence of two years in Orange County Jail, according to the release.

The district attorney's office said Tennant is accused of posting a fellow officer's photo and personal cellphone number on the dating website doublelist.com, on Sept. 20 and 26, 2020. The other officer was made aware of the ads when he started receiving texts from unknown numbers referencing the internet postings that featured his picture and phone number.

The ads were posted after the other officer began dating Tennant's ex-girlfriend. The Huntington Beach Police Department initiated an investigation after the officer reported the harassment to a supervisor.

"Impersonating another individual on the internet is not a joke," Orange County Dist. Atty. Todd Spitzer said in a statement. "It is a crime that could result in serious harm. This is not boys will be boys or cops will be cops behavior. It is curious and beyond disturbing that a sworn police officer would engage in such reckless behavior to endanger the safety of a fellow officer."

Tennant is scheduled to be arraigned on May 5 at the Orange County Central Justice Center in Santa Ana.
