## With a waiver, St. Joachim School offers peek at pandemic learning

After enduring months of distance learning, largely separated from teachers and friends, TK-6 St. Joachim Catholic School students joyfully returned this week to the Costa Mesa campus to engage in a new school year, albeit with a pandemic twist.

Kids and parents arriving on campus posed for pics on the playing field, where gold letters staked in grass spelled out "Welcome Back Sea Kings." Inside, instructors welcomed students with a smile and a quick temperature check. Most wore masks and sat

## F.V. Council candidate ordered to correct campaign statement

The Fountain Valley Chamber of Commerce filed for and secured a writ of mandamus in Orange County Superior Court to have Tom Nguyen, a candidate for Fountain Valley City Council, remove false information that appeared in his candidate statement.

Nguyen had stated on both his campaign website and in his candidate statement that he was

serving as a board member for the Fountain Valley Chamber of Commerce. The candidate, who is one of seven vying for two seats on the City Council this November, is a director for the Santa Ana Chamber of Commerce.

As of Wednesday afternoon, Nguyen's campaign website was down.

A court order was signed granting the Fountain Valley Chamber

of Commerce's petition on Sept. 2. Among the stipulations made by the order, Nguyen must identify that he is a director of the Santa Ana Chamber of Commerce and delete all statements that he is a director or member of the Board of Directors of the Fountain Valley Chamber of Commerce. This must be done for any form or avenue in which the misinformation appeared, in-

cluding Nguyen's website, political candidate forums and publications.

Nguyen must also clarify that Janet Nguyen is a former state senator, Dana Rohrabacher is a former congressman and David Valentin is the police chief of the Santa Ana Police Department. The candidate's statement said that he is endorsed by all three.

## First responders honored at Huntington Beach blood drive

His name is a bit of a misnomer, because Cliff Walker loves to run.

The Irvine resident, 53, said he's run more than 40 marathons, six half-Ironman competitions and one full Ironman.

Walker, who used to live in Huntington Beach, returned to Surf City on Wednesday to receive a special award. He was one of four first responders honored during a blood drive hosted by Nuvision Credit Union, the American Red Cross and the Huntington Beach Fire Department.

The event was held at Refuge Calvary Chapel Church. The church's inside auditorium was used for the blood drive, in which

more than 100 people gave blood. The local fire department was on hand grilling hamburgers.

Walker, who served two tours in the Navy, works as a firefighter at the Seal Beach Naval Weapons Station. His message during COVID-19 is ultimately one of hope.

"Understandably, [the pandemic] has created a lot of setbacks for a lot of people," said Walker, who plans to run across the state of California next year in one month — a little more than a marathon each day — to raise awareness for his issues. He said he would be donating his entire \$500 prize to Muertos Coffee Co.'s "Roast For Relief" foundation, which raises money for first responders.

"You've also got to look at

what's good out there, man," Walker said. "Everybody's coming together. Everybody's kind of meeting this head on. In order to get past it, we've got to get through it first. The only way we can do that is following the rules, as much as they suck. For me, from military to paramilitary, following the rules is something I've done."

Walker was one of the first responders who received an award in Nuvision's first year sponsoring the contest. Eastvale resident Mike Pradin of Los Angeles County Fire Station 51 was another.

"I was surprised," said Pradin, who has been with the department for 16 years. "I mean, a lot of

# H.B. council votes to extend Main Street closures through end of year

The Huntington Beach City Council voted 6-1 on Tuesday night to extend the closures of the second and third blocks of Main Street to vehicular traffic.

Main Street will now be open to pedestrians only, up to Orange Avenue, through the end of the year. The street closures have primarily been used for outdoor dining during the coronavirus pandemic.

Orange County moved from the purple tier to the red tier of reopening Tuesday, meaning that restaurants can open for indoor dining at up to 25% capacity or 100 people, whichever is less. But City Council members agreed that the outdoor dining program, which was kick-started in May and expanded to the third block in early August, has been well-received and reinvigorated the downtown area.

The downtown Business Improvement District had submitted a letter showing the support of 19 businesses in continuing the closure of the second block of Main Street. But City Manager Oliver Chi said in a report that some businesses in the third block were less enthusiastic about the closure. The third block of Main Street has fewer dining establishments and more retail businesses.

Councilman Mike Posey said a contingency plan still was needed in case indoor dining doesn't open back up as quickly as hoped, and that's why he made a motion to keep both the second and third blocks closed to traffic and open to outdoor dining through the end of the year.

"There is an energy on the second block which hasn't quite migrated to the third block," Posey said.

"What I see is that the water barriers create a physical, a visual and maybe even a psychological barrier for those who want to venture off of second to the third block. I think to get that energy jump the street, we have to make those water barriers camouflaged. I think it could be done relatively inexpensively by just putting a banner up there. On one side of the banner, you put the restaurants on the west side [of the street], and on the other side of the banner you put the retailers and Avila's El Ranchito on the [east] side."

Posey also suggested bringing a live music element on each side of the third block of Main Street.

Mayor Pro Tem Jill Hardy mentioned that some residents she's talked to indicated that they wanted downtown to permanently have the outdoor dining options.

Councilman Erik Peterson was the lone dissenting vote against keeping the third block closed through the end of 2020.

"I'm not quite as comfortable as you guys telling these businesses that we're going to do this," he said. "I'd prefer that they come to some sort of vote between them, except for the second block. I think that's a given, but the third block ... I'm really not as enthusiastic about that."

Councilwoman Kim Carr made a substitute motion to Posey's motion, proposing to continue the third block closure through the end of October and reevaluate the situation at that time. It was defeated 4-3 with Hardy, Posey, Mayor Lyn Semeta and Councilwoman Barbara Delgleize voting no.

## H.B. TO ENACT BICYCLE REGULATIONS

The City Council unani-

mously voted Tuesday to instruct Chi to prepare regulations that would make the repair and sale of bicycles and bicycle parts illegal on public property in the city.

Councilman Patrick Brenden introduced the item after he said a resident made the suggestion. He said the city of Long Beach recently passed a similar ordinance.

"It's a good step in the right direction," Brenden said. "I think we've all seen more often than we'd like,

someone on a bike coming down the street and rolling another bike alongside of them. We all know that bike theft in Huntington Beach is rampant. As long as there's this underground network of chop shops that's providing an easy way to traffic stolen bike parts and bikes by drug addicts and other criminal elements, we're never going to really be able to address this problem of bike theft."

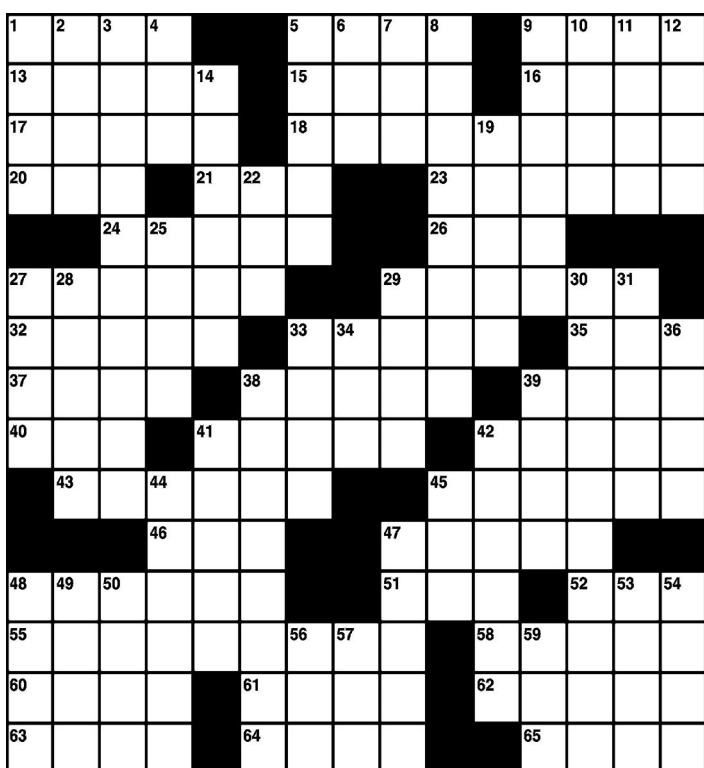

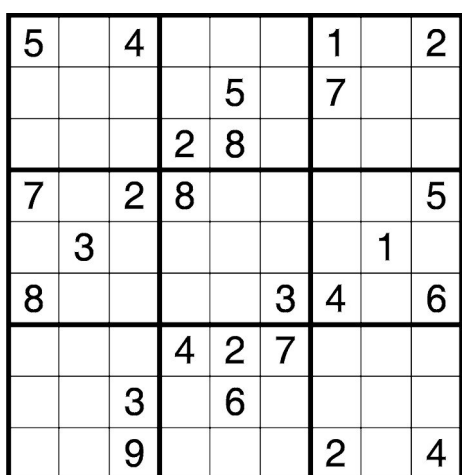

us feel like we're trained to do a job we have, and we're happy to do it. But it's nice of them to be doing that. It's nice to see the fire truck here, and it's nice when they honor law enforcement and first responders. I'm just one of many."

Kelly Jones of Riverside, 34, also was on hand to receive an award. During the pandemic, Jones pivoted and was stationed in Costa Mesa as part of the disaster response team for CalMET, spending months away from her family.

The fourth award recipient was Margarita Gardner, an Orange sheriff's deputy.

Huntington Beach Mayor Lyn Semeta was happy to be at Wednesday's

blood drive, which also featured singing and dancing.

"If there's a bright spot to COVID, it's that the community has just come together in so many ways," Semeta said. "People have pivoted, people are being flexible and doing different roles than they did before to stand up and help each other. That's been incredibly gratifying as mayor, to watch that. Huntington Beach has always been a community that watches out for each other, and we've really seen that exponentially grow this year because of the circumstances that we're all under."

Semeta was not the only member of the Huntington Beach City Council to attend. Barbara Delgleize also showed up to give blood.

Delgleize said she gave blood a few months ago and recently received an automated phone call from the Red Cross to do so again. She said her blood type is O-positive, which is needed because it's given to patients more than any other blood type.

"I just really appreciate when the community comes together and does stuff like this," Delgleize said. "I'm a longtime Realtor, and I know how important community is. When people buy a home, they want to know if it's safe to live here. We have great schools, we have great services, and we also have people that love to voice their opinions, sometimes too loudly. But overall, I think it's an amazing place to live."

# Fountain Bowl owners plan to sell due to pandemic

Dave Osborn has worked in the bowling industry for 52 years.

His career began in 1968 when he took a job at an on-campus bowling center in college, and he went to work for Brunswick in 1972.

For more than three decades, Osborn has partnered with Gary Forman as owners of Fountain Bowl.

Like any prepared business owner, Osborn would consider the worst-case scenarios. The challenges wrought by the coronavirus pandemic have proven to be beyond belief.

"I used to think about things that could happen that could affect our business, and I never even dreamed about anything like this ever happening," Osborn said.

After enduring nearly six months of being shut down, Osborn and Forman have determined that they will have to sell the business. Although it would be ideal to sell to a buyer who wanted to continue to operate the bowling alley, the owners think that is unlikely to be the case.

Fountain Bowl has been around for 46 years. On Sept. 15, Osborn and Forman will have owned it for 32 years. The venue has hosted professional tournaments in addition to its claim as a staple of the Fountain Valley community.

Forman said that people in the bowling industry anticipated that closures due to the pandemic would last several weeks — but certainly not as long they have.

Fountain Bowl had 72 employees before the initial shutdown in March. When the bowling center was able to reopen on June 13, Forman said they resumed operations with a "skeletal staff" of about 30 employees and were open just 10 hours a day.

Then the bowling alley had to close again on July 1, which left its owners won-

dering why after the protocols that had been put in place.

Fountain Bowl, which has 60 lanes, had erected plexiglass at all stations, Osborn said. He added that social distancing was in place, tables were separated in the eating area, only every other lane was available for use, and staff were cleaning and sanitizing constantly. Osborn said the bowling alley was operating

at about 30% capacity the first week and 50% the second week after reopening in June and felt the worst had passed.

"We got nothing but compliments because we were doing it probably better than anybody around as far as making sure that it was a safe, clean, sanitized place to come in," Osborn said. "We did all that, and we still got shut down for it. We never had one inci-

dent of anybody that had COVID. We had nothing — no employees, no customers. We did all the right stuff, and it didn't make any difference."

Under the new color-coded guidelines that were issued by the state on Aug. 28, bowling alleys would not be able to open until their county progresses to the third tier of "moderate transmission," and operations would be scaled back

to 25% capacity.

"Our biggest frustration right now as an industry is with the governor, [Gavin Newsom], because bowling is open now in 48 states," Forman said. "California and New Mexico are the only two that won't allow us to reopen."

Both of the owners agreed that if Fountain

Bowl is discontinued, it would be a big loss for the community.

"Emotionally, it was a very difficult decision to do," Forman said of the decision to sell. "But realistically and pragmatically, when you have no cash and you have bills to pay, you're kind of left little choice."

Forman added that the pandemic has made it impossible for businesses to budget because of the unknown.

"Fountain Bowl was like the gathering spot for the community," Osborn said. "We raised millions of dollars there over the years for fundraisers. We had all of the social organizations and service clubs meeting there — the Chamber of Commerce, the Rotary club, Kiwanis. Everybody used that place as their place to meet. It was a focal point of the city."

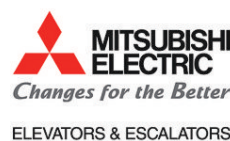

at desks fitted with plexi-glass dividers and spaced 6 feet apart.

The return was sanctioned by the California Public Health Department, which in August established a waiver process allowing Orange County Schools to resume in-person learning for lower grades, so long as the county made progress reducing coronavirus infections and met other benchmarks.

St. Joachim applied for a waiver Aug. 13 and was approved Sept. 2. Principal Lisa Gilbert said officials heard the news the following day.

"We knew kids needed to be on campus and needed to be back to somewhat of a normal setting," Gilbert said. "We wanted to make sure we could meet everybody's needs but still keep everybody safe."

The Costa Mesa private school was one of 140 countywide to apply for the waiver. In the cities of Costa Mesa, Huntington Beach, Newport Beach, Laguna Beach and Fountain Valley, below are the 25 schools that applied:

- **Costa Mesa:** Christ Lutheran School; Mariner's Christian School; Page Academy Newport Mesa; St. Joachim Catholic School; St. John the Baptist School; Waldorf School of Orange County

St. Joachim's school's seventh- and eighth-graders, and those who prefer the remote option, will continue with online lessons for the time being.

New state school reopening guidelines released last month placed Orange County on the first, most restrictive tier for having "widespread transmission." But with a relatively flat rate of new cases, the county transitioned Tuesday to a less restrictive "substantial transmission" tier.

If trends remain positive for 14 days, Orange County schools can reopen without waivers as soon as Sept. 22. School districts across the county are hashing out plans for that important milestone while institutions with waivers prepare to welcome back students in higher grades.

And, given the data coming in from the Orange

County Health Care Agency, the picture looks somewhat promising.

Agency officials reported 194 new cases Wednesday and nine deaths, bringing Orange County's total infections to 50,190 and its death toll to 1,065. An estimated 44,220 people are thought to have recovered from the virus.

With 5.2 daily positive cases per 100,000 people and a positive testing rate of 4.2%, the county continues to remain within the confines of the substantial transmission designation. Both numbers are a seven-day average and include a seven-day lag period.

Among the infected, 234 were being hospitalized Wednesday with COVID-19, the disease caused by the virus, while 62 were being treated in intensive care units.

A member of St. Joachim Catholic School's reopening committee, junior high English teacher Jill Cavanaugh said she's been keenly aware of the county's virus transmission trends and what that could

mean for teachers and students returning to campus.

While she and other teachers prepared this summer for the 2020-21 school year ahead, not knowing whether classes would be online or in person, Cavanaugh felt both the pull of wanting to be back in the classroom and the fear of possibly being exposed to the virus.

"It was kind of a roller-coaster — there was a ton of thinking and soul searching," she said. "There were days I was terrified, thinking, how can I do this? I was scared to death. And other days, I was like, 'Let's go! I want to be back with my students.'"

Yet once Cavanaugh heard from the school that TK-6 in-person learning had been given the green light, and she began organizing her classroom in preparation for the big day, her nerves began to calm.

On Tuesday, teachers spent much of the day getting students acclimated to the new rules of the school year. Kids seemed eager to learn what was expected of

them. By Wednesday, classes shifted to traditional instruction.

Sue Kelly, whose 9-year-old son, Jack, entered the fourth grade at St. Joachim on Tuesday, can attest to her son's enthusiasm to rejoin his classmates for the first time in 179 days.

"This Tuesday when it opened, he was up at 6 a.m., dressed and ready to go," she said. "His smile was huge — he was very eager and very happy to see his friends."

Gilbert said the school's enrollment, a bit flat in recent years, has seen an uptick in 2020-21.

She credits the increase to St. Joachim's rapid response to provide a comprehensive distance-learning plan immediately after March 13 closure of school campuses, which garnered a good reputation among local parents as complaints about other schools proliferated.

Gilbert also thinks people enrolled their kids when they learned the school had been granted a TK-6 waiver and would be reopening at a time when most larger districts have elected to stay online only.

"Parents wanted their kids on campus," she said. "And they knew we were working on getting them back."

City spokesman John Pope said that city staff and code enforcement officers witnessed numerous violations of the temporary use permit's conditions, which included the usage of indoor space for dancing and alcohol consumption; violation of occupancy limits for outdoor patio space; violations of the 9 p.m. closure times; and calls for police service as a result of outdoor alcohol consumption.

City staff also said that the restaurant made "no attempt to practice social distancing or require face coverings by patrons and staff."


"The vast majority of restaurants and businesses are complying with the conditions of their emergency temporary use permits under the 'Back to Business' program and [state] guidelines," Pope said. "However, the permits can be revoked if restaurant owners are found to be operating unsafely, in violation of the terms and conditions or guidelines."

Restaurant owners declined to comment on Wednesday, but the Peninsula Lounge reports on OpenTable and Yelp that staff are required to wear face masks and temperatures are checked. It also states that surfaces are sanitized, seats are limited and tables are spaced in accordance with social-distancing requirements.

Reported operation hours vary across websites.

City staff said that though the permit was revoked, it only affects the restaurant's outdoor dining but not the indoor dining due to Orange County moving this week to the "substantial" red tier from the "widespread" purple tier in the state's new guidelines for reopening. As part of that, restaurants are allowed to resume indoor operations at either 25% capacity or 100 people, whichever number is less, and close by 10 p.m.

July 1, 1929 - September 7, 2020

Dr. Robert August Hinrichs, 91, passed away peacefully on Monday, September 7, 2020, in Palo Alto, CA. His wife of 66 years, Marianne Powell Hinrichs, preceded him in passing on April 1, 2019, after a brief illness. Bob and Marianne spent most of their long and happy lives in Corona del Mar, California. Bob was in private surgical practice at Hoag Hospital for many years, and served as Chief of Staff and on the hospital's Board of Directors for many years. Bob always knew that he wanted to be a surgeon, and was passionate about caring for his patients. He served on local and regional medical associations and was appointed to the California Board of Medical Quality Assurance by then Gov. Jerry Brown. Away from the hospital, Bob was an avid golfer, an accomplished bridge player, and a determined fisherman and skier.
