

Governor's Cup win delights the host club

Jeffrey Petersen of Balboa Yacht Club wins the 54th annual event on Saturday, taking the championship final 3-2 over Denmark's Emil Kjaer.

When the host club wins, the celebration cannot be contained.

So it was when Balboa Yacht Club's Jeffrey Petersen and his crew sailed through the finish line in the decisive race of the 54th annual Governor's Cup International Youth Match Racing Championship on Saturday.

Spectator boats blew their horns in celebration, and on land, cheers and a round of applause emanated from the bar from members watching a

livestream of the regatta.

In a back-and-forth final, Petersen emerged victorious 3-2 against Denmark's Emil Kjaer, winning the last two races of the championship series to give Balboa Yacht Club its second winner of the last four Governor's Cup events.

"I love that boat a lot," Petersen said. "You'll see pictures of me. I went and kissed it, said, 'Thank you, boat.' I mean, the boats are great, but this one in particular has a got a little special place in our hearts now."

Christophe Killian had been the most recent winner for Balboa Yacht Club in 2017. Australia's Harry Price won in 2018 and then New Zealand's Nick Egnot-Johnson in 2019. The Governor's Cup was canceled last year because of the coronavirus pandemic.

Joining Petersen on the boat were main trimmer Max Brennan and bowman Scott Mais, both members of the Newport Harbor High School class of 2019. Petersen graduated from Mater

'Rockin' Fig Day' to be considered

The H.B. council could take up the item on Tuesday. A paddle out is scheduled Aug. 28.

Details are emerging on ways to honor Rick "Rockin' Fig" Fignetti, the Huntington Beach surfing celebrity who died July 16 after suffering a heart attack

A paddle out organized by Huntington Surf and Sport owner Aaron Pai and Fignetti's good friend Don Ramsey is scheduled for Aug. 28. The paddle out to honor Fignetti, who was 64 when he died, will be held at 9 a.m. at the north side of the Huntington Beach Pier.

It will be followed by a celebration at Pier Plaza, with live music, from noon to 4 p.m.

There also may be a "Rockin' Fig Day" each year in Surf City. A Huntington Beach City Council agenda item up for consideration at Tuesday night's meeting would establish a day named in honor of Fignetti annually each Saturday of the Surf City Days event.

Surf City Days, which includes several beach activities, is typically celebrated in September after Labor Day, but this year it was delayed to Oct. 9-10 due to the coronavirus pandemic. Therefore the first "Rockin' Fig Day," if

Hoag gets \$3M from the Iacocca Family Foundation

The donation will expand the type 1 diabetes program at the hospital.

Hoag Memorial Hospital Presbyterian Monday announced a \$3-million gift from the Iacocca Family Foundation to expand a program for type 1 diabetes at the Mary & Dick Allen Diabetes Center.

In appreciation of the gift, Hoag is naming the Mary & Lee Iacocca Program in Type 1 Diabetes to honor the foundation's mission to fund diabetes research that could lead to a cure for the disease and alleviate its complications.

Onetime Ford Motor Co. and Chrysler Corp. executive Lee Iacocca, who died in 2019, established the foundation in 1984, after his wife Mary died from complications of type 1 diabetes.

Since its inception, the Iacocca Family Foundation has funded more than \$40 million in promising research projects.

"We could not be more grateful to the Iacocca Family Foundation for supporting Hoag's role in becoming the preeminent, trusted destination for comprehensive type 1 diabetes care in Orange County," said Flynn A. Andrizzi, president of the Hoag Hospital Founda-

"This gift facilitates research and educational programs to expand our knowledge of diabetes prevention and management and will help provide truly comprehensive, connected and customized care for the lives of people living with diabetes and their families," Andrizzi said.

Hoag's Mary & Dick Allen Diabetes Center offers traditional clinical services, dietitians, nurse educators, health coaches, support groups, pump trainings and a specialized pharmacist, as well as access to cutting-edge technology through clinical trials.

"Through the Mary & Lee Iacocca Program, patients with type 1 diabetes have an Orange County hub for patient-centered care across their entire lifespan," according to a hospital statement.

"From supporting pediatric patients and their families, to successfully transitioning adolescents into young adulthood, to navigating healthy pregnancies and to reducing long-term complications in older populations, the program provides care that is tailored to an individual's personality, cultural upbringing and values."

Lee and Mary Iacocca's daughters, Lia Assad and Kate Hentz, said they are carrying on their parents' legacy by establishing the program on the West Coast on behalf of the family's foundation.

"Until we find a cure, it feels right to help people with diabetes through a program that has an immediate impact on their day-to-day lives," Hentz said.

Assad, an Orange County resident, agreed.

"It's important to me that families right here in our community have the resources and support they need," she said.



"It's actually an advantage to be in the repechage, I'm 100% sure, because the boats are completely new for us. We've never sailed in these boats before, and it's the same for most people when you go to match-racing events.

Kjaer will certainly consider his experience at the Governor's Cup as valuable training, as he remains in town for the Youth Match Racing World Championship, which will also be hosted by the Balboa Yacht Club from Aug. 9 to 14.
