Tanaka Farms plants roots with Hana Field

Just as young sunflowers follow the sun, visitors craned their heads skyward to greet some of blooms towering over them.

People cradled white, plastic vases with bunches of sunflowers — some yellow, some red and zinnias, their small pruning shears at hand in case they this year," said Ken Tanaka, a fourth-generation farmer who owns and operates Tanaka Farms with parents Glenn and Shirley Tanaka.

"We have our main farm in Irvine and when they offered us to lease the field in Costa Mesa we thought it might be a good opportunity to try something new. We have never grown flowers on this large of a scale, so we

Rhonda Bolton named to H.B. council

An attorney who has served on the city's Human Relations Task Force, she was sworn in to fill Tito Ortiz's seat.

Huntington Beach has found its seventh City Council member.

On Monday night, the Council voted 4-2 to appoint lawyer Rhonda Bolton to the seat vacated when Tito Ortiz resigned on June 1.

Bolton was one of 105 candidates who were interviewed by the council over two lengthy sessions earlier this month. During a special meeting held July 19, the council was unable to reach a consensus on naming Ortiz's replacement and the matter was continued to this week.

Mayor Pro Tem Barbara Del-

The 30-acre field opened to the public on Mother's Day weekend in May, and Tanaka estimates that at least 12,000 people have visited since then.

Field manager Brandon Flores said the field's currently on its second crop of sunflowers and will soon be on its third.

Driver arrested after hit-and-run on PCH kills 1 pedestrian, critically injures another

Huntington Beach police have arrested a 26-year-old Victorville woman they believe killed one pedestrian and critically injured another Saturday night in a hitand-run collision on Pacific Coast Highway, officials reported.

Chillandra Dalanalea Bell was driving a Nissan Altima northbound on Coast Highway at 8 p.m. when she reportedly ran a red light at Newland Street and struck a man and a woman in a crosswalk, according to a police department release issued Monday.

Witness accounts and video surveillance footage indicate that following the collision, Bell continued driving before stopping a short distance away and abandoning the vehicle along with a female passenger inside the Altima. Police reported the pair entered a white sedan waiting nearby and fled.

First responders arrived on scene and pronounced one of the pedestrians, DeAnna Stuve, a 48-year-old school teacher from Hemet, dead. Fredrick Stuve, 50, of Hemet was found to have sustained serious injuries and was transported to a nearby hospital where he was listed Monday in critical condition, according to

police.

While police could not immediately confirm the relationship of the two victims, an online search indicates the pair were a couple and that DeAnna Stuve worked as a teacher at an elementary school in the Hemet Unified School District.

With the assistance of multiple witnesses, officers traced the

Governor's Cup youth match racing regatta returns despite challenges from COVID-19

The 54th annual Governor's Cup International Youth Match Racing Championship got underway on Tuesday afternoon off the coast of Newport Beach, marking a long-awaited return for sailing fans.

Although the regatta is back after being shelved due to the coronavirus last year, the pandemic continued to pose a very real threat to the event.

Those challenges included the inability for some of the invitees to get to the regatta and back to their homelands in a timely manner, resulting in a Governor's Cup that features teams exclusively from the United States and Europe.

A group of 10 teams will vie for the chalice of champions that is the Governor's Cup. In a new wrinkle this year, there will be a second trophy awarded.

Either the Americans or the international fleet (made up of teams from Denmark, France and Sweden) will be awarded the Lew Beery Continents Cup, regatta officials announced at the Governor's Cup banquet Monday night at the host Balboa Yacht Club.

Andy Rose, chairman of the

steering committee for the Governor's Cup, said he was finally able to breathe a sigh of relief when all 10 teams showed up.

"All the teams and the umpires had to be tested [for the coronavirus]," Rose said in a phone interview on Tuesday. "We were very pleased to see that all were negative, which was great. Most of them had been vaccinated, in any event, but that was great news, so everyone is out there on the water right now, which is great."

Rose also gave credit to Catherine Shanahan, a youth racing

Steel seeks to honor Kobe Bryant

Rep. Michelle Steel (R-Seal Beach) announced Tuesday she has introduced a congressional resolution to designate Aug. 24, 2021, as "Kobe Bryant Day" to honor the late Lakers star, who died in a helicopter crash on Jan. 26, 2020.

"Kobe Bryant used his platform to inspire millions and help kids around the world achieve success and strive for greatness. On August 24 we should remember Kobe, celebrate his life and encourage the next generation to dream big just like Kobe did," Steel said.

Bryant lived in Orange County, within the 48th Congressional District represented by Steel. The date of Aug. 24 was chosen to represent the two uniform numbers Bryant wore with the Lakers, 8 and 24.

Last year, Steel led a successful effort to pass a similar Aug. 24 resolution locally when she was of the Orange chair County Board of Supervisors.

Her congressional resolution cites the work Bryant did in the community in addition to his athletic accomplishments, includ-

ing: the Bryant Family Foundation, founded by Kobe and his wife Vanessa "with a mission of helping young people in need, encouraging the devel-opment of physical and social skills through sports and assisting the home-less; the Black Mamba Sports Academy, founded to connect aspiring athletes with experts to help them achieve their goals, and the Mamba and Mambacita Foundation, which was founded through the vision and loving memory of Kobe, and Gianna Bryant continues this legacy with a mission to create positive impact for underserved athletes and young women in sports."

Bryant's career was not without controversy. He was accused of raping a 19-year-old hotel clerk in Edwards, Colo., on June 30, 2003. Prosecutors charged him with one count of felony assault but later dropped the case after the alleged victim declined to testify.

The woman initiated a civil suit against Bryant, which was eventually settled out of court in March 2005.

Body found in lake at Mile Square Park identified as Anaheim man, 57

Orange County Sheriff's Department officials on Monday released the name of a man whose body was discovered in a lake at Mile Square Park in Fountain Valley last week and indicated foul play did not likely play a role in the man's death.

Spokeswoman Carrie Braun confirmed the coroner's office identified the individual found Friday as Juan Carlos Aleman Perez, 57, of Anaheim.

The department's Homicide Detail closed the lake to the visiting public the day the man's body was discovered, as units combed the shoreline in search of clues or evidence that might identify the decedent.

Aleman Perez's body was reportedly found sometime before 10:45 a.m. Friday by parkgoers riding a swan boat on the lake, a spokes-man said from the scene.

Braun said although investigators remained lakeside several hours into the evening before ending their search, no evidence or identifying materials were discovered.

Officials are still waiting for final word from the coroner's office to determine whether to conclude their investigation.

"Based on information we have from the family ... our investigators don't believe it's something suspicious," she said.

"But if the autopsy shows us something different, then that will lead the investigation in a different

measured decisions, and I believe she will be a complement to our City Council by bringing expertise to the leadership and business knowledge for these reasons."

"I was born and raised here in Orange County. Especially toward the Irvine-Costa Mesa border, there's a lot of cities and corporate buildings like that. I think it's a refreshing kind of break in between all the city life to have the flower field," Pham said.

Tran said that it was a nice change in scenery, adding that she felt that there wasn't enough space for anything similar like Hana Field or Tanaka Farms in Los Angeles and it was different.

Van Der Mark, who finished fourth in last November's election that got Ortiz, Kalmick and Moser onto the dais, had dozens of supporters at Monday's meeting. They asked the City Council to "honor the vote" and appoint Van Der Mark, or go the special election route at a cost estimated at \$1 million.

Instead, the council went with Bolton, who attended the meeting with her husband John.

Local teams claim 3 platinum division gold medals at USA Junior Olympics in Irvine

The Costa Mesa Aquatics Club had won gold medals at the USA Water Polo Junior Olympics before — but never in the top division. That changed Sunday.

Costa Mesa Aquatics Club stormed back to claim a 10-6 victory over Bay Area-based Sharks for the Junior Olympics 12-andunder mixed platinum division title match at Woollett Aquatics Center in Irvine.

They were one of three local divisions to earn platinum division titles in Session Two of the tournament, joining Newport's 12and-under girls and Vanguard's 14-and-under girls.

"A lot of these kids have been playing together for four or five years, and it's just been building toward this moment," CMAC coach Olivia Schwartz said. "We've just been working with Splashball and 10U, putting all of their years of hard work together. That's what got them to this point here ... it's amazing."

In its historic win, CMAC had to rally from a 5-2 firsthalf deficit. But the local club was able to do so, led by division MVP Kamryn Anderson. One of six girls on the mixed-gender team, Anderson had two goals, seven steals and four assists in the final.

Madison Mack led CMAC with three goals, while Jay Larson and Sadira Anavim had two goals each. Dominic Diaz also scored for the winners, who also got contributions from Evan
