'There was a breaking point'

Black Lives Matter protest draws hundreds to Fountain Valley's Mile Square Park Thursday in response to George Floyd's death.

Hundreds gathered to participate in a protest march against racial inequality and police brutality on Thursday at Mile Square Park in Fountain Valley.

The "Black Lives Matter" demonstration followed a wave of protests that have swept the nation since George Floyd, an unarmed black man, died from suffocation after a Minneapolis police officer knelt on his neck for nearly

A memorial service was held for Floyd on Thursday. Among the speakers was the Rev. Al Sharpton, who likened Floyd's death to the history of black people in America. He said the reason black people could not be who they dreamed of being was because "you had your knee on our neck."

Impassioned speech was found in Fountain Valley too, where the demonstrators walked the perimeter of the park with an abundance of chants and signage.

'It's sad and it sickens me that simply because of my skin color. I look like a weapon." said Tyyana Albert, 25, of Long Beach. "You are threatened by me, and there's power within

out here. That power that they're threatened by, I need to use it to speak out for those people out there that feel like they can't speak out for themselves, for those people out there who lost their lives because nobody stood up and fought for them as they were losing their lives for 8 minutes and 46 seconds as the life was choked from them."

me. That's what that says, and so that's why I'm

Albert added that she believes police brutality needs to be criminalized, and in her view, it took too long for the officers involved in the death of Floyd to face charges.

Staff Photographer On Wednesday, the charges against Derek Chauvin, the officer who knelt on Floyd's neck, were upgraded to include second-degree murder. Three other officers at the scene were charged with aiding and abetting second-de-

gree murder and second-degree manslaughter. Social gathering had been discouraged during the coronavirus pandemic, but some at the protest felt that more are being made aware of the issues of police brutality and racism as they watch the protests from home.

Police arrest suspect armed at protest

He pulled a handgun from his backpack and held it aloft during a demonstration in Newport Beach.

A Newport Beach man has been arrested after allegedly pulling a gun on protesters Wednesday on the Balboa Peninsula.

A video clip circulating on social media shows a shirtless man later identified as Travis Patrick White in a verbal altercation with a protester on the sidewalk at the corner of 30th Street and Newport Boulevard just before 3:30 p.m. The suspect then pulled a black handgun from his backpack and held it aloft as a handful of demonstrators backed off and one took cover behind a parked car. The armed man backed away.

"We've got him pulling out a gun," the man behind the camera narrated from a car alongside the skirmish. "He's got a gun. He's got a gun."

Newport Beach police credited media coverage and the input of local citizens in identifying White, 48, as the suspect. He was arrested Thursday on charges of assault with a deadly weapon and criminal threats.

The gun incident turned out to be one of two reported violent moments during Wednesday's largely peaceful protest over the killing of George Floyd in Minneapolis. The protest started as a gathering near Newport Pier before becoming a march up and down the boardwalk and Balboa Boulevard.

A motorist, identified as Newport Beach resident Don Wallace, allegedly sped a white Mini Cooper through a group of protesters near Mar-

Outdoor dining takes on a new meaning in Costa Mesa

Dining out in Costa Mesa is about to take on a whole new meaning after city officials Tuesday approved measures to make it easier for restaurants just beginning to reopen with coronavirus distancing restrictions in place to do business outside.

City Council members unanimously approved an urgency ordinance that allows business owners to seek six-month temporary use permits that would allow for the formation of temporary dining areas on adjacent parking lots, sidewalks, plazas and vacant spaces from 6 a.m. to 11 p.m.

Economic and Development Services Director Barry Curtis estimated with best practices and physical distancing protocols in place, dine-in

restaurants could see their pre-pandemic capacities reduced by 50% to 70%. Outdoor dining would help recoup some of that

Expansion onto private property like nearby vacant commercial space, which would not put seating in required setbacks or landscaping areas, would be approved by right.

7 new COVID-19 deaths reported

Eight new deaths and 107 new cases of the novel coronavirus that causes COVID-19 were reported Thursday by the Orange County Health Agency.

That brings the cumulative number of COVID-19 related deaths in the county to 165 since the pandemic began in March. The figure includes 76 skilled nursing facility resi-

There are 6,783 cases to date in the county, includ-

ing 764 skilled nursing facility residents and 379 Orange County Jail inmates. The agency estimates that 2,890 of the cases have re-

Of the active cases, 293 of them are currently hospitalized, which matches the county's single-day high from May 27. There are 129 cases in the intensive care unit, which is a new single-day high.

There were 1,658 tests reported given on Wednesday, the second-lowest total in the last month. To date, 144,916 people in the county have been tested for COVID-19.

Males have accounted for 51% of the cumulative cases and 57% of the cumulative deaths. Those who identify as Hispanic or Latino account for 38% of the cases, followed by whites at 18% and Asians at 8%. The race/ethnicity of 27% of the cases is unknown.

UCI panel discusses mourning, anti-black violence in response to protests, COVID-19

They began with Toni Morrison.

"In this here place, we flesh; flesh that weeps, laughs; flesh that dances on bare feet in grass," read Tiffany Willoughby-Herard, an associate professor of African American studies at UC Irvine, at the start of an hour-long discussion on anti-black violence, racism and the act of mourning Wednesday.

"Love it. Love it hard. Yonder they do not love your flesh. They despise it. They don't love your eyes; they'd just as soon pick 'em Willoughby-Herard read from Morrison's "Beloved." "No more do they

It was held virtually on Zoom and on Facebook Live.

panel featured The speakers Willoughby-Herard, Jessica Millward, an associate professor of history, and Sabrina Strings, an associate professor of sociology.

"We are experiencing not just physical isolation but also social isolation," Wu said. "We need a space to collectively learn and process the inhumanity that is evident in our society and to assert our desire for justice and compassion. This is what I believe is the role of the humanities, to explore and claim

"This has been an issue forever." said Marv Delurey, 55, of Fountain Valley. "It's a horrible, horrible thing that institutional segregation has been perpetual in this country, 400 years of this, and we're finally at a point where there was a breaking point, and people are actually listening to this and starting to make some changes.

"I think it's so important for everybody to say something, to participate, to evolve themselves because it will never change unless we make an effort.'

The crowd included youthful faces, and members of other minority groups said they were also keen to rally behind the African American communi-

Joshua Juarez, 20, of Santa Ana, held up a sign condemning police brutality as he joined in chants that included "Black lives matter," "I can't breathe," and "No justice, no peace. No racist police." He said that people have a right to protest peacefully.

"We are all equal, and we

are all in this together," Juarez said. "We all have to come together for this cause. It's deeper than Black Lives Matter, but we are here for them now, in this moment. It starts with them."

Sarah Dilitkanich, 20, of Mission Viejo referred to what she called white privilege, and said she felt it was important to get involved in the fight for civil rights.

"I think that it's really important that people use their privilege, people who are white, people who don't

have to struggle with these things, [to] use their privilege to fight for these things because it's really important," said itkanich, a criminal justice and sociology double major at Loyola University Chicago.

"This is such an important event, the Black Lives Matter movement. It's so crucial to support right now because this is the last straw. We've had enough."

our common humanity." Wu said the panel was held in response to ongoing violence against black people and the recent deaths of George Floyd, Breonna Taylor and Ahmaud Arbery, which sparked protests across California and the country.

"It is also a response to the repression and brutality of [treatment to] protesters seeking to assert that Black Lives Matter," Wu said.

"We received an overwhelming response of interest, and it really heartens me to know there are so many [viewers] concerned, outraged [and] want to be part of a community to talk about these issues," Wu said, adding that the center received over 900 RSVPs for the event. Zoom capped off at 500 attendees.

Speakers responded to questions of the disproportionate amount COVID-19-related deaths of black people, the history of policing, public mourning, with Millward describing mourning as "an act tests, going on to discuss a

that accompanies every aspect of African American history, from slavery through its afterlife.'

Millward said that she had been practicing selfcare in order to process "the anxiety and trauma linked first to COVID. By the time Ahmaud Arbery, Breonna Taylor and George Floyd were all murdered, I was already ready to borrow from [civil rights activist] Fannie Lou Hamer's 'sick and tired of being sick and tired.' "

"I won't speak for every black person. I will just speak for those in my circle, who I speak with," Millward said.

Millward said that scholars, historians and laypeople need to be committed to struggling for radical social justice and give themselves the permission to grieve, to be angry and to practice "radical self-care" by turning off the news or electing to not provide commentary to news stations unless they decide to.

Strings said she looked forward to the panel to process her feelings on what has been happening as it relates to not only the pandemic but to the prolack of affordable healthcare available and its correlation to black people dying as a result of COVID-19.

Willoughby-Herard drew upon the history of violence against black women and men to connect to current struggles.

Viewers asked questions on recommended readings, ways to have multigenerational discussions on societal change and advice on how to provide space as educators for students to grieve and actively process current events.

"It's so frequent that I've been invited to speak on these issues and people have wanted to jump ahead to the solution. Strings said. "'Well, how do black people fix this?' It's not on black people's shoulders to fix this.

"It's on the entire community of the United States to fix this. This is an American problem that's been going on for hundreds of years, and we're not going to solve it in an hour. It requires years and years of work and conversations and the willingness to put in the effort," Strings said.



temporary permits, which city officials will review on a case-by-case basis, Curtis said. After the 180-day period has passed, council members will have the option to expand the program further.

"It really is a way to create some very special spaces for our restaurants," Mayor Pro Tem John Stephens said of the ordinance. "Oddly enough, it might turn into a real silver lining for this crisis we're addressing."

Also Tuesday, council members approved an emergency declaration made by City Manager Lori Ann Farrell Harrison over the weekend, ratifying her decision to impose a citywide curfew on May 31 and June 1 to help maintain safety in the face of possible anticipated demonstrations and rioting.

The council also authorized Farrell Harrison to accept \$2,746,469 from the county in CARES Act funding, to be used for economic recovery from losses sustained during the coronavirus pandemic.

The city manager said staff would return to a future council meeting with recommendations for how to spend the allocation, which comes with certain restrictions.


It is an affront to God to take life, especially in such an unjust manner. We urge our community to stand against systemic racism wherever it is found.
