Driver accused in killing released

Wynne Lee of Costa Mesa, charged as an accessory in the shooting of a 6-year-old boy, was freed on \$100,00 bail Saturday.

The driver accused of being an accessory to the alleged May road rage killing on the 55 freeway is now out on bail, officials at the Orange County district attorney's office confirmed on Monday.

Jail records indicate that Wynne Lee, 23, was released on Saturday on a bail of \$100,000. Lee was previously held on a bail of \$500,000 until a hearing on Friday lowered the amount to \$100,000. Court officials said that Lee would need to surrender her passport and would be subject to GPS monitoring and barred from having contact with co-defendant Marcus Anthony Eriz, 24.

Eriz remains in custody as his bail was revoked last Friday.

The two were charged in the shooting that killed 6-year-old Aiden Leos.

Lee is charged with being an accessory to the crime after the fact and of having a concealed firearm in the vehicle. She pleaded not guilty with Eriz to all charges on June 18.

Prosecutors say that on the day of the shooting, the couple was heading to work in the HOV lane of the 55 Freeway at about 8 a.m. May 21 when they approached a Chevrolet Sonic, driven by Joanna Cloonan, who was taking Aiden, her son, to kindergarten.

Lee then maneuvered her Volkswagen Golf SportWagen into the left lane and cut Cloonan off. After a few miles, Cloonan then

LBUSD employees to receive 4% raises

The pay increases will go into effect Thursday when the 2021-22 fiscal year begins.

Laguna Beach Unified School District employees will receive a 4% salary increase for the 2021-22 fiscal year, after a collective bargaining agreement was ratified last week.

The district reached an agreement with the Laguna Beach Unified Faculty Assn. on May 19, signed by Sara Hopper, president and bargaining chair of the association, and Mike Conlon, assistant superintendent of human re-

The agreement was approved 5-0 at the school board meeting on

The 4% pay raise, which is for all nontemporary employees, will go into effect Thursday when the new fiscal year begins. District Public Information Officer Shelley Spessard said the raise includes all district administration, including Supt. Jason Viloria.

"LBUSD staff holds an in-depth understanding of the systems needed to address each student's individual academic and socialemotional learning needs," board President Carol Normandin said in a statement. "The board is so proud of all employees for their unwavering dedication as they tirelessly worked to develop innovative ways to ensure all students received the best education amid the biggest crisis in education in our lifetime. While a raise doesn't seem like enough, it is the amount that balances our commitment to fiscal

Newport Beach senior, former police volunteer 'cards' officers

ewport Beach resident Dotty McDonald is a wanted woman — that is, there isn't a police officer within a 100-mile radius who wouldn't want her living in the immediate vicinity.

A volunteer with the Newport Beach Police Department from 2015 to 2019, McDonald officially logged more than 2,000 hours of service, conducting home security checks for residents on vacation, filing records or scanning pawn shop inventory lists for items that might be connected to a local burglary.

"It was so exciting," she recalled of her service. "I loved it, and I loved them. They're awesome.'

McDonald was always game for a latenight ride-along, getting to know the officers on duty and doing whatever she could to support local men and women in blue. But a recent back surgery forced the 91-year-old to sideline her volunteer position.

Now, she uses the Fourth of July weekend - a time when police departments traditionally ramp up staffing and enforcement to

COVID-19 numbers rise in county this week

But the hospitalizations remain low in O.C., according to statistics released on Tuesday.

Orange County's weekly averages for COVID-19 cases ticked up this week, but hospitalization numbers remained low, data released Tuesday show.

According to weekly state data released every Tuesday, the county's average daily new case rate per 100,000 residents edged up from 0.9 last week to 1, while the overall test positivity rate ticked up from 0.7% to 0.9%.

The county's Health Equity Quartile rate, which measures positivity in hot spots in disadvantaged communities, climbed from 0.7% last week to 1.1% this

The county on Tuesday reported 44 new COVID-19 infections, pushing the cumulative total to 256,266. Hospitalizations inched up from 51 on Monday to 56 on Tuesday, while the number of intensive care unit patients decreased from 11 to 10.

The Orange County Health Care Agency also logged two

Another \$8-million boost from state legislators for purchase of Banning Ranch property

Conservationists are now at the \$72-million mark of their \$97-million goal to acquire Banning Ranch, a 384-acre property at the mouth of the Santa Ana River, and turn the oil field into a public

The Trust for Public Land announced Monday that state legislators allocated \$8 million to be put toward the purchase of the property. Assemblywoman Cottie Petrie-Norris (D-Laguna Beach) said in a Facebook post that she was "thrilled" to have secured the allocation in this year's upcoming budget.

The budget is now on its way to Gov. Gavin Newsom to sign prior to the start of the new fiscal year

on July 1. "Forever protecting Banning Ranch is a onein-a-generation opportunity," Petrie-Norris said in

a prepared statement. "This project will restore

vital coastal wetlands, provide unparalleled coastal access for surrounding underserved communities and preserve this jewel for all Southern Californians to enjoy," she said.

The Trust for Public Land secured an exclusive agreement with the property holders of Banning Ranch in May after Newport Beach philanthropists Frank and Joann Randall donated \$50 million to the Banning Ranch Conservancy in 2019.

As part of that agreement, the organization needs to raise the total funds needed to purchase

the land by next April. Upon doing so, the land would then be conveyed to a public agency to be turned into and main-

tained as a public park. Efforts to protect the land date back decades, according to the Banning

Ranch Conservancy.
The Trust for Public Land also recently received an \$8-million grant from the California Fish

and Wildlife Department.

A spokeswoman for the nonprofit said that the organization now has \$22 million in public funds recommended, awarded or in the state budget and is currently working with other funders to bridge the remaining gap.

At least \$11 million is still being sought after in pending federal grant requests.

"Assemblywoman Petrie-Norris and Senator Min, as well as the governor and members of his administration deserve the gratitude of all Californians for their vision and hard work," said Guillermo Rodriguez, the state director for The Trust for Public Land in a statement. "Reducing oil operations and putting Banning Ranch in public hands is a legacy issue for California, one that will provide park equity and coastal access to millions in the region."



more fatalities, but they happened in February. One of the fatalities was an assisted living facility resident, increasing the number of dead in that category

The overall death toll is 5.120 for the county. The death toll now stands at six for June; 22 for May; 42 for April; 198 for March; 610 for February; 1,559 for January, the deadliest month of the pandemic; and 966 for December, the next deadliest.

Andrew Noymer, a UC Irvine professor of population health and disease prevention, said Friday that "the numbers are still lookgood for Orange County.'

There has been concern about the more contagious Delta variant spurring an increase in COVID-19 cases globally, but Noymer emphasized that "the Delta variant is covered by the current vaccines.'

He added, "What worries me about the Delta variant is not the Delta variant per se...it's some future variant...Anyone concerned about Delta should get vaccinated right away."

coronavirus the spreads to unvaccinated people, it could continue to mutate and develop strains that could more easily evade vaccines, Noymer said. As of last week, the county had 1,734,537 fully vaccinated residents. Of those, 1,621,711 received both doses and 264,074 had received one shot of the Moderna or Pfizer vaccine, which require two doses. Another 112,826 people received the one-dose Johnson & Johnson vaccine.

The county on Tuesday reported 5,346 tests, increasing the cumulative tally to 4,110,483. The county's weekly average of tests per 100,000 residents fell from 198.6 to 175.2.

exited the lane but raised her middle finger to the two. Shortly afterward, she heard a loud bang behind the rear of her vehicle and

her son say, "Ow."

The couple proceeded to work and Cloonan pulled over, prosecutors said.

Aiden was taken to the Children's Hospital of Orange County, where he was declared dead at 8:39 a.m.

Lee's attorney initially requested that Orange Superior Court County Judge Larry Yellin lower Lee's bail to \$50,000 to be on par with what she is charged with, a request that was rebuffed by Yellin as being too low because she continued to allow Eriz to ride with her as a passen-

Court documents indi-

cated that the two were involved in another incident in the week after Aiden's death, in which Eriz allegedly brandished his gun at the driver of a blue Tesla on the eastbound 91 Freeway.

Eriz and Lee are scheduled to appear in court at the Central Justice Center in Santa Ana on Aug. 27 for a pretrial hearing.

respond to enhanced activity - to show members of the Newport Beach Police Department how much they are appreciated in the community.

"My fun now is collecting money so I can feed our cops," she said. "I just want to do something for them, and there are so many people in this town who support our police."

On Monday, McDonald delivered heaping helpings of gratitude directly to Chief Jon Lewis, in the form of \$25 gift cards for employees to use at local businesses to get a meal or a cup of coffee.

The gesture may be modest, but the totality of the funds raised by the Newport Beach senior is nothing to sniff at.

This year's collection plate amassed nearly \$11,000, enough to provide 240 gift cards to local eatery Sgt. Pepperoni's Pizza Store and 150 cards for Coffee Nature.

'You can't go wrong with pizza," McDonald surmised.

Aside from the police station, the nonagenarian is equally well-known at the Newport Beach Yacht Club, where she is a member. That's where local residents Andrew and Karen Littlefair heard about her annual fundraising effort and decided to put a little wind in her sails this Fourth of July.

Giving her some seed money in the form of a sponsorship, courtesy of Newport Beach business Clean Energy, where An-

drew Littlefair is a chief executive, they circulated letters throughout their social network.

"We were impressed with what she was doing," Karen Littlefair said Monday. "We typed up a letter she'd written and put a little envelope with a stamp in there and, sure enough, she raised \$6,000."

Newport police Officer Sabrina Fabbri, president of the Newport Beach Police Assn., said McDonald and her philanthropic efforts are well-known throughout the department.

'She's one of our biggest cheerleaders and a champion of our cause," said

Fabbri, who also mentored the senior during her volunteer stint. "She has long ties to this department."

The officer said Monday's special delivery will go a long way as the Fourth of July holiday, and the extra enforcement it requires, stretches across several days

"This year, everyone's been cooped up and everybody's ready to get out and celebrate," Fabbri said. "We definitely will be tired by the end of the weekend. But I think these gift cards will be a nice pick-me-up."

solvency and a true testament of support to the most important resource we have, our employees."

Under the 2020-21 salary schedule, teachers in the district received a minimum of \$61,409 for less than 10 years of experience, a bachelor's degree and up to 55 graduate semester units. With a 4% increase, that yearly salary would jump to at least \$63,865.

Per the contract, the direct hourly instruction rate of pay is \$51.53 per hour, up from \$49.55 per hour. The hourly rate for other districtapproved work done by a bargaining unit member on a voluntary basis will now be \$45.09, up from \$43.36.

Viloria made a reported \$292,722 in salary in 2020-21. He was previously on a step salary schedule where his salary would increase each vear, but this year he's getting the same 4% increase that the rest of the employees are getting, Spessard

"When we ask ourselves how we can provide the highest quality education and experience for our students, the answer is clear by investing in our staff," Viloria said in a statement.

"We want to recruit and retain the highest-quality employees to serve our students and deeply appreciate our board prioritizing this as an ongoing, multiyear strate-

Mr. Irrelevant Stuard roasted at Lowsman Banquet

A man who looked remarkably like Captain Jack Sparrow from the "Pirates of the Caribbean" movies waited patiently.

Grant Stuard finally arrived on a pirate ship Monday night, pulling into the dock next to the Cannery

"I was a little nervous about surfing, and it turned out to be a blast," Stuard said. "It's definitely going to be something that I'm going to do in Tampa, and moving forward.'

Stuard said he also enjoyed the message at the church service. If he makes it with the Buccaneers, he will definitely be someone to root for, as he enjoys helping others and wants to be a role model

Salata, now 94, was not present at Monday's ceremony, but his daughter Melanie Salata-Fitch has been running the show for a while

Salata-Fitch and event emcee John Ireland are both Corona del Mar High School alumni. Ireland is currently the radio voice of the Los Angeles Lakers, but he had time to help his old friend after the Lakers were proven irrelevant in the NBA Playoffs. They lost in the first round.

Ireland said his first job as emcee was to give Salata-Fitch, who he said he once dated in high school, a hard time. But his other job was to celebrate Stuard, who he called probably the best Mr. Irrelevant player ever.

cutive of the OC Fair & Event Center.

"This is who we are, and this is what we do, and not getting to do that this past vear was very sad," she said Tuesday. "We're now getting to do what we're trained to do, what we're experienced in doing. So, there's a joy

that comes with that." Some aspect of this year's event will be a little different from typical fairs. For instance, organizers plan to cap admission to 45,000 per day, and all tickets must be reserved online in advance. Once capacity has been reached, the day will be sold out.

Touch-free security gates and even concession sales will be in place to keep visitors safe.

"There's going to be fewer booths and attractions," said OCFEC spokeswoman Terry Moore. "We're spreading things out on the fairgrounds just to give everybody more room.'

And while attendees who've been vaccinated against COVID-19 will be allowed to remain unmasked, those who are not fully vaccinated must wear facial coverings when indoors.



PREPARATIONS FOR the 2021 Orange County Fair, which runs from July 16 through Aug. 15, continued on Tuesday.

Richards said officials began envisioning different versions of a modified-capacity fair as early as October 2020. And although attendance restrictions may have been lifted, organizers decided to stick with a 75% capacity model that had earned a blessing from the Orange County Health Care Agency.

The reduced crowds will give guests space, while reducing impacts to the surrounding neighborhood and maintaining fiscal viability, Richards added.

Officials had previously estimated that, at 50% capacity, the 2021 fair would take in about \$20.3 million in revenue which, after ex-

would penses, \$6.4 million in net proceeds. Richards said Tuesday, the current 75% configuration would increase that net gain.

With little more than two weeks remaining, O.C. Fair employees and operators can't wait for the fun to be-

"We've been through such a challenging time as a community, and people are really feeling joy at the simple things that are coming back," Richards said.
