'Dynamic' space opens to help Surf City police train

Laguna Beach pledges funding

Council cites desire to be 'equitable,' agrees to add up to 20% of cost to underground utility lines along West Street.

In a move that could help secure more votes for a proposed underground utility district in south Laguna Beach, the City Council agreed to contribute up to 20% of the estimated \$7-million cost if the district gets the nod from affected property owners.

The district — identified as West Street — includes 101 assessable parcels along portions of West Street, Monterey Street and Eagle Rock Way, among other streets.

Property owners within the district would bear the majority of the cost of the project, although a draft engineer's report called on the city to provide 10% of the cost in the form of a general benefit contribution.

Pierre Sawaya, a senior project manager for the city, advised the council that there was precedent for the city covering a greater por-

Travis Hopkins was appointed as Huntington Beach's city manager at Tuesday night's City Council meeting.

Hopkins, 56, becomes the city's first permanent city manager in more than a year. His appointment was unanimously approved 7-0 by the council.

Group to host concert in support of Eaton and Palisades fire survivors

A pair of Newport Beach moms put together a benefit show happening Saturday at the Balboa Pavilion as part of a homegrown effort to keep support flowing to victims of the January Eaton and Palisades fires.

Marmar Salimian Sikka lived in Pasadena for about eight years

before moving to Newport Beach. She felt compelled to help her former neighbors and others impacted by the disasters, so she coordinated with a friend in L.A. County to organize a supply drive.

Salimian Sikka hoped to gather at least enough goods to pack an

Grandma Brigade protest against 'Musk takeover'

A small but determined group of women gathered Saturday afternoon in Costa Mesa carrying signs decrying the White House's insertion of billionaire Elon Musk and his Department of Government Efficiency, or DOGE, into federal affairs.

Stationing themselves in front of the Tesla showroom and service center on Pullman Street, the loosely knit group calling themselves the Grandma Brigade were there "as part of the global effort to stop the Musk takeover," according to organizer Debbie Marsteller.

"We want people supporting Tesla [one of Musk's companies] to know they're supporting an authoritarian takeover of democracy, she said. "We're going to have to do something while we still can, even as our rights are slowly pulled away.'

The retired 70-year-old Costa Mesan said the Grandma Brigade, comprised of like-minded local residents who are roughly

between the ages of 50 and 80, is just getting started. Members of her group have the time and resources to put up a fight, she said, and feel the responsibility to do SO.

Although many members of the Grandma Brigade have been active in politics since they were teens, Saturday's protest was their first foray as a group. But it won't be their last; they are in it "for the duration," Marsteller said.

"We've spoken out, we've had marches. Now we have to really go after the economy of Elon Musk. That's all he cares about. Trump and Musk don't care about us. They are here to fleece us," she said, adding her group is concerned the cuts being made by DOGE will impact the most vulnerable populations first.

"We're joining together with different progressive groups in our area. We haven't moved to civil disobedience yet, but we probably will eventually."

A Jan. 6 insurrectionist who was pardoned by President Donald Trump is scheduled to speak today at a meeting of the Republican Club of Laguna Woods, and members of the Laguna Woods Democratic Club and their counterparts from Laguna Beach, Mission Viejo and Irvine are planning to protest.

Jeffrey Scott Brown was convicted by a jury and sentenced to 54 months in federal prison for participating in the attack on the U.S. Capitol on Jan. 6, 2021. He was pardoned by Trump after he was inaugurated for a second term in January.

The Republican Club of Laguna Woods invited Brown to speak at

a meeting Friday at a Laguna Woods community clubhouse, billing him as a "victim of the Jan. 6 tragedy." The meeting is scheduled to start at 11 a.m.



tion of undergrounding projects.

"City Council did take prior actions on contributing to assessment districts on the last two projects," Sawaya said at the Feb. 25 meeting of the City Council.

"A 10% general benefit was applied to those projects, in addition to a 10% city contribution, so for a total of 20%," he said. "That was applied to the Diamond Street project, which was completed two years ago, and was applied to the recently formed Woods Cove district, which is currently in construction."

The Diamond Street assessment district contained 20 parcels, while the Woods Cove project had 380 assessable parcels.

Councilman Bob Whalen said the city needed to be "equitable among the neighborhoods" in making a motion for a 20% city contribution, including the general benefit. It was approved by a 4-0 vote. (May-

or Alex Rounaghi recused himself from the item because the district would involve immediate family members.)

"If it's a \$7-million esti-mate and we contribute \$1.4 million, that gets it down to about \$5.6 million, which is up about 12% from the original \$5 million that was estimated back in 2021," Whalen said. "Well, we all know [with] inflation, everything's gone up and things are more expensive.

"I think we should look at doing a 25-year scenario, so they can stretch payments out over a longer period of time, reduce the annual cost. ... I want to make sure that the city purchase of bonds is a possibility here for this district, because we can control the interest rate on that better than out in the public market. We may be able to save some interest costs on that and reduce some legal and other costs, if we look at that alternative."

Several residents appeared before the council to request the additional contribution. In some cases, the ask of the council was for the city to cover 30% of the cost of construction. Proponents of an additional city contribution cited inflation and assessment amounts as "costprohibitive" to supporting the project.

"Since the project's in-ception in 2021, costs have ballooned from \$5 million to \$7.2 million, a reality that puts this crucial safety initiative at risk," said Amy Berk, a resident of Eagle Rock Way. "Our community took action early with 65% of residents voting in favor and committing significant personal funds. However, without city support, the financial burden may prove too great, preventing us from completing this project.

"We've all seen the devastation caused by wildfires - the Coastal fire in 2022, which would have taken our homes if the wind was blowing toward the ocean, at least from my block, and the tragic Palisades fires. Ninety-nine percent of fires caused by electrical lines can be prevented by undergrounding utilities. Why wait until tragedy strikes

Laguna Beach? Our district is the last remaining area in the south Laguna neighborhood surrounding Aliso Canyon that needs undergrounding."

City staff will meet with the assessment engineer to determine what changes will be made to the assessment amounts of the individual parcels. A meeting

will then be set up with property owners within the district to review the engineer's report.

Sawaya said the engineer's report could be brought forth to council for approval in the spring. City staff would also return with a funding strategy to cover the additional city contribution. A staff report said the city could appropriate \$700.000 from the street lighting and utility fund to cover the general benefit.

A public hearing and vote on the project by property owners within the district would likely come in the summer, Sawaya said.

nology-driven system that's really going to benefit the officers and the community."

The K9 training field, which has synthetic turf and lighting for night training, features plenty of obstacles to get the police dogs a wide variety of reps, Parra said. It was named in honor of K9 Kim, a Huntington Beach police canine who was stabbed to death while apprehending a fleeing subject in 1991.

"When we put [the trained dogs] into tactical environments, it's not a surprise for them," Parra said. "We already know how they're going to react, because we've trained them in that environment. It's much safer for them, safer for the handler, safer for

the public."

The field was completed at the end of 2023 as part of the project's first phase.

The Simunitions and Tactical Training Building features the ability to build a house with movable walls, Huntington Beach Police Capt. Öscar Garcia said. "This enables the department to do movement training with recruits, patrol officers and even our SWAT team."

"When we're preparing for warrants and operations that we can pre-plan for, we can set that facility up to kind of mimic that environment that we're going into," Parra said. "It makes it much safer for the officers, much safer for the public."

In addition to the movable walls, there's an interior camera system and sound system for creating chaos, like people yelling.

"It also has lights that can be dimmed, so we can work in low lighting," Garcia said. "At the north end, we have a breaching door, so we can actually train as a group breaching a house and making entry.'

There's also a tear gas training container for controlled simulations.

Parra said the training center cost about \$1.1 million, the majority of which was covered by donations. At the entrance to the facility is a donor wall, featuring engraved shields with personal dedications.

Contractor Westling and Associates also donated about 700 work hours. It's owner, Josh Westling, is the board secretary of the Huntington Beach Police and Community Foundation.



planned in the parking lot of Clubhouse 5 in the Laguna Woods Village, the site of the meeting.

Brown, 58, of Santa Ana, was found guilty in federal court of seven felonies, among them assaulting, resisting or impeding law enforcement officers, using a dangerous weapon and interfering with a law enforcement officer during a civil disorder.

Prosecutors said he took pepper spray from a police officer and then used it on Capitol Police during the Jan. 6 melee. After his conviction in December 2022, Brown started his prison sentence in April 2023 and was released from a federal correctional facility in Lompoc after serving time in 11 prisons.

During his trial, Brown called himself a political prisoner. The Republican Club highlights Brown's achievements as an Eagle

Scout with a bachelor's degree in business administration and an FAA commercial pilot license.

Pat Micone, the president of the Republican Club of Laguna Woods, denied a request by City News Service to be interviewed. She said in an email response, "Our Governing [Board of Directors] has decided to not allow press nor an interview."

Ribando said a number of Democratic groups have contacted her, "incensed about the idea of celebrating this man." "Everyone saw what

happened on Jan. 6 and people who say they didn't see it. I don't know, they must live under a rock," Ribando said. "It's demeaning to hear people play it down. It was an appalling sight. It was an embarrassment for us as a country. We weren't planning anything inside until we got pushback from residents who said it's not enough to do it outside. We want to be inside, show

them that we're not happy with them coming into our space with this person."

Ribando said she contacted the administration of the Laguna Woods Village about how they disagreed with the decision to allow Brown to speak at the Republican Club meeting.

Ribando said she was told that the clubs are independent and they have autonomy from the Village administration. Each club and its members have freedom of speech.

In response, Ribando told the Village administration the Democratic Club was going to protest the event at the clubhouse. Village security and the Orange County Sheriff's Department are aware of the planned protests.

Ribando told her club members the gathering needs "to be a quiet, respectful and peaceful vigil. No confrontation."

the public works director from 2007-2019, when he was promoted to assistant city manager.

Huntington Beach Police Chief Eric Parra served as the interim city manager for a year after Al Zelinka resigned from that position in 2023. In November, Hopkins became acting city manager.

"I love this community, and I've enjoyed serving this community for over 18 years," Hopkins said in an interview following Tuesday night's meeting. "Definitely, I wanted to be a public works director, then the more time I spent in this community, I looked for the opportunity to become assistant city manager and city manager. I'm honored and humbled to become the city manager here."

Hopkins grew up in Idaho and holds a bachelor's degree in civil engineering from the University

of Idaho. He moved to Huntington Beach in 1992, he said, and holds a Master of Public Administration degree from Cal State Long Beach. He is also a registered civil engineer in California.

Hopkins' contract runs for four years, beginning on March 15. His annual salary

will be \$311,750. There are no salary increases built into the contract, but the council may approve meritbased increases.

If the council votes to terminate him without cause, he will be eligible for six months pay and benefits unless at least six months' notice is given.

SUV once or twice. But members of the Newport Beach community overwhelmed her expectations, requiring her to rent a U-Haul truck on Jan. 20 to deliver all of the donations left at her home over just a three-day period.

"People I didn't even know just kept coming by my house and leaving stuff in front of my garage and at the door," Salimian Sikka said. "And some of those items were brand-new items. Some of the bags were filled with hundreds of dollars of gift cards also. It wasn't just clothes and shoes and toiletries. The generosity in the community coming together to help was really beautiful."

She branded the network of donors and supporters



them during their time of need. It will also offer a moment to unwind as they navigate the uncertainty of starting over after losing practically everything they owned.

There will be an ongoing need for support as fire survivors try to get by while waiting for disaster relief from the government. Salimian Sikka is determined to continue and further develop the Grassroots Project so long as people need help rebuilding their lives.

"My family, I saw them have to rebuild over and over and over again," said

Sage Hill denied the crown by Knight in CIF division 3AA final

Throughout its playoff run, Sage Hill had figured out ways to stay within striking distance and make plays when it mattered most in the fourth quarter.

In a three-point game at the half, it appeared the Lightning were headed down that road again, but the opposition had another idea.

The three-point shot began to fall for Palmdale Knight after the break, foiling the best laid defensive plans, as Sage Hill lost 64-43 on Saturday night in the CIF Southern Section Division 3AA boys' basketball final at Edison High.

In a battle between teams seeking the first section title for their respective programs, Knight (26-6) realized the dream.

"I told my guys when they were handing out the [runner-up] trophy to Sage Hill, I said, 'Hey, show them

respect. I've been there twice," said Tom Hegre, who has coached the Hawks since the school opened in 2003. "This is my third time in the finals. Our guys were not going to be denied tonight."

Knight previously appeared in the Division II-A final in 2008 with a roster led by Paul George. The nine-time NBA All-Star was then in his senior year with the Hawks. In 2018, Knight suffered a double-overtime defeat to Crean Lutheran in the Division 3AA final.

Amare Larane had a game-high 26 points, adding five rebounds, three assists and three steals to lead Knight. The junior forward also accounted for half of the Hawks' eight threepointers.

Entering the halftime locker room with a slim 24-21 advantage, Larane said the mindset was if the Hawks threw the "first punch" in the third quarter, they would win the championship.

"Tonight, we just trusted our shot," Larane said. "In the first quarter, we went two for 10. We went into the locker room at halftime and just said, 'Stay with it. Shoot the same way every time.' In the third quarter, we just came out and we hit all our shots."

Knight, the Golden League champion, nearly doubled its scoring output in the first half with a 23point third quarter, extending its lead to 47-34 heading into the fourth quarter. It was significant separation from a Sage Hill team that did not take a lot of three-pointers and made just two — both by Carson Ellis.

James Karahalios scored 16 points to pace Sage Hill (18-11), adding six rebounds and three assists. Jackson Cryst contributed nine points, nine rebounds, four blocked shots and three assists. Tre Cradle chipped in

June 8, 1924 - February 23, 2025 John "Jack" Vedder Croul, a military hero and veteran of "The Greatest Generation" passed away peacefully at his Newport Beach residence on February 23, 2025. Jack lived his motto; "Just do the right thing and think of other people." He was born June 8, 1924 in Hartford, Connecticut to Gertrude and Rex Croul.

Raised in San Marino, California with his three brothers, Ed, Richard and Jim, he took the "Red Car" of the Pacific Electric Rail to and from South Pasadena High School during the early 1940's.

In 1943 at 18 years of age, Jack enlisted in the U.S. Army Air Force during World War II. By 1944 he was a lead navigator for the 96th Bomb Group, 338th Squadron, flying thirty-three, B-17 missions, including two on D-Day. Jack earned a Purple Heart the Air Medal and the Distinguished Flying Cross. Postwar, he received the French Legion of Honor Medal for his service. He retired as Captain, Army Air Corps, in 1945. After the war, Jack enrolled at Stanford University, transferring to Claremont Men's College when he began to date Janet Behr, whom he married in 1950. Jack was a "Pacesetter" and a member of one of the first graduating classes at Claremont Business School. As an alumnus, he endowed multiple scholarships and professorships, including the Janet Croul Memorial scholarship to honor Janet who died in 1993, the John V. Croul Professorship of European History and the Kingsley Croul Professorship of American History, among others

Upon graduation, Jack turned his energy to the business world and was hired as an early employee of Behr Process Corporation. He was instrumental in building Behr Process Corporation, a paint company, into one of the largest private companies in Orange County, with more than 1000 employees. Eventually, he rose to prominence as the Chairman of Behr. Around the time of his retirement from Behr, Jack met his second wife Kingsley Roney Brosnan and the two of them traveled the world together.

A passionate collector of postwar European automobiles, Jack amassed an impressive collection of sports and race cars. He didn't just collect cars – he drove them, navigating the winding mountain roads from California to Asia, Africa, South America and Europe. Jack's collection was inspired by the famous Italian Mille Miglia car races that took place in the first half of the 20th century, and his cars participated in twenty-eight Mille Miglia retrospective rallies. His collection became a living tribute to the golden age of racing.

Jack's many passions included restoring vintage fighter planes, flying gliders, prop planes and at 73, he received his helicopter license. He loved his community and was instrumental in saving the historical Cannery Restaurant in Newport Beach from destruction. He was a man of discretion, elegance and great generosity. Jack endowed the Earth Systems Science building at University of California, Irvine and his generous philanthropy will continue through the Croul Family Foundation, which he founded.

His wife Kingsley survives Jack, as do his two sons – Brad, his wife Judith; Spencer, his wife Susan, and their families. He is also survived by Kingsley's sons Rick, Tim, his wife Jenny, and her daughter Kingsley and their families, as well as his brother Jim, his wife Susie and Richard's wife Jane. Jack is preceded in death by his first wife Janet, and his brothers Ed and Richard. He will be cherished for his stories of valor, his infectious enthusiasm, laughter and his warm, generous nature.

Knight made its advantage in the ball-handling categories. The Hawks had 19 assists against just six turnovers.

Sage Hill committed 17 turnovers (including 10 steals for the Hawks), which led to Knight scoring 27 points off turnovers and 18 points in transition.

"Earlier on, when we were kind of locked in and we were staying level with the ball, we were fine," Sage Hill coach D'Cean Bryant said. "I think when we started looking at the ball too much, they kind of drove the gaps."

Da'vian Brooks scored a dozen points to go with four assists for Knight. Jaylen Mims had 11 points, four assists and three steals, and Jay'len Brooks added six points, eight assists and three steals.

Sage Hill was playing in its second CIF final in three years and third overall. The Lightning lost to Oxnard Santa Clara in the Division 5AA final in 2019, then to Long Beach Jordan in the Division 4A final in 2023.

There was anticipation on campus this week as Sage Hill prepared to compete for CIF championships in two sports. The girls' soccer team prevailed in penalty kicks over La Mirada in the Division 4 final on Saturday afternoon.

"Everyone was talking about the big games," Karahalios said. "Everyone wanted to go. Everything in the last week has been built around this, so we were all super excited.

Sage Hill was the No. 2 seed in the CIF State Southern California Regional Division III boys' basketball playoffs. The Lightning were upset by Lake Balboa Birmingham, 56-48, on Tuesday at home.
