Fishing ban is lifted on O.C. coastline 2 months after spill

BY LILLY NGUYEN

Nearly two months after the closure of Orange County's coast in the aftermath of the estimated 25,000-gallon oil spill off of Huntington Beach, the California Depart-ment of Fish and Wildlife made an announcement Monday — let them fish.

The order was lifted Tuesday afternoon to the relief of business owners impacted by the closure of the fisheries in addition to local politicians, including state Sen. Dave Min (D-Irvine) and Orange County Supervisor Katrina Foley.

"I am relieved to see that our fisheries will finally be able to reopen," Foley said in a statement.

Newport Beach Councilman Noah Blom said he enjoys a glass of red wine with every dinner. There's no problem with that, residents say, except when it's during City Council meetings.

Blom said the issue first came up following the council's last meeting on Nov. 16, when he said he dumped a nearly full cup of red wine into the trash following the meeting.

Residents Tuesday night condemned his actions and argued that a council member shouldn't be allowed to drink while sitting on the dais and that it may affect his judgment.

Blom confirmed Wednesday morning that he has consumed wine at prior meetings and hasn't hidden it, though he objects to being viewed as a role model.

"I've said oftentimes I'm not a politi-

Surf City resident Eric Parra is new police chief

Huntington Beach has hired a Surf City native to guide its police force.

The Huntington Beach City Council approved the hiring of Eric Parra as police chief by a 6-0-1 vote in a special meeting Wednesday afternoon. Coun-

"This oil spill immediately put a halt to the operations of many small businesses in our community whose livelihoods depend on the ability to fish off our Southern California coast. The order was initially implemented in October, prohibiting the taking of all fish and shellfish from Huntington Beach to Dana Point.

and about 45 miles of shoreline, according to the state agency. Boundaries included all bays and harbors from Seal Beach to San Onofre State Beach in San Diego County.

That meant while the Office of Environmental Health Hazard Assessment was

Parra, 57, is currently the police chief of Alhambra, a position he's held since March. He came to Alhambra after 31 years with the Los Angeles County Sheriff's Department, where he reached the rank of division chief before leaving in 2019.

O.C. Model Engineers steamed over vandalism at Fairview Park train depot

Orange County Model Engineers - who offer free minitrain rides to the public at Costa Mesa's Fairview Park — arrived at the depot Wednesday morning to find vandals had stormed the station and a nearby storage building, causing extensive, and costly, damage.

"I've never seen anything like this," member Hank Castignetti said of the scene. "We've had graffiti and stuff before, but they

just destroyed the place. They went absolutely nuts.'

Suspects reportedly ripped shingles off the roof of the train depot, pried open metal roll-up windows, smashed nearby picnic tables and damaged the station's water supply.

Locks and light fixtures were found ripped from their moorings, and fire extinguisher cases were broken into and their contents stolen.

Coroner IDs pedestrian killed in Costa Mesa Thanksgiving morning

A pedestrian killed early Thanksgiving morning while walking on Newport Boulevard in Costa Mesa has been identified as Jose Armando Estazuy-Racancoj, officials with the Orange County coroner's office reported Monday. Estazuy-Racancoj, 24, of Costa Mesa, was reportedly walking among lanes of shortly traffic before 2:30 a.m. Thursday when he was struck by a vehicle traveling northbound on Newport Boulevard just south of 17th Street, according to a release issued

Thursday by the Costa Mesa Police Department. First responders found Estazuy-Racancoj unresponsive and attempted to perform CPR but were unable to resuscitate him and pronounced him dead, the release stated. The driver of the vehicle remained at the scene and cooperated with members of CMPD's Major Accident Investigation Team as well as crime scene investigators called to the incident.

Fortunately, a fleet of model trains kept under lock and key in a compound on the site were not disturbed or broken into. Also, security cameras on that part of the property likely captured footage of whomever is behind the vandalism.

cian. I will say that again. I am my own person. I vote my own heart, and I do so based on what I think is best and right for the city," Blom said Tuesday night. "In doing that, I think that I am also in a very different position of a lot of people that I'm from a different fabric and from a different cloth.

"I know based on the rhetoric that politics has produced that it is not the cloth I'm from," Blom said.

"There's very angry politics out there, and I don't want to be part of that ever. I want to be up here to support everyone that wants to be positive and supportive. I fully recognize how that was not what we want to be doing up here as I've heard it from many people from different accords.

"From this point forward, I think all you'll ever see up here is some iced tea, maybe a beautiful cappuccino or a glass of water from me because it's no longer in the decorum of what the public would like," Blom said, thanking residents for their comments.

But some residents objected to Blom's statements, with some describing his actions as improper and his apology as condescending.

One resident brought a glass of sparkling cider to illustrate her point, describing a monologue by Blom at the Oct. 26 council meeting about the "Elect Our Mayor" ballot initiative as incoherent.

Others called on other City Council members to prohibit drinking alcohol at public meetings.

Newport Beach city code prohibits the drinking of any alcoholic beverages in or on public streets, alleys, sidewalks, public or private parking lots, restrooms, piers, beaches, vacant lots or public parks.

It does not, however, include public buildings, such as City Hall and the City Council chambers.



Councilwoman Diane Dixon suggested the matter be brought up for discussion at the next council meeting on Dec. 14.

"I think part of our issue in the city is that we probably need to clarify and define appropriate council decorum so people understand what it is because it has not been clarified," Dixon said.

In an interview with the Daily Pilot Wednesday, Blom said he has read the city code and didn't see anything explicit about decorum.

"I get it that the city and government is a different

entity that takes itself more seriously, but sometimes I think we lose sight of who we represent, that this isn't mob rule in the city," Blom said.

"We have a lot of people that live in Newport Beach. If I listen to the thousand people on Nextdoor, who are paranoid about everything that comes up before the dais, but not to the thousands of other people, then I have a failing grade across the board. I've never pretended to be anyone other than who I am.'

testing seafood in the area, businesses like Newport Landing and Davey's Locker Sportfishing & Whale Watching had to pass up good fishing in nearby spots to keep fishers safe and follow state guidelines.

Authorities announced Monday there was no further risk to public health consumption of from seafood in the affected area.

Education manager Jessica Roame said the business saw the greatest impact in the first five days following the oil spill, which included the temporary closure of Newport Harbor.

Once the closures lifted, the company was able to resume its whale-watching tours, but its sportfishing tours had to stay on hold for at least three weeks before operators could figure out a way to take people out farther beyond the impacted region. "Fishing is so nice on the

coast of Orange County, but the whole of that area was blocked off. Thankfully, our crew and captains were ... able to strategize a Plan B, but they had been telling me that [they] were driving past really good fishing areas and having to tell customers that [they] couldn't anchor up there," Roame said.

"We can't fish there, but we're seeing all these fish here," Roame said. "We have to go 15 miles this way. It's been a big pain, but thankfully that's over now.'

Pipeline operator Amplify Energy is currently facing a number of lawsuits — including two from a bait and tackle store in Costa Mesa and a Newport Harbor fuel dock — that allege the company acted negligently for failing to maintain its aging infrastructure and that the businesses themselves

faced financial losses as a result of it.

But Roame said that at least for Newport Landing and Davey's Locker, the biggest impact has not necessarily been the closures but public perception.

She said she didn't want to understate the environmental impacts of the spill, which has killed a number of birds, sea lions and a bottlenose dolphin, according to the Oiled Wildlife Care Network at UC Davis.

Officials said Tuesday that the Unified Command, responsible for coastline cleanup, has signed off on 69 shoreline segments out of a total of 107 — about 190 miles of coast.

But beaches, in addition to Newport Harbor, reopened about a week after the oil spill, which meant business for much of the harbor could return to some normalcy. However, Roame said she canceled trips early on due to the circumstances and fielded a number of cancellations and calls from people concerned about their potential impacts on the waters. She's gotten fewer calls these days, but business is slower compared to this same period last year.

"We're very excited and we're happy to hear there's no risk to public health to seafood consumption," Roame said.

'We were very hopeful that was going to be the case. We're back to business as usual, moving back to the holiday season ... COVID was the first issue, then the oil spill. It's one hit after another. It's really hard for local businesses to bounce back after really traumatic events like that,' she added.

"We're hoping with the fisheries opening back up that people will get back out, get back on the water and do more of our fishing in the local area."

living in Huntington Beach since 1993, and said he intends this to be his last position in law enforcement.

"It is a remarkable feel-ing," he said. "It doesn't matter where I work, I give 200% wherever I'm at. But to go to work every day, put in effort in my community, then drive home and see it coming together ... that's the world to me.

"Now, if there's something I put into play that's not working, I'll know it when I'm on the way home. I'll know it when I'm driving around, when I go to the store. It will give me the opportunity to constantly measure whether I'm effective or not."

Parra holds a bachelor's degree in criminal justice from Cal State Long Beach and a law degree from Western State. He is licensed by the State Bar of California. Through his career he helped lead Los Angeles County jail system reforms, community policing programs and a variety of patrol initiatives.

He said public trust, transparency and accountability are challenges for law enforcement in general right now. In terms of Huntington Beach specifically, he identified homelessness and proper policing for large events as two key issues.

"We need to figure out how to partner better with our local, state and federal partners to have full wraparound services and full connection with other services," Parra said, addressing homelessness. "It's not just law enforcement, it [should be] everybody working together from a government, nonprofit and community perspective to help homeless people reach a level where they're not homeless, they're employable and they're functional in society."

The city launched a mobile mental health crisis response team in a partnership with Be Well OC this year, freeing up police officers.

"What I want to do is find

out from the community what they believe the officers should do with that time," Parra said. "What type of enforcement efforts would they like to see? Then, we're using that time for something that's productive and something that the community wants.

Huntington Beach City Council members commended Harvey for his service, particularly during a turbulent time for the city. At the same time, they said they look forward to working with Parra.

Besides the chemistry and the personality and the stellar qualifications, we have a hometown hero in our next chief," City Councilman Mike Posey said, ad-dressing Parra. "You live here, and that's comforting to know."

Mayor Kim Carr said the first time she met Parra, "I went, 'Oh my gosh, this guy's serious.'

"You were a little bit imposing," she said. "Then once we got to know you, you're a really funny guy. You have a great sense of humor, and it was fascinating to see that whole evolution. I'm really looking forward to getting to know you.

"Our city absolutely adores our police officers, and we support them. This is a community that will support you, and this is a council that will support you. If there's anything that you need, just let us know because we've got your back."
