

Open letter to the UC Regents seeking investigation of the UC Riverside – Beacon Economics relationship

We, the undersigned University of California faculty, staff and graduate employees, urge the Regents to investigate the use of the UC name and trademarks on research reports produced by a private company that pays the university to publish under the name “[UC Riverside School of Business Center for Economic Forecasting and Development](#).”

Since 2015, the company, [Beacon Economics, LLC](#), has had an [agreement](#) with the Regents that allows Beacon to operate as the Center for Economic Forecasting and Development and to use the UC Riverside logo and other trademarks on its research products. In exchange, Beacon pays UCR a 10 percent royalty on revenue from producing those products.¹ That revenue often comes from corporations and industry groups that sponsor research and use the findings to advance their interests. We do not know how much sponsorship revenue Beacon reaps, because as a private firm it can claim exemption from California’s Public Records Act.² In addition to avoiding disclosure of its finances, Beacon appears to conduct its research without meaningful faculty oversight:

- There is no faculty oversight committee for the Center for Economic Forecasting & Development, according to Beacon management.³
- Beacon co-owner and Center Director Christopher Thornberg identifies himself as a UCR [adjunct professor](#), but he does not appear in either the [UCR business school faculty directory](#) or in the UCR [profile directory](#).
- In fact, **none** of the [staff](#) of the Center for Economic Forecasting are UCR faculty according to the [UCR business school faculty directory](#) and UCR [profile directory](#).

Without funding transparency or real faculty oversight to enforce academic rigor, this arrangement has allowed corporations and industry groups to underwrite Beacon reports attacking proposals to improve the lives of working Californians.

We unequivocally support academic freedom and freedom of speech, and we note that Beacon Economics produces quality macroeconomic forecasts. We believe, however, that Beacon’s UC-branded, corporate-funded reports often fail to meet the high standards we strive to meet in our research, thus endangering the credibility of our work and harming the University of California’s good name.

Most recently, in a franchise-industry-funded [report](#),⁴ Beacon asserts that legislation allowing fast-food workers a say in setting their pay would mean fast-food price hikes of up to 20 percent or more.⁵ Fast-food companies are spending [tens of millions of dollars](#) to promote the findings of this report – which they funded. They are trying to convince voters that empowering fast-food workers – [most of them women and most of them Latino, Black, or Asian](#) – means a 20 percent “[food tax](#).”

Research into actual restaurant prices in cities and states that have enacted large minimum wage increases, however, tells a different story. For example, a [2019 study](#) by researchers from MIT and the Federal Reserve Bank of Boston found about a half-percentage-point menu price increase for every 10 percent rise in the minimum wage.⁶ Similarly, [Allegretto and Reich](#) found in 2018 that San Jose's 25 percent minimum wage increase raised restaurant prices by 1.45 percent.⁷

Beacon has produced other industry-backed research, prominently bearing the UC Riverside logo, attacking workers' gains in California. Examples include Lyft-funded [reports](#)⁸ supporting the repeal of ride-hail drivers' employee rights and a California Restaurant Association-funded paper [criticizing minimum wage increases](#).

As UC faculty, staff and graduate employees, we call on the Regents to ensure high standards for research products bearing the name of the university. Specifically, we urge the Regents to:

- Require the Riverside campus to establish meaningful faculty oversight of the Center for Economic Forecasting and Development.
- Investigate the arrangement allowing Beacon to license the UC Riverside name.
- Require Beacon to cease using UC trademarks while the investigation proceeds.

¹ The contract limits Beacon's use of the UCR trademarks to products and services related to the Inland Empire or produced for persons or firms "in the Inland Empire," defined as Riverside or San Bernardino counties. However any person or firm that "conducts any business in the Inland Empire or otherwise has a presence in the Inland Empire" qualifies as "in the Inland Empire." This arrangement extends to Beacon representatives, such as Christopher Thornberg, serving in volunteer capacities so as to utilize UCR email addresses."
