'The Nutcracker' performance makes magic for disabled kids

Orange County families filed into the Irvine Barclay Theatre on Dec. 10 for an abridged performance of Festival Ballet Theatre's "The Nutcracker" during a holiday open house for the Regional Center of Orange County.

"Can I ask you a question?" a young man said to Larry Landauer, executive director of the center. "What's the rat's name?" He was referring to the Rat King, a character in the ballet.

The RCOC serves children and adults with disabilities in Orange County, which Landauer said can range from intellectual disabilities and autism to cerebral palsy and epilepsy. "When we get an opportunity for an

Man gets 15 to life in fire captain's death

Mike Kreza was killed in a 2018 vehicle collision that occurred while the driver was under the influence of narcotics.

A Mission Viejo man was sentenced Friday to serve 15 years to life in prison for the death of offduty Costa Mesa fire Capt. Mike Kreza following a 2018 vehicle collision that occurred while the driver was under the influence of narcotics.

Stephen Taylor Scarpa, 28, was convicted of one felony count of second-degree murder in September, when a jury found him guilty in the Nov. 5, 2018, death of Kreza, a 44-year-old Rancho Santa Margarita resident and father of three daughters.

Kreza, who'd served 18 years with Costa Mesa Fire & Rescue, had been riding his bicycle on Alicia Parkway in Mission Viejo the morning of Nov. 3, when a van driven by Scarpa drove off the road near Via Burgos, crossed over a bike lane and sidewalk and up onto an embankment, striking him.

Then 25, Scarpa had been driving home from a party in Westminster, at which he'd taken unprescribed "downers" lorazepam and benzodiazepines and reportedly hadn't slept for two days, according to testimony given in court.

Although defense attorney Rudolph Loewenstein attempted to paint a picture of a man who thought he was OK to drive and had nearly reached his destination when the collision occurred,

A Huntington Beach man arrested in a Jan. 28 FBI raid, after social media posts placed him at the U.S. Capitol insurrection, was sentenced in federal court Tuesday and ordered to pay restitution, records indicate.

Mark Steven Simon who faced felony charges of unlawful entry into a restricted building with the intent to disrupt gov-

ernment business and engaging in unlawful activities on Capitol grounds — was sentenced to 35 days incarceration and must pay

OBITUARY Former Daily Pilot society columnist, editor recalled by her family as trailblazer

The first thing readers should know about Vida Dean is that she went to more parties than most people.

"People always tell me about things they would do for their parents," said daughter Victoria Hernandez. "They'd take their parents to nice dinners or things like that. But I could never take my parents to all of the nice parties that they went to. They opened up everything during the 1980s. It was a great time to be a society writer."

Dean, 95, was the editor at the time for the Daily Pilot's society section and a common fixture of the Orange County social scene.

She talked to actors and musicians, and her three children — Victoria, Major and David — still balk when they think about the celebrities she acquainted herself with. Dean retired from




