# Gilchrist, Musselman share the road to Paris Olympics

Kaleigh Gilchrist is excellent at both water polo and surfing and is also blessed with an engaging personality that flows as naturally as her curly blond hair.

"She has a good balance of water polo and life outside of water polo," said Maddie Musselman, Gilchrist's teammate on the United States Olympic women's water polo team. "I think people admire that about her. She has so many friends. It's actually insane how many friends she has." in search of their third straight gold medal and the fourth straight for Team USA overall. That's true literally as well as figuratively, as they typically would carpool to practice every day.

Gilchrist, a big fan of the Los Angeles Lakers and late star Kobe Bryant, is getting married to Tom Gehret on Aug. 24 — Kobe Bryant Day — a couple of weeks after the Olympics. Musselman, whom Gilchrist calls a forever friend, will be one of her bridesmaids.

# Police beef up patrols in Costa Mesa

Residents ask officials for support after a minor was shot in third known incident of gang violence on west side since June.

Costa Mesa Police Department advised residents it may be increasing police presence on the city's west side, following a possibly gang-related shooting Monday during which one unnamed minor was wounded.

CMPD spokeswoman Roxi Fyad reported the incident took place at 2:30 p.m. on the 700 block of Hamilton Street and resulted in a non-life-threatening shoulder injury.

Further information on whether the individual may have been hospitalized was not being released to the public, as the matter is still under investigation. Community members on social media referred to the shooting as a "drive by" but Fyad clarified the only vehicle involved was the one occupied by the person injured.

Bringing their lifetimes of experience to the task, two retired Newport Beach residents are among the many volunteers who keep OASIS Senior Center humming throughout the year. And they maintain they reap great rewards for their unpaid work.

"Volunteering [at the center] makes me feel good and gives

me purpose," said Mike Zimmer-

man, president of Friends of OASIS, the support arm of the facility that raises thousands of dollars annually for its programs, special events and newsletter to augment the \$3.7 million the city earmarks in its budget for the center. "I'm here to assist the senior population in the community."

# Newport council initiates talks to upgrade Balboa Yacht Basin

#### **BY ERIC LICAS**

Plans to renovate a roughly 80year-old marina near Promontory Bay made progress this week when the Newport Beach City Council agreed to formally enter negotiations with a developer selected to take on the project.

The Balboa Yacht Basin at 829 Harbor Island Drive consists of a 172-slip marina, a restaurant called the Galley Cafe, shipyard, marine store, a small park, offices, storage garages and apartment buildings. These were built in the late 1940s and have fallen into disrepair.

"The buildings within the premises have reached the end of their useful life and require substantial investment to continue operating or to renovate," accord-

Although the shooting took place near Costa Mesa's Pomona Elementary School, the campus was closed due to the summer break and was not occupied at the time, a Newport-Mesa Unified spokeswoman confirmed Thursday.

Monday's incident is at least the third episode of gang-related violence to hit the city's west side in recent months. A 22-yearman was fatally old stabbed June 11 outside a liquor store on the 1700 block of Placentia Avenue,

while a second man, aged 19, was believed to have been assaulted by the same suspects nearby, about 1 mile away from Monday's crime scene.

Two suspects — Israel Antonio Valencia, 25, and Christopher Mathew Pena, 18, both of Costa Mesa were taken into custody the following day. Court records indicate Valencia pleaded not guilty to a felony murder charge.

Valencia also was charged with a special enhancement for the personal use of a deadly weapon that could add one year to any sentence he may receive. Pena currently faces no charges

stemming from the incident, according to court records.

On June 14, another male adult was reportedly injured in a shooting that occurred near a makeshift memorial erected near the Placentia Avenue liquor store where the fatal stabbing took place.

Police responded to the reported sound of gunshots and located evidence of a shooting at the scene but saw no victims or witnesses. Shortly afterward, an area hospital contacted CMPD to report a man had arrived seeking emergency medical treat-

Even though we only live 10 minutes away form each other, if it wasn't for water polo, we probably never would have been as close as we are now.

"She's stuck with me, unfortunately for her, but fortunately for me," Gilchrist added with a laugh.

Team USA opens its title defense on Saturday against Greece, at 6:35 a.m. Pacific time. The following match is against Spain on Monday, in the same time slot.

The Americans play Italy on Wednesday at 9:30 a.m. Pacific before closing out Group B against host France on Friday, also at 9:30 a.m. Pacific.

Gilchrist, a former Newport Harbor High and USC star, is the oldest player on the United States roster at 32. She never played against Musselman, the former CdM and UCLA standout who is seven years her junior, growing up.

Yet the two have formed a deep bond. They actually debuted for Team USA on the same travel trip to the Canada Cup in December 2013, more than a decade

ago. "Our time and beginning on this team was exactly the same, so we've kind of done this entire journey together," Gilchrist said.

Between the triumphs of winning gold in Brazil in 2016 and Japan in 2021, there were challenges.

Musselman had shoulder surgery in July 2018. A year to the day later, Gilchrist was injured when a nightclub balcony collapsed following a win at the FINA World Championships in Gwangju, South Korea, killing two people.

'We've been through a lot of personal injuries where we've kind of been the hype person for each other," Musselman said. "It's glued us together, the adversities we've been through."

Musselman, who earned Olympic MVP honors in Tokyo, is widely regarded as one of the best women's water polo players in the world — maybe even of all time.

"She's inspiring others to be better," United States coach Adam Krikorian said. "That's what the great ones do in any sport."

Gilchrist does it too, in her own way. Musselman called her probably the most professional player on the team, willing to do whatever is required for success.

Yet, challenges have continued. Musselman got married last fall to Pat Woepse, who was diagnosed with a rare form of lung cancer around the same time. She said Gilchrist has been her goto teammate to confide in things outside of water polo.

Both have strong family pedigrees in athletics. Gilchrist's father Sandy and recently deceased uncle Allen were both two-time Olympians for Canada in

swimming. Musselman's father, Jeff, is a former Major League Baseball pitcher and her mother, Karen, played soccer at Rutgers.

'We're just in phases of our life that are similar, and we've been through a lot that's been similar," Mad-die Musselman said. "I'm just very thankful for Kaleigh. I definitely wouldn't be able to keep playing without her love and support, especially given all of the things outside of water polo that are going on. I feel like she allows me to just keep playing water polo and also remember why I do it.'

Newport Harbor High water polo coach Ross Sinclair coached Musselman for two years at CdM and also has a good friendship with Gilchrist, who shares of his love of the Lakers and Brvant.

The "Mamba Mentality" that Bryant championed is something that Gilchrist feels has also strengthened her during challenging times.

"How cool is that, to have two of the best players in the world coming from Newport Beach, one from Newport Harbor and one from CdM?" Sinclair said. "It's inspiring stuff. They're both just incredible role models. It's really cool to see them both do their thing and have the success that they're having.

"I think the friendship that they have is nothing but beautiful."

ran a sales and marketing business geared toward the automotive industry. His experience has served him well in his volunteer leadership role at OASIS.

"I'm a car enthusiast along with motorcycles and anything with an engine," laughed Zimmerman. "I still enjoy sales and marketing.'

It's no surprise then that the sixth annual car show, coming up on Sept. 14, was Zimmerman's brainchild.

"When I eventually sold my business I couldn't imagine myself here at OASIS," said Zimmerman. "When people retire they look for things to do like golf, boating, lawn bowling, pickleball."

Zimmerman's philosophy on retirement is that one needn't look too hard for a purpose. "You won't find it, it will find you," he said.

Zimmerman, who first discovered OASIS when he attended an exercise class there with his wife 10 years ago, said "I really looked, and boom, it found me," said "I've been president of Friends of OASIS for six years and I'm here every day volunteering, putting in at least 20 hours a week.

#### **'BEATS ANY EXPERIENCE**<sup>'</sup>

"I think Newport Beach has the best senior center

in the United States, it beats any experience you've had,' said OASIS member Howard Herzog, a lifelong volunteer. "It's amazing! Everyone is a volunteer. What an amazing place."

In recognition for his support enriching the lives of seniors, a plaque presented in 1984 by the Board of Trustees of the Educational Alliance is proudly displayed on a wall in Her-

zog's Newport Beach home. "My job as trustee of the Wallace S. Whittaker Foundation within the Educational Alliance of New York City was to oversee the senior services, which is how I got involved with seniors,' said the New York native.

Herzog moved full time to Newport Beach in 1988 while continuing to maintain his insurance brokerage office in New York until its closure during the COVID-19 pandemic.

For nearly 30 years, Herzog has volunteered his services in a variety of Newport Beach organizations. The last three years his volunteer job has been treasurer for the Friends of OASIS.

"I organize finances, set up budgets and see that we don't overspend," Herzog said. "I'm also on the Newport Beach Civil Service Board, which is a volunteer position appointed by the City Council." The board provides oversight and advice to the council, primarily addressing city personnel issues.



He has also served as a commissioner on the Newport Beach Arts Commission and was an integral part of forming the Newport Beach Arts Foundation.

Herzog's list of qualifications is long. He is a CPA, a Chartered Global Management Accountant, an attorney and insurance investigator for the jewelry and fine arts industry. When he's not volunteering, he works as a consultant with Jewelers Mutual insurance.

Although Zimmerman and Herzog bring to the table different backgrounds and credentials, it's their common goal to build together a strong and effective community at the center, which sees up to 12,000 participants per month.

"This isn't your mom and dad's senior center," said Zimmerman. "This is a corporation, a lot of things are happening here that did not happen a decade ago – technology, computer fundraising, concerts — all to try to get the community involved in all these facets. DANCING UNDER the disco ball was the place to be during a past event at OASIS Senior

That's our goal."

Zimmerman said the Friends of OASIS membership currently totals about 3,500. "We are all volunteers in one sense or another," he said. "Depending on the event, like the yearly rummage sale ... there are literally hundreds of volunteers that help."

OASIS Senior Services Manager Melissa Gleason confirmed there are roughly 150 volunteers. "And, as Mike mentioned, this number increases due to the size of the event and the need for more help.'


