141 people charged in recent county robberies, burglaries

More than 140 people arrested by an Orange County-wide task force combating home-invasion robberies and smash-and-grab burglaries now face criminal charges, Orange County Dist. Atty. Todd Spitzer said Wednesday at a news conference in Santa Ana.

The thefts happened throughout the county, including Fountain Valley, Newport Beach, Orange and Irvine, and many involved violence.

"These are carefully calculated and planned attacks on what should be our safe place: our homes," Spitzer said.

Among the 141 suspects charged were four men who allegedly broke into a Fountain Valley residence in January, forced their way into a locked

bathroom, then held the woman inside at gunpoint. Her husband was reported to have been pistol whipped, and their 12-year-old and 14-year-old children were home at the time.

Those thieves allegedly stole two vehicles from the family. One was pursued by police for about 10 minutes in a high-speed chase that ended in Long Beach.

Most of the people facing charges in connection with robberies and burglaries in Orange County over the past year were not from the area. They included people from Los Angeles, Riverside, San Bernardino and San Diego counties, according to the district attorney's office. Some are residents of Chile who have been taking advantage of a loop-

Costa Mesa drafting affordable housing law

When the Costa Mesa City Council met in 2016 to consider requiring developers to include a percentage of affordable units in new housing projects as a means of securing shelter for lower income residents, the discussion met a dead end.

Then-Mayor Pro Tem Jim Righeimer said an inclusionary housing ordinance constituted "socialized housing" and amounted to theft by depriving developers of their right to sell homes at fair market value.

"If you cannot afford to live here and your kids can't have decent housing, you should look at where you can afford," Righeimer said before the council agreed not to advance such a policy.

Later that year citizens approved Measure Y, mandating certain large-scale developments be put before the voting public for approval, a move some say stymied growth and kept muchneeded homes from being built.

Seven years later, as California faces a critical housing shortage,

Surf City decides to pull out of troubled OCPA

In contentious vote, City Council decides 4-3 to leave the Community Choice Energy program at a special meeting.

A sharply divided Huntington Beach City Council erased another remnant of previous city leadership during a special meeting Tuesday night, voting 4-3 to exit the city from the Orange County Power Authority.

Mayor Tony Strickland made the motion to withdraw, seconded by Mayor Pro Tem Gracey Van Der Mark. Councilmen Casey McKeon and Pat Burns were the other yes votes, while their council colleagues Dan Kalmick, Natalie Moser and Rhonda Bolton voted against leaving OCPA.

Huntington Beach, one of four founding cities in the Community Choice Energy program, had been contemplating leaving the authority for months. But Tuesday night's special meeting was called with just 24 hours notice and without a staff report.

McKeon, Huntington Beach's recently appointed representative on the board of directors of the green energy agency, called OCPA "a total disaster and doomed for failure" from the very beginning.

"I believe in providing choice to consumers, but I do not believe the government is the vehicle to provide choice in the private sector, especially not in the incredibly complex and volatile

Young athletes enjoy All-Sports Cup lunch, success in rivalry

Students who might otherwise avoid lunch lines were happy to wait their turn Wednesday at Costa Mesa High, as the annual All-Sports Cup luncheon arrived on campus.

What has become tradition over the course of more than a decade with a catered lunch from Newport Rib Co. has added incentive to the crosstown rivalry, known to those who have played in it as the Battle for the Bell.

Costa Mesa boasted a 115-75 margin of victory over Estancia in the overall competition, claiming wins in 15 of the 23 team sports contested between the schools.

The Mustangs made big gains in sweeping the home-and-home sets for boys' and girls' volleyball, girls' soccer, softball and boys' tennis. In addition, Costa Mesa emerged victorious for both genders in cross-country, track and field and swimming.

Highlighting that group was the

boys' swimming team, which won the CIF Southern Section Division 3 championship.

"I think ... for all sports, it's a huge thing, beating Estancia [and] being the better school in sports," Natasha Ruiz, a senior middle blocker for the girls' volleyball team, said of the rivalry. "It was fun, especially since we had a good game against them, too. It made it a lot more fun."

Ruiz was referring to a 25-20, 26-28, 25-17, 18-25, 15-10 marathon win at home to cap a sweep of the Eagles in the fall.

After recounting her experience on the court, Ruiz returned with a plate full of ribs, baked beans, mashed potatoes and macaroni and cheese. She took her first bite in front of Newport Rib Co. owner John Ursini, giving it her verbal approval.

Ûrsini donned a Costa Mesa basketball jersey for the event, one he said had been in his pos-

CdM bounces back with victory over Upland

Corona del Mar is on a "revenge tour" after its lopsided loss to archrival Newport Harbor in last weekend's CIF Southern Section Division 1 boys' volleyball final, so motivation wasn't an issue as the Sea Kings started their regional playoff run.

Not having their most prominent star, their go-to leader, their intimidating giant at the net? That's another matter.

News that George Bruening, the 6-foot-9 senior opposite bound for UC Santa Barbara and a slamdunk, soon-to-be All-CIF selection, had been sidelined by a stress fracture in his left foot prodded supreme efforts from pretty much everybody — and especially junior outside hit-

ters Sterling Foley and Reid McMullen — to send CdM into the Southern California Regional Division I semifinals with a 25-13, 25-21, 25-20 home victory over Upland.

Foley delivered 18 kills (with a .425 hitting percentage) and two blocks, and McMullen had 10 kills (on .500 hitting) and a service ace as second-seeded Corona del Mar (21-9) set up a final-four date Thursday with Los Angeles Loyola (27-2). A win there and the showdown most desired — with national No. 1 Newport Harbor (35-2) — is the likely prize.

"This is big for us," Foley said. "After getting swept in the final, that's brutal. Definitely a punch in the face. We want to get back to that final and hopefully play Harbor and beat them.

We're on a revenge tour."

Loyola, too? The third-seeded Cubs, 25-20, 25-18, 25-21 winners over Scripps Ranch, were the Southern Section's No. 1 team until Corona del Mar beat them to advance to last weekend's final, and Foley said he "saw a look on their faces. They are ready for revenge."

A win there would lead to the Sailors, who won the Regional Division I championship last year and have back-to-back section titles, as long as they beat San Diego Section Open Division champion Cathedral Catholic (23-3) on Thursday. The final will be played Sat-

The Sea Kings, who have captured four regional titles (one of them in Division I, the last in 2018), were a level too high for Di-

vision 2 champion Upland (28-5), which battled gamely in the second and third sets after learning some lessons in the opener.

Foley's kills provided seven of the first 18 points and McMullen served an ace and had five kills in a first-set blowout, pacing CdM on a 10-2 run that had the Highlanders reeling.

"It shows [my players] another level," said Upland coach Scott Robertson. "When you don't consistently play that level ... that was that first set, that little learning curve. Trying to figure out the speed, figure out the tempos. Once we did that, we were able to battle."

The Highlanders, led by AJ Contreras (14 kills) and twins Kai and Isaiah Vogel (nine kills each), led much of the second set and some of the third behind strong support — Upland supporters were at least three times CdM's — before fading late in each as Corona del Mar used superb defense and dominance at the net, with seniors Kai Van Bourgondien and Cade Alcano contributing five kills apiece.

Van Bourgondien was a pivotal link, giving a strong performance after stepping into Bruening's spot. Bruening had been dealing with the foot injury for some time, but it flared up in the sectional final and again in practice Monday.

"It's different not having George, but I thought he did a terrific job of being a leader off the court," CdM coach Katey Thompson said. "Sterling did a phenomenal job. He definitely stepped up in a time that we needed him, and that's showing a lot of maturity."

Newport Harbor 3, Tesoro 0: Luca Curci had 16 kills and three aces, as the host Sailors swept the Titans 25-16, 25-19, 25-17 on Tuesday in a regional playoff opener.

Riggs Guy had 13 kills, seven digs, four blocks and two aces for Newport Harbor. Jake Read added 10 kills and three aces.

Tesoro was the runnerup in the CIF Division 2 playoffs, falling to Upland in four sets in the final on Saturday.

Edison duo shine at CIF Finals, 10 locals qualify for Masters

MOORPARK — Top athletes from across Southern California came together at the CIF Southern Section track and field championships on Saturday, battling it out for section glory and a spot in the upcoming Masters Meet. In the girls' hurdle events, a pair of Edison competitors came out as champions.

Chargers seniors Sophia Menchine and Lindy Tarvin both earned CIF titles at Moorpark High on Saturday, highlighting a day where 10 local athletes qualified for 11 events at the Masters Meet on May 20.

"I'm honestly blown away," said Tarvin, who won the 300-meter hurdles in 43.26 seconds, docking more than a second off her seasonal-best time set at the Arcadia Invitational on April 8. "I cannot believe I had that big of a jump in my time. I did feel like it was my best race [in a] technical aspect of hurdling. My mind was just in it from the get-go."

Menchine kicked off the banner day when she separated herself from the pack halfway into the 100 hurdles to win the race in a lifetimebest 15.06 seconds.

"It felt good," Menchine said. "I had a good start. It wasn't my best race, techni-

cally, but, I ran well, so what could I ask for?"

Tarvin, who competed against Menchine in the 100 hurdles and finished seventh in 15.61 in the event, turned it around in the 300 hurdles and qualified for the Masters Meet.

"I don't think it affected me at all because I was hoping, of course, for a better time," said Tarvin of her 100 hurdles performance. "But I'm still satisfied with the progress I've made in the 100 hurdles in the past couple of weeks."

Corona del Mar junior

Ava Simos and Newport Harbor senior Leo Davis were also crowned CIF champions.

Simos, who was the sprints athlete of the meet at last month's Orange County track and field championships, clocked in a personal-best 11.98 to claim the Division 3 girls' 100 race.

"Coming in today, I was feeling pretty nervous," said Simos, who will be the only area athlete to compete in two events in the Masters Meet, racing in the 100 and 200 sprints.

"Last year, when I was a sophomore, I made it to the finals, but I didn't qualify for Masters. So this year, I obviously wanted to get a [personal record], but my goal was really to get to the Masters. I did both of those things today, and I'm feeling really good about it."

Davis cleared 15 feet, 3 inches in the Division 2 boys' pole vault to win the event and qualify for Masters. The CIF-winning mark was tied for the second-best overall on the day, topped by Redondo Union senior Dylan Curtis' clearance of

15-9.

A trio of local athletes finished runner-up at Saturday's championships.

Corona del Mar junior Melisse Djomby Enyawe will join Simos at the Masters Meet with a second-place finish in the Division 3 girls' 1,600 in 4:57.05, her first time breaking five minutes in the event.

Huntington Beach junior Makenzie McRae, the lone Oilers athlete to compete in Saturday's CIF finals, came in second in the Division 1 girls' 3,200 with a qualifying time of 10:26.47, good enough for third overall on the day.

Newport Harbor sophomore Marley McCullough was the runner-up in the Division 2 girls' 3,200 race in 10:55.23 (14th overall in the CIF finals), but the performance left her on the outside looking in for a spot in next week's competition. The top 12 from the CIF finals in the event advanced to the Masters Meet.

In an event where 16 competitors made the cut for Masters, Sailors freshman Natalie McCarty cleared 5-2 in the Division 2 girls' high jump.

Additional Newport Harbor athletes advancing included sophomore Keaton Robar, who finished third in the Division 2 girls' 800 in 2:09.66, and senior Kenny

Wanlass, who placed fourth in the Division 2 boys' 3,200 in 9:12.07.

Pacifica Christian Orange County will also be represented in the Masters, courtesy of senior Caeden Connell, who cleared a lifetimebest 6-4 to earn a thirdplace medal in the Division 4 boys' high jump.

In the other field events, Edison junior Alexa Sheldon was the final Masters qualifier in the girls' shot put. Her 40-1 mark in Division 2 competition saw her finish fourth. Sheldon, however, narrowly missed out on qualifying in the girls' discus following a 125-9 toss in the Division 2 event, which was also good for fourth.

Marina senior Khang Nguyen, who committed to Cal earlier Saturday, was the first cut in Masters qualification after a fifth-place, 44-4½ performance in the Division 2 boys' triple jump.

Three local girls teams finished top-10 in the overall team standings.

The Edison girls finished fifth in Division 2 with 34 points, ahead of Newport Harbor girls, who were tied for seventh with Mater Dei with 26 points. In Division 3, the Corona del Mar girls placed seventh with 31 points.

city leaders are looking for new ways to spur residential development and comply with a state order to plan and zone for 11,760 new housing units by 2029.

new housing units by 2029. A city-sponsored Measure K, which passed in November by just 22 votes, repealed the Measure Y mandates in certain industrial and commercial corridors, paving the way for rezoning that will eventually allow for the building of high-density housing.

And now, with 47% of residents living in low-income households and nearly half of all renters spending more than onethird of their incomes on rent, city leaders are once more considering an inclusionary housing ordinance. But this time, it just might work.

The City Council and Planning Commission on Tuesday held a joint study session to explore how such a policy might create more affordable housing without being so stringent as to discourage developers from building in Costa Mesa.

Kathe Head, president of Los Angeles-based firm Keyser Marston Associates, shared different options and opportunities for drafting an ordinance that would create standards builders had to meet. Developers, in turn, could get entitlements to build bigger projects more easily.

Eight cities in Orange County have inclusionary housing programs, including Huntington Beach, where projects of three or more units must set aside 10% of the total units for renters who earn 80% or less of the area median income. Developers may alternatively pay an in-lieu fee, develop the required units off site or rehabilitate a commensurate number of existing apartment units in town.

Head advised Costa Mesa

Head advised Costa Mesa policymakers to define their own unit thresholds, set-aside levels and alternatives that worked for them.

"You don't want to be confiscatory, you don't want to deprive a property owner of a fair and reasonable return on their investment

and you don't want to create a constraint to housing," she said. "You have to have developers building housing in order to get housing."

Commissioners and council members discussed the possibility of establishing different low-income housing requirements for different areas in town.

For example, parcels to be rezoned under Measure K or at the state-owned Fairview Developmental Center, where the city hopes to redevelop roughly 100 acres into high-density housing, could incorporate a higher percentage of low-income units

income units.

Some panelists expressed a desire to accommodate the 29% of Costa Mesa households identified as

very low- or extremely low-income.

"That's where I'd like to focus, in particular," said Councilwoman Andrea Marr. "They are at the most risk of living in unsafe housing conditions, of massive overcrowding and of not being participating members of society."

Councilman Manuel Chavez expressed an interest in encouraging projects that qualified for high density housing bonuses from the state. He cited a recent Los Angeles Times article that indicated more than 7,700 residents moved out of Costa Mesa ZIP codes 92626 and 92627 between 2019 and 2022, likely due to

high housing costs.

"We are shrinking as a city — there are people who

lived here who could no longer live here anymore," he said.

Mayor John Stephens agreed something needed to be done to incentivize home building. "We haven't had any

housing developments in the city to speak of since 2016," he said. "We have a pent-up situation, where we actually need to catch up."

Head and city staff

Head and city staff agreed to consider comments and questions generated during the discussion as they developed recommendations for an ordinance to be brought to the planning commission and council in the future.

energy market," he said. "Despite all of this, the founding cities of OCPA forged ahead with poor decision after poor decision, the worst of which was hiring a CEO with zero experience in the complex and volatile energy sector."

Last month, OCPA fired that CEO, Brian Probolsky, and replaced him with interim CEO Joe Mosca last week. Probolsky still was in attendance at the meeting Tuesday night.

Huntington Beach's withdrawal, which is expected to become final in Ĵune 2024, leaves Irvine, Fullerton and Buena Park as the three remaining cities in the troubled agency. The county of Orange voted to pull out last December.

OCPA has been subject to several audits, and each of the remaining cities also has considered withdrawing at some point. But with the new board and leadership, there was optimism in the program, which began providing commercial service to Surf City businesses in April 2022 and residential service last October.

Strickland said he made the motion to withdraw from OCPA for many rea-

"I will not stand by while the OCPA shuffles the

chairs on the deck of the Titanic," he said. "OCPA has spent its entire existence discrediting itself every step of the way."

Per the City Council's previous direction, Huntington Beach residents default to the OCPA "basic choice" program, which provides 38% renewable energy — and costs 2% less than Southern California Edison. OCPA also has built up more than \$40 million in cash reserves, and Chairman Fred Jung said that number is expected to be \$70 million by the end of the fiscal year.

Kalmick pushed back against Strickland's motion, saying that OCPA is now on the right track.

"There's no staff report for this," he said. "We have no idea what this is going to cost. This is absolutely irresponsible ... The base rate is 2% cheaper than Edison, so all of the businesses in Huntington Beach that are enrolled at the base rate are going to see a 2% increase in their electric bill in June of 2024 when we leave. Probably more, because as the power authority keeps purchasing more and more power and longerterm contracts, they'll have the ability to decrease that amount."

Kalmick added that if OCPA can't sell Huntington Beach's power at a profit, the city would put

its residents on the hook for a large amount of money, though Strickland and McKeon both said they don't believe that will be the case.

"The county of Orange's decision to withdraw from the OCPA in December, and their analysis of the purchase contracts, have shown that we can sell our energy contracts for higher than what they were purchased," McKeon said.

McKeon was frustrated in recent months that he couldn't get copies of energy contracts purchased on of Huntington behalf Beach.

"A simple nondisclosure agreement became a fourmonth pulling teeth process until we finally received the contracts a couple of weeks ago," he said.

Kalmick, though, noted that Strickland voted for AB 117, which helped make Community Choice Energy programs possible, when he was in the state Assembly in 2002.

"I don't understand why, if this has no risk to the city currently, we would even begin to contemplate this with no staff input," Kalmick said. "We're going to all hold hands and jump off a cliff with no idea what this is going to cost \$50 million, \$80 million, who knows?"

A substitute motion by Moser, to get some analysis about what would be required to leave OCPA and understand financial ramifications to the city and its residents, garnered just three of the four votes needed to pass.

Jung, who is also the mayor of Fullerton, called Huntington Beach's decision to leave OCPA "reckless" in a statement Wednesday.

"Not only does this eliminate the opportunity for Huntington Beach to take bold steps against climate change, it strips away renewable energy choice from its residents and businesses," he said. "Huntington Beach families and businesses want and deserve an alternative to the decades-long fossil fuels-powered SCE monopoly. Huntington Beach has put politics ahead of the health and well-being of those who call Huntington Beach home."

Several spoke against leaving OCPA at Tuesday night's special meeting, including Huntington Beach resident Joclyn Rabbitt-Sire, who is part of the Orange County chapter of the Climate Reality Project.

"I'm shocked," Rabbitt-Sire said after the meeting. "I'm incensed, really. When the residents truly understand what we're going to miss and what we're going to lose, I think they will be incensed too."

hole that allows them to flee the U.S. before facing prosecution, Spitzer said.

All of the defendants are members of one of five organized crime rings investigated by Orange County's Home Invasion Eradication Interdiction Strike Team, Spitzer said. The robberies and burglaries they are accused of "are not crimes of opportunity," Spitzer said.

"These crews that we are talking about today are organized criminals - organized — who are absolutely

working together to exploit the vulnerability of people who have gone back to work," Spitzer said.

Prosecutors allege seven of those accused in recent Orange County heists specifically targeted Asian Americans and Pacific Islanders. Spitzer's office is pursuing hate charges against those defendants.

'We're not going to sit idly by and let this happen," Špitzer said.

The district attorney promised to prosecute burglars and thieves to the full extent of the law. However,

he railed against what he

described as lax-on-crime policies in neighboring areas that he implied promoted lawlessness.

"They're coming into our county which means that lenient policies in Los Angeles, a contiguous count, in the [purview of the] Los Angeles district attorney, has major implications for other counties," Spitzer said.




