bout 100 vessels of all sizes decked out with Christmas lights, inflatable holiday figures and more dazzled spectators during the opening night of the Newport Beach Christmas Boat Parade Wednesday.

This is the 116th year the event has been held, and it runs nightly through Sunday Dec. 22. Aside from spreading holiday cheer, the dozens of vessels entered in the festivities are competing for a variety of honors, including the best representation of this year's theme: "Christmas Across the Decades."

Several entries also included tributes to Ben Carlson, a lifeguard who died after rescuing a swimmer caught in 8-foot surf 10 years ago.

The parade's route stretches across the entire bay, so there are numerous vantage points to watch it from. Some recommended by event organizers include the Balboa Bay Club north of Lido Isle as well as Marina Park and the Balboa Fun Zone on the Peninsula.

The event, sponsored by the Commodores Club of the Newport Beach Chamber of Commerce, helps generate about \$10 million in revenue for local businesses each year, event organizers said.

Surf City council honors outgoing fire chief

Deputy Fire Chief Eric McCoy will become the city's acting head as Scott Haberle retires from a 36-year career.

Scott Haberle joined Huntington Beach as its fire chief in February 2020.

A month later, the world shut down due to the coronavirus pandemic.

Haberle's leadership through that difficult period did not go unnoticed by the public and

other city officials.

"Our fire department, our first responders, were incredible," City Atty. Michael Gates said.

"They were amazing. I think they set the standard countywide, really, for how to handle a crisis."

Haberle is retiring, effective Dec. 30, after a 36-year career. He was presented a certificate of commendation by Mayor Pat Burns at Tuesday night's City Council meeting.

Checks awarded at F.V.'s council meeting

Community groups that joined the Hyundai Hope on Wheels 5K were honored Tuesday for their participation.

The Hyundai Hope on Wheels 5K and Color Fun Run has continued to grow in recent years, and it has provided opportunities for local community organizations to get a monetary return for their participation.

Hyundai Motor America, which has a headquarters in Fountain Valley, has held the run to raise funds for pediatric cancer research for 26 years. The city of Fountain Valley became a partner of the event in 2022. Since then, participation has skyrocketed.

"While Hyundai has been hosting the run for years, we began our partnership in 2022 with 516 runners," said Christie Araiza, the community services manager for the city. "In 2024, we were up by 271% with 1,398 runners. ... We will continue to work with our community groups. Each year, the

Newport Beach surfer recovering from heart attack at beach

Footage monitoring the waves at Blackies just west of Newport Beach Pier caught a surfer collapsing next to his board in ankle deep water as he was returning from the ocean on Thursday, Nov.

A few bystanders either froze or simply failed to acknowledge what was happening. But an off-duty firefighter who happened to be nearby stepped in to begin CPR. Another person called 911.

Newport Beach lifeguards had just finished a training session when the call came in. They were packing up paddle boards and

rinsing sand off of themselves only 400 feet away at their head-quarters when they heard the words "full arrest" announcing a heart attack over the intercom. Lifeguard Officer Carly Christian was in the middle of a shower at the time, but the first to run out the door and literally dash to the scene.

"I had soap on my face," she recalled during an interview with the Daily Pilot alongside her colleagues Monday. "Still had my wet suit on though."

The others on duty with her followed in trucks carrying life-

goal will be to grow the numbers. We can do that with everyone involved, and we are lucky to have such great organizations in our city."

A dozen groups that had at least 20 registered runners were in attendance at the City Council meeting Tuesday, where they were recognized and received checks for their organizations. The race took place at Fountain Valley Sports Park on Sept. 28.

"What's great about this event, it benefits Hyundai Hope on Wheels, and our cause is to help kids fight cancer," said John Guastaferro, the executive director of Hyundai Hope on Wheels. "It's a life-saving cause, so with every step along that 5K, you are helping kids who are fighting cancer, but we're also helping the kids of this community.

"That's why it's a collaborative event. The proceeds benefit Hyundai Hope on Wheels, as well as benefiting the local community here in Fountain Valley. ...

That's why we consider this one of our most special events throughout the year, which happens in September during Childhood Cancer Awareness month.

Community organizations that came out in big numbers largely featured local schools from the elementary to high school level. The Fountain Valley dance team had 138 runners and received a check for \$4,830. The program had the most runners for the second year in a row after it had an event-best 63 runners a year ago.

Courreges Elementary School (\$4,200; 120 runners) and Masuda Middle School (\$2,520; 72 runners) rounded out the top three participating groups.

Michelle Karajelian, manager of corporate social responsibility and external relations for Hyundai, said the event raised \$10,000 for Hyundai Hope on Wheels in support of pediatric cancer research, while \$38,455 went back to local community groups.

"He changed this department from good to great," Sheppard said of Miali, who died on Nov. 16. "He was a transformative leader, and he was just all about speaking the truth and connecting with the people, and putting the right people in the right positions. "I was fortunate to walk

into his door one day, and he offered me a job. He's the one that started my career here in Fountain Valley, and I'm very thankful for him."

Miali, who joined the Fountain Valley police department as its police chief and served in that position from 1986 to 2003, began his career in law enforcement with the San Gabriel police department in 1967.

His tenure as the police chief saw the department implement the use of the Live Scan fingerprinting system, bring motor officers back to the traffic bureau, and create the law enforcement and apprehension program, which is now called the special investigations unit.

LEGAL COUNSEL RECEIVES EXTENSION

The City Council approved a one-year extension for the city's legal consultant, Harper Burns.

Additionally, the panel approved a 3.2% increase to the hourly rates for services rendered, as requested by the firm, to adjust for inflation. The raise is in line with the consumer price index increase for the greater Los Angeles-Anaheim-Long Beach area, per a staff report.

Following the increase, the hourly rate for a partner will be \$199. A senior attorney will come at an hourly rate of \$182, an associate at \$165, a law clerk at \$107, and a paralegal at

Newport Harbor conquers Sunset League opener

The Newport Harbor High boys' basketball team drew a tough assignment Wednesday night in its Sunset League opener, traveling to play a squad that brought a lot back from a CIF championship run a year ago.

The result for the Sailors still ended up being Berry

Senior guard Jack Berry had game-high totals of 24 points and 10 rebounds, as Newport Harbor earned a 60-43 win at Marina.

"We've got to bring the energy," Berry said. "These past few games, we've been slacking a little bit, but energy-wise we were there tonight. It seemed like after halftime, they were kind of shaken up by what we have to show in the first half, so energy was the main thing for us to get the win tonight."

The league has changed to a seven-team league this season, as the fourteam Surf and Wave Leagues from the recent past are no more.

That means it's a long road to a title, with 12 league games instead of six. Still, Berry helped the Sailors (10-3) get off to a good start with his play.

He scored 10 points in the first quarter, as Newport Harbor built an early lead. His defense was also key on standout Marina senior point guard Barak Simon, a key returner from last year's title run for the Vikings along with seniors fellow Dylan Gomez and Luke Pratali.

"He's a tremendous volleyball player, and the last couple of years he's just done a great job of competing at both ends," Sailors coach Bob Torribio said of Berry, who was the MVP of the Euclid Extravaganza earlier this month after helping lead the Sailors to the title. "Everybody knows he's a leaper and scorer, but when he's defending like he can, he's really tough to score on with that athleticism. It's hard to simulate his length until you go up against it."

Junior Owen Saukkola scored 16 points for Newport Harbor, hitting four three-pointers. Junior Gavin Guy added nine points, and senior guard Nolan Payne and senior forward Nash McKown also combined for nine

saving equipment. The man who had collapsed didn't have a pulse and wasn't breathing when they arrived.

The team moved him away from the shallow water he was in and onto dry sand. His eyes were open as he laid on his back, but they were dilated and unfocused. For about five glacial minutes, lifeguards worked in concert with one another to get his heart beating again.

"He looked like he was not alive," Lifeguard Capt. Andy White said.

Christian and Natalie May fitted a mask and oxygen tank onto him then monitored his breath-Battalion Chief ing. Michael Ure took over chest compression for the bystander who came to help earlier. White went to fetch additional aid and equipment from paramedics stationed at a nearby parking lot. Capt. Andrew Matsuyama prepared a defibrillator.

The patient had to be shocked twice before he slowly started coming to. It began with a slight movement of his hand. Some time passed before his eyelids eventually fluttered as he adjusted to the light.

"It was pretty crazy to see someone come back at the scene like that," Matsuyama said. "And especially, there was a collective sigh between us because we knew who this person was."

The man they resuscitated is a well known local surfer who's become a fixture at Blackies. Most know him only by his first name, Rick, even friends who have known him for over 30 years like T.K. Brimer, owner of the Frog House surf shop.

Brimer said "surfer lore and love" flowed through Rick's veins. For decades, if he wasn't out in the water on a longboard he could be found in the parking lot at Newport Beach Pier practically every day from sun up to sun down, eager to share his knowledge and experience with anyone he came

"So I went to Hoag Hospital, I went 'Hey, my buddy Rick had a heart attack at the beach down at Blackies,'" Brimer recalled during an interview at his business Monday. "And they go,'Oh the surfer guy, right? Everybody's showing up to see that guy.""

Brimer said Rick was recovering and has been in good spirits since his ordeal. However, it may be at least a week before he can paddle out again.

"He wants to get back in the water horribly, like anyone who makes surfing their life," Brimer said.

One other was hiccup keeping Rick from getting back to what he loves doing most: Lifeguards had to damage his only wet suit in order to fit defibrillator

pads onto him.

"The first thing he said when he gained consciousness was 'Why'd you have to cut up my wet suit?""

Lifeguards came into Brimer's store a few days later with a small amount of money and brought up the idea of getting a replacement for Rick. The shop owner was happy to help and covered the difference between the cash they had on hand the price of a discounted suit. The new gear was presented to the Newport Beach area local during a ceremony at the Beach Ball bar on Thursday, Dec. 12.

Eric McCoy, currently the city's deputy fire chief, will become the acting fire chief on New Year's Eve.

"I'm so grateful for the opportunity to be here in Huntington Beach," Haberle said during Tuesday's meeting. "I think when I look back on my career, I never thought as a young firefighter in Monrovia that I would finish my career in such an amazing place. The community is so supportive of public safety, the fire department and police. The council, you have all been so incredible with how much support you have given me personally, the department itself and public safety here. I think all of that has just made every challenge and everything we've worked through together just in-

spiring and amazing.' The council members all had plenty of nice things to say about Haberle, known for his pleasant nature and his service to the city. He was previously a fire chief in Monterey Park after being promoted to deputy fire chief in Monrovia, where he grew up.

"I have to say, I've never seen someone that never has a bad day," Councilman Tony Strickland said. "You're always smiling, you're always optimistic, you're always uplifting. No one has ever said a bad thing about you."

Councilman Casey McKeon said it's rare for a public safety department to bring in revenue

He's really set up the city for success in the future with his succession planning, getting everyone on the same page through his leadership to carry the mantle and keep our fire department in good hands for years to come."

Haberle said in an interview with the Daily Pilot that he was proud of working to improve response delivery times through analytics, as well as a "recruit-
