# **City of Hope holds 'topping** off' for new cancer hospital

#### BY MATT SZABO

Orange County's first hospital exclusively dedicated to treating and curing cancer is one step closer to completion.

City of Hope Orange County held a "topping off" ceremony Wednesday morning for the in-stallation of the final beam of its specialty cancer hospital at FivePoints Irvine campus, slated to open in 2025.

More than 400 people, including City of Hope staff, con-



will be connected to the adjacent City of Hope Orange County Lennar Foundation Cancer Center, which opened in August 2022. The nonprofit is investing \$1 billion, fueled in part by philanthrophic efforts, into the combined cancer campus.

One person who wiped away tears on Wednesday was City of Hope Orange County President Annette Walker.

"We've been planning this for months, and I thought, 'Well, you know, it's going to be anoth-er ceremony,'" Walker said. "But I did get really emotional. It made me reflect. In 2018, City of Hope first announced that we're going to come [to Orange County], and I'm looking at this and I can't quite believe that it's here now for our neighbors and us and our children. It's hum-

# Council majority charges ahead in Surf City

A 4-3 vote at Tuesday's council meeting OK'd a controversial new Policy on Human Dignity, and a member was censured.

A Huntington Beach City Council that remains fiercely divided introduced a new Policy on Human Dignity on Tuesday night.

The amended policy was approved by a 4-3 vote, with Mayor Tony Strickland, Mayor Pro Tem Gracey Van Der Mark and Councilmen Casey McKeon and Pat Burns voting in favor. Councilman Dan Kalmick and Councilwomen Natalie Moser and Rhonda Bolton voted against.

The policy came from an ad hoc committee that consisted of Van Der Mark, McKeon and Burns. At six paragraphs, it is much shorter than the original Policy on Human Dignity, which was first adopted in 1996 and last amended in 2021 by the previous council.

The new document no longer states that the city condemns hate incidents and hate crimes and in fact removes all references to them. One paragraph of the new document states that the city "will recognize from birth the genetic differ-ences between male and female and respect the strengths and differences of each. Each sex carries advantages and disadvantages that warrant separation during certain activities (i.e. sports)."

Most residents who spoke during public comments Tuesday night were unhappy about the change. Some called that paragraph of the new document insensitive to transgender or non-gender-conforming people. "I think to truly understand the gravity and importance of this policy, we need to first define equality versus equity," Huntington Beach High senior Briana Lee said during public comments. "Equality is treating everyone the same, while equity is ensuring that groups who have been previously oppressed have the

struction representatives, community members and elected officials gathered for the event. Guests were invited to sign the final 28-foot steel beam, which was then adorned with a wishing tree — containing tags with messages of hope for cancer patients — before it was raised to the building.

"Today is not just a milestone for Irvine," Irvine Vice Mayor

Tammy Kim told the crowd assembled. "It is a triumph for all those who hold faith in the transformative power of compassionate community. Right here in Irvine, united in purpose, we are forging ahead to the future and to a world without cancer."

# Victims of trailer park fire face challenges finding new home

Newport Beach resident Michelle Martin remembers the morning of Aug. 16.

Martin, 69, and her 99-yearold mother, Lynn Scherer, were sound asleep in the aging trailer the two shared in the Beach/Bay Mobile Home Port at 7204 West Coast Hwy. She remembers waking up early, but on that particular morning she'd been groggy enough to want to catch a few more winks.

It would be the only morning she didn't get up at her usual hour that there would be a fire, she said in an interview Wednesday, pointing out the irony of her decision to go back to sleep.

"Both of us are hard of hearing and we didn't hear the hard pounding on the gate [around our trailer], but [neighbors] literally broke the gate post trying to wake us up. We were asleep, wearing next to nothing. I had pants and a top on, and [a man] grabbed my mother. I grabbed our dog, her wheelchair and we ran out," Martin said.

"By that time, our trailer was already catching fire, and the heat - I've never had an experience like that. He kept saying, 'Go, go, go' down the street, and I have a degenerative disease so I wasn't walking so well, but I was pushing her wheelchair and I forgot the [footrests] so her feet were dragging. I'm trying to see the humor in it, but it wasn't

there at the time."

She said she remembers seeing the plumes of black smoke, the firefighters and her mother, who has chronic obstructive pulmonary disease, being moved into to an ambulance. The Newport Beach Fire De-

# Laguna Beach hires retired Sean Joyce as interim city manager

Sean Joyce, a retired public servant who has held the role of city manager for other Southland municipalities, will be taking the reins again, this time as interim city manager for Laguna Beach, following action taken by the City Council at a closed meeting Tuesday.

Joyce will temporarily oversee the top job in City Hall recently vacated by Shohreh Dupuis, who parted ways with the city in a separation agreement announced Aug. 24 to settle a workplace claim she filed. Dupuis was officially released from her job at the start of September. She was originally appointed city manager in April 2021.

As recently as December 2021, Joyce was the interim city manager in Huntington Beach after previous City Manager Oliver Chi left for Irvine.

Joyce is not seeking a perma-

nent position. Prior to his retirement, he was a city manager for the city of Irvine, South Pasadena and Sierra Madre. He was also an interim city manager for San Clemente and South Pasadena.

The Laguna Beach City Council approved hiring Joyce for no more than 960 hours this fiscal year at \$143 per hour.

"I am honored to be asked to serve the city of Laguna Beach as Interim City Manager," Joyce said in a news release announcing the appointment. "I will work closely with the City Council and executive leadership during these next few months to ensure a seamless transition and continued forward momentum for city staff, City Council initiatives and current and future projects."

Laguna Beach city officials confirmed they will embark on a nationwide search for a new city manager.

opportunity to be on the same level with those who are privileged.'

Lee, 17, said she was "terrified" to speak at the meeting, adding that it was one of the first times she has publicly come out as queer.

"What is it about my existence as a human being, and the existence of all LGBTQ individuals in our city, that makes you so uncomfortable?" deeply she asked the council. "Why do you feel the need to erase us from policy ... why do you hate us?'

Earlier this year, the conservative council majority voted to stop flying the Pride flag on city property each June for Pride Month.

But when the item came up for discussion at nearly 2 a.m. Wednesday, Councilman Pat Burns said comments like Lee's were far from the truth.

"Why are certain segments trying to alienate themselves away from ev-eryone?" Burns said. "I don't like identity politics, I think it's divisive, and I think it really hurts our community. This brings us all together under one umbrella, as everyone.'

Councilwoman Rhonda Bolton, who is Black, disagreed.

"We are not all under the same umbrella because you do not ever have to worry about being pulled over for driving while Black or being killed because you're Black, being shot at your synagogue," she said.

#### "As much as I'd like to say, yes, we're all under the same umbrella, we're not there yet."

Elaine Keeley weighed in during public comments. Her father, the late Huntington Beach Mayor Ralph Bauer, helped form the original Declaration of Policy on Human Dignity in response to hate crimes in Surf City in the mid-1990s.

Keeley called the updated version, which uses some language from the original, "plagiarism." She noted that it changes words like "diversity" to dependence" and pender "inter-"independence."

'Your attempt to write a policy on human dignity has failed," she said. "What you have written is a statement of your own political beliefs."

In a letter to the city, the Anti-Defamation League called the changes dangerous and discriminatory.

McKeon on Tuesday night questioned whether a policy was even necessary.

"I think every rational person condemns hate," he said.

The new Policy on Hu-man Dignity was finalized on the same night that the Human Relations Committee was officially dissolved, among other committees.

Moser further blasted the City Council's conservative majority.

"This council seeks to dismantle our city and foment chaos and division," she said in a statement. "They continue to work to make us smaller, weaker and more divided. They create nothing. They build nothing. They put extremist party level politics over what is actually good for our town.

bling. It's humbling to be part of it."

"Topping off" ceremonies are a tradition in the construction industry, for the "suits" to honor the boots on the ground. Wednesday's ceremony included construction workers in hard hats and vests running through the crowd, as music played.

City of Hope has brought together a team of healthcare experts to build and design the hospital, including Freeman Group, Jacobs for project management, Hensel Phelps for construction and HOK as the architect. The 164.000square-foot hospital will have 73 beds. Mark DeSantis, who lives nearby in the Great Park, is certainly appreciative of the efforts. DeSantis' big sneeze in November 2021 led to his vertebrae bursting, and he had to go to the hospital for emergency back surgery. While there, testing led to his diagnosis of multiple myeloma, a rare form of blood cancer. He has now received care at City of Hope's Duarte and Newport Beach locations, as well as the Lennar Foundation Center Center since it opened last summer. "It's meant the world to me, to be able to receive care so close to home," said DeSantis, a finance professor at Chapman University. "I feel good. I'm active, I exercise daily. Right now, I'm receiving what they call maintenance therapy, so I come to this facility once a month. I get my blood work, see my doctor then go upstairs and receive my treatment. "I'm so excited that this state-of-the-art facility is right here. You can't truly appreciate the impact that this facility is going to have until you or a loved one needs the services it provides.'

partment reported they responded to calls about a fire at around 9:35 a.m. that day, and that the blaze was put out by 10:08 a.m., but not before it destroyed three homes and damaged three others.

The cause of the fire remains under investigation, according to Newport Beach Fire Department spokesman Josh Leith.

One of the trailers destroyed in the blaze was Martin's. She and her mother lost everything.

Right now, Martin is living out of a friend's spare room while her mother is being cared for at an outpatient facility, where she's been improving and is expected to be discharged this weekend.

Martin said she doesn't know what the two of them will do going forward. Finding a new home has been her biggest priority, though so far she's had no luck. Her hope was to stay in Newport Beach or Costa Mesa, so they could remain nearby Hoag Memorial Presbyterian, Hospital where her mother's medical team is, but the rental costs are proving prohibitive.

'We have nothing," Martin said tearfully, adding that every little thing was a new expense that neither she nor her mother could afford. Clothes have been generously donated, but she simply does not have the money to replace basic household items or have work done on her car.

For those reasons her friend, Natasha Beavin, launched a GoFundMe charity drive for Martin and her mother with a goal of raising \$300,000. As of Thursday afternoon, just \$1,000 had been raised. Any funds would to go toward housing and replacing essentials such as their medical necessities, including hearing aids.

with the two when she was in between housing herself. She said she's done what she can to help during the duo's displacement.

The Beavins believe firmly that Martin needs an advocate to find housing that works for her and her mother. But securing the help is a nightmare, said Sanne Beavin.

"I know the system is difficult," Sanne said, briefly sharing a story about her other daughter, who suffers from a concussion that has since impacted her everyday life. "We have walked through that system with her, and again at a distance because she lives somewhere else. But it's so far away, and her whole life's changed. The system really sucks. It's so hard to get help."

They'd been hopeful their GoFundMe would gain traction on social media, but beyond some donations from a friend of a friend's, Natasha said, the response has been low.

"I know no one knows [Martin]. I got a donation ... I don't even know this lady [who donated personally], but our friends posted it on there. It's really cool when a stranger donates. They know someone that's connected to me. That's true help when a stranger gives," said Natasha.

For now, Martin and her mother remain uncertain of where to go or what they can do. She expects to have to temporarily move her mother in with her, sharing the same room at her friend's home, though she doesn't know if it will fit another bed or even a double bed.

But, she said, there's always a reason to hope for
