Walking 50 miles in her shoes

For her 50th birthday, Laguna Beach resident touts breast cancer awareness by walking one mile in all 50 states (virtually).

Sharael Kolberg said she wanted to do something fun for her 50th birthday. At first, the plan was to visit all 50 states within the year.

Then, after beating breast cancer in December 2019, it became her goal to run 1 mile in every state to promote awareness and advocate for current patients and encourage women to do breast cancer screenings to catch the disease early. She started planning for her travel at the end of the year, only for her plans to be interrupted by the arrival of the COVID-19 pandemic.

By March, Kolberg decided to pivot — she would run virtually with one person from every state, every day for 50 days. She found her last runner on Sunday in Delaware, just two days before her run began on Aug. 11, the day of her 50th birthday.

"The people that I'm partnering with are running in their own town. They're not traveling. I'm not traveling, but I still get to see a little bit of every state," Kolberg said.

"The fun part is that when I was going to travel, I was going to go to all the tourist destinations in each state to see the attractions. But through this process, I've been able to meet people in little tiny towns that I never even heard of," Kolberg said, "and ... really get to know the insider's glance at different states."

Kolberg said she was diagnosed in August 2018 with triple-negative breast cancer, a type of breast cancer

that can limit treatment options due to its lack of commonly found receptors.

She said she was overdue for her mammogram when she felt a lump. She completed treatment in December 2019 after two lumpectomies and months of standard chemotherapy and oral chemotherapy.

"There definitely were days when I

LOCAL ELECTIONS

Costa Mesa mayor, council seat vacancies attract total of 15 contenders

With the filing period for three seats on the Costa Mesa City Council and one at-large mayor position closed as of Friday, a total of 15 candidates have been qualified to run in the Nov. 3 election.

Costa Mesa City Clerk Brenda Green confirmed Tuesday five candidates had filed papers to run for a two-year mayoral term, including current Mayor Katrina Foley and Councilwoman Sandy Genis, who finishes her second and final term on the council in November but may run for mayor.

The three council openings are for full, four-year terms in Districts 1, 2 and 6 — new geographic districts approved by voters in 2016 but seated by remaining "at large" council members Genis, John Stephens and Allan Mansoor.

Stephens has filed to run for the District 1 seat in November, while Mansoor is not seeking reelection.

Here is a quick look at the candidates who have filed for office, by position and district:

MAYOR

Katrina Foley (incumbent): In 2018, Foley was the first Costa Mesa mayor to be elected by voters, rather than appointed by the council. An attorney and business owner, she first served on the council from 2004 to 2010. She re-

turned in 2014, serving one four-year term before the mayoral election. Her position as president of the Foley Group, PLC earns her an annual income above \$100,000.

Al Melone: A retired accountant who owns an asset recovery firm, Melone ran for City Council in 2012, 2014 and 2016. Describing himself in 2016 as "resistant to growth," Melone serves on the city's Finance & Pension Advisory Committee and was a member of a Pension Oversight Committee that no longer meets. Documents place his income between \$1,001 and \$10,000 and disclose stock holdings in Amazon, Microsoft and Bed, Bath & Beyond.

Quentin "Q" Pullen: A former U.S. Marine and Gulf War veteran, Pullen is a certified personal trainer and owner of Body By Q Fitness, which earns him an income between \$10,000 and \$100,000. Calling himself a change candidate, Cullen claimed in a 2016 lawsuit against the YMCA of Orange County he was never paid for a fitness obstacle course he created.

Sandra L. "Sandy" Genis (current councilwoman): A graduate of Estancia High School, Genis first served on the council from 1988 to 1996. She returned in 2012 and will term out of her council position in November. In

O.C. Board of Supervisors declares Aug. 24 as Kobe Bryant Day

The Orange County Board of Supervisors has declared Aug. 24 to be Kobe Bryant Day, in honor of the late former basketball star and Newport Coast resident who died in a helicopter crash in January.

Board of Supervisors Chairwoman Michelle Steel said at Tuesday's meeting that she picked the date to honor both of Bryant's numbers with the Los Angeles Lakers, 8 and 24. Kobe Bryant Day will be one day after Aug. 23, which would have been Bryant's 42nd birthday.

"I'm proposing Aug. 24 to be dedicated to the memory of Kobe Bryant and all that he brought to the Orange County community," Steel said. "We should strive to live by his words of encouraging those around us to never give up

on their dreams."

She then repeated a quote of Bryant's: "The most important thing is to try and inspire people, so that they can be great in whatever they want to do."

Bryant played his whole NBA career for the Lakers from 1996 to 2016. He and his 13-year-old daughter, Gianna, were two of nine people killed when their helicopter crashed on Jan. 26 in Calabasas.

Longtime Orange Coast College baseball coach John Altobelli, his wife, Keri, and 14-year-old daughter, Alyssa, were also among the deceased, along with Sarah and Payton Chester, Christina Mauser and pilot Ara Zobayan.

In approving the resolution, Supervisor Don Wagner said Bryant's life "should not be judged by its worst day or only the worst elements in mind." Bryant was ac-

cused of rape in Colorado in 2003, but the criminal case was dropped when the accuser would not testify. A civil suit was settled out of court in 2005.

"Kobe Bryant faced challenges of his own making and challenges thrown at him by life," Wagner said. "He overcame them. Today we celebrate the effort in overcoming those challenges and the good in that life. It's not to discount the bad but rather to recognize and encourage the good."

Bryant was a five-time NBA champion and 18-time All-Star with the Lakers. He was selected as part of the 2020 Basketball Hall of Fame class, but that ceremony has been pushed to 2021 due to the ongoing coronavirus pandemic.

Huntington offering COVID-19 relief for select small businesses

The city of Huntington Beach has launched the OneHB Business Support Campaign, with the goal of delivering \$5,000 grants to qualified small businesses that have been negatively affected by the COVID-19 pandemic.

Local real estate developer Robert Mayer Sr., who developed the Waterfront Hilton and the Hyatt Regency Huntington Resort and Spa, has donated \$100,000 to help launch the program. To apply for the first round of 20 grants, applicants must own a small business in the Resort District and meet additional eligibility requirements available at *OneHB.org*.

Applications are available at that website, and must be completed and submitted no later than Monday at 5 p.m. The city plans to evaluate and award all 20 grants before the end of August.

All eligible applicants must

have been negatively and financially impacted by COVID-19, and priority will be given to applicants who have not received

any other COVID-19 related financial assistance. The \$5,000 grants may be used for payroll, rent or lease payments, utilities, inventory and other approved operational expenses.

If more applications are received than money available, a lottery system will decide who receives the grants.

“We are incredibly grateful that Mr. Mayer is supporting our OneHB community with such a substantial contribution toward the growth of our local economy,” Huntington Beach Mayor Lyn Semeta said in a release.

“The city and dedicated supporters such as Robert Mayer Sr. are committed to working hand-in-hand with our local businesses as they navigate a new economy that has been shaped by COVID-19. We wish to demonstrate that our community backs them 100% and that we are in this together.”

The city will host a webinar on Wednesday at 2 p.m. to pro-

vide prospective applicants with information about the program and application process.

As new contributions, donations and funding of up to \$25,000 are received into the OneHB fund, the city will reopen the application process and invite all qualified small businesses citywide to apply.

Grants will also be funded via direct donations and the sale of OneHB apparel and yard signs.

“The OneHB Business Support Campaign is an excellent example of the tremendous business community we have here in Huntington Beach,” Huntington Beach Chamber of Commerce Board Chair Sheik Sattaur said.

“We appreciate the many generous donations and commitment from our community to create a program that will benefit those in need during an unprecedented time.”

library after receiving a notice by phone or email that the item is ready.

The borrower then calls the number on the sign upon arriving and waits for library staff to place the requested items on the outside table.

When library staff goes back inside the building, the items can be retrieved. All checked-out items are to be returned through the book drops.

“Since Orange County Public Libraries’ curbside launch [on June 16], we have had over 50,000 curbside transactions and over 172,000 items have been borrowed,” Orange County Public Libraries communications librarian David Lopez said.

“In fact, our curbside pickup service has reached about 70% of our regular circulation, which is reassuring to see in less than two months of implementation.

“We knew curbside service would be greatly used because of our community’s love for books and the incredible need for entertainment. Orange County Public Libraries is pleased to be able to offer this service and continue our mission to provide access to information for all while promoting the importance for literacy at every age.”

Lopez added that any combination of up to 50 library items may be checked out per library card, and regular loan periods are in place.

Overdue fines have also been postponed through Oct. 31.

A digital library card can also be acquired by visiting ocpl.org/elib/ecard.

Virtual programs continue to be offered by Orange County Public Libraries, including virtual story time and book groups, do-it-yourself and crafts projects, and teen gaming.

Lopez said that more than 1 million online resources have been borrowed by library users this year.

There are several local branches.

They include Costa Mesa – Donald Dungan (1855 Park Ave.) and Mesa Verde (2969 Mesa Verde Drive), Fountain Valley (17635 Los Alamos St.) and Laguna Beach (363 Glenneyre St.).

The Orange County Health Care Agency reported 11 new coronavirus deaths and 245 positive tests for the virus that causes COVID-19 in the latest numbers released on Wednesday.

A total of 745 deaths due to the virus have been reported countywide, while the cumulative number of cases stands at 41,823.

Hospitalizations as a result of the virus were at 440 as of the latest update, with 141 of those patients in intensive care units.

An additional 5,917 tests for the virus, were reported in the last day, bringing the total number of tests administered in the county to 504,559.

To date, the estimated number of recoveries made in the county from the coronavirus is 32,218.

- Santa Ana: 8,125 cases; 195 deaths
- Anaheim: 7,142 cases; 175 deaths
- Huntington Beach: 1,860 cases; 54 deaths
- Costa Mesa: 1,366 cases; 13 deaths
- Irvine: 1,279 cases; 12 deaths

CdM alumna makes semis at U.S. Women's Amateur event

Alyaa Abdulghany has always had a competitive spirit bigger than her 5-foot-even height.

As a junior at USC this spring, she was part of a Trojans team that was ranked No. 1 in the country by Golfweek. Dreams of an NCAA title ended in March, when sports shut down due to the novel coronavirus pandemic.

Abdulghany, a 2017 graduate of Corona del Mar High School, was forced indoors like everyone else as she returned home to Newport Beach.

"When we first went to lock down I was at home for a good month, not touching a club, maybe like putting on my rug," said Abdulghany, 21. "We were hit pretty hard."

Golf, being an individual sport where social distancing is more possible than

many sports, has been one of the first to return.

Abdulghany, who was the CIF State individual champion as a junior at CdM in 2015, certainly showed her talent again last week at the United States Golf Assn. Women's Amateur Championships at Woodmont Country Club in Rockville, Md.

Playing in the prestigious tournament for the fourth time, she went further than before. Abdulghany earned match play wins over Kirsty Hodgkins (University of Colorado/Australia) in the round of 64, Marissa Kirkwood (Kent State/Pennsylvania) in the round of 32, Ellie Slama (Oregon State/Oregon) in the round of 16 and Riley Smyth (University of Virginia/North Carolina) in the quarterfinals.

Abdulghany reached her first semifinal at the U.S. Amateur before losing 2 and 1 to eventual champion

Rose Zhang, a 17-year-old from Irvine, on Saturday.

"My game was as best as it could have been getting ready, and I played exceptionally well in stroke play and all through match play," Abdulghany said. "I'm really happy with how I played, even though I fell about a day short."

"[Zhang and I] actually practice at the same facility and we see each other almost every day. We're quite good friends. It was nice to be able to play with someone like her ... we expect nothing but the best from each other."

Zhang, a Stanford commit, won on the second playoff hole over USC senior and defending champion Gabriela Ruffels to claim the title Sunday.

Abdulghany, who was an honorable-mention All-American this year for the second straight year, said she was proud that six Tro-

jans — also including senior Allisen Corpuz, junior Malia Nam and incoming freshmen Brianna Navarro and Christine Wang — played in the tournament. USC's six golfers were the most of any school at the U.S. Women's Amateur;

Corpuz and Nam also advanced to match play.

"I was really proud of the girls," Abdulghany said. "It shows how good of a team we are and how hard we've worked. We're just looking toward the future and things to come."

"It was pretty tough, having the season get cut short and having no championship. It was disappointing, but it's something out of our control and we have to have to take the health concerns of not just myself but everyone around the world, and make sure that we battle COVID. It's disappointing and it sucks, but we have to look at the bigger picture."

The bigger picture for Abdulghany is that she is back to playing the sport she loves. She said she will compete next in the Southern California Golf Assn. Women's Amateur Championship, which begins Monday at Goose Creek Golf Club in Mira Loma.

Abdulghany is the defending champion of the event.

did not want to get out of bed. The fatigue was the worst thing because you can't move. I couldn't even open my eyes," Kolberg said. "Your body just shuts down. Even on my worst days, my family was so great."

"They were like, 'You know what? Just get out of bed. Let's just go for a walk' and it made such a difference to just get up, even when you don't feel like it," Kolberg said.

"I really just wanted to give people hope and inspiration that are going through treatment right now because not too long ago, I was in a position where I could barely get out of bed," Kolberg said, "[I] just wanted to give people hope — that there is a light at the end of the tunnel."

Kolberg's run will end on Sept. 29, just ahead of Breast Cancer Awareness Month in October. Kolberg said she would be participating in the Susan G. Komen Orange County's More Than Pink Walk with her team, 50 for the Cure.

"The tagline [of More Than Pink Walk] is 'Walk where you are.' [Kolberg]'s no longer the one traveling to all 50 states and we're asking people to do the same thing," said Megan Klink, chief executive of Susan G. Komen Orange County.

"You can walk in your neighborhood, go to a park, but this is really in honor and protection of all our immunocompromised brothers and sisters who are battling breast cancer," Klink said.

Kolberg said that she started searching for runners in March, first with her friends and family before she started reaching out through Facebook and LinkedIn.

The organization also helped Kolberg find running partners in the states she needed.

"We saw this amazing woman come up with

something really creative and dynamic for her 50th and she lives in Laguna Beach," Klink said. "We really worked together to build awareness for breast cancer and give people a platform to take action against the fight in the disease."

"I think that for us it's just inspiring to see that she was successful in getting a representative from 50 states to then rally people to walk where they are to build awareness for breast cancer," Klink said.

"For us, this is really critically important. In Orange County, five women a day are diagnosed and one woman passes away from breast cancer and that hasn't changed because of COVID-19."

Joining her on her inaugural run was her daughter, Katelyn Kolberg, 17, who matched her mother with a hot-pink face mask.

The Kolbergs and a group of their friends began their run Tuesday at Main Beach and finished at Bluebird Beach, where balloons celebrating Sharael Kolberg's birthday, doughnuts and coffee awaited. "I think it was a really cool way for her to kind of come full circle," Katelyn said.

"Running was something that she was really passionate about before she went into treatment, so for her to raise awareness to her journey while also doing something that she loved was really special."

cial. Today was the first day of her kicking this off."

The Kolbergs said that the two would be running together, a mile a day, while streaming on Zoom with their running partners.

"Not a lot of people are doing this or utilizing Zoom in this way to connect on a physical level — getting out there, doing exercise — instead of using it for just strictly educational purposes," Katelyn said.

"I think this was a really creative way for her to use this platform in a way that no one's ever really used it," Michelle Dunn, a friend of Kolberg's, said she wanted to participate in the run on Tuesday because she knew "this has been a hard road for her, fighting cancer."

"She's such a survivor just in the way that she's handled it and I was excited for her to see how much she put into this in putting this on. My sister's going to run with her. She's in Colorado, so it's exciting how she's gotten so many people involved," Dunn said.

"I'm just impressed and wanted to support and be here for her 50th birthday."

Kolberg was smiling at Bluebird Beach on Tuesday, adding, "I'm walking for those who don't want to get out of bed right now, who can't get out of bed and cheering them on."

Costa Mesa Fire & Rescue officials are investigating the cause of a small brush fire that broke out Wednesday morning in the city's Canyon Park in a wooded area not far from homes on Discovery Drive but was quickly contained.

Spokesman Capt. Joe Noceti said the fire was called in at 11:04 a.m. by citizens who initially believed the fire had broken out in the eastern portion of Talbert Regional Park, on the city's

west side.

A battalion chief, patrol vehicle and one engine arrived on scene within minutes and quickly pinpointed the locus of the blaze, which Noceti described as being about 70 feet by 70 feet in area.

"It was an area of really light brush," he said, adding that the fire spread slowly and stopped when it hit a dirt road. "We just put out the remaining hot spots — it was extinguished very

quickly."

Noceti said a park ranger, who'd been patrolling the area, was on scene during the fight.

The area is known as a place frequented by transient individuals, though the exact cause of the fire has yet to be determined.

her candidate filings, Genis disclosed more than \$100,000 of stock holdings in Allstate Insurance, as well as Discover Financial Services, Morgan Stanley and Land's End.

Wendy Leece: Leece served on the Costa Mesa City Council from 2006 to 2014. Before that, she was a Newport-Mesa Unified School District trustee, from 1994 to 2002, and a Parks and Recreation commissioner in Costa Mesa for four years. She is vice chair of the city's Finance & Pension Advisory Committee. A teacher at College Hospital Costa Mesa, Leece indicated earnings between \$10,001 and \$100,000.

DISTRICT 1

(Includes Mesa Verde, Upper and Lower Birds, State Streets, Wimbledon Village and the South Coast Collection area as well as the Fairview Developmental Center)

John B. Stephens (incumbent): A business litigation attorney and partner of Stephens Friedland, L.L.P., Stephens came to the council in 2016 after narrowly losing a bid in 2012. A supporter of the city's police and fire departments, Stephens disclosed earnings above \$100,000 and more than \$10,000 in income earned as a council member.

Don Harper: With a background in business and accountancy, Harper served on the Parks and Recreation Commission and resigned in April 2016. In 2012, he ran for a seat on the city's Sanitary District and was endorsed by the Costa Mesa Taxpayers Assn. A former member of the city's Finance & Pension Advisory Committee, Harper declared no investments or earnings.

Jason Komala: A business development professional and leadership coach who works as a store director for Target, Komala serves as a member of the

city's Cultural Arts Committee. A self-identified fiscal conservative, he disclosed more than \$100,000 in income from Target as well as between \$10,001 and \$100,000 in stock holdings in the company.

DISTRICT 2

(Encompasses Halecrest, Mesa North, South Coast Metro and the Sobeca District, while District 6 covers most of the city's Eastside, except for small portion just east of the 55 Freeway covered by District 3)

Ben Chapman: A South Coast Metro resident for the past eight years, Chapman works as a leasing consultant for a Riverside-based property management company Hunt Pacific Management. A former Orange Coast College student, he has served on several campaigns and grassroots organizations throughout Orange County. Chapman disclosed salary earnings between \$10,001 and \$100,000 but listed no investments.

Loren Gameros: A former Costa Mesa High student, Gameros has been a resident for nearly 40 years. He works as an inspection coordinator for the non-profit Operating Engineers Training Trust Local 12, where campaign documents indicate he earns more than \$100,000. He is also a career and technical education teacher accredited through Rio Hondo and Santiago Canyon colleges.

Gary Parkin: A member of Costa Mesa's Historical Preservation Committee and a former Pension Oversight Committee member, Parkin has served as a Senior Commissioner and is an advocate for the Costa Mesa Senior Center. In his campaign documents, the Costa Mesa resident disclosed between \$100,001 and \$1 million of stock holdings in General Motors, his former employer.

DISTRICT 6

(Covers nearly all of the city's Eastside, except the portion in District 3)

Hengameh Abraham: The co-owner of Costa Mesa wellness coaching center the House of Medicine, Abraham is the mother of two small children, a former pharmacy technician and a 2011 graduate of Cal State Fullerton, where she earned her bachelor's degree in health sciences. In campaign documents, Abraham disclosed between \$1,001 and \$10,000 in earnings from her business.

Jeffrey Harlan: An attorney and urban planner, Harlan has served as a planning commissioner for the past four years and been on the Costa Mesa Community Foundation Board for eight years. As an "of counsel" attorney for Beverly Hills law firm Ervin, Cohen & Jessup, Harlan disclosed earnings above \$100,000 and indicated he's raised \$23,000 in a grassroots campaign.

Jeff Pettis: A graduate of Corona del Mar High School and Cal State Long Beach, Pettis worked in sales for several years before deciding to go back to school for a nursing degree. Today, he works as a manager in Outpatient Psychiatry with the VA Long Beach Healthcare System. Pettis did not report disclosable earnings or investments.

Lee Ramos: A longtime Eastside resident and former member of the city's Senior Commission, Ramos ran for open seats on the City Council in 2014, when he reportedly knocked on 7,000 doors, and again in 2016. He previously served on the city's Charter and Fairview Park Citizens Advisory committees and the Pension Oversight Committee.
