# **Operation Open Water hosts paddle from Catalina to H.B.**

A 32-mile paddle from Catalina Island to the south side of the Huntington Beach Pier sounds intense.

It was just that Wednesday for veterans, first responders and lifeguards who participated in an endurance event held by nonprofit Operation Open Water designed to promote camaraderie, wellness and connection for those groups and to raise awareness about post-traumatic stress disorder.

On Veterans Day, the ultimate goal was bringing people together, and to that end

After a successful first year, the Coast Film Festival returns to Laguna Beach this week on a larger and broader scale.

The cinematic event, which tailors itself toward outdoor living and the environment, will feature more than 50 films this year.

Laguna Beach resident Ben Warner co-founded the film festival — now in its second year along with Enich Harris, a sports brand marketer, and Ben Classen, a lifestyle brand marketer.

"What's really unique about our film festival is the oceans and outdoors collectively come together," Harris said. "So often, they celebrate each other in parallel and not really together, and for us, we thought it was a really unique opportunity to bring the ocean community together with the outdoor world and celebrate both together in one festival."

As a community that is known for its affinity for the arts and its scenic coastlines, Laguna Beach was chosen as a location where cinematic art could be presented and appreciated. Beyond that, Harris said that Laguna Beach can be an example because "it's a really unique community where they have the long-term vision of protecting both lands around us and the ocean."

The festival this year will have a different look, as most events have, due to the coronavirus pandemic. Thursday will kick off the live and in-person portion of the festivities with three days of film showcases at The Ranch in Laguna Beach. Tickets can be purchased at coastfilmfestival.com. Tickets will not be sold at the venue. There will be three sessions from Nov. 12 to 14, each running from 5 to 10 p.m. General admission for a night session is \$50, while VIP tickets are \$100. Event organizers said Wednesday that Thursday night is already sold out. On Friday and Saturday, there will be three short film blocks: 10 a.m.-noon; 12:30-2:30 p.m. and 3-5 p.m. General admission for one of those blocks is \$25 and a student ticket is \$15. There will be a limit of 150 guests per live event and seating will be socially distanced. Masks will be required when not eating or drinking.

"We owe a profound debt of gratitude to our veterans, to the

Mayors from the six cities in Petrie-Norris' 74th Assembly District congratulated the former servicemen and women whose service spans from World War II, through Vietnam, to the present decade — in introductory remarks.

Costa Mesa Mayor Katrina Foley recognized Carol Singleton, a former telecommunications operator in the U.S. Army Signal Corps from 1983 to 1986, who spent a year in Germany during the Cold War.

Singleton works as supervi-

sor of the Heroes Hall veterans museum at the Orange County fairgrounds, where she shares stories from history with future generations. She said her military service helped her gain self-discipline and confidence and, most importantly, prepared her for her work today.

"Heroes Hall is a place where I get to work with veterans ev-

High school athletes around the country looked to the future as fall signing day arrived on Wednesday.

The coronavirus pandemic has altered many things, including the way that signing day was celebrated. Some schools opted to postpone in-person signing day ceremonies in the hopes that conditions might improve and there would be less restrictions later in the school year.

Marina girls' soccer player Mc-Kenna Pua, a Daily Pilot Dream Team selection at center back, said that she signed in front of family and friends at home to join the Washington State program.

Kaitlyn Paculba and Pua are teammates on the Vikings, and they were teammates when they won a national championship in the Elite Clubs National League at the age of 15 while playing for a Slammers team coached by Walter Camargo. They will now be rivals in the Pac-12, as Paculba signed with Oregon. "I'm super excited for her," Pua

Fall sports did not start on time, but Corona del Mar outside hitter Molly Joyce, the reigning Dream Team Girls' Volleyball Player of the Year, is looking forward to broadening her horizons in joining Boston College's program.

"I was looking at ... schools in the area, just in the Northeast," Joyce said. "I also really, really liked the coaches when I went, and my older cousin goes there, so I just felt like it would be a familiar place when I did go there."

Sea Kings third baseman Blake Butcher, who said he had started for CdM since his freshman year, was ecstatic to sign with San Diego State for baseball.

"I would say it's a 10 out of 10," Butcher said of his excitement to make it official. "I've been looking forward to this day for a while. For it to finally come true, come to life, it's a surreal feeling."

The Sea Kings also have three girls' water polo players set to play in college in Kaitlyn Greenwald (Harvard), Grace Myers (UCLA) and Katherine Snyder (Hawai'i).

Mater Dei High was a rare school that held a signing day ceremony Wednesday, though that



Corona del Mar resident Skye Selinsky and Huntington Beach resident AJ Valle were two members of the Monarchs baseball program to sign, and each is headed to Columbia University. Drew Porter, a Costa Mesa resident, is bound for Cal State Northridge.

Selinsky, an outfielder, and Valle, a right-handed pitcher and third baseman, were each pumped to be headed to the Ivy League school. They earned it, as Mater Dei baseball coach Richard Mercado said during his comments honoring them that each had a 4.4 cumulative grade-point average.

Valle said it was an "academic and athletic grind" to get in. "We've had to push each

"We've had to push each other a lot the last couple of years, to make sure we were on top of our stuff getting there," Valle said. "It's going to be nice to not know nobody across the country."

Mater Dei senior swimmer Kailia Utley, a Huntington Beach resident, signed with Vanderbilt University. As a sophomore, Utley finished ninth in the 100-yard butterfly and 10th in the 200-yard individual medley at the 2019 CIF Southern Section Division 1 championships. Though last spring's CIF

meet was canceled due to the pandemic, Utley hopes to return as a senior. She said she liked the athletics, academics and community service prospects that Vanderbilt offered, plus there was a more personal reason for her decision.

"I'm a really big fan of country music, and it's in Nashville," she said. "That's kind of fun."

Mater Dei senior boys' volleyball player Josh Rosenblum is headed to Long Beach State. Rosenblum, a 6-foot-6 setter and Newport Coast resident, said it was older sister Ally who provided motivation to get to this moment.

Ally Rosenblum, a big part of the Monarchs' girls' basketball team before graduating in 2016, recently graduated after four years in the UCLA women's basketball program.

"It's something I wanted to do my whole life," Josh Rosenblum said. "My sister is a big-time Division 1 athlete, and those are big footsteps I always wanted to fill. I wasn't positive I was going to achieve it because of COVID, but it's such a big deal for me." Edison had four girls' soccer players sign or commit in Sophia Drake (St. Mary's), Lucy Granger (UC San Diego), Riley O'Brien (Montana) and Jaqueline Peterson (Em-

bry-Riddle). The Chargers also have Evan Knipe headed to the Long Beach State baseball program.

Arizona State-bound Max Wilner, a three-time CIF Southern Section champion and two-time state medalist in wrestling, headlined Fountain Valley's signees.

Huntington Beach baseball continues to produce next-level talent, as three more Oilers made their plans to continue their playing careers — Caden Aoki (Notre Dame), Blake Penso (UC Irvine) and Shane Stafford (San Diego State).

Laguna Beach had 11 girls' water polo players alone sign or commit with college programs. The most recent to commit was Rachel Carver, who is headed to Princeton.

the paddle along with Operation Open Water cofounder Kyle Kelly, who participated for the second straight year.

Green, who said he was an elective amputee in 2015 after he was injured serving with the U.S. Army Special Forces in Afghanistan, made it through the channel without an issue.

"This is such an important event, bringing first responders together and veterans, and then you have all the community support," Green said. "You just can't quit. I look at it as a 'no fail' mission."

He said he had support from his physical therapist, who flew out from North Carolina.

Morgan Hoesterey of Huntington Beach also guided him along the way.

"The way he had to sit and paddle was really hard to do," Hoesterey said.

"The pain level that he just endured for nine hours was pretty high, and he did it with a smile on his face, which is amazing. It was one of the more amazing things I think I've ever seen, honestly. He did great. He only got stronger as the channel went on, and it was great."

Kane Johnson, an engineer with the Huntington Beach Fire Department, was one of two members of the department who completed the whole 32-mile solo paddle. The other was Dane Morrissey.

They were among about 20 to complete the paddle, including two relay groups. Johnson said he had ne-

ver paddled the channel before, adding that it really tested his mental fortitude and physical ability.

Other Huntington Beach firefighters waited in support on the sand when he finished, with signs reading, *"Sí se puede*, Kane" ("Yes you can!" in Spanish) and, *"Paddle, Kane, Paddle!"* 

"About 7 miles in we hit a completely offshore headwind blowing right in our faces, and mixed-up swell," Johnson said.

"It was very challenging conditions. I was laughing, because when that hit us, we had a pod of dolphins come in. That pod of dolphins followed us for like 30 minutes right when we needed it the most, gave us some energy. There was this connection, and it was incredible. It's hard to explain unless you did it."

Huntington Beach Mayor Lyn Semeta was on hand at the finish, presenting the group with a certificate of recognition.

Johnson said he had a mantra, "Anything is possible," which he repeated to himself in Hawaiian during the paddle.

"When I was starting to hurt, I was thinking about the veterans that we were escorting across and everything that they've gone through," he said, starting to tear up.

"Then you just go, 'This is nothing.' We have Jake, missing a leg, a Green Beret serving our country. He's going across, and he lost a leg ... It gives you a lot of perspective."

Nichols started Operation Surf years ago, giving veterans and active military an opportunity to learn how to surf in Surf City.

Now, Operation Open Water has furthered that effort of togetherness. This is the second straight year the paddle has been held on Veterans Day.

"With Operation Open Water, what Danny and the team wanted to do was really help to bring people together," said Aaron Anderson, a Huntington Beach resident who is on the Operation Open Water board and founded the Green Beret Foundation in 2009.

Anderson, himself a veteran, completed the paddle Wednesday as part of a relay team.

"It's about being in the water and how the water brings people together," he said.

"With the surf culture here in Huntington — Surf City USA — it's one of those things where that culture can bring to others something that is so important and vital to the uplifting of the soul and spirit."





ery day," Singleton said. "I get to hear their stories and share them with the community - I want to make sure their stories are told and their sacrifices are not forgotten.'

He later graduated first in his class at Claremont Gradu-University's Peter ate Drucker School of Management and co-founded the company Voxx Analytics.
