### Judge to rule on Pacific Airshow case

Gina Clayton-Tarvin sued Huntington Beach last year after the city denied her request to review its settlement with air show operator Code Four.

An Orange County Superior Court judge heard arguments Monday afternoon over whether the city of Huntington Beach should be forced to release its complete multimillion-dollar settlement document with Pacific Airshow operator Code Four.

Judge Jonathan Fish presided over proceedings at the Central Justice Center in Santa Ana that lasted about an hour. Gregory Pleasants argued for the plaintiff, Gina Clayton-Tarvin. Savannah Skelton represented the defendants, the city of Huntington Beach and City Atty. Michael Gates, who was also present but did not speak.

Fish will rule in the coming days or weeks, though either side could appeal. He asked for the settlement itself to be put into the court records, under seal, and both sides agreed.

Clayton-Tarvin, a longtime member of the Ocean View School District Board of Trustees, sued last June after Gates refused to release the full settlement, valued at up to about \$7 million. Instead, following her California

#### State auditor to examine Surf City's \$7M air show settlement

Joint Legislative Audit Committee votes in Sacramento to take a look at the settlement.

The California Joint Legislative Audit Committee voted Tuesday in Sacramento to examine Huntington Beach's multimillion-dollar settlement with Pacific Airshow operator Code Four.

The joint committee voted 10-2, with one abstention, to review the settlement that was agreed to last year.

Among the yes votes were state Sen. Dave Min (D-Irvine), who requested the audit. Min represents a portion of Huntington Beach and has often been critical of its current conservative City Council majority.

Code Four sued for breach of contract after the final day of the 2021 Pacific Airshow was canceled due to an oil spill off the coast. Huntington Beach ended up settling with the air show operator for about \$5 million, plus \$2 million more if Huntington Beach recovers money in its own oil spill

# Law is helping to curb no-fault evictions

Costa Mesa passed an emergency ordinance in November to assist tenants displaced due to no fault of their own.

Last November, with the number of renters facing no-fault evictions at a critical peak, Costa Mesa city leaders adopted an emergency ordinance requiring landlords to report imminent displacements and broadening tenant protection and assistance efforts

The new law took effect immediately, requiring property owners give occupants a 60-day notice and notify the city within 72 hours of issuing a notice of eviction related to a substantial renovation or demolition or, alternatively, an owner's desire to move in or take a property off the rental market.

Landlords must also provide one month of fair market value rent to evicted residents and share documentation and permits for renovations substantial

# Balboa Library and Fire Station project moves to final design phase

The Balboa Library and Fire Station No. 1 project will move ahead to its final design phase before it goes out to bid next summer, following a unanimous vote of the Newport Beach City Council on Tuesday.

Council members ultimately decided on the second of the three possible layouts for the project, which is currently estimated to carry a \$16-million price tag. The proposed layout will bring the size of the building to about 9,170 square feet. The li-

brary will occupy 3,770 square feet, while 5,400 square feet will be used for the fire station.

An initial proposal for a public works storage facility was removed. Other additions include a playground and some additional green space. The new layout will orient the facility along Balboa Boulevard with public parking and the library entrance off of Bay

Both facilities are in need of being updated, according to assistant city engineer Tom Sandefur, who delivered the staff presentation Tuesday night.

The Balboa Library was constructed in 1929 and was originally 566 square feet before it was expanded in 1952 and again in 1962 to encompass about 4,500 square feet, including 360 feet of museum space. Fire Station No. 1 was built in 1962 and is 3,431 square feet, according to the city.

Sandefur said the Public Works Department coordinated with the library, fire department, city staff and the recreation and senior services department to develop plans for the 24,000-square-foot

# City of Hope expands with Seacliff facility

Kathy Miller Willahan may be 74 years old, but that doesn't stop the Huntington Beach resident from getting on the pickleball court five days a week.

Surviving breast cancer in her 50s also didn't permanently deter her, nor did a 2017 diagnosis of Stage 4 mantle cell lymphoma, a rare form of non-Hodgkins lymphoma.

"There was no cure at that time for my type of blood cancer, and few people survived past five years," she said.

Willahan said that her husband drove more than

# Trial begins for woman, 70, accused of killing mom in H.B.

The daughter of a 92year-old Huntington Beach woman attacked her mother with a knife and then dragged her into a swimming pool for "greed" to collect on an inheritance, a prosecutor told jurors as the defendant's attorney said the real culprit was her client's sister.

Cynthia Roberta Strange, 70, is charged with murder with a special circumstance allegation of murder for financial gain. She is accused of killing her mother, Ruth Strange, on Sept. 4, 2018, at 6812 Vista Del Sol Drive. Her trial got underway this week at the Central Justice Center, Santa Ana.

"The defendant — Cynthia Roberta Strange — sitting right there brutally and viciously murdered her 92year-old mother," Senior Deputy Dist. Atty. Nick Thomo said, pointing to the defendant in her wheelchair.

The victim's other daugh-

ter, Amy Hamilton, arrived her death was caused by to pick up her mother for a doctor's appointment about 10 a.m. that day, Thomo said. She saw a small garage door open and an inner door leading to the house locked, which she thought was suspicious, Thomo said.

Hamilton called police for a welfare check when her mother did not answer her phone calls.

"As soon as they open the door they see the blood" and Hamilton jumped back, Thomo said. Police asked her to stay

back while they searched the house and found a bathroom "covered in blood" and bloody footprints leading to a bloodspattered recliner before a sliding-glass door to the outside patio, Thomo said. When officers checked the backyard they found the victim in the swimming pool, he added.

Cuts and lacerations to the victim's head were deemed "superficial," and

drowning, Thomo said.

Strange killed her mother to inherit money and to avoid repaying a debt, Thomo said.

In court papers, Thomo said Strange was receiving supplemental income from her mother after she told her she got divorced from her husband. But she never got divorced and continued receiving benefits from the U.S. Navy service member while also getting a profit from selling her Oceanside home and moving to Irvine, which angered her mother, Thomo said in a trial brief.

On Sept. 3, 2018, Strange went to her mother's house about midnight, prompting her mother to repeatedly try to call Hamilton, leaving voicemail messages begging for help and a call back, Thomo said.

"You have to help me; I'm afraid," the victim told Hamilton in a voicemail played for jurors.

6,000 miles between 2021 and 2022 to take her back and forth to City of Hope in Duarte.

City of Hope Seacliff will start seeing patients on Monday, City of Hope Orange County President Annette Walker said, adding that it was about two years in the making. The previous, smaller location in Huntington Beach, Beach Boulevard, will close, its services transferred to Seacliff.

part of the Orange County community and be as close to the people as we can," Walker said.

City of Hope Seacliff features 20 infusion bays with varied coastal views from the third floor, as well as 15 light and bright exam rooms with large monitors for patients to review tests with their specialists.

Doctors there will offer expertise in gynecologic oncology, urology, Mohs surgery for skin cancer. blood cancers and more. Walker said the unique artwork on the wall originally came from the Lennar Foundation Cancer Center in Irvine, but it was selected for the new center to fit the Huntington Beach vibe.

Speakers at Tuesday's ceremony included oncologist Dr. Nishan Tchekmedyian, himself a Huntington Beach native and Edison High graduate, as well as Huntington Beach Mayor Pro Tem Pat Burns.

Burns shared that he was diagnosed with cancer three years ago, was treated at City of Hope by Dr. Jeffrey Yoshida and had his prostate removed.

lot. Those plans were first reviewed by the Board of Library Trustees and the public in January, then by the Parks, Beaches & Recreation Commission in March.

Both favored the first layout, which includes the storage space, along with the "cottage house" theme for its exterior design.

The much-needed updates have been met with some concern from residents as the project would call for the removal of two existing landmark trees a blue gum eucalyptus tree and a Canary Island date palm. City staff said removals are necessary as the eucalyptus tree is experiencing an internal fungal rot while the date palm faces removal because of "unavoidable" construction impacts.

City staff said the progression of the rot in the eucalyptus is at about 7% and that it would only take about five years before it would impact one-third of the tree — the threshold at which trees are typically recommended for remov-

Members of the public raised objections in January after the first hearing on the project, saying they felt the city removes more trees than it plants and that the removal would impact what remaining habitat there is in Orange County for birds like the

great blue herons that nest there. The city said it would not be removing the trees during nesting season, so no birds would be displaced.

Comments during public comment Tuesday reflected many of the same concerns. All of the speakers agreed that updates were necessary, but some residents said a few of the additions folded into the project were unnecessary, like the playground, equipment storage and additional parking.

"[The great blue herons] are our friends and neighbors, and your city staff says these birds are opportunistic. But I look on my rides, and I'll see a hummingbird on a certain tree. And every time I go that ride, hummingbird is there. On the other hand on the south-side of the Back Bay trail, I notice the city or county took down a big tree that was a hawk's home. Every time I go by there, no more hawk," said resident and bird watcher Don Abrams.

"On Balboa Island, a neighbor pruned a tree down and a juvenile night heron, which had been living there for years, is now gone from the community," he continued. "So, I'm not so much a tree lover although that tree, I've gone over and looked at it, and it's magnificent — but I'm a bird lover.

"These great blue herons, they're not opportunistic. They're not looking

for a new place to live anymore than we would want to give up our homes.'

Mayor Will O'Neill said both buildings have been on the city's capital improvement program for some time. He said he felt there wasn't a question as to whether or not they would need to replace either facility.

"The question that we've been trying to work through as part of this design project has been what it would look like to do so," O'Neill said.

O'Neill said Corona del Mar saw the completion of a library-fire station hybrid in 2019 and noted replacements, not rehabilitations, were necessary for both the Balboa Library and Fire Station No. 1. He also said the city has added about 680 trees to the Balboa Peninsula over the last two decades.

"When we've done the testing, and we've done it

[through] an arborist that's been trusted in the past and has done a great job for the city, it's not enough to tell us that you can look at a tree and there's not a problem, [that] 'the arborist doesn't know what he's talking about.' We don't have that luxury to do that because, in the past, we have had limbs fall on people. We have had limbs fall on property.

'We have had major problems with trees like this ... we cannot allow for a failure. This is the point of why we do these tests in the first place, to make sure that we're paying attention to the safety concerns as well as what we're working through ... knowing that we have to do this work, it's not feasible for us to be trying to design around a tree that is not going to work."

The settlement stems from the cancellation of the final day of the Pacific Airshow in 2021, due to the oil spill off the coast of Surf City.

Gates has said he didn't release the full settlement because it could compromise the city's success in litigation against the oil

spill polluters — though any such litigation has yet to be officially filed. Critics have argued that the lack of full transparency raises concerns about the relationship between Gates and the conservative City Council majority with Code Four chief executive Kevin Elliott.

"What I'm concerned with as a resident and a taxpayer is this: It's not the money that they just paid, it's the money that they will encumber into the future," Clayton-Tarvin said following the hearing. "My tax

dollars could go into infinity and beyond into this private corporation. As a taxpayer, I should be able to go to my government and say, 'Hey, maybe you should go out to [a request for proposals] ... Maybe this isn't a good deal for the public.' I'm worried that there is an evergreen clause in that settlement."

Skelton argued in court the city was in a difficult position, where release of the full settlement could undercut its own position in what she called "pending and future litigation."

She also argued that Gates was within his legal rights to use his discretion to decide whether to release the full settlement, though Pleasants disagreed.

"At the time it was drafted and signed, there was never a thought that this would be disclosed publicly," Skelton said in court. "These terms are sensitive ... the settlement terms document provides all important terms to the petitioner. We're not trying

Pleasants said the settlement agreement's release serves the public interest. He pointed to a California Coastal Commission letter sent to city officials in February that alleges the air show privatized public land and waters in Huntington Beach without a needed coastal development permit. In the letter, Coastal Commission staff also ask for the public release of the full settlement with Code

Skelton countered that the letter was irrelevant to the CPRA request and didn't exist when it was made.

Pleasants also disagreed with Skelton's claim that pending litigation would be hurt by the settlement's release.

"There is no other litigation," he said. "It's outrageous to come in here and say that there is ... the city of Huntington Beach is no longer a party."

ologist who was active in her senior community where she was known as being "kind" and "gentle," Ross said.

The defendant had a full replacement shoulder surgery shortly before the killing and suffered from arthritis in her right wrist, Ross said.

Hamilton "hates working to an extreme," so she relied heavily on her mother for income, Ross said.

'She was in significant debt, way over her head," Ross said. She also said Hamilton was "abusive, aggressive, hostile, lazy and money hungry."
Prior to 2016, the two sis-

ters got along fine, but that changed in April of that year when Cynthia Strange moved from Oceanside to Irvine to be closer to her mother, Ross said.

"Hamilton doesn't like this," Ross said.

In December 2016, Hamilton got her mother to buy a condo for her, but despite the monthly income and no house payment her daughter continued racking up debt, Ross said.

"She's in so much debt she starts cashing out stock her mother gave her a year before," Ross said.

The defendant's father was an engineer who had a knack for building a nest egg with wise investment choices, Ross said.

When Ruth Strange got sick Hamilton convinced her mother that Cynthia got her ill, Ross said. That's when she got her mother to change the family trust that was set up in by their parents in 1992, Ross alleged.

The house in Huntington Beach was to be split up by the three daughters and the rest of the estate to be divided up by the four siblings, Ross said. But Hamilton convinced her mother to list Hamilton as the beneficiary of a stocks account worth about \$1.66 million, Ross said. When adding in \$100,000 from an IRA and money from the sale of the house the total inheritance would be \$2 million for Hamilton, Ross said.

Cynthia Strange showed up at her mother's house about midnight Sept. 3 because she had an unpleasant encounter with a "creep," her attorney said.

Ross said Hamilton acted suspiciously the day of the killing, not calling 911 but the non-emergency line instead when she arrived to pick up the victim who did not answer the phone.

When officers told Hamilton her mother was found in the pool, Hamilton asked, "Was she stabbed?" according to Ross.

'They only knew she was stabbed after the autopsy, but she knew right away, Ross said.

Ross also said police "failed" to adequately investigate Hamilton, who had a box of latex gloves in her car that were never tested.

The defense attorney acknowledged the "weird stuff," including true crime stories, that her client searched for online, but Ross said police never bothered to check Hamilton's search history despite a "dummy" email address she gave investigators.

"Like hundreds of businesses along the Huntington Beach coastline, there is no doubt that the Pacific Airshow lost revenue during the beach closures that followed the 2021 oil spill," Min said in a statement following the vote. "But it is unclear that they were owed any damages from the city for its decision, made in conjunction with the state and the County of Orange, to shut down its beach. It is also unclear whether their lost revenues were anywhere close to the amount provided by the city's settlement.

"At a time when public trust in the integrity of our governments is at an all time low, it is more critical than ever that we provide transparency and assure the public that their tax dollars were not used in inappropriate or illegal ways," Min continued. "I'm grateful to my Democratic and Republican colleagues for voting to authorize this audit, which will hopefully get to the bottom of this."

The committee vote happened a day after arguments were heard in Or-County Superior Court in Gina Clayton-Tarvin's lawsuit against the city, and City Atty. Michael Gates, relating to the denial of her California Public Records Act request to release the full air show settlement to the public. A decision is expected soon from Judge Jonathan Fish.

Gates, as well as interim City Manager Eric Parra, represented Huntington Beach at Tuesday's hearing in Sacramento.

Parra said during his hearing comments that the air show was "vitally important" to the city but that Pacific Airshow operators had made it clear there would be no show in 2023 unless a settlement was reached, which the City Council voted to pursue.

"The city's contention is that it was an appropriate settlement," Parra said.

Gates said that negotiations spanned five months before the city settled in May 2023. He added that the California Supreme Court has repeatedly upheld that charter cities like Huntington Beach have the autonomy to spend their resources as they deem fit, when it comes to their own municipal affairs.

"We believe that as a matter of law, the requested audit is not justified or proper," Gates said. "As a matter of fact, the record shows that the 2023 settlement with Pacific Airshow was justified, at least in public comments by the City Council, as a prudent decision to ensure future air shows and the related vast economic benefits to the city. And, as importantly, to avoid any risk associated with proceeding to

Min said during the hearing the audit request was simply about looking for information and transpar-

"I'm not making any determination as to whether this was a public gift," he said. "We would just like information to start making that determination our-

State auditor Grant Parks said during the hearing that Clayton-Tarvin's shouldn't impact the state's ability to obtain the records it needs, but it could impact the level of specificity that a public audit report could get into.

He estimated the audit would take about 2,300

hours to complete. There is no established timeline for the audit.

enough to trigger displacement of 30 days or more.

The city, in turn, approved \$300,000 in Federal Rescue Plan Act funding for local nonprofits to provide case management and financial assistance, allocating \$250,000 for legal help and advocacy. Another \$600,000 was budgeted for two outreach workers, a senior planner and code enforcement officer to implement the program.

The hope was to prevent families from being forced into homelessness. One month prior, four Newport-Mesa Unified School District families who had been displaced were living on the streets, while 67 no-fault evictions were reported between July 1 and Oct. 25. Officials anticipated Costa Mesa could see another 160 to 170 evictions in the next

That grim forecast appears to have been avoided, however, according to a sixmonth progress report delivered to the Costa Mesa City Council during a May 7 meeting.

Management analyst Sergio Escobar told the council that since November, a total of 35 eviction notices were filed with the city — a decline of nearly 50%. Of those, 25 were of the nofault variety, while the remaining 10 pertained to occupants for failing to pay rent, causing a nuisance or breach of contract.

Among the no-fault evictions reported by landlords, 17 were initially deemed to be out of compliance with state and city laws. Four of those were withdrawn altogether, resulting in no displacements, while the others were amended and resubmitted, buying tenants

time to find new accommodations.

Despite some successes, challenges remain. Although 21 no-fault evictions were given notice to proceed by the city, only one household so far has granted a \$500 voucher for moving-related expenses.

Displaced households that earn 50% or less of the area median income (set at \$78,900 for a family of four) may also be eligible to receive supplemental assistance for things like storage fees, security and utility deposits as well as application and holding fees.

Escobar said city staff could only speculate as to why more people were not taking advantage of the offer of assistance.

"In some cases, the most important reason is that individuals must be able to identify and secure a new housing unit before the financial assistance is available to them," he said. "If they are not able to locate a unit by the date they are to vacate, we do have emergency alternatives available.

Council members praised the initial progress of the ordinance, asking for more data specific to the city's six council districts and possible barriers to access as well as continued updates on trends and impacts of the program.

Manuel Councilman Chavez, the only renter on the dais, said he was glad the city responded to an urgent need in the communi-

"I'm pleased we have seen a reduction in no-fault evictions," he said. "Obviously, it's not perfect, but it's a right step in the right direction. '

NORWALK — Jackson Cryst's arrival instantly transformed Sage Hill's boys' volleyball program into a powerhouse, and the first tangible reward arrived Saturday on the biggest of

A dominant Cryst posted 54 kills, an astonishing total, to power the Lightning to a 19-25, 25-22, 22-25, 25-18, 15-13 triumph over San Marino in the CIF Southern Section Division 5 title game. He was phenomenal if hardly perfect, but the victory required the efforts of all involved, not just the 6-foot-10 centerpiece.

"The more he gets an opportunity, the more he shines," Young said of Gapp.

Senior middle blocker Aidan Powell had three kills and a block. Senior setter Brayden Brien, junior mid-

dle blocker Omar Al-Khatib, and libero Dylan Han and outside hitter Ryan Manesh, both sophomores, also made big contributions.

Cryst has 200 kills in five playoff games, along with 21 blocks — he had three Saturday — and nine aces.

"Six-[foot]-10 will do that for you," said Young, whose team is 16-3 since Cryst became eligible in mid-March. "And the experience that he has and the upbringing [by former pro Geoff Cryst, a Long Beach State standout in the 1990s]. He comes from a long line of high-level volleyball. He's got it.

Cryst wasn't perfect. The ball was a lighter ball than what he's used to - he had three service errors, sent four swings into the net and had several that sailed long, and "could have been more efficient," he acknowledged — and Young said it was "a pretty good example of, like, he's still human."

He nearly wasn't enough. San Marino, which hadn't dropped a playoff set, used 4-0, 9-2 and 7-2 runs to sprint to the first-set win, finished the third set on a 9-4 tear for a 2-1 advantage, then turned a 10-4 deficit into a one-point clash in the final set behind a versatile crew led by left-handed opposite Casey Chan (15 kills, two blocks), middle blocker Luca Moggio (12 kills and two blocks) and expert setter Jared Wang.

The Titans, who had fewer (51) kills than Cryst, made late charges in all three sets that Sage Hill won, turning six-point deficits into close encounters in the second and fourth sets before that fifth-set rally fell short.

"It was good that we went through that adversity [in the earlier playoff rounds]," said Cryst. "I feel like [our

bracket] was a lot more difficult than [San Marino's]. We had a game go to five sets [the second-round win at Camarillo], we had a game go to four sets [two: at Fullerton in the opener and against No. 2 Moreno Valley Rancho Verde in the

quarterfinals. "We were battle-tested, they hadn't dropped a set, so I feel like they weren't ready, and that's how we got that jump out of the gate, and that's why we could continue to push even when it got to scary sideout, side-out volleyball. We really thought it's our volleyball [toward the end], that we just have to play our volleyball. We're better, and everybody has that supreme level of confidence, no matter where the ball goes. We have confidence in our ability to play volleyball as a unit. It doesn't have to be one guy."

Young's message to her team after the third-set loss: "We're either ending their season or they're ending ours. How bad do you want it? What are you willing to do to get that win?'

'We can take care of business. We totally can,"

she said. "And I think the more we are able to get ahead, stay ahead and finish, the more we'll see that that's our level. We don't have to fight, let's just take

Sage Hill came into the playoffs without much fanfare — it hadn't won a playoff game since a 2018 wildcard triumph, hadn't won within the bracket since 2010 — but arrived with great confidence, and Cryst called the title "great for the school, kind of building a culture in volleyball."

It didn't surprise anyone within the program.

"We worked toward this all season, so it's nice to have everything come to fruition ...," Gapp said. "We always believed that we would win."

Sage Hill lost at Valencia West Ranch 25-14, 19-25, 25-17, 25-18 in a CIF State Southern California Regional Division III opener on Tuesday, ending its season. Second-seeded West Ranch was the Division 4 champion in the Southern Section.

### Pacifica Christian sprints into first CIF final

Pacifica Christian County had seen its three-run lead disappear and stood one out from extra innings in Tuesday's CIF Southern Section baseball semifinal, with anything possible, good or ill, from that point.

Up walked Blake Hayes to the plate, so forget about all that.

The freshman catalyst was unstoppable in the Division 8 showdown at Orange Coast College's John Altobelli Park — he's been nearly so all season — and the Tritons, in just their third campaign, trotted into Saturday's title game as his fourth extra-base hit of the afternoon was followed by Scout Escobedo's single to the left-center field gap and then a thunderous celebration.


The 4-3 triumph over visiting San Bernardino, built primarily upon Hayes' expertise at bat and with the glove and sophomore right-hander Jon Stone's eloquence at the edge of the strike zone, takes Pacifica Christian Orange County (22-6) deeper into uncharted territory, gloriously so. "It feels fantastic," said head

coach Chris Gomez, who has led the top-ranked Tritons from a tough first season to a CIF berth in year two and now within one victory of a most unexpected prize. "I went to a dark spot when they scored that three-spot [to tie it up], but I'm so happy for these kids. They support each other, they've been getting after it all year long, they work hard, they're great kids. So they deserve it."

They'll play Saturday at 10 a.m. at Diamond Stadium, the home of the San Diego Padres' Single-A affiliate Lake Elsinore Storm. Their opponent is second-seeded Azusa (17-5), a 9-5 winner at Edgewood in the other Division 8 semifinal.

'This means everything to me and this program," said Escobedo, who had hit the ball hard but at fielders in his first three atbats. "It's the third year, so no one really expects us to be in the championship this early in the program, but we're glad to be

mostly behind underclassmen. Escobedo, too, is a freshman, among five in the Tritons' lineup Tuesday, alongside three sophomores and junior Keegan DeMots behind the plate. Of 20 players on the roster, only four are upperclassmen. Thirteen are freshmen.

"They're a young team, for the most part," Gomez said. "Really young, so what they're doing all year is pretty impressive for such a young ball club.'

Pacifica Christian, which had out-tallied its first three postseason foes by a combined 38-6, was in command most of the way in this one. The hosts took a 3-0 lead in the third inning through No. 9 hitter DeMots' leadoff single, triples by Hayes and sophomore shortstop John Coopman's and sophomore left fielder Reed Fry's sacrifice fly.

That ought to have been enough, given Stone's precision on the mound. He'd allowed just one hit through 5 1/3 innings, with 46 of 58 pitches for strikes.

Then things went awry in the sixth. Miller dropped a throw from Hayes on what should have

been the second out, and Aiden Zuno followed with a single to right. Both runners moved up on a sacrifice bunt. Then Stone plunked Alexander De La Paz, and San Bernardino (15-5) had bases loaded.

Antonio Quintero ripped a triple to the wall in left-center and it was 3-3.

"At that point, I feel it's back to 0-0," said Stone (6-2), who ended up with a four-hitter, eight strikeouts and 66 strikes on 86 pitches and has a 0.88 ERA with 59 strikeouts and just five walks in 39 2/3 innings for the year. "This is where I start over and show them my stuff again."

He'd noticed that "the low outside corner was being called [for strikes]," hit his spots, and it led to the strikeouts and 10 grounders, two off them very high choppers that Hayes handled expertly, beating both runners by a step.

"He's a bulldog out there," said Gomez, who has Coopman (7-1, 0.56 ERA) ready for the final. "He pounds the zone all day long and hits spots, and it's a good recipe to be a solid pitcher."

Right-hander Zuno, who relieved struggling starter Shaun Bonds after successive walks to start the bottom of the second, retired the Tritons in the sixth, striking out the last two. The fourthseeded Cardinals made nothing from a one-out single in the seventh, and it looked like Pacifica

Christian wouldn't, either. Then Hayes, who is hitting .447,

stepped in. Along with that triple, he'd doubled twice, in the first and the fifth, stealing third base after both his 30th and 31st stolen bases of the season — but advancing no

further. He worked Zuno to a full count, berating himself after taking a strike down the middle, then popped the ball up not far beyond second base. Rikou Sasser raced in but couldn't reach it, and Hayes took second when it bounced over the center fielder's

"Blake has been doing [what he did today] all year," Gomez said. "He's the spark plug at the top of the lineup, [and] we knew if we could get him on base, we had a good chance."

With Escobedo stepping into the box, Hayes figured it was a done deal.

"I knew the game was over," he said. "He hit the ball hard all day, and eventually the [ball] is going to drop.'

Escobedo blistered the first pitch, a fastball down the middle. into the gap in left-center, and that was that.

"Phenomenal job on [Pacifica Christian's] side," said San Bernardino head coach Josh Doty, whose team was seeking its first Southern Section baseball final since winning the title 99 years ago. "There's a lot of sadness out here, and I think it's just because the trip's over for us, and we've had great time, a great experience. it's been a heck of a ride.

"To lose to a team that like that, very respectful and just a solid team, our hat's off to them. And now, of course, we hope they go take it."

and I'm really grateful now he's going to be in my backyard for a follow-up," Burns said. "This is not just a medical facility, it's a lifeline for our community, offering healing and support to those who need it most."

Guests heard music from the swing band of Johnny Kleker, 86, a longtime Huntington Beach resident and patient of Tchekmedyian. Additionally, local artist Melissa Murphy, better known as Melissa Murals, was on

site painting surfboards. One of Murphy's surfboard paintings will be hung in the facility in honor of former City of Hope employee Todd Lindquist, who worked closely with the nonprofit's facilities, design and construction teams at many City of Hope locations throughout Southern California.

Lindquist was diagnosed with esophageal cancer in November 2022 and died this past January, Walker

"He was an inspiration to everybody who worked on this project," Walker said. "While he did lose his battle, we know that Todd's contributions will continue to mean something for countless patients and their families who come through these doors."

Before she was done talking, Willahan told the ceremony attendees that her cancer "did not define" her. After years of fighting, she was told at City of Hope that she was a candidate for CAR T-cell therapy, which proved successful on the second attempt.

"My body had cancer. My brain, my heart and my soul didn't have cancer," Willahan said. "I did my best to live every day as well as I could, and that's exactly what I'm doing today, because of City of Hope.
