Rising costs set the Stand to shutter after 48 years

ongtime residents of Laguna Beach often cite a small-town feel they had grown accustomed to in the community, rich in charm and local flavor.

For its niche customer base, the Stand Natural Foods possessed those qualities, enabling the vegan eatery to have a lifespan that covered parts of six decades.

The last chance to order from the Stand's extensive menu may be in the coming days, as the walk-up restaurant is set to close on Sept. 5, following Labor Day weekend.

Alizabeth Arciniaga, the owner of the Stand, got emotional in discussing the decision to shutter the hangout, which Edward Brancard opened for business in 1975.

Financial factors have made it difficult for Arciniaga to keep the Stand, which is located in a barn-like property at 238 Thalia Street. Her hopes for a long-term lease went unanswered, and the rising cost of organic food contributed to the challenges of making ends

meet.
Since buying the business from Brancard

COVID cases climb in Orange County

While positive tests are increasing, health data show hospital stays due to coronvirus infection remain relatively low.

While state data indicate that COVID-19 testing in Orange County has declined, the positivity rates for those tests have made a steady upward trajectory since June — reflecting concerns made public in early August by the Orange County Health Care Agency.

County health officer Dr. Regina Chinsio-Kwong encouraged residents to take greater measures to protect those at risk: taking tests if they come into close contact with anyone infected with the virus, staying home if they are sick, wearing a mask in crowded spaces, continuing good hand and cough hygiene and staying up to date with vaccinations.

"Now is the time for everyone to reassess and implement mitigation strategies — especially for those who are or who work or live with at-risk individuals. Improving indoor ventilation and the use of face masks can offer protection and reduce transmission," Chinsio-Kwong said, as residents head into the start of the Labor Day

As of Thursday, the Orange County Health Care Agency reported 60 individuals in hospitals being treated for COVID-19, but Chinsio-Kwong said it would not be appropriate to characterize that as a spike in cases. Hospitalizations remain relatively low, even though admission of patients

continues to grow.

About 1,053 positive cases were reported this week to the county of the 6,696 tests reported. Three deaths related to COVID-19 were also recorded.

Numbers here mirror those in the rest of the state of California.

"The immunity is stronger today than at any other point in the outbreak," Dr. Mandy Cohen, the director of the U.S. Centers for Disease Control and Prevention,

Blind cabaret singer to join students with disabilities in concert

For vocalist, cabaret artist and disabilities advocate Marleena Barber — born legally blind due to a genetic condition called albinism that affects pigmentation and causes sensitivity to sunlight — music played a vital role on her personal journey toward self-acceptance.

And in "A Million Dreams," a Sept. 8 performance at Segerstrom Center for the Arts' Samueli Theater in Costa Mesa, Barber will bring her personal story to life in a song and spoken word concert benefiting the arts nonprofit's Studio D, which provides music, dance and theater education for children and adults with disabilities.

The event aims to support the programs of Studio D, which give those age 4 or older a chance to sing, dance, move and perform in

Pacific Airshow, lawsuits remain hot topics in Huntington Beach

The Pacific Airshow is less than a month from returning to Huntington Beach on Sept. 29. Though the U.S. Air Force Thunderbirds, Canadian Forces Snowbirds and other planes remain right on schedule, the event continues to be politically charged following the May settlement of a lawsuit against the city.

Åbout 100 people attended Huntington Beach Mayor Tony Strickland's monthly town hall meeting at the Senior Center on Wednesday night. Strickland, City Atty. Michael Gates, Visit

Huntington Beach CEO Kelly Miller and Visit HB chief marketing officer Omark Holmes gave remarks on the air show and its benefits before a question-and-answer period.

Strickland has laid claim to saving the show, with the settlement ensuring that Code Four CEO Kevin Elliott didn't take it elsewhere. The settlement, related to the cancellation of the final day of the 2021 Pacific Airshow due to a massive oil spill, calls for the city to pay Code 4 at least \$4,999,000 over the next six years, with an additional up to \$2 million possible if Huntington Beach recovers money in its own to-be-filed oil spill lawsuit against the alleged polluters.

"It's crystal clear to me, no settlement, no air show,' Strickland said Wednesday night. "When we talk about the numbers, the settlement, yes, is a little bit higher than I wanted it to be. But I will tell you, that pales in comparison to the value that we're going to have from this air show moving forward in perpetuity. The goal is that we have this air show every year in

perpetuity." Gates said the process of negotiating the settlement was long — about five months — and arduous. But two lawsuits related to the Pacific Airshow remain unresolved, though a judge ruled against former Mayor Connie Boardman and Mark Bixby in their attempt to stop the settlement payouts from occurring.

Gina Clayton-Tarvin, vice president of the Ocean View School District Board of Trustees, filed a lawsuit demanding Gates release the full settlement with Code Four. And though the city itself has settled with the Pacific Airshow, former Mayor Kim Carr remains a defendant in a pending

Both Clayton-Tarvin and Carr attended Wednesday night's meeting.

Gates said he has not released the full details of the settlement because attorneys representing the city in the pending, larger oil spill lawsuit advised him against it.

"It was my judgment that doing so would compromise the success of the city in that lawsuit," he said. "Under state law, I was not required to. There's an exception under the Public Records Act."

He reiterated that he would release the full settlement if a judge ordered him to do so.

"We're not hiding anything," Gates said. "We're trying to be careful and diligent toward the city. My job is to protect the best interests of the city, period." Gates and Strickland

both said that Code Four's Elliott did not donate to their 2022 election campaigns, though Code Four did produce a campaign event for the four eventual winning conservative City Council candidates prior to the election.

"I am a member of the State Bar of California," Gates said. "I could lose my entire livelihood over something like that."

But town hall attendee

Bill Nees, who identified himself as a 79-year-old retired attorney and U.S. Marine Corps veteran, questioned the settlement. He said he saw no evidence that the show cost \$21 million to put on, if the loss of a day was worth up to \$7 million.

"A lot of information was shared during confidential settlement negotiations,' Gates responded to Nees' comments. "I will say that their demands were on an order of magnitude much higher than it was settled

Resident Diane Bentley asked why the city wouldn't open the air show contract to a competitive bid.

"[Code Four has] done a remarkable job ... and why wouldn't we want to go with a company from Huntington Beach if we Strickland replied.

Strickland, who has about three months left in his stint as mayor, said that saving the air show would be at the top of his list of accomplishments. According to the 2022 Pacific Airshow economic impact report conducted by Destination Analysts, the show brought in a total direct economic impact of \$70.4 million spent by people coming from outside Surf City.

Carr, who was mayor in 2021, remains a party to the lawsuit, with the Pacific Airshow seeking unspecified damages and the city defending her.

An amended complaint submitted by Pacific Airshow lawyer Suoo Lee in late June alleges that Carr and former Interim Police Chief Julian Harvey halted the air show because of animosity toward Elliott and a "personal need for media attention, in furtherance of [Carr's] political career." Harvey is not named as a defendant in the lawsuit.

"If you read the amended complaint, it wasn't so much that [the air show] was canceled ... but how it was canceled," Gates said at the town hall.

Carr responded Thursday in a phone interview.

"My answer to him is that, oh, you saved the air show?" she said. "Well, we're not talking about that you saved the air show, but

Judge on sex case drops more charges

Prosecutors have 10 days to refile counts 'sufficiently' alleging charges against Dr. Grant Robicheau, Cerissa Riley.

Prosecutors were dealt another legal setback this week in the case against a Newport Beach hand surgeon and his girlfriend when an Orange County Superior Court judge granted a motion to dismiss charges alleging they drugged a

Orange County Superior Court Judge Michael Leversen, however. gave prosecutors with the Attorney General's Office 10 days to refile charges against Dr. Grant Robicheaux, who turned 43 on Monday, and Cerissa Riley, 36.

Prosecutors said they intend to do so. During a hearing Monday, Leversen granted a demurrer motion that dismisses felony counts of poisoning and sale of phencyclidine against Robicheaux and Riley, and a felony count of sale or transport of cocaine against Riley.

Robicheaux still faces four misdemeanor charges of possession of a controlled substance - psilocybin, Ecstasy, cocaine and GHB — as well as two felony counts of possession of an assault weapon. With the judge granting the demurrer, Riley no longer faces any charges. A demurrer is a legal move to dismiss charges based on an argument that there are not enough facts to support the allegations.

On July 7, Leversen gutted much of the case after a preliminary hearing, dismissing charges that the pair had drugged and assaulted two women.

Robicheaux's attorney, Philip Cohen, argued Monday that the

Fundraiser for Julian's Lego Corner at CHOC underway

Sgt. Pepperoni's Pizza Store on Friday is kicking off its ninth annual fundraising cycle for Julian's Lego Corner, which pays for Lego sets for patients undergoing treatment at the Children's Hospital of Orange County. The fund was created in memory of Julian Dunn, who died in 2013 at the age of 9.

"All of us at Sgt. Pepperoni's are proud to support Julian's Lego Corner and CHOC during Childhood Cancer Awareness Month," said Sgt. Pepperoni's Pizza Store co-owner Jeff Roberts in a statement on Wednesday. "We are grateful and very humbled to stand beside Julian's parents, Andrea and Rich Dunn, who have shown so much strength and love. What started as a lemonade stand by our kids, has grown to become very near to our hearts."

Last year, Sgt. Pepperoni raised about \$55,000 and collected 125 Lego kits. This year's goal is \$65,000 and hopes for hundreds more Lego sets.

said in a video briefing last week. "That means we're moving toward COVID-19 being a more manageable illness with less severe illness."

But those unvaccinated continue to face the greatest threat of severe illness. which grows riskier in older age groups and in those who have not yet experienced an infection. Underlying health conditions also play a major factor, and the

risk of developing long COVID remains persistent.

Subvariants of the Omicron variant of the coronavirus lead the infections in Orange County, and health officials are now on the lookout for another subvariant, BA.2.86, which scientists are calling Pirola. Few cases have been identified in the U.S. so far, but there are concerns it may be more capable of causing infection in those who have already had COVID-19.

James Toohey argued, however, that prosecutors met the three-year deadline for filing the case. The dispute is about when the clock began ticking on prosecuting the filed case, which dates back to 2018.

In issuing his decision, the judge said, "The real question I have in front of me is counts one through three and whether they're sufficiently alleged, and they're not. The demurrer is sustained. But I'll give you leave to amend and that has to be done in 10 days."

Deputy Attorney General Namita Patel told Leversen, 'Yes, your honor, we intend to file an amended information."

The attorneys will return to court Sept. 25 to consider another expected demurrer from defense attorneys.

The embattled case sparked headlines when it was filed, with then-Orange County Dist. Atty. Tony Rackauckas touting allegations that the reality TV personality Robicehaux

and his girlfriend lured women they met at Newport Beach bars, drugged their drinks and sexually assaulted the victims.

It turned into a political football when current Orange County Dist. Atty. Todd Spitzer was running to unseat Rackauckas, and Spitzer criticized his predecessor's handling of the

Spitzer as a candidate questioned why Rackauckas waited as long as he did to file charges. After ordering a review of the case when he was elected the county's top prosecutor, Spitzer moved to drop the case. But when one of the alleged victims objected in court, that move was denied, and Spitzer's office was eventually thrown off the case.

After the Attorney General's Office took over, the case was pared down. What began as a case that included a total of 13 accusers was eventually boiled down to two victims.

One of the judges involved in the case recused himself because he foresaw a potential conflict of interest. Another judge backed out of the case when his temperament was questioned by defense attorneys, and another judge died while overseeing it.

The defense attorneys failed in earlier attempts to have the case dismissed based on arguments of outrageous governmental conduct and defects in an original search warrant.

Patel indicated in court Monday that prosecutors are discussing a possible settlement with defense attorneys.

in 2015, Arciniaga had also picked up work in the mortgage industry to help navigate through the light foot-traffic winters of a beach town. The timing of the decision comes in advance of another upcoming off season.

"I've worked for various mortgage companies because I had to because the Stand cannot cover the expenses in the winter,' Arciniaga said. "You go into debt in the winter. ... Laguna, it's a tourist town, and for a business like us, we depend on the tourists and the locals.'

As the end nears, Arciniaga has thought back to how it all began. As a freshman at Laguna Beach High, she wanted to go to the Sadie Hawkins dance and needed some money to pay for the outing. Alfredo Arciniaga, her father and a plein air painter who exhibited at the Festival of Arts and the Sawdust Festival, suggested she see if the Stand was hiring to make her dream come true.

Arciniaga, 1982 graduate of Laguna Beach High, got a job after demonstrating to Brancard's then-girlfriend, Cindy Constantine, that she could cut carrots.

"Whenever I was in Laguna Beach, I would always come to the Stand," Arciniaga said. "I feel like that's what everybody does. If you're anywhere near Laguna and you've eaten here before, something just draws you back. Even when you walk up, you smell the smells of the Stand. ... We get people all the time that are like, 'I came here 10 years ago,' ... 'I came here 30 years ago.' It's just that kind of place.'

And what did people come back for? Arciniaga suspects it's the romanticized model of making their offerings from scratch, an old-school style she likened to "the way your grandma used to" get things done in the kitchen. That has included freshsqueezed apple and orange

juices and nut milk made in house. The soft-serve was made exclusively from fruit. Arciniaga condensed the menu, but added acai bowls during her time in

The Stand provided a first job to many community teenagers, including Arciniaga and Leslie Lance, a former manager of the eatery. The interior of the Stand almost demanded that its team members form close bonds, the intimate kitchen and narrow hallway leading back to the refrigerator affording little chance to take a break from each other throughout the

A 1983 graduate of Laguna Beach High, Lance worked weekends at the Stand with Arciniaga when she was in school, before returning later under the latter's leadership.

"It was a great experience for me," said Lance, who added that the Stand was a place where its workers learned necessary life skills. 'Those girls took me under their wing when I was that young and just nurtured

Looking back, Lance recalled Laguna Beach as a place that was home to artists, hippies and surfers. The Stand became a local landmark to a loyal base.

"I want to say that the hippies really kind of were the stronghold for the base," Lance said. "Obviously, you need a strong base of your community

for any restaurant or business to grow and continue flourishing. I know that over the years, back in the 1990s, that's when the tapestry kind of changed here in Laguna.'

Arciniaga has left a goodbye message for fans of the Stand on its Instagram page. It includes a video of her with Brancard after she bought the business.

"Thank you to everyone that has supported us during the last 48 years," the post said. "It has been a groovy and amazing time! As heartbreaking as saying goodbye is, we are so grateful for all of the wonderful memories.'




