

Cherry Blossom Festival blooms once again in H.B.

The last Orange County Cherry Blossom Festival brought an estimated 70,000 visitors to Central Park in Huntington Beach.

Big crowds came to the celebration honoring Japanese and Japanese American culture. "All of the food trucks ran out

of food," said Carmen Erber of the Huntington Beach Sister City Assn. with a laugh. "They were selling the rubber off the tires."

Patrons have had to wait for an encore, but the free event returns to Central Park this weekend.

This is the first Orange County Cherry Blossom Festival since

2019, as the traditionally annual affair was canceled the last three years due to the coronavirus pandemic.

Local creative agency Code Four returns to put on the event, which runs Friday from 5 to 10 p.m., Saturday from 10 a.m. to 10 p.m. and Sunday from 10 a.m. to

"We're really excited to be able to bring it back this year," Code Four marketing manager Taylor Donahue said. "A lot of people have been showing a positive reinforcement, so it makes it even better. We're trying different

Laguna officials reflect during State of the City

A crowd a couple hundred strong packed into a conference room at the Montage Laguna Beach Tuesday to mix and mingle before listening to the State of the City address.

In the first such event since Gov. Gavin Newsom declared an end to the state of emergency with respect to the coronavirus pandemic, Mayor Bob Whalen looked back on navigating that period in his remarks, calling the business of the city "impactful" in that time.

Whalen, who was mayor at the outset of the pandemic, recounted the beach closures and tightened rules on local businesses, but he noted that compliance yielded results.

"According to data compiled by the Orange County health de-

Costa Mesa's Orange County fairgrounds will transform this weekend into a playland with a purpose as Imaginology — an interactive festival focused on science, technology, engineering, art and math - STEAMs back into action.

More than 20,000 visitors came to the site last year to take part in hands-on science demonstrations, art activities and maker projects provided by more than 100 exhibitors during the free, two-day event.

Kids learned the science behind bubble-making, sharpened their wits on a larger-than-life chess set, played with robots, held baby chicks and made their own terrariums to take home,

among other activities.

Orange County Fair & Event Center Chief Executive Michele Richards explained that, since 1989, organizers had produced a Youth Expo designed to showcase items created by kids of all ages in a competition format similar to the O.C. Fair.

When attendance began to fall off, organizers sat down and reimagined the festival as a place where participants could learn, play and explore different possibilities within the STEAM fields.

We wanted kids of all ages to come to the event and do all kinds of hands-on activities in those fields and learn how their passions might turn into ca-

Man suspected of trashing Laguna car dealership

A man in a stolen Polestar led police in a pursuit before he was arrested in Newport Beach and is suspected of trashing the Laguna Beach dealership the vehicle was taken from on

Officers were summoned "during the early morning hours" to a burglary in progress at Polestar South Coast's Laguna Beach location at 305 N. Pacific Coast Hwy., according to a news release issued Saturday by Police Chief Jeff Calvert of the Laguna Beach Police Department.

A glass wall and brick retaining wall had been destroyed when they arrived, according to the release, and several vehicles in the showroom had been vandalized. One was stolen.

The missing vehicle was later spotted in Newport Beach. Its driver was arrested after leading police in a pursuit.

Arshad Allauddin, 41, of in custody in lieu of

partment, the city of Laguna Beach had the lowest per capita COVID death rate of any city in the county," Whalen said to a round of applause. "Clearly, there were some socioeconomic factors in play here, but I know that our approach as a city contributed in a significant way to that favorable outcome. Our number one priority always is to protect the health and safety of our residents and visitors, and I believe we did an excellent job with that throughout the last three

Another highlight of the pandemic response included allowing more outdoor dining, leading to the Promenade on Forest. The city is continuing to pursue making the Promenade a permanent fixture, Whalen said.

The mayor also revisited the \$1.4 million put forth for the "LB Cares" program that provided financial support for businesses and the community.

City acquisitions were a focus of the address, including the purchase of the library and the takeover of South Laguna beaches from the county, as well as the deal with the Diocese of Orange for the former St. Catherine of Siena school property that is being converted into the new Laguna Beach Community and Recreation Center.

In her update, City Manager Shohreh Dupuis detailed some public safety changes, while also providing a moment of levity in poking fun at herself. She spoke to the creation of a neighborhood enhancement team to focus on quality-of-life issues, as well as a traffic division within the police depart-

ment. "We used to have a position called beach patrol officers, and they really didn't have a lot of responsibility as to how they could enforce regulations,' Dupuis said. "We converted that position to what we call a park ranger position, and we're going to, by this summer, have seven park rangers, and their main duty is to work through the neighborhoods, on our beaches and our parks to make sure that people are not engag-

ing in bad behavior. "We also created a traffic division for the first time. ... Currently, we have two motor officers that enforce speeding, loud vehicle noises, and all sorts of public-safety issues. We're going to increase our motor officers to four motor officers by this summer, and they're going to be focusing on traffic violations, so make sure if you're driving through town, you're

not speeding, and you're

also not using your cellphone," Dupuis said, alluding to a traffic ticket she received last fall for speaking into her phone while behind the wheel.

The event was attended by 225 people, said Erin Slattery, chief executive of the Laguna Beach Chamber of Commerce. The attendees were given the opportunity to write down questions to be answered by city department heads at the end of the program. Assistant City Manager Gavin Curran addressed future long-term uses of the community and recreation center.

"For the long-term plans, it's going to be part of a facilities master plan," Curran said. "A facility master plan really looks at all our city facilities, how we're going to modernize those facilities, and how we can provide services at those facilities right now and well into the future.

"We have a City Council subcommittee looking at a scope of services for that master plan, and that will be coming back to the City Council in May," Curran said. "I do know there have been some suggestions for the long-term use at the property, which include a community pool, a cultural arts center, some additional parking and a permanent skateboard park."

Oilers earn Sunset League split against Vikings

Huntington Beach and Marina were battling through a tight, emotional encounter Friday afternoon, a game of punch and counterpunch with the young, upstart Vikings twice surging ahead of their host and its superstar pitcher and hitter, then falling behind by a run in a Sunset League softball showdown carrying championship implications.

Up steps Zoe Prystajko, and boom.

Game over.

Prvstaiko's three-run, fourth-inning bomb over the solar panels behind the second left-field fence the fence 30 or so feet beyond the outfield fence pushed Huntington Beach's lead to five runs, and that was that. The Oilers, claiming their fourth win in as many days, cruised to a 9-4 triumph behind their Stanford-bound standout, who went four for four, struck out a dozen and surrendered just two earned runs.

It turns the title chase into a two-team race between Huntington Beach (13-4, 7-1), No. 7 in the CIF Southern Section's Division 1 rankings, and softball archrival Los Alamitos (16-2, 6-0), which sits atop the poll. Whether that's really so is up for debate, but the teams face off April 18 on the Oilers' diamond and a week later at Los Alamitos, and a whole lot of things would have to slip into place if something else is going to determine the champion.

What will make the difference for Huntington Beach?

"Hitting," said Huntington Beach coach Jeff Forsberg, whose group had 13 hits against Marina (17-6, 5-3). "Our pitching's going to keep us in the game. I think it's our hitting [that'll decide things for us]."

How about the Griffins' hitting? Forsberg smiles.

"I've got Zoe."

Prystajko, the Daily Pilot
Softball Player of the Year
and an All-CIF selection last
season, is the centerpiece of
a talented and powerful Oilers lineup, a big junior lefthander who bats right and
dominates in the circle and
at the plate. She showed
that off Wednesday, certainly with her bat, catching

the left-field line with a twoout single in the bottom of the first inning; starting the three-run, go-ahead march in the third inning with a one-out single, the first of three successive hits (and four in five at-bats); bashing that mammoth homer in the fourth; then going to right field to set the table for the final run in the sixth.

The game turned when Prystajko found her rhythm in the circle, honed in on sophomore catcher Abcde Ornelas' glove and struck out the side in the top of the fourth inning on 11 pitches. Ten minutes later, Prystajko hit her seventh home run of the season into the parking

lot.

Macy Fuller worked a full-count walk off Marina freshman right-hander Mia Valbuena to start the bottom of the fourth, stole second base, then beat the throw home for a 5-3 Oilers lead as senior center fielder Sophia Knight took an extra base on a bloop single to left.

Valbuena then hit sophomore left fielder Morgan Drotter, and up stepped Prystajko. She took a strike, then launched the next pitch where nobody — not in a game, according to Forsberg — has gone before.

"She got all of that one.

Zoe over the solar panels? That was a shot," Forsberg said. "Zoe's Zoe. She's one of those kids, she's very cerebral and she was on a mission. You just get out of her way."

It might have traveled 300 feet. Nobody measured, and Prystajko didn't stop to watch.

"I was just looking for a pitch to drive," she said. "They weren't giving much, but I was sitting on that pitch and waiting for it. ... [I've cleared the panels] in practice, but never in a game. It felt good off the bat, but I wasn't looking [to see where it landed]."

Said Marina co-coach Dan Hay: "One of the longest home runs I've ever seen hit. Ever."

It brought about the Vikings' fourth straight onfield loss after a 17-1 start — they also took an 8-0 forfeit against Huntington Beach after declining to play a league opponent in the third-place game of the Michelle Carew Classic — greatly diminishing their title possibilities.

"It could [knock us out]," Marina co-coach Shelly Luth said. "It would take somebody else to beat one of these guys."

That someone could be Edison (12-9, 3-3), which played Huntington Beach tight in a 2-0 loss April 4 and pulled out a 4-2 win over Marina Thursday, but dropped an 8-1 decision Friday against Los Alamitos.

Marina looked good in the first three innings against the Oilers.

The Vikings got runners to second and third in the

first inning then pushed home an unearned run in the second on singles by Rylee Gonzalez and sophomore right fielder Liz Byer, a passed ball and a run-scoring groundout by junior second baseman Coral Piramo

They added two more runs in the third, one unearned, on successive singles by Rachel Ruiz, Makayla Mathis and Anaya Togia and a passed ball.

Huntington Beach answered each punch, scoring in the second on Marina transfer Liah Lummus' double and taking a 4-3 lead in the third as Prystajko, sophomore first baseman Tea Gutierrez and Long singled with no one out and two came home, one after a throw went awry, on a one-out single by Saige Anderson.

Prystajko was in command before the third inning was done and retired 12 of the 14 batters she faced through the sixth inning, eight on strikeouts. Both teams added late runs — Huntington Beach on a sixth-inning Gutierrez single and Marina with a walk, two singles and a Togia sacrifice-fly in the seventh.

"I think as innings go on, you get more used to the umpire's zone, the batters, the pitches they can or can't hit," said Prystajko, whose riseball was particularly effective. "It's good going through [struggles] and knowing that it's only going to get better [as the game proceeds]."
