Crisis averted, relocated animals brought home

BY MATT SZABO

Coastal Orange County residents took precautions Saturday before Tropical Storm Hilary rolled in, but they weren't the only ones who were potentially in harm's way.

The Huntington Beachbased nonprofit Wetlands & Wildlife Care Center sprung into action to protect creatures that couldn't necessarily help themselves.

The center's executive director, Debbie McGuire, said about 1,000 animals were temporarily relocated due to concerns that Hilary would bring flooding and other damage.

After the storm passed through Sunday night, Mc-Guire and her staff began the task of getting those animals back to the center.

Beach cities largely escape Hilary's wrath

Around town in Laguna Beach, businesses and the city took precautions in preparation for the tropical storm barreling its way north over the weekend.

Laguna Beach had announced that all three of its art festivals would be closed on Sunday and Monday. Exhibiting artists took their work home with them, protecting

parts of the state, helped the cities in the Daily Pilot's coverage area — particularly low-lying Laguna Beach, Newport Beach and Huntington Beach — escape major damages.

"August is a generally dry month for Southern California, and this tropical storm has smashed a lot of rain records," Mark Moede, of the National Weather Service in San Diego, said Tuesday.

Huntington Beach paced the area, seeing 2.4 inches of rainfall during the storm, according to data collected by Orange County Public Works. Costa Mesa received 2.13 inches of rain, Laguna Beach had 2.01 inches, and Newport Coast had 1.89 inches. The area typically sees only trace amounts of rainfall in August.

Flood-prone Pacific Coast Highway in Huntington Beach was closed between Warner Avenue and Seapoint Street as the deluge began. The northbound lanes were reopened by 11 a.m. Monday, with the southbound lanes following later in the afternoon.

Huntington Beach public affairs manager Jennifer Carey said damage was minimal in Surf City.

"We have reports of a few down trees, and there were

just a couple down power line calls that came in," Carey said. "Nothing major. A few spots of localized flooding, but for the most part we didn't see anything significant. We think a lot of that is due to the community's efforts in being as prepared as possible, making sure that they had sandbags to avoid any flooding around their residence and also taking into consideration the winds and bringing items indoors. A lot of people did their best to prepare as much as they could."

In a text Monday, Newport Beach spokesman John Pope said there were no major incidents in his city, either. While there was

some localized flooding and a handful of felled trees and branches, it was nothing out of the ordinary compared to a typical winter storm, Pope said.

Reviewing the storm for the Laguna Beach City Council this week, staffers said the public works department provided more than 1,000 prefilled sandbags to help mitigate the potential impact of the storm. The communications team sent out eight storm-related Nixle alerts to the community. By 7 a.m. Sunday, as the storm was still classified as a hurricane and barreling northbound over Baja California, La-

their creations from the expected deluge.

It proved a wise move. Art-A-Fair officials returned Monday to find that the storm had ripped through the sunshade at the venue.

Kim Brandon-Watson, the vice president of marketing for Art-A-Fair, said the festival would not be able to reopen on Tuesday as planned, adding that the hope was that it would welcome back patrons this weekend. "So many artists came on

their own just to check out what's happening, and then helping clean up because there was mud and stuff all Brandon-Watson over." said in a phone interview Monday. "Everybody's coming together. We're going to try to fix the tarps. They're ripped, but I ordered some new ones that aren't to the quality, but at least get some in [Tuesday], and we might be able to patch something together. Half the show's OK. The other half isn't."

The summer art festival season is rapidly coming to an end. Art-A-Fair plans to offer free admission to the grounds for the time re-



sion, even as the festival is set to lose a week's worth of visitors. "We're going to patch-

work these tarps up," Brandon-Watson said. "There's going to be a few empty booths compared to [being] full. We just figured that's what we need to do to make up, also, for the week that we're going to have lost."

Sharbie Higuchi, director of marketing and public relations for the Festival of Arts, said the festival utilized various communication channels to notify the public of the closure.

Artwork brought by the exhibitors was removed from the grounds, and team members worked to cover all electrical equipment on site.

"As the recent tropical storm threatened coastal community, the Festival of Arts and Pageant of the Masters took swift and comprehensive measures to safeguard our exhibits," events and Higuchi wrote in an email. "The priority was to ensure the safety of attendees, volunteers, artists and staff, as well as to protect Festival

To accomplish the task, McGuire rented a U-Haul van. Then, with the help of another van, crates of ducks were transported back to the care center on Pacific Coast Highway.

"I think we got very fortunate that we didn't have a direct hit [from the storm]," McGuire said, adding that there was minor damage to the center, including an outside triage tent that came apart and an outside flight cage that was damaged. "[The storm] changed a little bit and went a little bit more east. But at the time, we had to make the decision [to evacuate the center] because it takes so long to make an effort like that. We had to make it then, so we did."

The Wetlands & Wildlife Care Center also partnered with the International Bird Rescue in San Pedro, which took in all of the seabirds and medical cases. The California Wildlife Center in Calabasas took some of the song birds, mourning doves and all of the raptors.

A wildlife center up in Santa Barbara took 30 ducks, four geese and four raccoons, McGuire said.

"All of these organizations came through big time in our time of need,' she said, adding that all of the animals were expected to be back in Huntington Beach by Wednesday.

Additionally, those birds that could fly were released on Saturday morning ahead of the storm, after talking to wildlife veterinarians and the California Department of Fish and Wildlife.

"They felt that was the best chance for those birds," McGuire said. "They feel the barometric change, and they know to leave. A lot of ducks went, gulls,

pelicans, egrets, herons."

McGuire said that some birds and other animals like opossums, which had to be fed every 30 minutes, went home with volunteers over the weekend for care.

Santa Ana Zoo manager Ethan Fisher said the zoo has helped with evacuations several times in recent years, including three Orange County Zoo evacuations due to wildfires.

"We're getting a little bit better at this than we would like," Fisher said. "We work together. We're operated by the city of Santa Ana, and even our parks director was here on Saturday and brought in some help from parks and recreation with a van. It was just such a time crunch to get them out of there, so whatever resources we could bring to help out the situation, we wanted to be supportive."

exhibitors' artworks, and mitigate potential damage. Thanks to these proactive steps, the impact was minimal, leaving us with little more than debris and leaves to contend with and some water runoff across the grounds."

The Festival of Arts' Runway Fashion Show was postponed from its scheduled date on Sunday to the following Sunday, Aug. 27, at noon. Art classes in the festival's Art Center for that date were also rescheduled for this Sun-

"This decision was not made lightly and was based on information provided by the National Weather Service and local authorities," David Perry, president of the Festival of Arts, said of the two-day closure in a statement. "Our priority is to provide a remarkable and safe experience for everyone, and appreciate understanding and cooperation of our patrons, volunteers, artists and participants.'

Hilary did cut short a planned three-day weekend fundraiser to provide aid following the wildfires in Hawaii. The "Spirit of Aloha" event had been scheduled to run last Friday through Sunday at the Sawdust Art Festival, which also has two weeks left in its summer show. The grounds closed Sunday and reopened Tuesday.



guna Beach's emergency operations center had opened.

"Our marine safety team ensured vulnerable lifeguard towers were moved and secured well before the storm," said Brendan Manning, the city's emergency coordinator. operations 'They had a plan in place to close the city beaches if that became necessary. [They] ended up closing the Aliso Beach parking lots out of an abundance of caution. [They] staffed additional marine safety personnel for the anticipated large surf. In addition to lifeguard coverage for the beach, we also staffed floodwater response units, just in case.

"Throughout the storm, they closely monitored the beaches and beach access points, and at one point had to temporarily close Thousand Steps 9th [Avenue] stair access due to some pretty significant storm runoff down the stairwell to ensure public safety.'

Laguna Mayor Bob Whalen thanked everyone involved in the tropical storm mitigation efforts.

"Hopefully, we don't have to do this too often, but it gave me a lot of confidence to see how prepared we are, and how hard you all work, and how coordinated you are across departments," Whalen told the staff. "I think we can all feel good as a community that when these types of emergencies come forward, we may not see much of it, but there's a lot going on in the background and great work.'

HIGH WINDS

Hilary brought with her the predicted high winds and caused some power

outages, but the gusts arrived later than expected, according to meteorologist Moede. Initial projections suggested winds would reach about 40 mph in local cities on Sunday.

At Newport Pier, close to midnight on Sunday, winds clocked in at 43 mph. Earlier in the evening, at 7 p.m., Huntington Beach Pier showed gusts of 47 mph, according to the National Weather Service station in San Diego.

As residents have commented on social media, the storm didn't seem nearly as bad as they had braced for based on media reports. That, Moede said, was likely due to confusion in the messaging.

"[The tropical played out pretty much as we forecast. I think for Orange County, and all areas west of the mountains, the messaging that we were getting out through the headlines from social media, television and all the sources that people typically get their news from, was that there was a tropical storm. Hurricane Hilary was moving up into Southern California, with the potential to bring catastrophic

flooding, so we better prepare for this," Moede said. "But the actual messaging that we sent out was that the likelihood for flooding was going to be in the mountains and the des-

On Sunday afternoon people were found venturing out into the beach cities, some to take advantage of favorable surfing conditions — especially at Newport Beach's famed Wedge and others to see for themselves what effect Hilary was having on the community. They generally shrugged off any fear for what the storm might bring overnight.

Dan Barabas, a New Jersey native, was visiting Laguna Beach with family. He said the trip had been planned for a few months, and they were dismayed to see some businesses buttoned up for the duration.

We're not going to let this little drizzle ruin our day," Barabas said. "We've been kind of horrified by how closed everything is because this isn't much of a storm so far."

dou and Nikki Syreeta, an intimacy coordinator on the Peacock show, "Bel-Air."

"I'm thrilled to have the three of them there," Rhone said. "We might add one or two more people, but because of the [Writers Guild of America] strike rules, I think actors and writers are not allowed to do festivals right now."
