Celebration to look back at Laguna's gay bar scene

A Pride event Saturday evening at Laguna Art Museum will feature a documentary on the fight to save the Boom Boom Room, followed by a dance party.

The beats of the old Boom Boom Room once dropped it right into the hearts of the gay community in Laguna Beach.

Those who can remember the old ways will look to relive their glory days through

an event Saturday evening at Laguna Art

"LAM goes BOOM: A Pride Celebration," will honor the history of the Boom Boom Room, including its place as a haven for the LGBTQ+ community stretching back to the 1970s and the unsuccessful but impassioned fight to save the bar some 15 years ago.

The event will feature a screening of "Saving the Boom," a documentary film by local activist Fred Karger focusing on the community's efforts to keep the Boom Boom Room as it was.

Stories told in the documentary include those of gathering signatures exclusively in the city for a petition brought before the Laguna Beach City Council. Those signatures were delivered in a wheelbarrow for dramatic effect. There was also an open casting call for a spicy calendar shoot of the hottest men in town.

Mike Johnson, a trustee for the museum, said the Boom Boom Room was the first LGBTQ+ establishment that he worked up the courage to walk into as he was coming

Huntington Beach leaders talk strategy in 4-hour workshop

Before tackling important city issues like homelessness, public safety and infrastructure, Huntington Beach City Council members had some fun Thursday morning.

A strategic planning workshop at Huntington Beach Central Library started with an icebreaker exercise designed to find common ground. The city leaders talked to their colleagues to discover non-workrelated things they had in com-

mon with each other.

Mayor Tony Strickland found out that Councilwoman Natalie Moser is really good friends with his college girlfriend. Colleagues laughed.

"Why aren't you still with that girl?" someone asked.

"She's married," Moser quickly replied with a smile.

So is Strickland. But love — or at least consensus — has not always been common in the first six-plus months of the cur-

Fence at Harper Park blocks public

City, school district officials field questions about new fence around property that went up without an explanation.

Regular users of Costa Mesa's Harper Park — a pocket park on a Newport Mesa Unified School District campus for special education students — were recently startled to discover a fence blocking entry to the property's wide open fields.

With no clear access provided, residents could no longer bring their children to play tag or fly kites on its grassy expanse. Dogs could no longer roam and sniff the perimeters of its mature oak trees.

Nearby resident Jenn Tanaka said while there's not much to the 1-acre park, it's popular among those who know of its existence, precisely for the roominess of the adjacent fields.

"Most of the time it's empty, so people love going to this park," she said in an interview Tuesday. "It's actually one of the few places in the [city's] east side where you have access to big, unstructured space."

Signs posted on the temporary chain-link fence inform visitors that the area is a "closed off campus" and warn against trespassing, skateboarding, biking and the presence of dogs but give no reason for the closure.

Tanaka, an attorney who serves on two city committees and involves herself in civic matters related to safe streets, parks and housing, set out to find why the area was no longer open to the public.

She reached out to Mayor Pro Tem Jeff Harlan, who represents

Wooden boat festival returns to Balboa Yacht Club after 3-year hiatus

The Newport Beach Wooden Boat Festival is back.

The festival, which started in 2014 under the direction of the late Ralph Rodheim, who died in 2017, is returning this weekend to the Balboa Yacht Club following a three-year hiatus. Organizers said the break was primarily caused by the pandemic.

"About November 2021, we got together and we said, 'Are we going to host this event, a public event in the summer of 2022?' At that point, we all, at least in my circles, were fearing a resurgence to COVID. I remember people were having Christmas parties and getting COVID shamed," David LaMontagne, event chairman, said in a recent interview. "I was sitting there and talking with

the commodore at that time, 'We got a lot going on. And to sit here and predict out eight months from now that COVID is going to be over, I can't do that.'"

LaMontagne said there was just

LaMontagne said there was just no sure way to know at the time. So, the 2022 event was canceled, just as it had been the previous two years in a row.

By the time planning started for this year's wooden boat festival in January, the situation was different and organizers decided to proceed with plans to relaunch the event. The festival will be at the Balboa Yacht Club and spans Friday through Sunday, though the only day the public will be able to attend is on Saturday, from 10 a.m. to 5:30 p.m. at a general admission cost of \$10.

Woman gets 15 to life for DUI fatality

39-year-old woman pleaded guilty Wednesday and was sentenced to 15 years to life in prison for a drunken driving collision that killed a 23-year-old man in Costa Mesa five years ago.

Kimberly Renee Martin pleaded guilty through tears to second-degree murder in the May 1, 2018, crash that killed Enrique Orlando Marquez.

"If I could change anything I would change everything," Martin said, sobbing.

mother, The victim's Barenice, told Orange County Superior Court Judge Sheila Hanson through an interpreter that her family is "still processing this. I've never in my life experienced such great pain. The first months were terrible."

The victim's mother said her son regularly attended Sunday services at their church and would play drums.

This has been the great challenge of my life to not hear the drum sticks anymore," she said. "He faithfully served at church every Sunday."

The victim's mother told the defendant she was "grateful to the Lord because you have taken responsibility for your actions. I am committed to pray for you and your family so you can find peace and

Hanson said, "There are no winners today.'

The judge noted the victim's family "lost someone so important," but added in reference to the defendant's family at the hearing, "Look behind you. I see so many in pain."

Martin's attorney, Randall Bethune, said his client has served as a dog trainer through a program while in custody and that another attorney in the Public Defender's Office adopted one of the dogs she trained. Martin also earned "numerous" certificates while in custody for various other programs.

Martin was given credit for 1,864 days already served behind bars.

Martin, who had a blood-alcohol content of 0.16, which is twice the legal limit, was driving 70 mph and flashed through a red light when she crashed her Volkswagen Tiguan SUV into a Honda at Mesa Drive and Santa Ana

Avenue about 12:20 a.m. May 1, 2018.

A neighbor who heard the collision dashed out of his home, saw the smoldering SUV and dragged Martin out while her boyfriend jumped out of the passenger seat and ran away, police said in Martin's preliminary hearing.

Newport Beach Animal Shelter named one of state's nonprofits of the year

The Friends of the Newport Beach Animal Shelter is getting some recognition from the state as it was honored Wednesday as one of California's nonprofits of the year at the nomination of Assemblywoman Diane Dixon.

The nonprofit was honored as part of the Nonprofit of the Year initiative, through which state legislators choose nonprofits they feel are doing outstanding work in their district.

FONBAS was formed in 2017 to not only establish Newport Beach's first permanent animal shelter but to help provide the more expensive veterinary care necessary to make some of their furry charges more viable for adoption.

\$2.9-million The opened in late May and was gifted to the city in December. The city is responsible for managing, operating and maintaining the building. The city's animal control department operates the shelter. The shelter is no-kill, and Dixon, through a representative at the opening, said the shelter was a "remarkable" story that came about because a city cared about its animals.

"Assisting our seniors, educating our children, protecting the environment, caring for animals — this is the work nonprofits do and do well," Dixon said in a statement announcing the honor. "I am proud to present California Nonprofit of the Year to FONBAS to acknowledge their part in mak-

ing a collective impact with other nonprofits in Assembly District 72 and across the State of Califor-

FONBAS Board President Jon Langford and Newport Beach Councilwoman Robyn Grant went to Sacramento on Wednesday to receive the recognition. Langford, in a statement, said that though the shelter's building is complete, the nonprofit's work isn't done. FONBAS will continue to work toward "healthcare beyond the scope of a typical city" for animals at the shelter, Langford said.

"The public-private partnership between FONBAS and the city is a remarkable example of the impact nonprofits can have in a community," said Grant, who is also a board member of the Friends of the Newport Beach Animal Shelter. "In this case, the partnership was funded entirely by private resources with the city as a recipient of valuable permanent amenities and infrastructure that benefit the community."

O.C. Press Club honors late journalist Fred Swegles

The Orange County Press Club Board of Directors announced Friday the group will posthumously recognize Fred Swegles with the 2023 Sky Dunlap Award at the 2023 Excellence in Journalism Awards at 6 p.m. on June 15 at Anaheim Hills Golf Course.

The award is the Press Club's highest honor and will be presented in conjunction with its "In Memorium" tribute to recently deceased journalists, which also includes baseball writer Jean Hastings Ardell and Los Angeles Times reporter Greg Yee.

Swegles died on Oct. 23, 2022, after suffering health complications because of a brain tumor. He was 74. His work spanned more than 50 years, having previously reported for the Daily Sun-Post and Orange County Register. He launched his CoastLines column with San Clemente Times five years ago.

"Fred Swegles is an institution in Orange County journalism. His tireless efforts over five decades to cover his beloved hometown of San Clemente are a testament to the impact one journalist can have on their readers. Our board's decision to honor Fred was unanimous and we sincerely wish it had arrived before his passing," said Daniel Langhorne, president of Orange County Press Club.

out. He had parked outside the bar a couple of times, but when he finally went in, it made him "comfortable."

"Definitely, I found as I frequented the bar more that it wasn't just a place for men and women to cruise and pick up," Johnson reminisced. "It was a place for socializing. It was a place that, I think, was pretty cathartic for a lot of people as a gathering place, and I think that's evidenced by the memory garden that's on the bluff just below."

Johnson was making reference to the Garden of Peace and Love, a spot that largely came to memorialize those who fell victim to AIDS among the coastal city's LGBTQ+ community.

Following the film, the museum will come to life, as attendees will be welcomed to dance the night away to the tunes spun by DJ SoulFire. Admission to the event, which runs from 6 to 9 p.m., is \$20 for museum members and \$35 for the general public.

"The museum has been here for over 100 years now, and it's always kind of been a place that the gay community can come to," Daniel Stachowski, public programs coordinator for the museum, said. "In the 1980s, we had a fundraiser for the AIDS crisis, and we're continuing that legacy of being supportive for the LGBTQ+ community by having these pride events here in Laguna, which was for the longest time a safe haven for the gay community to come and be who they are.

"Now, all those bars that were so famous are all gone, and there's no real place for the community to gather, especially during Pride Month. By having these kinds of celebrations, it's paying homage to Laguna's past, but also offering a safe place for LGBTQ+ members and the allies that support them."

her district on the council, but he hadn't heard of the fence. Same with Krista Weigand, the NMUSD trustee for her area.

Eventually, Tanaka learned from Costa Mesa's Parks and Community Services director that the school district had, indeed, contacted the city about its plan and was doing some sort of pilot pro-

"I believe staff was aware Newport-Mesa was going to do this, and I'd like to know why they didn't bring it to any elected officials who could bring it to the public," she said.

NMUSD spokeswoman Annette Franco clarified Thursday the entire property belongs to the district, which has granted the city an easement to operate the playground and pocket park. Field space is used by students at the district's Harper Assessment Center and a charter school that leases space there.

'The temporary fence

between the park and our school fields was installed to improve safety conditions for students," she wrote in an email. "This allows students to have a dedicated outdoor space that separates them from the public that utilizes the public park during school hours.'

Although the remaining acreage is not technically for use by the public, Franco said, neighbors may still access the fields during non-school hours (9 a.m. to 6 p.m. on weekdays) and on days when school is not in session.

Entry is available at the front of the school along 18th Street but not directly from the park, whose entrance is at Tustin Avenue.

Franco said the district reached out to the city about the fence and is continuing to work with staff about how to best meet the needs of every-

That fact was confirmed by City Manager Lori Ann Farrell Harrison during a City Council meeting Tuesday, after Tanaka shared her and neighbors' concerns in a public comment and some council members supported removing the fence.

"I am working with the mayor and Mayor Pro Tem Harlan on the issue but also with Wes Smith, the superintendent," she said. "We didn't put the fence up, and it's not our fence to take down. However, they're open to a conversation."

Harlan said the city could have done more to inform residents about what was happening at the site and called what happened "an epic fail."

'It's a failure of communication, a failure of implementation and a failure of accountability," he added. "I know we as a city can do better. It can be corrected, and I'm expecting that to be done quickly.

Tanaka said few people come to the park since the fences were installed less than a month ago. She'd like to see that change.

"I think people are just not coming anymore," she added. "To me, that's a shame."

rent City Council, which has seen a lot of 4-3 votes on key issues. Strickland, Mayor Pro Tem Gracev Van Der Mark, Casey McKeon and Pat Burns, all elected in November, have the conservative majority.

But Thursday's workshop was about working together to find key goals and priorities for the next four vears. It was facilitated by accounting and consulting firm Baker

Steve Mermell, the former city manager of Pasadena, led the council and City Manager Al Zelinka through much of the fourhour discussion. It feabrainstorming tured based on six general topics: fiscal stability, public engagement, housing and homelessness, infrastructure investment, fostering a high-performing organization and public safety.

The discussion on housing and homelessness was particularly detailed. A large majority — 79% — of Surf City residents surveyed for a quality of life study, the results of which were shared at Tuesday night's Council meeting, said that homelessness was an "extremely" or "very" serious problem.

According to last year's county Point in Time summary, there were 330 homeless people in Huntington Beach, including 188 unsheltered and 142 sheltered individuals.

"If we do not address the real issue, which is the mental health and the drug addiction, nothing will be changed," Van Der

Mark said. "We have the state constantly on top of us, telling us, 'Build more houses and everything will be solved,' and that's not the case. I think we need to focus more on the real issue, the fundamental health services they need. The county needs to step up some more."

But housing advocates have consistently argued that the lack of affordable housing is a driving factor in homelessness. The median home price in Huntington Beach is more than \$1.1 million, higher than the county average.

"We're not going to be able to raise wages to the \$280,000 to \$290,000 a year it takes to buy a median home in Huntington Beach," Councilman Dan Kalmick said. "[Prospective buyers won't] qualify for a loan without what I call early inheritance, which is receiving a down payment from your parents. That doesn't create a sustainable community."

At the end of the workshop, each member of the City Council was asked to identify nine specific priority items they wanted accomplished during the first two years of the strategic plan. In the category of financial stability, they included considering options for new revenues and an economic development strategy. Five of the seven also

identified implementing a 311 system to manage and track calls for municipal services as a key public engagement goal. housing, four said they wanted to take action to maintain local control of land-use planning. Huntington Beach has a pending lawsuit against the state of California over

housing issues.

In infrastructure investment, four said they wanted to provide worldclass beach facilities, including the renovation and expansion of 15 beach restrooms, new lighting for Pier Plaza, security and programming. Four also said they wanted to prioritize exploring additional sports and concert venues.

"I was thinking like a volleyball and basketball facility, or a world-class pickleball facility," Strickland said. "They can do tournaments and bring people from all over California and Nevada to our community. Right now we have an economic study on our softball and baseball Sports Complex, and the economic study was dramatic in how positive it was for our city.

In terms of creating a high-performing organization, all seven said they wanted to establish a onestop-shop to consolidate development and frequently used services in one location. And, in the realm of public safety, five said they'd prioritize a Huntington Beach Fire Department community risk reduction program, including an engagement coordinator, opioid prevention and targeted risk reduction campaigns.

Baker Tilly will next provide a written workshop report before city staff drafts a strategic plan for City Council approval, to be reviewed in September. A final strategic plan and implementation plan would be introduced for council adoption in Octo-
