Top seeds win volleyball titles at AVP H.B. Open

The duos of Andy Benesh and Miles Partain, as well as Taryn Brasher and Kristen Nuss, prevailed on Sunday on the north side of the H.B. Pier.

Andy Benesh was simply in the

The Rancho Palos Verdes native had six blocks and four aces in the first set alone of Sunday's AVP Huntington Beach Open men's volleyball title match. He's 6-foot-8, but the play seemed even bigger.

'It's fun," he said after the match. "I got into a little bit of a flow state. Sometimes the plays seem like they're coming to you.'

Top-seeded Benesh and partner Miles Partain cruised through to their second title in Huntington Beach, taking a 21-14, 21-14 decision over fellow 2024 Olympians Chase Budinger

and Miles Evans, the No. 2 seeds, on the north side of the Huntington Beach Pier.

The women's final was closer, but also featured the top seeds earning the hardware. Tarvn Brasher and Kristen Nuss got past No. 3-seeded Terese Cannon and Megan Kraft, 21-17, 21-23,

Benesh and Partain, who advanced to the quarterfinals at the Paris Olympics, had previously won Huntington Beach in 2023. That was their first AVP victory together as a team, and this year's title represents their fourth

as a team. Both the men's and women's

Costa Mesa resident Angie Nicargi, who during World War II was among the millions of American women embodied by the cultural icon known as Rosie the Riveter, was celebrated Friday to mark her 104th birthday.

The daughter of Italian immigrants, Angie was born in Brooklyn, New York on May 11, 1921. She was one of six children and is the only one still living.

She married her childhood sweetheart, Bill Nicargi, during the war.

"Bill was a wonderful man," Nicargi said. 'He was even awarded the Soldier's Medal for heroism when he saved the pilot of a burning While Bill was serving in North Africa,

Angie, then 21, joined the female workforce making airplane parts in a defense plant on the home front.

"It gave me a good feeling doing something in wartime," she said.

She and Bill made their home in Brooklyn, where they became the parents of three

School board seeker alleges 'smear' job

Lawsuits filed against companies run by Andrea McElroy have raised concerns in NMUSD board bid.

A Republican-backed candidate touting experience as an entrepreneur and running for a seat on the Newport-Mesa Unified School District's board in a special election scheduled June 10 — which will cost taxpayers more than \$400,000 — claims political opponents sought to "smear" her by misrepresenting a record of litigation filed against companies run by her and her exhusband.

Andrea McElroy is one of two people seeking to become the trustee for district Area 5, which includes neighborhoods served by Newport Elementary, Ensign Intermediate and Newport Harbor High. She's the parent of a former NMUSD student and the owner of Fair Play Active, a pickle ball-themed clothing brand, ac-

Triangle Square to be seen on Travel Channel

A segment hosted by Holly McDonald, a Costa Mesa resident and local real estate agent, will be aired on Friday.

Costa Mesa's iconic Triangle Square will soon take a turn in the national spotlight, as a handful of tenants at the 200,000-squarefoot retail complex will be featured in a segment airing on the Travel Channel Friday.

Hosted by Holly McDonald — a Costa Mesa resident and agent in Compass Real Estate's Newport Beach office — the roughly 5minute segment is set to air at 7 a.m., spotlighting upscale Western-themed steakhouse Westwood Coast along with other restaurants and entertainment destinations at the center.

Since last fall, McDonald has produced a string of episodic features on area neighborhoods, cultural institutions and hot spots as a Southern California host for "American Dream," a national real

3 O.C. 6th-graders bring gun, ammo to middle school

Three Fountain Valley 6th-graders brought a handgun and ammunition to a middle school campus earlier this week, po-

lice announced Tuesday. Officers responded to a report that a student possibly had a firearm at Vista View Middle School on Monday, according to the Fountain Valley Police Department.

It was not an active

shooter incident, police said. Officers allegedly discovered a "handgun and ammunition,"

backpacks, officials said. Three 6th-grade students were detained in connection, the minors' names were not released.

Two of the students were arrested and booked at the Orange County juvenile hall. The third was taken to a hospital for a mental health evaluation.

"Preliminary investigation indicates this was not an active shooter incident," police said in a statement. "It appears to be an isolated event, and there is no ongoing threat to campus safety. Out of an abundance of caution, FVPD will maintain an increased presence at the school in the coming days to ensure the continued safety of students, staff, and families."

"FVPD remains deeply committed to protecting our schools and community. As always, if you see something, say something.'

View Middle Vista

School Principal Manny Quezada assured parents that safety is a priority for students on campus. The campus remained open Tuesday following the detainment.

'The situation was investigated and has been resolved. Out of an abundance of caution, there will be an increased police presence on campus today to ensure that students, staff and our community feel secure and have direct access to law enforcement support. We are fully committed to maintaining a safe and supportive learning environment for all," Quezada said in an email to parents on Tuesday.

Trial begins for woman accused of masterminding fatal shooting

A 29-year-old woman recruited a "killer with a smile" to gun down a friend in Fountain Valley she suspected of leaking her hiding place from an ex-boyfriend, a prosecutor told jurors Wednesday, while the defendant's attorney argued the shooter "went rogue" and said her client had nothing to do with it.

Mary Diedra Chavez is charged with murder with special circumstances of lying in wait for the victim and conspiracy to commit murder. Co-defendant Oliver Reynaldo Leon, who is facing the death penalty, is set to go on trial separately.

Chavez, known as Mumbles, had been convicted on drug dealing and forcing currency and was on probation when she was accused of "masterminding" the July 19, 2021, executionstyle killing of 26-year-old Phia Marie Albanese, Senior Deputy Dist. Atty. Nick Thomo said in court pa-

In July of 2021, Chavez was "dating" Gustavo Alvarezmoreno, whose nickname was Clumsy, while he was in prison for carjacking, Thomo said.

Previously, she had been dating "J.J." and was the getaway driver in an attack her ex-boyfriend, Thomo said.

When J.J. survived the attack, she feared retaliation began "bouncing

around from Airbnb to Airbnb to hide from J.J.," Thomo said in his opening statement of the trial.

Her friend, Albanese, was also dating someone behind bars, so the two agreed to hang out, Thomo

"Guess who shows up at her door? Thomo said. "J.J." Chavez figured Albanese told J.J. where to find the defendant, Thomo said. "Consumed by her rage over a friend's betrayal," she "invited" Leon and other associates to get together for a meeting to plan revenge, Thomo alleged.

"They all decided Phia has to die," Thomo said. Police were called at 6:11 p.m. July 19, 2021, to 10372 Amberwood Circle regarding a traffic collision and found the victim's body in a Volkswagen Jetta, which was still in drive and on a front lawn, Thomo said. She was still buckled in the driver's seat and sustained three gunshot wounds to the back of her head and one to her left hand, Thomo said.

Police found a receipt for the Residence Inn in Tustin in the vehicle and when they went to the room the victim rented they talked to Lisa Bergstrom, who told investigators Albanese had received a phone call alerting her that someone was vandalizing her car, Thomo

The prosecutor alleged

this was part of the plan to "lure" the victim out of the hotel to kill her.

When the two went out to check the Jetta, Chavez drove up in a Mercedes Benz with Leon and another man, Thomo said.

Albanese left with Chavez and the others, Thomo said.

Video surveillance from the hotel showed the Mercedes entering the parking lot at 4:44 p.m. the day of the killing, Thomo said. Albanese's vehicle left the hotel at 5:40 p.m. with Chavez in the front passenger seat, while one of her friends trailed in Chavez's Mercedes, Thomo said.

"This is not a whodun-nit," Thomo said. "The shooter is Mr. Leon. The mastermind is the defend-

Chavez drove her friends back to Los Angeles and dropped them off after the fatal shooting, Thomo said.

Some of the evidence in the case will come from jailhouse phone calls, Thomo said. Chavez and her boyfriend discussed the hit on the victim, he alleged.

Leon "is the guy you bring around when you someone killed," want Thomo said.

After the shooting, Chavez called her boyfriend in jail and "tried to be a sophisticated crook," feigning surprise at Albanese's killing, Thomo said.

"She pretends like she

didn't know what happened to Phia," Thomo said. "She tries to set up her alibi, but [her boyfriend] doesn't catch on," so she changes the subject, Thomo said.

Leon is "a killer with a smile... Those are his words, not mine," Thomo said.

At one point in a jailhouse call, Leon expressed disappointment that his photo wasn't included in a newspaper account of the killing and referred to himself as a killer with a smile," Thomo said.

Chavez's attorney, Jessica Ann Sweeney of the Orange County public defender's office, said Leon "went rogue," and said the "situation was out of Mary's con-

Chavez "never wanted Oliver to kill Phia. She's not guilty of murder or lying in wait," Sweeney said.

"The truth is this was a chaotic, drug-fueled series of events," Sweeney said. Chavez had survived childhood sexual abuse, and her ex-boyfriend had beaten her while she was pregnant, Sweeney said. At the time she was trying to pull her life back together, the defense attorney said.

Chavez was staying with Jennifer Jacobs in a rented Airbnb at the time. Sweeney said. Jacobs told investigators Chavez admitted directing the killing of the victim, Thomo said, but Sweeney told jurors that the witness had

a motive to lie as she cut

a plea deal.

Chavez "was hiding from" her ex-boyfriend, Sweeney said.

She called Leon for protection, Sweeney said.

"Her main concern was getting out of that Airbnb alive," Sweeney said.

Chavez even left behind a letter for her godmother in case she Sweeney said. was

Chavez never told Leon to kill the victim, and "she did consider Phia her friend," Sweeney said.

"She just wanted Oliver for protection," there Sweeney said. "She didn't want Oliver to hurt Phia. There was no plan. There was no agreement."

Leon ingested methamphetamine before the shooting and "got angry and impatient," Sweeney

Before the shooting, Leon told Chavez "to get out of the car," Sweeney said.

Chavez "thought she would be next" to get killed, Sweeney said.

In the past, Chavez told Leon not to beat someone up, and he honored that, so the defendant thought he wouldn't kill Albanese, Sweeney said.

"She thought she could trust him on his word and obviously she couldn't," said. Sweeney "Oliver promised not to do anything."

It's a great way to showcase the progress that's been made at the center in recent years, according to Charity Dahlke, a property manager for Cannon TTM, which purchased Triangle Square in 2017.

The owners had big plans for the property and were making major upgrades just before the COVID pandemic hit, changing consumers' shopping behavior and impacting the center's progress. Only now is that bigger vision starting to come to life, Dahlke said Wednesday.

And the added exposure from McDonald's "American Dream," which focuses on the different kinds of elevated experiences visitors can have at the center, only serves to further that cause.

'Triangle Square has definitely gone through a bit of a metamorphosis lately," the property manager said. "This used to be a crown jewel in Costa Mesa, and now the owners are dedicated to getting this jewel back to where it was.

children, one of whom died as a child and another as a young adult.

When Bill passed away after 52 years of marriage, Angie continued to live in New York where she immersed herself in full-time volunteering, from childcare at a convent to kitchen work at a senior center.

But after her surviving son and his family moved from the East Coast to Southern California in 2006 and settled into Huntington Beach, she took a leap in her late 80s and decided to relocate herself.

"I don't regret moving to California," Ăngie said. "I have a wonderful son and daughter-in-law and no [family member] was left in New York."

Today she is blessed with

four grandchildren and five great-grandchildren. With Mother's Day falling on her actual birthday this year, a party in her honor with her family and friends was moved up to Friday at Coastal Heights Senior Living, an independent living facility in Costa Mesa.

For nearly 16 years, Nicargi has lived independently in her Coastal Heights apartment, where she is both the oldest at the facility, as well as its longest tenant.

"She is a definite firecracker, as someone who is full of life, a lot of energy,' said Heidi Peter, Coastal Heights activities director. "When you talk to her, she's just full of positive energy and has a lot to say. Never negative about anything."

When her vision began to fail, it was Angie's optimistic attitude that led her to acquire skills needed to

live as independently as possible through the daily living training program at Helen Keller Services. Rather than give up, she learned adaptive techniques and organization systems to keep her home and life in order.

"I used to play bridge and do crossword puzzles, which I miss a lot," Angie said. "Now I listen to [Amazon's AI service] Alexa and ask her all about the important news."



cording to publicly available candidate forms.

Her campaign highlights a career with Microsoft "shaping digital advertising strategies during the dotcom boom." She also owned the Paper House, a stationery store that had been in Newport Beach, according to her website.

The Balboa Bay Club sued the Paper House in 2007, claiming the store's proprietor didn't pay for advertising in the club's monthly publication, Bay Window Magazine. The store was also sued in 2008 by its landlords for unpaid rent. A judge ruled in favor of the plaintiffs in both cases, resulting in the payment of \$1,741 and \$9,784 in damages, respectively.

Those were among six cases filed against companies run either by McElroy or in partnership with her ex-husband, Russell Young, involving allegations of unpaid rent, nonpayment of attorneys' fees and breach of contract. Critics of her bid for a seat on NMUSD's board say these raise concerns about her qualifica-

"As an entrepreneur, I can tell you that business owners in California are often targets of frivolous litigation," McElroy said. "Business owners are often a target of false and malicious accusations, like those being leveled against

"DRAGGED INTO SOME LITIGATION"

One lawsuit filed by South Coast Trade Center 3, L.P. against McElroy known as Andrea Young at the time — and her ex-husband in 2013 resulted in a dismissal for reasons not clear in readily available court records. In that case, the defendants were contracted to develop a retail market called OC Mart Mix and attract customers as well as vendors to lease stalls at their location in Costa Mesa. In their complaint the plaintiffs claimed that, even after three years of operating, "because of defendants' poor management ... the company still had insufficient cash flow to satisfy the company's obligations."

Court records show that McElroy and Young attempted to launch other similar retail concepts. The company they formed, Union Market LLC, also operated the District at Tustin Legacy. Attorneys representing McElroy described it as a "thriving business for many years," but hardship brought on by COVID-19 pandemic led to the closure of many of its stores.

"Union Market fought in good faith to remain open at the District and to timely pay its monthly rent," an attorney representing Mc-Elroy, Robert P. Gowe of the firm firm Goe, Forsythe & Hodges, wrote in a letter sent to media outlets. "However, Union Market was unable to maintain its monthly rental payments due to the loss of revenue."

As a result, McElroy, Young and Union Market were sued for unpaid rent in 2022 by the company their business was leasing the Tustin property from, Vestar/Kimco Tustin LP.

McElroy's attorneys note that she was dismissed as a plaintiff in that case. Judgment was rendered only against Union Market, awarding \$747,843.98 in damages to Vestar/Kimco.

Vestar/Kimco filed a second lawsuit claiming \$4.5 million in additional damages in 2023 against Union Market, McElroy and her current husband. Allegations against the latter were "frivolous and unfounded," and he was later dismissed from that second case, Gowe said.

"Andrea has certain defenses to the 2023 Vestar lawsuit and disputes the allegations contained therein," her attorney added.

In a statement, McElroy told the Daily Pilot she was "dragged into some litigation" with her ex-husband. She went on to say political opponents and "far-left blogs are now running around with half-truths and full lies about that history to demonize me."

McElroy, under her former surname, was also listed among defendants in four additional suits filed for unpaid rent between 2009 and 2012 at various residences in Newport Beach. Those, as well as a 2011 case filed by Greater California Financial Services for an unpaid loan, also resulted in judgment in favor of plaintiffs.

The Daily Pilot was made aware of past litigation involving companies associated with McElroy by an Area 5 resident who acted independently, but is listed as among those endorsing her rival, candidate Kirstin Walsh.

Walsh, an occupational therapist and Newport Harbor High Parent Teacher Assn. president, said she and her campaign were not involved in researching Mc-Elroy's legal history or the distribution of that information to the media or public.

Mail-in ballots for the election were delivered Monday, and an in-person voting center at Coastline College in room 119 will be open from May 31 through 8 p.m. on Election Day, June 10, according to the Orange County Registrar's

FILLING A VACANT SEAT

The term for the position McElroy and Walsh are seeking ends in December 2026. It became vacant after former trustee Michelle Barto was elected to the Newport Beach City Council in November.

McElroy was among the four potential replacements considered at that time. She had support from board president Krista Weigand and trustee Lisa Pearson; they noted former trustee Barto was elected by about 65% of voters in the 2022 election, and said they wanted to appoint someone with views similar to hers.

Those who voted for Walsh highlighted her background of service in the district. During the spe-

cial meeting that resulted in the PTA president's appointment to the board on a 4-2 vote, trustee Ashley Anderson described Walsh as a person of balanced, open-minded judgment who made decisions "not based on national political things that are not necessarily relevant to us."

SPECIAL ELECTION

Walsh held the position about five weeks before a petition drive garnered 361 votes, enough to override her appointment and force a special election. Laws protecting the privacy of those who signed that petition prohibit its release to the public.

The election may cost \$444,695 between \$493,802 in public funds, according to the Orange County Registrar's Office.

McElroy emerged as the sole candidate running against Walsh. Her list of endorsements includes Barto, Pearson, Newport Beach Mayor Joe Stapleton, the Republican Party of Orange County and that organization's chairman, Will O'Neill, the former Newport Beach mayor.

Those endorsing Walsh include NMUSD trustees Anderson, Carol Crane, Michelle Murphy and Leah Ersoylu, as well as former Newport Beach Mayor Nancy Gardner.

Walsh said she was hesitant about entering the race, and only did so after learning that the costs incurred by the petition ousting her could not be undone even if she abstained from running. She said friends warned her pursuing public office could potentially expose details about her life, and told the Daily Pilot she hoped Mc-Elroy "had someone on her side to give her that same advice." She declined to comment on her opponent's business ground.

McElroy described concerns raised by Walsh's supporters as a "non story."

"The story should be that my opponent agrees with Gavin Newsom on forcing schools to keep secrets from parents about their children's health and gender," McElroy said. "Additionally, my opponent appears to be comfortable with books that are not age appropriate for young children in school."

In past interviews with the Daily Pilot, Walsh has said she opposes censorship. She has also acknowledged the state law giving educators discretion to share or withhold information about a student's gender identity, known as AB1955, may protect some from retaliation due to being forcibly outed.

Walsh said she is not interested in stirring conflict with lawmakers in Sacramento. She said her major priorities would be addressing overdue maintenance and other improvements to the district's infrastructure.

Both she and McElroy have expressed support for measures to improve campus safety, like the installation of AI-assisted surveillance cameras. They have also both voiced interest in expanding early career education for students who might want to pursue alternatives to college after high school.

SCHOOL BOARDS BECOME BATTLEGROUNDS

Newport-Mesa Unified has thus far steered clear of conflict related to alleged obscenity in materials distributed to youth or the question of whether educators should be required to divulge information about students' gender identity to their guardians. But those topics have been the center of debate in other commuacross Orange



In September 2023, the Orange Unified School District became the sixth in California to adopt a policy requiring campus staff to tell parents if their child began identifying as a gender other than the one listed on their birth certificate, directly in opposition to AB 1955. A similar initiative was considered, but ultimately rejected by the Capistrano Unified School District's board of trustees about a month later.

Last fall, conservative members of the Huntington Beach City Council approved a "Parent's Right to Know" ordinance. However, the city does not have jurisdiction over schools in Huntington Beach, which are governed by several different boards. That means the law only applies to instructors working at libraries, parks and other city facilities.

Right-leaning members of the Huntington Beach City Council also championed the implementation of a parental review board to identify and sequester material in libraries they deem either sexually charged or otherwise obscene and inappropriate for children. Opponents note that similar bodies have flagged titles for benign references to puberty and other biological functions, and decry them as an exercises in book banning and censorship.

Cultural issues associated with the perception of vulgar materials in classrooms and opposition to policies either meant to accommodate the needs and concerns of LGBTQ youth or include ethnic studies in curricula have been rallying cries for conservative politicians. As a result, school boards are repeatedly becoming battlegrounds in a broader conflict of ideologies and, according to the nonprofit CalMatters newsroom, California GOP officials have been actively recruiting and training Republican candidates to run for seats on what are officially nonpartisan boards.

champions received trophies shaped like a surfboard.



Local teams earn top-five finishes at CIF D1 swim finals

WALNUT — Fountain Valley High School sophomore Alyssa Ton celebrated her Sweet 16 birthday on Saturday.

Ton gave herself two great gifts at the CIF Southern Section Division 1 Champi-Swimming onships.

She won the girls' 200-and 500-yard freestyle events going away, posting personal-best times in each event in the process.

"I didn't know [the meet] was on my birthday until maybe a couple of weeks ago," Ton said. "I think honestly, it's pretty fun to have it on my birthday. To go lifetime bests in both [events] on my birthday, that's really fun.

The special talent helped the Barons' girls place a strong third place as a team, up two spots from a

Newport Harbor's boys set three school records at the Division 1 finals and finished tied for fifth as a team.

Ton repeated as Division 1 girls' 200 freestyle champion, going out fast and cruising to a first-place finish in a time of 1 minute, 44.12 seconds.

"I wanted to go out pretty fast and see if I could hold on, and I think I did just that," she said.

She won the girls' 500 freestyle by nearly five seconds, cruising to the wall in 4:43.19. Fountain Valley coach Nathan Wilcox said that at Thursday's meet preliminaries, Ton had broken the 1974 school record of Olympic champion Shirley Babashoff in the event. She lowered that time by more than a full second on Saturday.

She also swam leadoff as the Fountain Valley 200 medley relay team, which also featured senior Kaitlyn Nguyen, freshman Audrey Prall and senior Leyna Nguyen, touched third in

Kaitlyn Nguyen finished second in the 200 IM and fourth in the breaststroke the Barons, while Wilcox said his team also benefited from the improvement of Leyna Nguyen, who made the "A" final in the 50 free and the "B" final of the 100 freestyle.

"We're building some-thing really good at Fountain Valley," Wilcox said. "We're hoping that in three

to five years, we're up there with Santa Margarita and we have a chance of winning it every year. That's the goal. That's what we're trying to build."

Newport Harbor junior Connor Ohl won the boys' 50 free in 20.04 seconds, a week after swimming a 19.79 at Sunset League finals to become the second Orange County boy to go under 20 seconds.

Newport Harbor coach Kevin Potter said the Sailors boys set school records in six of 11 events this year, while Arie also set the 500 freestyle record last year. The Newport Harbor pool is under reconstruction and set to reopen next school year.

"Next year, when that new record board goes up, it's going to be a lot of new names on there," Ohl said. "Mulvey and Dash really wanted to have their names on that board."

Huntington Beach tunes up for final

It all went as it was supposed to go, another sweep to gird the resolve ahead of a top-tier boys' volleyball final — a No. 1-versus-No. 2 showdown, thanks to what was occurring up the coast — with a shot at a CIF Southern Section championship for the first time in a decade

Everyone wished it could have been otherwise.

Huntington Beach, ranked second in the state and third in the nation, marched into Friday night's Division 1 title game at Cerritos College against topranked Mira Costa by making easy work of defending champion Los Angeles Loy-

The 25-15, 25-21, 25-21 home triumph last Friday evening didn't mean a whole lot — the Oilers had clinched Pool B's berth with Tuesday's sweep of Redondo Union, and Loyola was going to miss the regional tournament regardless — except for their aspirations and, more vitally, the Cubs' desperation.

Loyola (27-7) arrived a broken team, reeling from the May 4 death of its team manager. Braun Levi, a University of Virginia-bound senior and Loyola tennis star, died early that morning after an allegedly impaired driver struck him as he walked across Sepulveda Boulevard in Manhattan Beach. Volleyball isn't the priority right now.

"They've checked out. They're not here," Loyola head coach Michael Boehle said before the game. "These guys have been hit with a lot. They got hit with my diagnosis of cancer early on [this season]. They got nailed with fires [in January]. And then they got nailed with the teammate's death. And they just aren't there.

"They're just not mentally there, you know? They're drained."

The Cubs hadn't practiced all week, and Boehle considered forfeiting their final two pool games, but "they wanted to play, and I love the fact that they gave it a shot."

Loyola, seeded third and aiming for a third successive CIF State Southern Cal-

ifornia Regional title, had opened Pool B play by, Boehle said, "overlook[ing]" Redondo, which was "flawless" and was "not going to get beat that night." Levi, whose family had relocated to Manhattan Beach after their home was destroyed in the Palisades fire, was killed three nights later. The close-knit Loyola community — the all-boys institution is the most prominent Catholic high school in Los Angeles — was devastated.

"There really isn't any words," said Boehle, who completed his 29th campaign as head coach. "I tried to navigate this as best I can. I just didn't have any answers for it. ... It's important that these guys stay together, as a group, as a brotherhood. That's what we've been telling them all week: 'This is your family. These are your brothers.'"

So they went out together Tuesday night against sixthseeded Newport Harbor and were listless in a fourset defeat.

"People are like, 'Hey, you're not in the finals this year,'" said Boehle, who has won seven section titles in 12 title-game appearances since 2003. "And I'm like, 'It's OK.' Like, 'We've got bigger things to worry about than being in the fi-

nals.'"

Friday night's finale was a chance for the Cubs to honor Levi. A moment of silence started the encounter, and Boehle made certain everybody got court time "so they can all say we did it for Braun."

"The outcome doesn't matter," he said.

The game was to be played Saturday, but Loyola held a "celebration of life" for Levi that evening, and Huntington Beach head coach Craig Pazanti "told Mike whenever he wanted to play, whatever he wanted to do, we were going to be OK with it."

"I think that's the great thing about the volleyball community," Pazanti said. 'We can come together when we have stuff like this. As much as we want to beat each other and are at each other's throats sometimes, you never want to see anybody have to go through this situation. I've been through it, as a coach a long time ago, when I first started coaching, and I know how devastating it can be to the team and the community."

The outcome was expected. Huntington Beach (34-3) has one of its best teams since winning section and regional champi-

onships in 2013, 2014 and 2015, had beaten Loyola twice, 3-0 the second time, and came in "respecting our opponents by playing our hearts out," senior libero Aiden Atencio called it.

"We want to play one way," he said. "We wanted to come out and win, 3-0. Even though this game didn't matter and we were clinched, we wanted to come out of a victory going into the finals."

The Oilers were dominant, using their serve-and-pass game and strong performances at the net from sophomore outside hitter Logan Hutnick (14 kills, two blocks) and senior middle blocker Nick Ganier Jr. (10 kills) to lead start to finish in the first set, take a sizable lead in the second, and pull away midway through the third.

Pazanti went deeper down his bench than usual, seeing it as "a great opportunity for a lot of guys to get on the floor who might not get on the floor." Starting outside hitter Colin Choi and opposite Ben Arguello, both juniors, had most of the night off.

The Oilers are short on stars — only setter Kai Gan, headed to Harvard, is set to play Division I in college —

but big on the collective. Choi and Arguello pounce on the chances outside, with Ganier and senior Justin Bulsom but manning the middle, and Gan ("one of the best setters in CIF," Pazanti says) — and Atencio, a four-year starter, keeping things moving. Hutnick, one of the best hitters in the 2027 class, and sophomore Easton Ebmeyer, just back from an ankle injury that's sidelined him all season, provide attacking depth.

It's looked like their best shot at the program's sixth CIF title since the 2013-15 reign, except for the presence of Mira Costa (31-2). The Mustangs, who lost to Loyola in last year's final, are a monster team.

"We're going to go get our slingshot, and we're going to give it our best effort," Pazanti said. "They're a big, physical team. We're not going to change. We're going to play our game. We're going to go out there and just do the best we can do. What we've been doing has been pretty successful."

The teams met back in February, at the Redondo Classic, with Huntington Beach, without Choi, dropping a 25-23, 25-23 decision. The Mustangs' only losses were in the Best of the West tournament final to Loyola (after the Cubs topped Huntington Beach in the semifinals) in early March and against national No. 2 Marist — two days after sweeping the Chicago school on their home court — at the Karch Kiraly Tournament of Champions in Santa Barbara in early April. Marist beat Huntington Beach the same day.

"[Mira Costa has] been pretty dominant the whole year ...," Gan said. "They're huge guys. They work really hard, and they're just allaround, really big competitors. Coming into it, you have to know you have nothing to lose. Us beating them would be truly a big accomplishment."

Mira Costa has won the last six meetings, two of them in Division 1 playoff games — 3-0 in a 2019 quarterfinal and 3-2 in 2023 pool play. The Oilers won semifinal showdowns en route to their 2013 and 2015 section titles.

Pazanti, who also won a 2021 Division II regional title, sees similarities between Mira Costa and his title teams that supplied the bulk of a 2012-16 winning streak that reached 121 games.

"[Our 2013-15 teams were] a different breed," he said. "You had the guy who started in the last two Olympics [T.J. DeFalco]. You have two guys who barely didn't make that cut in the Olympics. You got guys playing professionally overseas. We had 12 Division I players on that team.

"You look at the [Mira] Costa roster, and that's kind of what they have. I don't know if they have any Olympians, but they've got 11, 12 guys that are going to go play Division I volleyball."

Atencio says it "all comes down to what we do on our side."

"I think the serve and pass game is going to be crucial, but also the blocking," he said. "They're a very big, physical team, and I think that we have the blocks to handle that, the defense to scramble, and so we just need to have that grit and show out and execute."

Loyola keeps working through the pain.

"[I feel for] the family," Boehle said. "As a parent, I can't imagine what they're going through. I've got four kids. Someone said it best at school: As a parent, I want to be buried before I have to bury my own child. My heart goes out to them."

Boehle has one last task. Levi's father, Dan, emailed the coach after the Palisades fire, sent him a photo of Braun wearing his volleyball championship ring, except it was melted.

"I ordered him a new ring, to present to him this year at the end of our banquet," he said. "And I'm not going to be able to do that. I still get goosebumps. It breaks my heart. You just never know.

"That's the one thing that I'm really crushed by, that I'm not going to be able to hand him that. But 'you earned this.' I've got to give it to his mom and dad."

The Huntington Beach High girls' lacrosse team had to deal with a lot of adversity this year, and it started a month before the season even began.

Kelly Reid, a junior who played lacrosse, flag football and soccer at the school, died with her father in a plane crash in early January.

"She would have been a huge part of our team," said Oilers coach Brian Eisenberg, knowing that Reid still played a major role, as "For Kelly" became the team chant.

Huntington Beach battled its way to the semifinals of the CIF Southern Section Division 2 playoffs, but top-seeded El Segundo earned a 13-10 win Friday night at Cap Sheue Field to end the Oilers' season.

Huntington Beach (8-12) jumped on El Segundo (16-6) early, opening up by scoring five unanswered goals in the first quarter.

As the match went on, however, the visiting Eagles did a better job of controlling the draws and fighting back

El Segundo freshman
Riley Clinton led everyone
with four goals scored,
while fellow freshman
Contessa Tipton also
scored and played a key

"They've just jumped right in from the start, and we're so lucky to have them," El Segundo coach Shea MacDonald said. "It's really special to have such young leaders, to have that opportunity. A lot of times, players have to wait until their junior or senior years

El Segundo pulled within a goal twice during the second quarter, before a late eight-meter goal from Huntington Beach senior captain Lolo Pilkington gave the hosts a 7-5 half-time advantage.

But the visitors, who will play St. Margaret's on Fri-

day in the Division 2 title match, scored three unanswered goals in the third quarter. They took their first lead at 8-7 on a quick shot by senior Arrow Koester.

Huntington Beach junior Elle Tran gained control near the left sideline midway through the fourth quarter and sped toward the goal in front of several opponents. Her strike tied the score at 9-9 with 7:37 remaining, before El Segundo scored three straight goals.

Ella Jones and Pilkington led the Oilers with three goals each, while Summer Vandergrift added a pair of goals. Tatum Viezbicke also scored for Huntington Beach, with Pilkington leading with four draw

Losing Reid before the season even began undoubtedly left its mark as well, she said, adding that the tragedy brought the team closer together in some ways.

"We were able to practice more as a team," Pilkington said. "We were able to bond in our sorrow, just able to share emotions. We can't change what happened, but that's why now we play for Kelly no matter what."
