## Kids get a handle on safety at Huntington Beach Bike Rodeo

Toby Do left his mother's side and shouted with excitement as he made a beeline toward rows of brand-new helmets laid out in the parking lot of Jax Bicycle Center in Huntington Beach Tuesday.

The 7-year-old couldn't contain his glee while flicking neon wristbands on himself or poring over pamphlets and coloring books, oblivious to the chuckling police department volunteers across the table from him.

"Toby, remember to ask first," his mother, Minh Do said in a chiding but patient tone as he palmed assorted pieces of safety gear.

Meanwhile, Huntington Beach Police Sgt. Mike Thomas led Toby's 5-year-old sister, Tessa Do, around an obstacle course lined by short orange cones set up on the asphalt. She pedaled, her bike's training wheels rattling behind her, around a wide hairpin and then hit the brakes ahead of a line on the ground and the word "STOP." She and the sergeant ended their drills with a high-five sign.

The Do family, one of a handful who came out to the police department's bike rodeo that afternoon, traveled from Fountain Valley. The event is held about once a month at either Jax Bicycle Center or First Christian Church Huntington Beach, Thomas said, although officials were open to hosting it at other venues.

"We try to go to where we can reach the most kids, especially the younger ones, before they start hopping onto e-bikes," Thomas said. "But the rodeo is for everyone. This time we added a tighter serpentine pattern

to give more of a challenge to the older kids." Police have received numerous reports of e-bike riders breaking traffic laws near

## OCMA prepares for opening, celebrations

After more than a decade of dreaming, planning and building, the Orange County Museum of Art is ready for its debut at the Segerstrom Center for the Arts campus in Costa Mesa.

Museum leaders in a media preview Wednesday celebrated the completion of the \$93-million space, designed by Thom Mayne of Morphosis Studio, offering a sneak peek at its inaugural exhibitions.

The museum opens to the public Oct. 8 at 5 p.m. with a 24-hour celebration featuring performances, film screenings and art-making workshops. OCMA admission — on opening

night and for the next 10 years — is free, thanks to a donation from Lugano Diamonds in Newport Beach.

"Access to art is a basic human right, it's not a privilege, and we want to provide that access so that everyone feels welcome and at home here," Museum Chief Executive Heidi Zuckerman said Wednesday.

## Disposal site in harbor draws protest

The Friends of Newport Harbor asks N.B. City Council to delay the project's application to the Coastal Commission.

The Friends of Newport Harbor said they are not being heard.

Members of the group gathered at the corner of Marguerite and 5th avenues Tuesday night before marching to Newport Beach City Hall to ask the City Council to delay an application submitted to the state Coastal Commission for the construction of a confined aquatic dredged disposal site in lower Newport Harbor.

Instead, as the matter was not on the evening's agenda, council members took no action.

The harbor, one of the largest recreational harbors in the country, must be dredged regularly to remove sediment that would otherwise impede its navigation by vessels. It was partially dredged in 2012-13.

City Council discussions of the confined disposal site — also known by the acronym CAD — date to 2019, after mercury-tainted sediment was found near the turning basin and near Lido

## H.B. mall may add apartment complex project

The city's planning commission approved the move to replace the Burlington Coat Factory at the Bella Terra mall.

A project to build 300 apartment units at Bella Terra mall was approved Tuesday night by the Huntington Beach Planning Commission.

On a 6-1 vote, the commissioners green-lit the project submitted by DJM Capital Partners, co-owner of Bella Terra. The seven-story building would include studios, one- and two-bedroom apartments, a three-level podium parking garage and 25,000 square feet of retail and restaurant space on the ground floor.

It would feature five stories of residential housing over two stories of retail space and parking, for a total of 392,000 square feet.

The project would demolish the existing Burlington (formerly known as Burlington Coat Factory) and more than 30,000 square feet of surrounding retail space. TCA Architects is overseeing

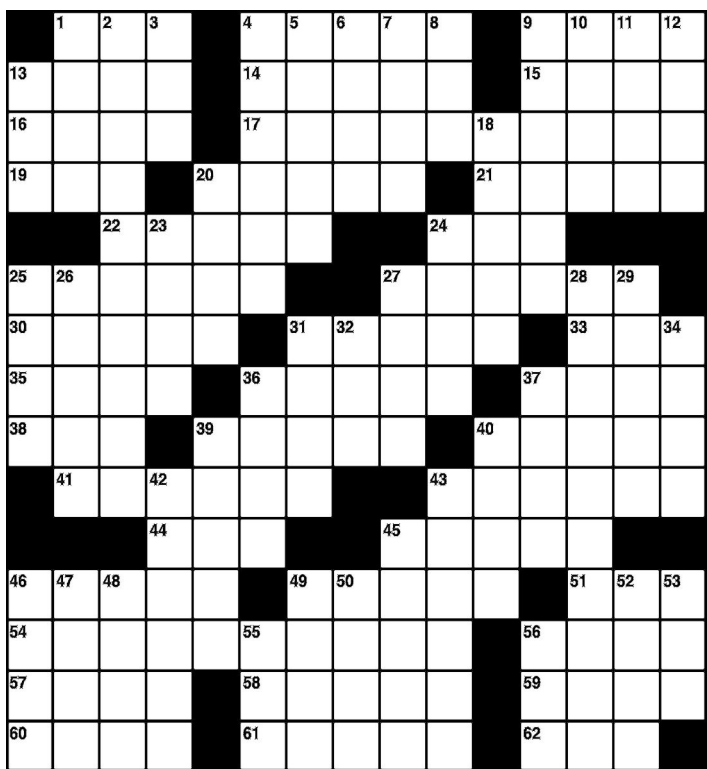

ing the plans.

After securing permits and construction, the apartments could open by 2026.

"Burlington Coat Factory marginally belonged in that mall in the first place, back when Bella Terra opened 15 to 17 years ago," Commissioner John Scandura said. "It was a dated department store, and over the years the business has declined to the point where only half the store is occupied now, and I doubt if it really generates much in the way of tax revenue."

"The problem is, to find a replacement for Burlington Coat Factory is almost impossible, because big-box retailers are contracting because of all the on-line retail business," Scandura continued. "Furthermore, the whole design of Burlington Coat Factory just doesn't fit in with the architectural design of Bella Terra mall. It's a square peg in a round hole."

Scandura said adding 300 apartment units will be helpful in alleviating part of the city's housing crisis and meet its Regional Housing Needs Allocation requirement.

"Clearly, there's enormous benefits about this," he said.

The new complex would also allow for a more direct

route for cars entering from Edinger Avenue, to the existing parking structure located on the north side of Bella Terra, adjacent to the movie theater.

Currently, cars have to head west toward Costco, which often gets crowded near the gas station.

The project, which will next go before City Council for approval, includes an affordable housing component. Forty-five of the units would be designated affordable housing, including 27 moderate-income affordable and 18 low-income affordable units.

Burlington's lease is nearly up, said Lindsay Parton, president of DJM Capital.

"We're prepared finally to, we think, make the final major improvement to Bella Terra," Parton said. "We're taking down Burlington Coat Factory and ultimately really solving a lot of the traffic and parking conundrum we've had at Bella Terra over the years."

The current allowed maximum building height under the Bella Terra Specific Plan is 75 feet and six stories, Huntington Beach senior planner Hayden Beckman said in a presentation, but a zoning text amendment would enable seven stories. Three proposed tower features, built as unoccupied space, would reach up to 91 feet, which is well within the plan's allowance of archi-

tectural features up to 125 feet high.

The commissioners wanted amendments made before they would support the project, including assurance that the new garage would have electric vehicle charging stations that wouldn't eliminate any parking spaces. Scandura proposed having directional signs to the parking garage, as well as a pedestrian bridge from the parking garage directly into the new apartment homes.

Planning Commission chairman Brendon Perkins said he wanted improved pedestrian access via walkways through the mall.

"I think this is a fantastic project," Perkins said. "The developer has taken lessons learned into account, as to what's not working and what is working on the property, and really being proactive in addressing that ... And I think mixed-use development is a fantastic way to go for adding additional housing stock in this city."

Commissioner Alan Ray was the lone dissenting vote. He said the seven-story project exceeded the city's specific plan, and he wasn't in favor of changing the specific plan.

Ray added he was opposed to using an addendum to an environmental impact report, instead of a full EIR, for the project.

Peninsula. The proposed CAD, with dimensions of 590 feet by 590 feet, would be located between Bay Island, Lido Isle and Harbor Island.

It would hold roughly 112,500 cubic yards of dredged material from the federal channels deemed unsuitable for open ocean release. The size of the CAD would allow for an additional 50,000 cubic yards of material from routine maintenance dredging outside of those channels.

The harbor ranges in depth from 10 to 20 feet. The top of the proposed CAD would be at a depth of roughly 22 feet.

As proposed, the 112,500 cubic yards of sediment will be put at the bottom of the hole, then capped with 1 foot of sand for approximately two years. Then, once the remaining 50,000 cubic yards of sediment is dredged, the material will be deposited on top of the first layer and capped with 3 feet of sand.

Its construction will close an existing anchorage in the harbor for a couple of years. City staff said they would direct traffic to another anchorage on the western side of Lido Isle.

The City Council voted to submit the proposal to the Coastal Commission in

May 2021. The application was initially up for review this September but was postponed to the state agency's October meeting.

Shana Conzelman, volunteer director of community outreach for Friends of Newport Harbor, said members of the advocacy group hoped that by speaking up at Tuesday night's City Council meeting they could convince council members to pull their application before state review, allowing the project's opponents to talk with the Coastal Commission and

review the application more carefully.

Conzelman said the organization — spearheaded by tech mogul Palmer Luckey, who with his team presented an alternative plan to council members in January — hoped the Coastal Commission would dismiss the project altogether at the upcoming October review.

"We originally came in [saying] we were not OK with this plan about four years ago. We were basically ignored and pushed aside, and they restruc-

tured their verbiage every time something came up," said Conzelman. "We've tried to take the high road because we wanted to work alongside with the city and we offered to present a better alternative."

City staff confirmed they reached out to Conzelman and other residents during the initial outreach for the environmental impact report four years ago. That report was approved last May.

Conzelman said the city agreed to grant them that opportunity, but the

Friends of Newport Harbor were unable to "properly present" their alternative to the city staff's proposal at an October 2021 hearing with the Harbor Commission. Three alternate areas for the sediment placement proposed by the organization were deemed implausible by city staff.

Luckey said he felt his January presentation hadn't been looked at neutrally and requested an independent analysis.

Conzelman said the Friends of Newport Harbor are in favor of dredging, which she said needs to happen whether or not the disposal site is installed. They are worried about the environmental safety of a CAD, but city staff maintain it is the most viable and economic way to dispose of that waste.

Public works manager Chris Miller said Wednesday that city staff have tested the sediment, modeled the disposal site and all needed tests have been submitted to the proper agencies.

"This is a project that is taking care of legacy material in our harbor that really hasn't been dredged thoroughly since the harbor was built," Miller said. "We've had sediment issues coming down through our watershed into the upper bay and the lower bay. Over the past 20 years, our watershed partners have done

an excellent job of controlling sediment that comes down from the upper reaches of our watershed."

Miller said the installation of the CAD does not mean the end of all dredging in Newport Harbor. The entrance channel will continue to need to be dredged, he said, and the possibility of spot-by-spot dredging remains, but nothing quite on the scale of what now needs to be done in the harbor will be required.

Conzelman and other members of Friends of Newport Harbor were disappointed but not surprised that the City Council took no action on their request Tuesday night.

"For us, we're not giving up. That I know for sure. We've lawyered up and we did not want to have to do that," Conzelman said. "In our opinion, their perspective on putting a CAD in our recreational and residential harbor that does not have an ocean flow ... We're an enclosed harbor. It's just wrong. It's not right for the people who visit or the ones that live here."

Conzelman said the group would head to San Diego to attend the Coastal Commission's meeting in October to voice their opposition to the proposed Newport Harbor CAD.

school campuses and other areas in Huntington Beach frequented by young people, Thomas said. He hopes that outreach through events like the rodeo will promote safer habits and reduce potential hazards on the road.

In addition to obstacle courses designed to teach responsible cycling, the rodeo also offers free helmets and safety gear paid for by grants from the California Office of Traffic Safety. People who come out can also have their

bicycles inspected to ensure that they are street-worthy.

Bentley Williams, 5, was the first child to arrive on Tuesday, along with his grandmother, Kathy Jarvis. She said the boy had been looking forward to racing through the course on his bike, which he started riding just a few months ago.

"They pumped up his wheels, found out that it was a little too low, and they completely checked out his spokes and breaks," Jarvis, of Huntington Beach, said. "It's nice to know that he's on a safe bike."

Minh Do said the bike rodeo and events like it are valuable opportunities for her children to connect with others in the area, especially because Toby and Tessa are homeschooled. And although their extracurricular-packed schedules don't leave much time for bike rides, Do wants to be sure that her children know the rules of the road.

"We don't have a chance to ride a lot, but this is a life skill," Do said.

Members of the Costa Mesa Police Department were also at the event. They plan on putting on their own bike rodeo at

Costa Mesa City Hall on Nov. 5, and decided to observe the one in Huntington Beach to get pointers.

Costa Mesa Police Officer Jose Torres added that their city has also seen numerous complaints related to e-bikes.

"We have a big problem with e-bikes because, to me, it's a vehicle; it's not a bicycle," Torres said. "We've had some pretty bad accidents [in Costa Mesa] regarding the e-bikes because they go too fast, they don't stop for stop signs."

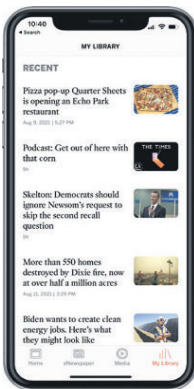

# F.V. City Council candidates forum addressed city issues, concerns

Eleven of the 13 candidates took part in a forum on Tuesday inside council chambers.

Candidates vying for seats on the Fountain Valley City Council addressed residents Tuesday night, each hoping to make the case for election in November.

The forum, held inside council chambers at Fountain Valley City Hall, was split into two parts, although the same line of questioning was implemented for both sections.

Memory Bartlett, president and chief executive of the Fountain Valley Chamber of Commerce, said the candidates did not have access to the questions beforehand. The candidates who participated in the second half were sequestered in another room prior to being brought out for their turn in front of the audience.

A rapid-fire round, during which the candidates held up green paddles to show support or red paddles to signal opposition to an issue, followed opening statements.

All the candidates said they were opposed to short-term rentals in the city. The council rejected an ordinance that would have permitted short-term

rentals in the city at its last meeting on Sept. 20.

Of the 11 candidates who took part in the forum, Shaun Diamond and Eugene Murray set themselves apart from the others in saying they would be in favor of allowing marijuana dispensaries in Fountain Valley.

The candidates proved to be more divided on allowing addiction recovery homes (incumbents Patrick Harper and Kim Constantine, along with Michael Mau, Diamond and Murray were in favor) and on their support for high-density housing projects in town (Rudy Huebner, Glenn Bleiweis, Jim Cunneen and Harper said they were in favor).

Panelists were asked to give detailed responses on topics such as fiscal issues to be addressed, zoning code and the approach to satisfying the city's Regional Housing Needs Assessment, for which the city has been tasked with planning for an additional 4,839 units by the end of the decade.

"One of the fiscal issues that's really at the forefront that's affecting the city right now is the unfunded pension liabilities," Huebner said. "When we're looking at actions that the city can take to pay down our debt, I think that we need to be mindful in

FULLERTON — Local cross-country teams got a chance to showcase their program depth on Saturday via the grade-level races provided in the Sunny Hills Wayne Walker Invitational. Corona del Mar High stood out in that regard, compiling a couple of individual victories while also seeing others place well within their races in the meet at Craig Park in Fullerton.

identifying revenue streams that will bring revenue to the city and allow us to pay down this debt at no cost to residents." Huebner added the electronic billboard proposed near the Fountain Valley water tower is one such way she believes the city can pay down debt without subjecting residents to further taxes. Darrel Mymon-Brown said the city could increase its percentage of the transient occupancy tax as a revenue producer, which she argued could prevent the need for a sales tax increase by passing the cost on to visitors. Jim Cunneen, who has been a trustee for the Fountain Valley School District since 2014, suggested that developer fees could also reduce the need for sales tax increases. "One of the benefits of new projects in our cities are that developers have to pay the city millions of dollars," Cunneen said. "In fact, the Slater apartments has nine conditions, of which that breaks down to many different permit fees." Although only a few candidates were asked to answer each question, the Slater Investments project was mentioned multiple times as a council decision within the last year that some candidates disagreed with.

Steve Nagel, a three-time mayor of Fountain Valley who was among the naysayers for that project, said the city should focus on local control when it comes to zoning code. "A lot of our zoning is dictated by the state," Nagel said. "Those are the things we have to try to get past and get through, and it causes a lot of grief at the local level. I don't always agree with how these things have come down, but we're losing some of that. The R1 residential areas are being changed, and we have different zoning requirements that we struggle with to make sure that we can make it fit to our general plan that we used to have. "Now, we're upgrading our general plan, and we're going to see some changes in that we're going to have to adapt to, so we have to try to fight to keep what we have but also make sure that we're flexible enough to see the future change a little bit. When asked what they believed the most important part of a local government was, Dwight Shackelford, Bleiweis and Mau all said public safety should come first. Thirteen candidates are in the race for three seats on the Fountain Valley City Council. Candidates Cindy Cao and Nancy Dugay did not participate in Tuesday night's forum.
