Second COVID-19 testing super site opened at O.C. fairgrounds

O.C. Health Care Agency director estimates site will process 500 tests a day before ramping up to around 1,000.

As California pushes to increase its coronavirus testing capacity, Orange County officials on Wednesday opened a new testing site at Costa Mesa's OC Fair & Event Center to aid essential workers, first responders and those potentially exposed to the virus.

Individuals exhibiting symptoms, healthcare workers and

residents and employees congregate living facilities along teachers, cery and food workers and public and utilemployees can register to be tested

Mondays through Fridays, from 7a.m. to 3 p.m., as long as they live or work in Orange County.

The new O.C. fairgrounds testing super site is the second of its kind countywide. The first, at the Anaheim Convention Center, has conducted more than 10,000 tests since opening July 15.

Both locations are backed by \$550 million in federal CARES act funding received by the county and are operated through a partnership between the Orange County Health Care Agency, the

Gov. Newsom announces increase in COVID-19 testing as county awaits reopening guidelines

BY MATT SZABO

Gavin Newsom on Wednesday announced vastly expanded COVID-19 testing, set to roll out within the next eight to 10 weeks.

Newsom also said at his daily press conference that he would be announcing new guidelines for reopening some businesses on Friday, as Orange and San Diego counties are both off the state watch list and Los Angeles County is showing positive about 100,000 tests per day.

Newsom said the state has agreed to a partnership with diagnostic testing and imaging company PerkinElmer, which would build a new laboratory in California. Once it is completed by November, the state would be able to conduct about 150,000 additional COVID-19 tests per day, bringing the average to 250,000, which is more than double the current average of

"We can bring down costs for everybody and improve reliability and access for everybody, in terms of getting tests and, more importantly, test results back in a timely manner," Newsom said. "There's an old song that says, 'You continue to do what you've done, you'll get what you've got.' Right now we are facing the prospects of moving forward over the next couple of months, moving into flu season. Flu season,

of course, puts tremendous stress and demand for testing ... So we're moving now in a new

Newsom said the \$1.4-billion lab will be able get test results turned around within 48 hours, much less than the five to seven days people typically now wait for results. Additionally, he said the test prices would drastically be reduced from the current av-

Students stuck in housing contracts

A new complex opens at OCC next month, but with courses online. students are looking to back out of their leases.

After years of planning the Harbour, a 323-unit housing development on the Orange Coast College campus that can accommodate 814 tenants, is in the final stages of construction and anticipated to be move-in ready for tenants by late September.

But since the new school year resumed Monday in an onlineonly format, after Coast Community College District officials decided in May to postpone in-person instruction amid a continuing coronavirus pandemic, just one question remains:

Who's going to move in now? Construction of the Harbour costs around \$100 million, officials

said, and is being funded through \$123.4-million tax-exempt college housing revenue bonds sought by OCC in a public-private partnership with National Campus and Community Development Corp.

The bonds will be paid off, in part, by rental income received. and the property managed by Chicago-based the Scion Group, LLC.

OCC second-year student Jonathan Kuse said he signed up to lease part of a two-bedroom unit intended to be occupied by four students each paying a monthly

Newport Beach stands behind its police department with resolution of support

In an era of hostility between citizens and police elsewhere, Newport Beach let its police department know Tuesday how

much it's appreciated. A resolution, unanimously passed by the City Council, applauded officers for how they handled several local protests earlier this summer that were part of an international movement against police brutality in the United States.

The resolution specifically

spotlights the Newport force's response on June 3, when five separate protests took place at various times and locations in town, drawing a combined 2,500 people. The protests were held to call out racial injustice in the wake of the death of George Floyd while in custody of Minneapolis police, and among dozens of similar protests in Orange County over the summer.

Aside from a local man driving his car through a crowd on Balboa Boulevard and another allegedly brandishing a handgun at marchers near the area of 30th Street and Newport Boulevard, the day of protest was peaceful, which the council attributed to police professional-

Councilwoman Joy Brenner said officers' recent expanded service has also included standing by for mass baptisms in the Pacific Ocean and the popular bioluminescence late-night events from a red tide that made the waves glow neon blue.

Drive-in movies screened at Huntington Beach's Stoney Harbour

Matthew Cramer was trying to set up a car show that could highlight his son Cole's automotive business.

He lived close to the Stoney Harbour space in Huntington Beach, located along Warner Avenue. It seemed like the ideal locale, so Cramer connected with Michael Shorey and Brandt Stebbins of Stoney's Pizza, who could rent out the space.

"I said, 'We want do a car show," Matthew Cramer said. "They were just starting to go into the food trucks every Wednesday, and I just happened to be at the right place. Mike goes, 'You've got to do more than one,' and I said, 'OK, all the way to Oct. 30.'

The car show idea has turned into the big picture show.

Cramer and his three sons launched SoCal Wheels & Reels, a drive-in movie experience at Stoney Harbour, on Aug. 14. Every Friday night through the end of October, they will be showing a movie on an 18-foot-tall screen overlooking the ocean.

For a \$100 fee per car, visitors get live music and comedy from 6 to 8 p.m., with the movie starting after that. There's also a food truck on site, and each car receives a \$20 credit with the entry price, though outside food and drink is permitted.

Wheels & Reels showed the original version of "Gone in 60 Seconds" for the first Friday night, and "Ferris Bueller's Day

Off" last week. The featured film this week is the surfing classic "The Endless Summer," which seems appropriate for Surf City.

The space can accommodate 40 cars with proper social distancing during the novel coronavirus pandemic, and Cramer, 58, and his sons are working hard to make the movie night more accessible. Walk-ins and people on bicycles will also be allowed starting this Friday, for \$18 per person.

"People walk by and go, 'What are you guys doing?'" said Matthew Cramer, a retired chiropractor. "I think it can take off, with the weather being nice this week and Labor Day weekend coming up."

Body found near H.B. Pier on Tuesday morning identified

A body found offshore Tuesday morning in Huntington Beach was identified as Dylan Haihuu Duong, 25, Orange County Sheriff's Department Sgt. Dennis Breckner said.

The cause of death appears to be drowning at this point, according to the autopsy, but toxicology reports have not yet returned, Breckner, said.

Huntington Beach Fire Department spokesperson Eric Blaska said that a marine safety officer was patrolling just south of the Huntington Beach Pier, near Lifeguard Tower 9, at around 8:30 a.m. when they saw an unknown object in the water. The marine safety officer paddled out and found Duong's body.

Duong, whose residence was unknown, was pulled ashore near Tower 9.

Blaska said no missing swimmers had been re-

Laguna Beach City Council candidates, other hopefuls take part in online forum

Candidates running for office in Laguna Beach streamed from homes all over the city Monday night to answer the call of an online forum meant to introduce them to local resi-

The forum, sponsored by Village Laguna and the Laguna Beach Community Summit, was moderated by residents Ann Christoph and David Raber. For about two hours, the five City Council candidates fielded questions submitted in advance, while candidates for other offices also participated. The forum was held through Zoom.

Council incumbents Bob Whalen and Steve Dicterow were joined by hopefuls Ruben Flores, who owns Laguna Nursery, land-use attorney Larry Nokes, and George Weiss, a co-founder of Laguna Residents First.

Laura Parisi, who is running unopposed for city treasurer, and city clerk candidates Ann Marie McKay, a law office manager and former city employee, and Mariann Tracy, the executive assistant to the city manager of Laguna Beach, joined the meeting.

The latter two are looking to replace City Clerk Lisette Chel-Walker, who said she would be retiring this year.

Candidates had about three minutes to introduce themselves.

Questions focused on the preservation of the city's character and concerns about development. One question asked council candidates their opinions on a ballot initiative put forward by Laguna Residents First, which, if approved, would allow for voters to decide on largescale commercial developments.

Other questions dealt with city budget priorities and tourism, as the city typically sees a tourist population of a little over 6 million annually. Candidates were also asked for their positions on parking and on a previous discussion where council mem-"seriously [considered]" reworking a \$11.3million Village Entrance project for a public art installation or a parking structure.

Incumbent Steve Dicterow pushed back on the question, saying he was opposed to redoing the entrance to establish a parking structure and that he preservation supported



erage of \$150 to \$200 for a PCR test.

Dr. Natasha Bhuyan, West Coast regional medical director for One Medical, said that establishing more testing before flu season hits is definitely ideal. She said medical professionals could be facing a "twin-demic," where people might have the flu, COVID-19 or the common cold.

"Having testing being widespread, accessible and affordable for people is one of our key public health pillars in fighting this pandemic," Bhuyan said. "If you think about the people of Orange County, I think just making sure that people have rapid access to testing with quick turnaround times is also critical."

Orange County was removed from California's coronavirus watch list on Sunday by the California Department of Public Health. If the county can keep metrics like hospitalizations, intensive care, ventilator capacity, positive test results and case rates low enough for 14 straight days, public school students could resume in-person classes at that time.

The Orange County Health Care Agency reported seven more deaths due to the coronavirus on Wednesday, bringing the death toll to 918. There were 448 daily positive COVID-19 tests received, and the cumulative case total is now 47,090.

There were 5,649 tests reported Wednesday, and 611,144 tests to date. The percentage of positive tests was listed at 5.2% Wednesday, well below the 8% threshold.

Bhuyan said this was not the time to relax, however, echoing the words of Newsom in recent weeks.

"It's good that things are trending in the right direction, but I still urge people to use caution," she said. "I don't want people to hear the news

that we're trending in the right direction, then throw caution to the wind. We still have to stay at home when we can, wear a mask when we go out, practice good hand hygiene, practice physical distancing and get tested when it's appropriate. Really, when I think about it, these are things that we're going to have to just keep doing until we get a vaccine."

The county also announced Tuesday that it would be retaining Dr. Clayton Chau as its director and county health care officer, positions he has held in a temporary role since June 8 following the resignation of Dr. Nichole Quick.

cities of Anaheim and Costa Mesa and 360 Clinic. Laboratory services are provided by Fulgent Genetics.

Rep. Harley Rouda (D-Laguna Beach), who attended a news conference marking the opening of the Costa Mesa site, said the boost in testing capacity is vital.

This long-anticipated step of providing testing has finally arrived, thank goodness, for people of Orange County who desperately need testing and tracking, as well as masking, distance and leader-Rouda said afterward.

The new site comes as health officials Wednesday reported 448 new infections and another seven deaths, bringing the cumulative number of infections to 47,090 and countywide fatalities to 918. So far, a total of 611,144 tests have been given, including 5,649 reported Wednesday.

It has been four days since Orange County was removed from a state virus watch list. If testing positivity rates, new cases and hospitalizations within thresholds defined by the California Department of Public Health, county schools may resume in-person instruc-

O.C. Board of Supervisors Chairwoman Michelle Steel said bringing the Costa Mesa testing site online is timely, as many teachers, students and school employees prepare for the potential reopening of school campuses in the wake of steadily declining countywide infections and hospitalizations.

"We understand that, with the start of school, there will be a need for our

teachers, students and families to use super sites such as Costa Mesa to ensure that they are free from COVID-19 in order to return to the classroom," Steel said.

"This site can get people in and out quickly and return their result within 48 to 72 hours," she added.

Earlier this month, Board of Supervisors Vice Chairman Andrew Do and 4th District Supervisor Doug Chaffee introduced a motion to allow schools to use the county's testing capability to meet state guidelines for school reopening. It passed unanimously.

Do said Wednesday the county has four testing sites that together are conducting about 3,800 tests per day.

"I cannot understate how important this testing capability is and how it fits into everything we're doing in the county to open up," he added.

Dr. Clayton Chau, director of the Orange County Health Care Agency and named county health officer, estimated the Costa Mesa testing site would likely process about 500 tests per day in the first week, before ramping

up to around 1,000 daily

tests by month's end. Costa Mesa Mayor Katrina Foley said the city was proud to host the new site alongside the OC Fair & Event Center and to help provide a vital means of identifying and isolating potential future hot spots for the virus.

Foley, who took a test at the site the day before in a dry run, said the process was simple.

"If you think you are at all exposed to anyone who has COVID-19, you should go online, check the box 'exposed' and come get tested," she advised.

rent of about \$995. That was in February, before the coronavirus closed campuses and crippled college plans nationwide.

Now, living with T-cell lymphoma, for which he's undergone chemotherapy, the immunocompromised 19-year-old has decided to live at home with his parents in St. Louis through fall semester distance learning rather than moving to be near the Costa Mesa cam-

"I'd sort of wanted my own space and access to all these things," he said of the desire to live on campus. "[But] there are many aspects now where I don't feel comfortable being with complete strangers.

Kuse got an email in early June informing him he had the option to cancel the lease within a 30-day window or to extend the contract start date to the 2021-22 school year.

Not knowing whether or when Orange Coast College might resume in-person classes, he responded and was told his lease was legally binding and could not be broken but that he could scale back to a six-month lease starting spring semester for an additional \$200 per month.

Kuse shared his predicament on a popular OCC student app, where he looked for someone to take over his share of the apartment. He even offered to surrender the \$500 down payment he'd paid under the original agreement.

His offer was one of many posted by OCC students looking to exit their agreements in the wake of coronavirus shutdowns.

"I just wish they'd be able to make some sort of con-

sideration with me and my health concerns or with students in general in these ever-changing times," Kuse said. "I know I'm not the only student in this situa-

Publicly available lease reports show 508 contracts had been signed by June 5, roughly reflecting 62% occupancy.

By the Aug. 3 reporting period, however, the number of leases had dropped to 404, including 50 new contracts signed in July. A total of 154 of the 508 lessees appeared to have backed out of their agreements by the end of July.

No report is listed for July, which would have reflected a 30-day cancellation window and indicated whether new leases were being solicited or signed even as students were canceling.

Jay Pearlman, senior vice president for the Scion Group, declined to share

the current number of leases Monday but said in an email while tenants had the option to leave or renegotiate, many elected to

stay.
"Most residents elected to keep their contracts in place and to live at the Harbour as soon as it opens," Pearlman said. "As a result, the majority of apartments at the Harbour's will be occupied this fall, but we still have available space and expect to be able to accommodate move-ins at least until January."

The complex is anticipated to open Sept. 25, according to Pearlman. Among those who chose to cancel is OCC second-year student Jude Esqueda, who originally agreed to rent part of a two-bedroom unit but decided not to move to campus during a pandemic.

"I was planning on moving into the new housing center. Now, I don't think it's

safe," he said of his decision to take OCC classes online from his parents' home in Riverside County. Esqueda became ac-

quainted with the Harbour and its leasing options in summer 2019, when he worked as a community adviser for the Scion Group, reaching out to students and prospective tenants to fill the housing complex. The 21-year-old said giv-

en how hard sales team members worked to get students to sign contracts, he's not surprised some tenants are having a hard time finding a way out. "Our only focus was get-

ting the highest number of leases," recalled Esqueda, who voluntarily left the position in January. The 21-year-old Esqueda

described the 30-day cancellation period as somewhat of an exodus but acknowledged many more may be stuck with a lease

contract that, for now, is of little use.

"Before June there was just a flood of students begging other students to take over their leases," Esqueda said. "A large factor was students couldn't afford it. Also, there's no point — if classes are online, it's not worth it."

Citing a busy Monday with classes back in session, Orange Coast officials said they were unable to speak for an interview by deadline. However, President Angelica Suarez assured in a statement students' needs were being considered.

"The college is looking forward to having students move into housing in September," Suarez said. "Safety is our top priority, and we will continue to accommodate our students in any way we can."

Zach Hale, who met the family as he works across the street from Cole's 320 Industries automotive shop in Huntington Beach, provides the screen. Hale owned a company called Utah Outdoor Cinema in Salt Lake City and hopes to officially launch HB Outdoor Cinema soon.

Overall, it has taken teamwork to make Wheels & Reels come together.

"We're all just trying to work toward one common goal," Cole Cramer said. "It was kind of a way to get a bunch of local start-up
