# Study suggests higher virus rate

Findings show 11.5% of a random sampling of O.C. residents' blood had COVID-19-related antibodies.

While reported cases of coronavirus in Orange County continue on a steady upward trajectory, the true number of people who may have been infected with the virus and recovered without exhibiting symptoms or being tested is thought to be much higher.

A recent study conducted through a partnership between UC Irvine and the Orange County Health Care Agency, the findings of which were released Wednesday, hints at just how much higher that unknown number

Researchers found that the blood of 11.5% of the more than 3,000 random participants sampled at 11 drive-through testing sites tested positive for COVID-19-related antibodies. That figure is about seven times as many people as health officials previously estimated and, when applied to Orange County's total population of 3.2 million works out to

roughly 368,000 residents.

"There was this lurking suspicion that there's a large fraction of people that have it that did not know," UCI Public Health Associate Professor Tim Bruckner said in a UCI news report Wednesday. "Either they had no symptoms and did not seek care, or they did not have symptoms and had no

reason to go."

An even higher rate of Orange County Latinos and low-income residents who participated in the UCI study — 17% and 15%, respectively — were found with antibodies indicating they had already been infected with the coronavirus.

In a media briefing Thursday, Orange County Health Care Agency Director and Public Health Officer Dr. Clayton Chau said the results of the study were not surprising but do indicate more work is needed to target groups most at risk for infection.

"The survey's key findings truly point to the need for something that we have known and have been laser focused on tackling and that is the issue of health equity," Chau said.

In addition to partnering with area organizations who work directly with vulnerable populations, the agency aims to recruit for a director of population health

# 'Just be open to everything'

Be kind. Be patient. Be inclusive and take nothing for granted.

Grace Murray said her older sister, Ava, taught her that.

Grace, 17, said she started volunteering with organizations like Best Buddies, Special Camp and Special Olympics Southern California when she started high school in Newport Beach because of Ava, who had Angelman syndrome, a rare genetic disorder that has shared characteristics with autism and cerebral palsy. Ava died at age 12 in 2012, but Grace said Ava's impact on her life has grown every day as she's gotten older.

She said she wants to continue her work into college and that her goal is to find a career in which she can help house or provide services to those with special needs.

So, when the pandemic closed Corona del Mar High School in the middle of her junior Corona del Mar High senior writes a book to children in honor of her sister, who had Angelman syndrome and died at age 12.

year and put a hold on her volunteering activities, all of Grace's plans for the rest of the year and her summer — Special Camp was canceled, she explained — ground to a halt.

"I was thinking of what I could possibly to do that I could do from home that could be beneficial for people without it being dangerous," Grace said. "So, I started to write the book."

This summer, Grace self-published "The Same But a Little Different," a children's book about a girl with Angelman syndrome and her sister on a trip to a water park. The intention, she said, was to instill in children from a young age to include all people, but especially those with special needs.

The book is about 26 pages with three to six sentences on each page, each one completed with illustrations from Antonio Pahetti.

"With my sister, I would see people staring at her or laughing at her because she'd wear diapers and be in a stroller at an older age," Grace said, adding that the story was based on a personal experience she and Ava had. "At the end of the story, there's tips on how to be kind and inclusive and why it's important to be sympathetic and nice to everyone."

So far, Grace estimates about 165 copies have been sold.

One of those copies was sold to Penny Schwent, whose own daughter, Emily, has Angelman syndrome. Schwent, who lives in Schaumburg, Ill., said she heard about the book through a Facebook group for Angelman syndrome and bought a copy for her

# Homeless in Newport down 50% since March

When the pandemic led to a statewide stay-at-home order, daily life as it was known stalled — that includes the estimated 60 to 70 homeless individuals in Newport Beach in early 2020.

At Newport Beach's City Council meeting Tuesday, city staff reported that it has reduced its homeless population by at least 50% or more. Estimates place the

current population at 20 to 30 as of October.

Many were housed as part of Project Roomkey, a statewide initiative to repurpose hotels and motels bereft of visitors in light of the pandemic to serve as temporary housing for homeless individuals more at risk for contracting COVID-19.

City staff said others were housed in sober-living facilities, supportive housing, congregate housing and other arrangements.

The program ended in late September, but city officials said the program allowed them to house 33 individuals. It was funded by the Federal Emergency Management Agency and the state.

Homeless coordinator Natalie Basmaciyan said the 2019 Point-In-Time count identified about 65 to 80 people experiencing homelessness in Newport Beach. Of those, 55 people have been housed and sheltered, but Basmaciyan stressed that those individuals may not be from the same people identified in Janu-

ary.
"Some people might find their own accommodations. Somebody else might start experiencing homelessness, but it's a working number that we've been us-

The five candidates for mayor include incumbent Mayor Katrina Foley, and current City Councilwoman Sandy Genis, who are running against three challengers — former Councilwoman Wendy Leece, Finance & Pension Advisory Committee member Al Melone and newcomer Quentin Pullen.

The Deily Bilet sent a question

granddaughter, who is 2.

All the proceeds for the book are donated to the Angelman Syndrome Foundation.

"I wanted [Maddie] to start out early and to not be afraid," Schwent said. "She knows her aunt is different. She loves her, but is a little bit wary sometimes because of the behaviors my daughter has. I brought the book down to them.'

They changed the girl's name to Emily, Schwent said, so now Maddie calls the book "Aunt Emmy's

"Last time she was there, she brought it to every single one of us to read Aunt Emmy's book to her. To her, it's a really nice book about her aunt and the girl on the front looks very similar to my daughter with the long, brown hair and the wheelchair," Schwent said. "That could be a picture of my daughter."

Schwent said she felt that the book helped her granddaughter see it was normal to have an aunt with special needs.

"I think it's so important to start out very young. You don't want to instill a fear or a worry about people being different and you start out, even as toddlers, letting them know that's normal," Schwent said. "She makes noises. She laughs a lot. She has trouble walking.

"They see that as a normal part of any person and they're so much more accepting as they grow up and as they grow and get out in the world more, they won't be afraid," she added. "They won't treat them poorly because of being different."

Grace's mother, Alissa Murray, said she was proud when Grace told her that she'd write a book about her and her sister. She said Schwent reached out to her on Facebook after buying the book.

"I was like, 'Aw, that's why Grace wanted to write this book.' It's not just Angelman syndrome. It's for anyone differently abled," Murray said. "It reaches out to so many."

Grace said she was a little shocked by the number of

people who bought the book but said she doesn't know if she'll write another. She's busy thinking about the next thing she could do to possibly help the special needs community.

But, she said, she hopes the message of being kind to everyone, not only those with special needs, is one she can spread widely.

"Everyone has bad days. Everyone has stuff at home that they don't want to share, and being kind is so easy to do and it's a lot of effort to go out of your way to be rude," Grace said. "It's so important to be kind and it really does make someone's day."

"Just be open to everything," she said.

and equity, who would work within all levels of the agency and in affected communities to develop strategies and partnerships designed to improve health outcomes.

"We are looking for someone who really has the ability to engage across sectors as well as listen to the communities in need and appropriately," Chau said of the position.

OCHA officials on Thurs-

day recorded 229 new cases of coronavirus and one death, bringing Orange County's cumulative case count to 59,442 and the fatality rate to 1,468. Area hospitals reported they were treating 181 individuals for COVID-19, including 59 in intensive care units.

The county's seven-day average of new cases stood at 5.1 per 100,000 residents, while the average health equity quartile positivity rate hovered at 6% — those figures would need to drop to 3.9 and 5.2% in order for Orange County to move to a less restrictive "orange" reopening tier.

Thursday also saw reporting of 9,102 tests countywide, bringing the cumulative total to 1,091,441 tests issued so far and accounting for a seven-day average testing positivity rate of 3.2%. On Thursday, Chau encouraged residents to get tested regularly.

"There are people walking around asymptomatic, and if they don't get tested, we don't know," he said.

ing," Basmaciyan said.

The next Point-In-Time count is scheduled for January 2021.

Basmaciyan said that since the 2019 Point-In-Time count, the city formed an interdepartmental "rapid response" team, which collaborates with homeless outreach service provider

City Net, to respond to community concerns.

"It is very frustrating for residents to see people in distress, living their lives publicly," Basmaciyan said. "I know there's an anger factor and we do our best to work with everybody and make sure their dignity is maintained while we're going through this very complicated, long process trying to reintroduce them into a better way of living."

"That is where City Net plays a key role. They have the connections and the referrals to help us do that," she added.

The city said it is also completing discussions with Costa Mesa on a regional partnership to provide shelter services, which Basmaciyan said would be more "cost effective than running [Newport Beach's] own shelter." Basmaciyan said both cities likely served

some of the same community members and would be able to avoid duplicating costs and efforts geared toward those repeat individuals.

Staff is expected to bring back a memorandum of understanding between the two cities for City Council's consideration on Nov. 10 and is also considering developer proposals to create permanent ' supportive housing for up to 50 indi-

viduals in the city. The 70bed Costa Mesa shelter is expected to be completed by March. If approved, it would pro-

vide 20 shelter beds for Newport Beach.

"This is not the cure-all, end-all, be-all," said Assistant City Manager Carol Jacobs. "This is not the cure for homelessness. A permanent home is the cure for homelessness and, again, that permanent supportive

housing that we're working on as well.

"But, we will be able to enforce the anti-camping laws a little bit more strongly, be able to get people in the shelter, which puts them in the process to get them permanent housing and that really is what the shelter is for," Jacobs

nity and respect, including respect for property rights. Defunding our police is not a solution. Neither is defanging them to where they can't do their job and their personal safety is threatened. Weeding out dysfunctional individuals from law enforcement is important. Longer term solutions will be up to national and state policymakers.



### housing crisis?

We are appealing the RHNA allocation. We will be meeting with and surveying residents throughout the city to build a consensus on appropriate development. That community feedback will drive our decisions. We are working with the state on developing units on Fairview Developmental Center in a beautiful village setting.

What else would you focus on as a council member?

My focus will continue to be on addressing homelessness, improving public safety and enhancing our traditional neighborhoods. We will be opening a permanent shelter near the airport in early 2021. We will increase public safety staffing (police officers and 911 operators). We will also work to build protected bike and walking lanes on Adams Avenue.

## City Council District 2

Costa Mesa's Second Council District encompasses Halecrest, Mesa North, South Coast Metro and the Sobeca District, while District 6 covers most of the city's Eastside, except for small portion just east of the 55 Freeway, served by District 3.

This summer, the Orange County area saw demonstrations related to issues of social justice, policing and inequity. How do you think constituents view these issues, and how would you address them on the dais?



As a planning commissioner, I have helped regulate sober living homes and would continue to ensure our ordinance is enforced. For the Eastside, I would protect our neighborhoods from impacts related to the airport, maintain the city's efforts to address homelessness, better manage traffic and improve pedestrian mobility and safety on

What are your thoughts on the city's response to the COVID-19 pandemic? If elected, how would you help the city recover?

Costa Mesa did well expanding ordinances to allow businesses to conduct commerce in outdoor spaces. A poor public response from Mayor Foley involved a public masking ordinance that carried a \$100 fine. I condemn such blatant government overreach and hijacking the pandemic narrative for political purposes. I will seek to lessen the culture of fear around the spread of COVID-19.

This summer, the Orange County area saw demonstrations related to issues of social justice, policing and inequity. How do you think constituents view these issues, and how would you address them on the dais?

Constituents support First Amendment rights to peacefully protest. Following the death of George Floyd, residents expressed concerns at the behavior of the police officers involved and supported the peaceful protests that followed. Attitudes changed when violence, vandalism and mayhem erupted. I reject defunding of our police due to the actions of a few. Law and order must be preserved.

I will reach out to those that can be helped while promoting enforcement of anti-camping and anti-vagrancy laws.

The First Amendment is powerful and the basis of our Constitution. We must support and facilitate a safe environment to practice our freedom of speech. Attitudes appear to be tied to political leanings. People need to be heard in a way that is peaceful and remain respectful of the property

The numbers are unrealistic and unattainable and would change the character of our city. Smart planning should always be the basis for growth and fulfilling community needs. Accommodating more residents with limited facilities will require smart planning and will be a challenge in a city that's 94% built out. Residents will have a voice with the small-growth initiative, Measure Y.

What else would you focus on as a council member?

During my campaign, I've found a distrust among residents regarding the city's budget and policies. Homelessness is another concern, along with public safety and parking. Residents feel homeless individuals have become very visible. We need to enforce anti-camping laws and expedite the city's new bridge shelter. That, sound fiscal planning, and communicating responsible virus practices are our three biggest challenges.
